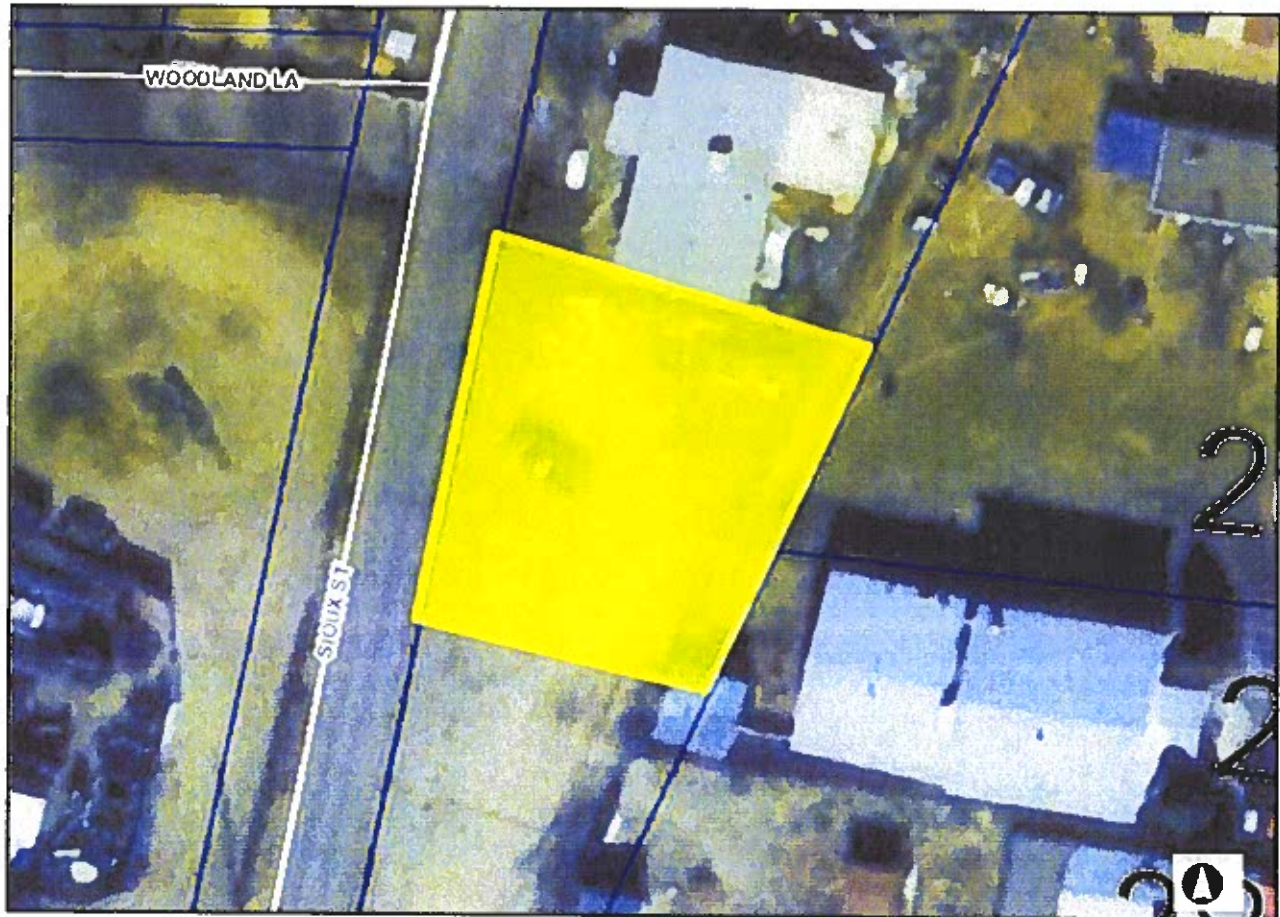

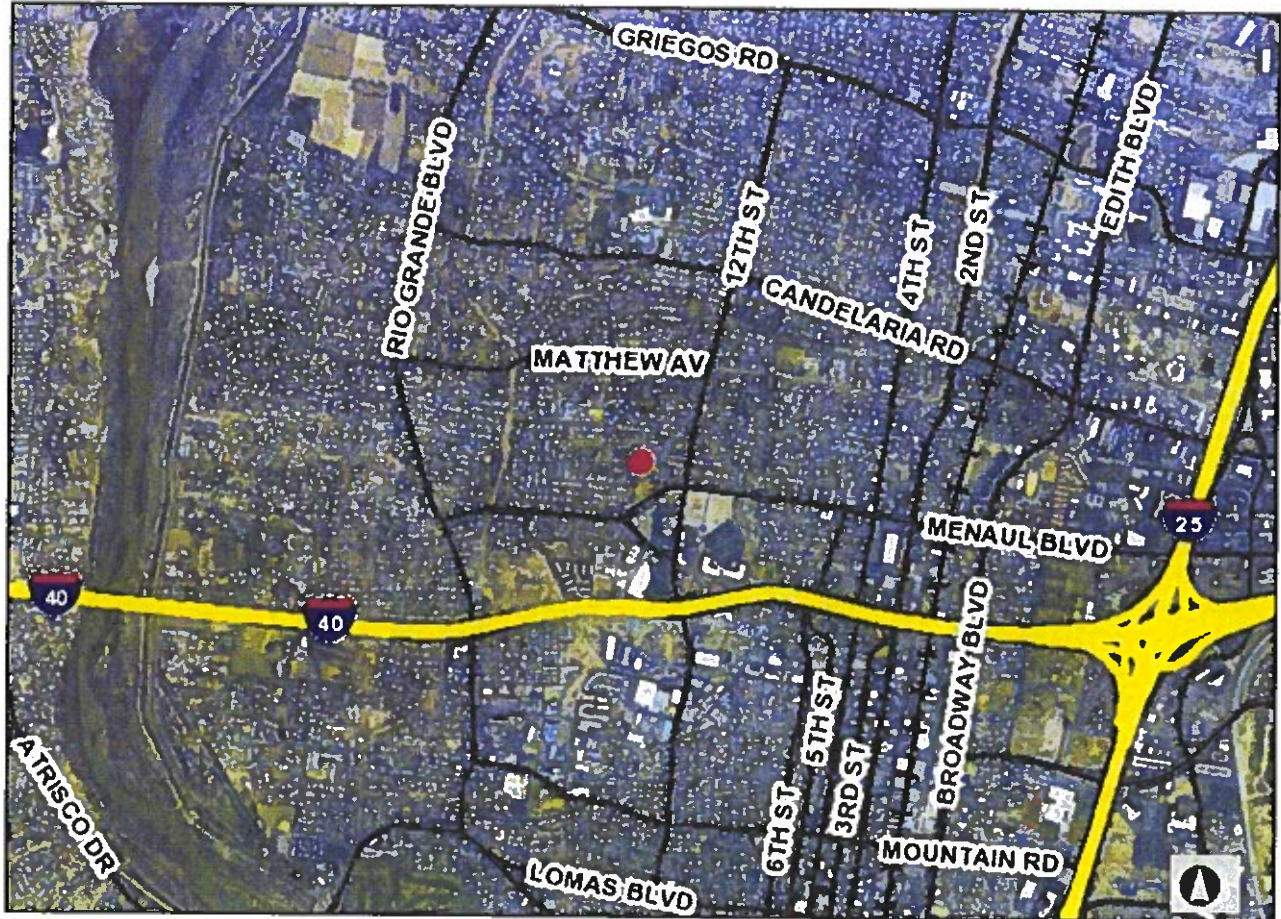

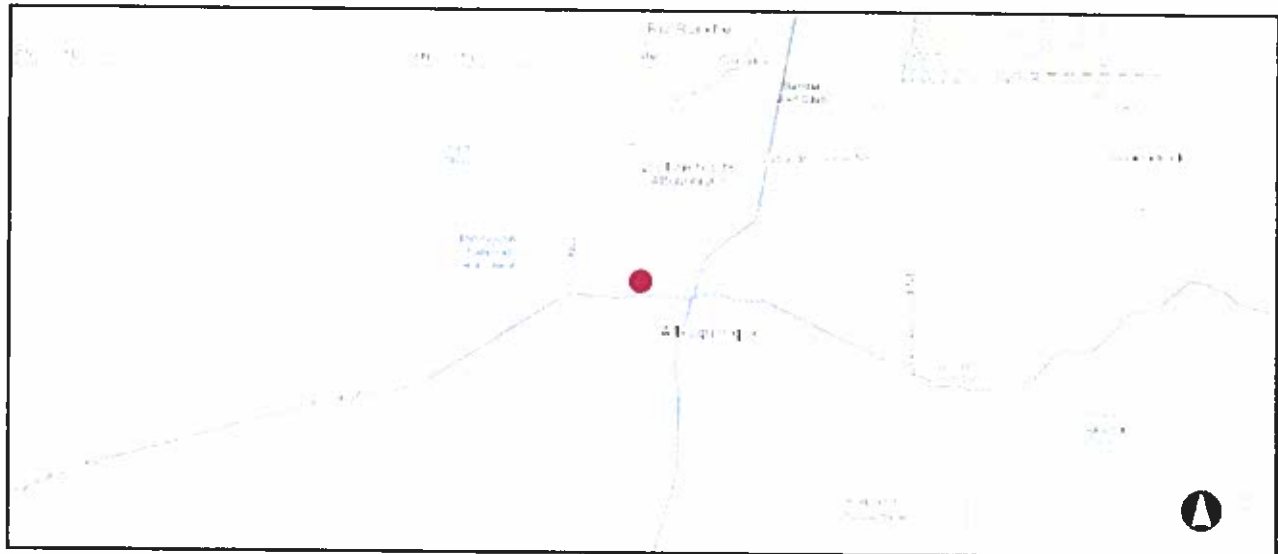


City of Albuquerque Property Fact Sheet

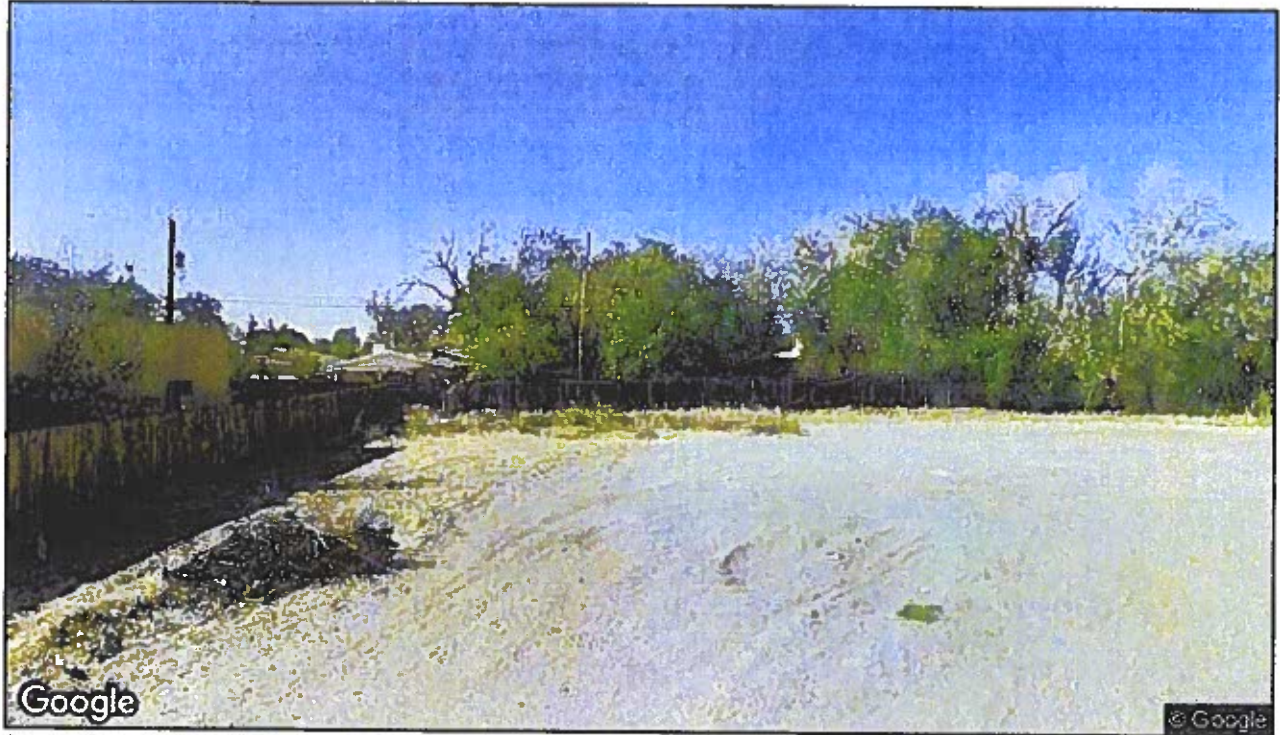
