5 NOTICE REQUIREMENTS FOR MEETINGS OF THE BOARD and APPROVING THE
6 2025 HUMAN RIGHTS BOARD REPORT

7 WHEREAS, § 10-15-1(B) (NMSA 1978) of the Open Meetings Act states that
8 “[A]ll meetings of a quorum of members of any board, commission, administrative
9 adjudicatory body or other policymaking body of any state agency, any agency or
10 authority of any county, municipality, district or any political subdivision, held for the
11 purpose of formulating public policy, including the development of personnel policy,
12 rules, regulations or ordinances, discussing public business or for the purpose of taking
13 any action within the authority of or the delegated authority of any board, commission or
14 other policymaking body are declared to be public meetings open to the public at all
15 times except as may be otherwise provided in the Constitution of New Mexico, or the
16 provisions of the Open Meetings Act;” and

17 WHEREAS, any meetings subject to the Open Meetings Act at which the
18 discussion or adoption of any proposed resolution, rule, regulation or formal action
19 occurs shall be held only after reasonable notice to the public; and

20 WHEREAS, §10-15-1(D) of the Open Meetings Act requires the Board to
21 determine annually what constitutes reasonable notice of its public meetings; and

22 WHEREAS, § 2-6-1-4(B) (ROA 1994) of the City of Albuquerque Public Boards,
23 Commissions and Committees Ordinance requires that every public board, commission
24 or committee created by the City of Albuquerque must determine what is reasonable
25 notice to the public of its meetings; provided that in no event shall notice be less than
26 the notice required for Albuquerque City Council meetings; and

27 WHEREAS, § 11-3-5(I) of the City of Albuquerque Human Rights Ordinances
28 requires that the Albuquerque Human Rights Board “submit annually a written report of
29 its activities and an evaluation of the effectiveness of this article to the City Council and
30 Mayor with recommendations for changes.”

31 NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ALBUQUERQUE
32 HUMAN RIGHTS BOARD:

33 SECTION 1. REGULAR MEETINGS

34 Unless otherwise specified, all regular meetings of the Board shall be held in [the Lower-](#)
35 [Level Hearing Room of the Plaza Del Sol Building at 600 2nd Street NW, Albuquerque,](#)
36 [NM 87102](#) starting at 5:00 PM Mountain Standard Time on the following dates:

- 37 (A) Thursday, January 15, 2026
38 (B) Thursday, February 19, 2026
39 (C) Thursday, March 19, 2026
40 (D) Thursday, April 16, 2026

- 1 (E) Thursday, May 21, 2026
- 2 (F) Thursday, June 18, 2026

- 4 (H) Thursday, August 20, 2026
- 5 (I) Thursday, September 17, 2026
- 6 (J) Thursday, October 15, 2026
- 7 (K) Thursday, November 19, 2026

8 **SECTION 2. SPECIAL MEETINGS.**

9 Special meetings of the Board may be called by the Chairperson of the Board or by a
10 majority of the Board members upon seventy-two 72 hours advance notice. The agenda
11 for a special meeting will be available to the public at least seventy-two (72) hours prior
12 to a special meeting.

13 **SECTION 3. EMERGENCY MEETINGS**

14 Emergency meetings of the Board will be called only under unforeseen circumstances
15 that demand immediate action by the Board to protect the health, safety and property of
16 citizens or to protect the public body from substantial financial loss, pursuant to the
17 Open Meetings Act, NMSA 1978, Section 10-15-1 (F). The Board will avoid holding
18 emergency meetings whenever possible. Emergency meetings may be called by the
19 Chairperson or a majority of the Board members upon twenty-four (24) hours' notice,
20 unless threat of personal injury or property damage requires less notice. Public notice
21 for an emergency meeting shall include an agenda for the emergency meeting.

22 **SECTION 4. PUBLIC NOTICE.**

23 Public Notice for all meetings described in this resolution, public notice requirements are
24 met if:

- 25 (A) The notice contains the date, time and place of the meeting is posted for public
26 viewing in the following location(s): in the 1st floor lobby of the Albuquerque
27 Government Center at 1 Civic Plaza NW, Albuquerque, NM 87102, unless
28 posting such notice is made impossible due to ongoing public health restrictions
29 or other legal limitations. An electronic copy of the notice will be posted on the
30 City website at <https://www.cabq.gov/civilrights/events> and this website address
31 may change from time to time as needed by the City or the Board.
- 32 (B) The agenda for a special and regularly scheduled meeting shall be available to
33 the public at least 72 hours (3 days) prior to such a meeting. An English
34 language agenda will be available to the public at [www.cabq.gov/office-of-
35 equity-and-inclusion/civilrights/human-rights-board/](http://www.cabq.gov/office-of-equity-and-inclusion/civilrights/human-rights-board/)
- 36 (C) Members of the Public or Members of the Board may request an agenda in any
37 other language by contacting the Office of Civil Rights & Consumer Protection
38 using the information found at [www.cabq.gov/office-of-
39 inclusion/civilrights/](http://www.cabq.gov/office-of-equity-and-inclusion/civilrights/)
- 40 (D) Notice shall include the following text:

1 “NOTICE TO PERSONS WITH DISABILITIES: If you have a disability and need
2 an accommodation in order to participate in this public meeting, please contact
3 the Office of Civil Rights at 505-768-4595 or civilrights@cabq.gov. Please
4 request any accommodation(s) necessary at least 72 hours prior to the
5 meeting. Further advance notice is preferred if possible, and you may request
6 accommodation(s) up to 10 days before the meeting. Best efforts will be made
7 to provide the requester with their auxiliary aid of choice. If doing so is not
8 possible due to time constraints or other logistical concerns, the city will work
9 directly with the requester to provide an alternate method of accommodation.”

10 **SECTION 5. CANCELLATIONS**

11 (A) Notice of Cancellations of meetings of the Board and notice of different meeting
12 times and/or dates and/or locations, may be announced at prior meetings of the
13 Board. Sudden cancellations of meetings may occur if a quorum of Board
14 members cannot attend a previously scheduled meeting time. Irregular meeting
15 dates and times may be needed if a regularly scheduled meeting date is a
16 federal, state or city holiday and City offices are closed that day. Different
17 meeting dates and/or times and/or locations may be needed for a regularly
18 scheduled meeting date if there is inclement weather, or if the meeting location
19 is not available for use, failure to adhere to OMA requirements for publishing
20 agendas within seventy-two hours, or for other reasons.

21 **SECTION 6. COMMITTEES**

22 (A) If any committees are formed that are delegated the authority to make
23 decisions on behalf of, formulate recommendations that are binding in any legal
24 or practical way on, or otherwise establish policy for the public body, shall be
25 equal to that specified in Section 4 of this resolution.

26 (B) Subcommittees are not required to adhere to the public notice requirements in
27 Section 4 of this resolution unless the subcommittee is authorized by the Board
28 to:

- 29 1. Make any judgement or decide any investigative outcome on behalf of
30 Human Rights Board; and
- 31 2. Formulate any legally-binding recommendations; and
- 32 3. Otherwise establish policy for the board autonomously.

33 **SECTION 7. CLOSED MEETINGS.**

34 The Board may close an otherwise Open Meeting of the Board to the public only if the
35 subject matter of such discussion or action is exempted from the open public meeting
36 requirement under Section 10-15- 1(H) (NMSA 1978) of the Open Meetings Act.

37 (A) If any open meeting is closed, the closure shall be approved by a majority vote
38 of a quorum of the Board taken during the open meeting. The specific provision
39 of law authorizing the closed meeting and the subject(s) to be discussed shall
40 be stated with reasonable specificity in the motion to close the meeting to public

1 observation and the vote of each individual member on the motion to close the
2 meeting shall be recorded in the minutes in a roll call vote. Only those subjects
3 specified in the motion to close the meeting may be discussed by the Board in
4 the closed meeting.

5 (B) If a closed meeting is conducted when the Board is not in an open meeting, the
6 closed meeting shall not be held until a written public notice of the meeting of
7 the Board, appropriate under the circumstances, stating the specific provision
8 of law authorizing the closed meeting and the subjects to be discussed with
9 reasonable specificity, is given to Board members and to the public.

10 (C) Following completion of any closed meeting, the minutes of the open meeting
11 that was closed, or the minutes of the next open meeting of the Board if the
12 closed meeting was separately scheduled, shall state whether the matters
13 discussed in the closed meeting were limited only to those specified in the
14 motion to close the meeting or the public notice of a closed meeting.

15 (D) Except as provided in Section 10-15-1(H) (NMSA 1978) of the Open Meetings
16 Act, any action taken as a result of discussions in a closed meeting shall be
17 made by a public vote of the Board in an open meeting.

18 **Section 8. ANNUAL REPORT.**

19 The Board hereby approves "OC-2025-99" (**Attachment A**) which includes the
20 "Albuquerque Human Rights Board 2025 Report" for publication on the Board's
21 webpage and distribution to City Council and the Mayor.

22 **Section 9. STANDARDS**

Albuquerque Human Rights Ordinance (§11-3)

The city of Albuquerque established the Albuquerque Human Rights Board in the Human Rights Ordinance (*Ord. 1973-106*). Section 5 of the HRO assigns the following powers and duties to the Board;

- A. Set such rules and regulations as are necessary for the operation of the Board;
- B. Conduct public hearings upon the request of the City Council or Mayor;
- C. Receive complaints alleging an unlawful discriminatory practice as defined in this article;
- D. Not receive any complaints that have already been filed with another agency;
- E. Use its best efforts to:
 - Promote mutual trust, understanding and respect among the citizens of the Albuquerque community and between the citizens and their governmental agencies.
 - Endeavor that all citizens may enjoy their rights and pursue their opportunities on an equal basis without unlawful discrimination.
 - Conduct programs of research and investigation into the existence, cause, prevention, and remedy of inter-group tensions and hostility, and prejudice and discrimination within the community and to inform and educate the citizens as to the results of such research and investigation.
 - Conduct programs of information and education within the community so as to advise citizens of their existing rights and opportunities and the means by which they may lawfully be attained.
 - Work in close cooperation with all agencies within the community whose aims or activities are consistent with the purpose of the HRO.
 - Provide review of all existing and proposed ordinances and policies which relate to the objectives of Article VIII of the Albuquerque City Charter;
- F. Work with governmental agencies and community organizations to carry out the purpose of Article VIII of the City Charter;
- G. Make recommendations to the City Council based upon its findings concerning problems occasioned by prejudice and discrimination in all fields of human relations and recommend corrective action to aid in carrying out the purpose of Article VIII of the City Charter;
- H. Submit an annual written report of its activities and an evaluation of the effectiveness of the HRO to the City Council and Mayor with recommendations for changes;
- I. Review and make recommendations to the Mayor, City Council, or Chief Administrative Officer regarding the City Affirmative Action Plan and Programs; city department, division, agency, and program affirmative action plans; and affirmative action guidelines for City contracts; and
- J. Conduct investigations, monitor, and make recommendations to the Mayor, City Council or Chief Administrative Officer about the city's implementation of such plans or guidelines. Recommend any remedial action necessary for compliance with approved plans or guidelines to the Chief Administrative Officer.

Albuquerque Human Rights Board 2025 Members

- This internal resolution established standard clauses for Board documents including a uniform severability clause and publication standards.

- Recommending public reporting by the General Services Department’s Metro Security Division (MSD) relating to the use of force, policies & procedures, and

the number of 911 calls diverted to MSD.

- Requesting the publication of any documents related to MSD including the founding ordinance/resolution, an organizational chart, and training policies.
- **Conclusion:** The Division provided most of these documents to the Boards' chair through the City Clerks office in response to [NextRequest 25-1172](#). The Clerk's office did not publish the request despite the Chair's request for publication. The Boards' chair has made these documents available through [this link](#) to a google drive folder.

HRB Successes 2025

1. The Board onboarded a new member, Mark Lamb.
2. The Board made recommendations relating to the OCR Online Complaint Submission Form through HRB R-2025-02; These recommendations were made by the office. OCR now has an updated complaint submission form to properly enforce the HRO as amended in 2024.

HRB Challenges 2025

- (1) Difficulties⁴ filling the Human Rights Officer equivalent position of the Office of Civil Rights resulted in;
- o inconsistent data collection and unclear administrative practices relating to the fulfillment of CABQ Ord. No. 2024-010, which significantly expanded the scope of the Human Rights Ordinance; and
 - o Miscommunications relating to technical administrative responsibilities for hosting meetings and providing public notice as required; and

⁴ These challenges are being resolved by the Director position within the Office of Civil Rights & Consumer Protections at this time. This challenge impacted the Board's work from 2024 through April 2025.

- Increased workload on administrative staff members who were assigned the responsibilities of the Human Rights Officer equivalent position of the Office of Civil Rights.
- (2) The Board was under-utilized as a resource of both the administration & council considering the powers and duties described in the following sections of the Human Rights Ordinance: **§11-3-5 (B, F, G, I, J)**
- (3) Numerous and frequent changes in federal policies have significantly hindered the Board's efforts to;
- "Promote mutual trust, understanding and respect among the citizens of the Albuquerque community and between the citizens and their governmental agencies.
 - Endeavor that all citizens may enjoy their rights and pursue their opportunities on an equal basis without unlawful discrimination; and
 - Conduct programs of research and investigation into the existence, cause, prevention, and remedy of inter-group tensions and hostility, and prejudice and discrimination within the community and to inform and educate the citizens as to the results of such research and investigation." (11-3-5 (E))

HRB 2026 Goal Setting

1. The Board will make efforts to reconnect with outside boards and agencies that have been collaborative partners in previous years, including but not limited to:

 - c. Americans with Disabilities Act Advisory Committee ([§2-6-5-5 \(I\)](#))
 - d. Navajo Nation Human Rights Commission ([MOU](#))
2. The Board will make efforts to ensure the proper enforcement & oversight of the Albuquerque Closed Captioning Ordinance. ([AI NO: 8-25](#))
3. The board will investigate the implementation the City's camping ban over the course of 2025, codified sections [§9-25-1](#) through [§9-25-7](#), as well as any implementing rules of policies of these ordinances. In particular, the Board will assess the health, social, and economic impacts of these laws and policies for people experiencing homelessness in Albuquerque, including implications for the City's effectuation of the Human Rights Ordinance. ([§11-3-5 \(F\)](#))
4. The Board will:
 - a. Investigate themes of discrimination faced by claimants pertaining to access to housing; ([§11-3-5 \(C - 2\)](#))
 - b. Research potential recommendations to protect consumers from housing discrimination; ([§11-3-5 \(H\)](#)) and
