MINUTES

1) Call to order & Introductions

a) The HRB⁴ meeting of October 16, 2025 was called to order by Vice Chair Bolton at 5:13 pm. Seconded by Chair Dass.

2) Review & approval of HRB Agenda October 16, 2025

a) Vice-Chair Bolton moved to approve the agenda. Chair Dass seconded. Motion approved 4-0-3.

3) Review & approval of HRB minutes – September 18, 2025

a) Chair Dass moved to approve the amended minutes posted on the website. Vice Chair Bolton seconded. Motion approved 4-0-3.

4) Public Comment.

a) No Public Comment was given.

5) Attorney Report

- a) Mr. Alden clarified questions from the September meeting. He shared that the current ordinance does not include language discrimination. He recommended expanding the ordinance to explicitly include language discrimination protections. While the Board could potentially hear complaints under the current framework under national origin or ancestry and interpret protections broadly, Mr. Alden advised that an amendment to the Human Rights Ordinance (HRO) would provide a more certain legal footing and formally expand the Board's jurisdiction. The Board has the authority to recommend such an expansion to the HRO.
- b) Concerning fundraising and financial limitations, Mr. Alden explained that the Human Rights Board, while sometimes perceived as similar to a nonprofit organization, is not a distinct legal entity. The Board's functions are clearly defined by ordinance, and city boards are generally not authorized to engage in fundraising activities. Any necessary expenses should be addressed through conversations with the appropriate city departments, including the Office of Equity and Inclusion (OEI). The Board cannot maintain its own bank account as it lacks separate legal entity status, and accepting or donating funds would violate anti-donation clauses. These activities fall outside the scope of the Human Rights Board's authorized functions.

6) Director's Monthly Report - OCR

- a) Gabriela Marques requested one-on-one meetings with board members to learn about their work.
- b) The online complaint form has been updated and a definitions list was added to the website for clarity.
- c) The OCR/OEI will be using social media to promote Human Rights Day on December 10th and to recruit new board members.
- d) The City requests switching from Zoom meetings to Zoom Webinar, all in-person, or Zoom with YouTube streaming to reduce public interruptions while maintaining public comment opportunities. The board needs to decide on this technology change by December 2025.
- e) The Quarter 1 fiscal year 2026 report was shared with the board.

7) OEI Quarterly Report – Dr Cooper, Deputy Director

- a) Acknowledged the Constituent Services Coordinator who supported the Office of Civil Rights for many months.
- b) Launch of the new Office of Asian Pacific Islander Native Hawaiian Affairs event on October 18th
- c) OBCE (Office of Black Community Engagement) is progressing with the Ujima Collective training program for entrepreneurs.
- d) OFE (Office of Financial Empowerment), the Financial Summit is scheduled for December 11th at 4pm at the Albuquerque Museum.
- e) OIRA (Office of Immigrant and Refugee Affairs) has a new podcast launched:



"Voices Across Borders"

f) There were multiple celebrations held for Indigenous Peoples' Day throughout the City, and they are continuing through the month.

8) Discussion & Proposals

- a) Additional Matters
 - i) Discussed whether amending the HRO is something the board wants to pursue. It was indicated that time is needed to review the ordinance, agreeing that language-based discrimination should be addressed. The board agreed to conduct a systematic analysis of the gaps in the Human Rights Ordinance and present its recommendations.
 - ii) The board consulted on how to proceed with the technology for the future meetings. Vice-Chair Bolton moved to approve using Zoom Webinar with an in-person option, with posting the recording on the GovTV post-meeting. Chair Dass seconds. Motion approved 4-0-3.
- b) Planning for 2026
 - i) The Board discussed holding a retreat on Wednesday, December 10th, which is Human Rights Day. It was noted that the retreat space will serve as an opportunity to plan activities and goal-setting for 2026. The time discussed was 12pm to 2pm, OEI will provide lunch, and the location is to be confirmed in a City building.
 - ii) Elections for Chair and Vice Chair positions will take place at the November board meeting. The elected officers will begin their terms in January 2026.

9) Announcements

a) Next Human Rights Board will take place Thursday, November 20, 2025, in the Plaza del Sol Hearing Room and on Zoom at 5pm.

NOTICE REQUIREMENTS FOR MEETINGS OF THE BOARD and APPROVING THE 2025 HUMAN RIGHTS BOARD REPORT

WHEREAS, § 10-15-1(B) (NMSA 1978) of the Open Meetings Act states that "[A]II meetings of a quorum of members of any board, commission, administrative adjudicatory body or other policymaking body of any state agency, any agency or authority of any county, municipality, district or any political subdivision, held for the purpose of formulating public policy, including the development of personnel policy, rules, regulations or ordinances, discussing public business or for the purpose of taking any action within the authority of or the delegated authority of any board, commission or other policymaking body are declared to be public meetings open to the public at all times except as may be otherwise provided in the Constitution of New Mexico, or the provisions of the Open Meetings Act;" and

WHEREAS, any meetings subject to the Open Meetings Act at which the discussion or adoption of any proposed resolution, rule, regulation or formal action occurs shall be held only after reasonable notice to the public; and

WHEREAS, §10-15-1(D) of the Open Meetings Act requires the Board to determine annually what constitutes reasonable notice of its public meetings; and

WHEREAS, § 2-6-1-4(B) (ROA 1994) of the City of Albuquerque Public Boards, Commissions and Committees Ordinance requires that every public board, commission or committee created by the City of Albuquerque must determine what is reasonable notice to the public of its meetings; provided that in no event shall notice be less than the notice required for Albuquerque City Council meetings; and

WHEREAS, § 11-3-5(I) of the City of Albuquerque Human Rights Ordinances requires that the Albuquerque Human Rights Board "submit annually a written report of its activities and an evaluation of the effectiveness of this article to the City Council and Mayor with recommendations for changes."

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ALBUQUERQUE HUMAN RIGHTS BOARD:

SECTION 1. REGULAR MEETINGS

55 **SECTION 3. EMERGENCY MEETINGS**

- 56 Emergency meetings of the Board will be called only under unforeseen circumstances
- 57 that demand immediate action by the Board to protect the health, safety and property of
- citizens or to protect the public body from substantial financial loss, pursuant to the
- 59 Open Meetings Act, NMSA 1978, Section 10-15-1 (F). The Board will avoid holding
- 60 emergency meetings whenever possible. Emergency meetings may be called by the
- 61 Chairperson or a majority of the Board members upon twenty-four (24) hours' notice,
- unless threat of personal injury or property damage requires less notice. Public notice
- for an emergency meeting shall include an agenda for the emergency meeting.

64 **SECTION 4. PUBLIC NOTICE.**

- Public Notice for all meetings described in this resolution, public notice requirements are met if:
 - (A) The notice contains the date, time and place of the meeting is posted for public viewing in the following location(s): in the 1st floor lobby of the Albuquerque Government Center at 1 Civic Plaza NW, Albuquerque, NM 87102, unless posting such notice is made impossible due to ongoing public health restrictions or other legal limitations. An electronic copy of the notice will be posted on the City website at https://www.cabq.gov/civilrights/events and this website address may change from time to time as needed by the City or the Board.
 - (B) The agenda for a special and regularly scheduled meeting shall be available to the public at least 72 hours (3 days) prior to such a meeting. An English language agenda will be available to the public at www.cabq.gov/office-of-equity-and-inclusion/civilrights/human-rights-board/
 - (C) Members of the Public or Members of the Board may request an agenda in any other language by contacting the Office of Civil Rights & Consumer Protection using the information found at www.cabq.gov/office-of-equity-and-inclusion/civilrights/
 - (D) Notice shall include the following text:

"NOTICE TO PERSONS WITH DISABILITIES: If you have a disability and need an accommodation in order to participate in this public meeting, please contact the Office of Civil Rights at 505-768-4595 or civilrights@cabq.gov. Please request any accommodation(s) necessary at least 72 hours prior to the meeting. Further advance notice is preferred if possible, and you may request accommodation(s) up to 10 days before the meeting. Best efforts will be made to provide the requester with their auxiliary aid of choice. If doing so is not possible due to time constraints or other logistical concerns, the city will work directly with the requester to provide an alternate method of accommodation."

SECTION 5. CANCELLATIONS

(A) Notice of Cancellations of meetings of the Board and notice of different meeting times and/or dates and/or locations, may be announced at prior meetings of the Board. Sudden cancellations of meetings may occur if a quorum of Board members cannot attend a previously scheduled meeting time. Irregular meeting dates and times may be needed if a regularly scheduled meeting date is a federal, state or city holiday and City offices are closed that day. Different meeting dates and/or times and/or locations may be needed for a regularly scheduled meeting date if there is inclement weather, or if the meeting location is not available for use, failure to adhere to OMA requirements for publishing agendas within seventy-two hours, or for other reasons.

SECTION 6. COMMITTEES

- (A) If any committees are formed that are delegated the authority to make decisions on behalf of, formulate recommendations that are binding in any legal or practical way on, or otherwise establish policy for the public body, shall be equal to that specified in Section 4 of this resolution.
- (B) Subcommittees are not required to adhere to the public notice requirements in Section 4 of this resolution unless the subcommittee is authorized by the Board to:
 - Make any judgement or decide any investigative outcome on behalf of Human Rights Board; and
 - 2. Formulate any legally-binding recommendations; and
 - 3. Otherwise establish policy for the board autonomously.

SECTION 7. CLOSED MEETINGS.


The Board may close an otherwise Open Meeting of the Board to the public only if the subject matter of such discussion or action is exempted from the open public meeting requirement under Section 10-15- 1(H) (NMSA 1978) of the Open Meetings Act.

(A) If any open meeting is closed, the closure shall be approved by a majority vote of a quorum of the Board taken during the open meeting. The specific provision of law authorizing the closed meeting and the subject(s) to be discussed shall be stated with reasonable specificity in the motion to close the meeting to public

123	observation and the vote of each individual member on the motion to close the
124	meeting shall be recorded in the minutes in a roll call vote. Only those subjects
125	specified in the motion to close the meeting may be discussed by the Board in
126	the closed meeting.
127	(B) If a closed meeting is conducted when the Board is not in an open meeting, the
128	closed meeting shall not be held until a written public notice of the meeting of
129	the Board, appropriate under the circumstances, stating the specific provision
130	of law authorizing the closed meeting and the subjects to be discussed with
131	reasonable specificity, is given to Board members and to the public.
132	(C) Following completion of any closed meeting, the minutes of the open meeting
133	that was closed, or the minutes of the next open meeting of the Board if the
134	closed meeting was separately scheduled, shall state whether the matters
135	discussed in the closed meeting were limited only to those specified in the
136	motion to close the meeting or the public notice of a closed meeting.
137	(D)Except as provided in Section 10-15-1(H) (NMSA 1978) of the Open Meetings
138	Act, any action taken as a result of discussions in a closed meeting shall be
139	made by a public vote of the Board in an open meeting.

Albuquerque Human Rights Ordinance (§11-3)

The city of Albuquerque established the Albuquerque Human Rights Board in the Human Rights Ordinance *(Ord. 1973-106)*. Section 5 of the HRO assigns the following powers and duties to the Board;

- A. Set such rules and regulations as are necessary for the operation of the Board;
- B. Conduct public hearings upon the request of the City Council or Mayor;
- C. Receive complaints alleging an unlawful discriminatory practice as defined in this article;
- D. Not receive any complaints that have already been filed with another agency;
- E. Use its best efforts to:
 - Promote mutual trust, understanding and respect among the citizens of the Albuquerque community and between the citizens and their governmental agencies.
 - Endeavor that all citizens may enjoy their rights and pursue their opportunities on an equal basis without unlawful discrimination.
 - Conduct programs of research and investigation into the existence, cause, prevention, and remedy of inter-group tensions and hostility, and prejudice and discrimination within the community and to inform and educate the citizens as to the results of such research and investigation.
 - Conduct programs of information and education within the community so as to advise citizens of their existing rights and opportunities and the means by which they may lawfully be attained.
 - Work in close cooperation with all agencies within the community whose aims or activities are consistent with the purpose of the HRO.
 - Provide review of all existing and proposed ordinances and policies which relate to the objectives of Article VIII of the Albuquerque City Charter;
- F. Work with governmental agencies and community organizations to carry out the purpose of Article VIII of the City Charter;
- G. Make recommendations to the City Council based upon its findings concerning problems occasioned by prejudice and discrimination in all fields of human relations and recommend corrective action to aid in carrying out the purpose of Article VIII of the City Charter;
- H. Submit an annual written report of its activities and an evaluation of the effectiveness of the HRO to the City Council and Mayor with recommendations for changes;
- Review and make recommendations to the Mayor, City Council, or Chief Administrative
 Officer regarding the City Affirmative Action Plan and Programs; city department,
 division, agency, and program affirmative action plans; and affirmative action guidelines
 for City contracts; and
- J. Conduct investigations, monitor, and make recommendations to the Mayor, City Council or Chief Administrative Officer about the city's implementation of such plans or guidelines. Recommend any remedial action necessary for compliance with approved plans or guidelines to the Chief Administrative Officer.

- This internal resolution established standard clauses for Board documents including a uniform severability clause and publication standards.

HRB Resolution No. 2025-06: Recommending Enhanced Reporting Practices Relating To Certain Activities Of The Metro Security Division Of The General Services Department

 Recommending public reporting by the General Services Department's Metro Security Division (MSD) relating to the use of force, policies & procedures, and the number of 911 calls diverted to MSD.

- Requesting the publication of any documents related to MSD including the founding ordinance/resolution, an organizational chart, and training policies.
- Conclusion: The Division provided most of these documents to the Boards' chair through the City Clerks office in response to NextRequest 25-1172. The Clerk's office did not publish the request despite the Chair's request for publication. The Boards' chair has made these documents available through this link to a google drive folder.

HRB Resolution No. 2025-02: Requesting updates to the Office of Civil Rights Discrimination Grievance Submission Form to comply with CABQ Ordinance No. 2024-010.

- Requesting updated phrasing on certain questions found on this online form.
- Requesting additional options to be included to certain questions found on <u>this</u> <u>online form</u>.
- **Conclusion**: The Office of Civil Rights & Consumer Protection has updated the form and added a <u>definitions page</u> for clarity.

HRB Successes 2025

- **1.** The Board onboarded a new member, Mark Lamb.
- 2. The Board made recommendations relating to the Office of Civil Rights Online Complaint Submission Form through HRB R-2025-02; These recommendations were made by the office. The Office of Civil Rights now has an updated complaint submission form to properly enforce the Human Rights Ordinance as amended in 2024.
- **3.** The Office of Civil Rights was merged with the Office of Consumer Protection, both under the Office of Equity & Inclusion.

HRB Challenges 2025

- (1) Difficulties⁸ filling the Human Rights Officer equivalent position of the Office of Civil Rights resulted in;
 - inconsistent data collection and unclear administrative practices relating to the fulfillment of CABQ Ord. No. 2024-010, which significantly

- expanded the scope of the Human Rights Ordinance; and
- Miscommunications relating to technical administrative responsibilities for hosting meetings and providing public notice as required; and
- Increased workload on administrative staff members who were assigned the responsibilities of the Human Rights Officer equivalent position of the Office of Civil Rights.
- (2) The Board was under-utilized as a resource of both the administration & council considering the powers and duties described in the following sections of the Human Rights Ordinance: §11-3-5 (B, F, G, I, J)
- (3) Numerous and frequent changes in federal policies have significantly hindered the Board's efforts to;
 - "Promote mutual trust, understanding and respect among the citizens of the Albuquerque community and between the citizens and their governmental agencies.
 - Endeavor that all citizens may enjoy their rights and pursue their opportunities on an equal basis without unlawful discrimination; and
 - Conduct programs of research and investigation into the existence, cause, prevention, and remedy of inter-group tensions and hostility, and prejudice and discrimination within the community and to inform and educate the citizens as to the results of such research and investigation." (11-3-5 (E)

HRB 2026 Goal Setting

- 1. The Board will make efforts to reconnect with outside boards and agencies that have been collaborative partners in previous years, including but not limited to:
 - **a.** Office of Civil Rights & Consumer Protections
 - **b.** Office of Equity & Inclusion
 - **C.** Americans with Disabilities Act Advisory Committee (§2-6-5-5 (I))
 - **d.** Navajo Nation Human Rights Commission (MOU)
- 2. The Board will make efforts to ensure the proper enforcement & oversight of the Albuquerque Closed Captioning Ordinance. (AI NO: 8-25)
- 3. The Board will make efforts to support the Office of Civil Rights & Consumer Protection and the City's Economic Development Department in any attempt to re-open the NM Minority Business Development Agency (NM MBDA) or other actions promoting economic resources focused on supporting minority business owners
