**Due to Covid-19, this is a “no frills” golf tournament, so the entry fees have been greatly reduced!**

**Entry Fee Categories per Player:**

**3-day Regular Green Fee - \$105**

**3-day Senior Green Fee (55+) - \$90**

**3-day Junior Green Fee (17 and under) - \$75**

**3-day City of Albuquerque Municipal Golf Course Annual Pass Holder or Lifetime Pass Holder - \$50**

**\*2-day Senior (70+)/Super Senior (75+) Green Fee (for Tuesday, Oct. 6 and Thursday, Oct. 8 only) - \$75**

**2-day Senior (70+)/Super Senior (75+) Green Fee with Alb. Municipal Annual Pass or Lifetime Pass - \$50**

## **GENERAL INFORMATION:**

- Open to all NM residents, amateur women golfers who have a USGA Handicap Index and meet all mandated Covid-19 requirements
- Field limited to the first 120 players to register
- The maximum handicap to which a competitor can compete is 40.4 per USGA Guidelines
- Entry fee includes green fees, tee gift and awards (Sorry, no luncheon due to Covid-19)
- Carts are not required and are not included in entry fee. Cart fees and range balls may be paid for separately at the respective golf course(s) on the day of play
- NM resident caddies may be used pursuant to USGA Guidelines
- 3 days of 18-hole stroke play—October 6-8—with flights (\*except for Senior and Super Senior Flights)
- Flights will be determined by Handicap Index
- \*Senior and Super Senior Flights are open to NM resident, amateur women golfers who have a USGA Handicap Index and are at least 70 & 75, respectively, years of age as of September 1, 2020. Two days of 18-hole stroke play—October 6 at Los Altos Golf Course and October 8 at Ladera Golf Course
- All Covid-19 mandated restrictions, at the time of the tournament, will be enforced
- Awards will be either available for pick-up or mailed to the winners after close of competition

**STARTING TIME:** Due to Covid-19 restrictions, tee times will be assigned to all players

## **ENTRIES:**

- Entry fees are subject to qualification categories
- Checks must be submitted with entry form (no cash, please)
- Entry Deadline: September 18, 2020. Refunds **ARE NOT** available for withdrawals after the deadline
