A slide show was presented by the architect showing the early stage conceptualization of design and location of the facility. The goal is to mitigate sound and light issues, provide erosion fixes, and update landscaping. There will also be utilities upgrades to park, fiber optic upgrades, public toilets and improved parking lot. Questions included:

• size of field? (225' x 360'),

- total area impact? 7 acres,
- seating capacity? Max 10-12K,
- Room for expansion? No,
- Define multiuse of stadium? The City will not prevent the team from renting out the stadium for other events will be addressed in the lease
- Not all neighborhoods notified of commission meeting? The City and the NM United Soccer organization are following all the process and procedures required by the City.
- Are there legal issues associated with the stadium deal?
- What are the lease terms? Still in legal entitlement process
- Is it a viable option for United to use the UNM stadium? Unknown
- Why build this if the taxpayers voted it down? They voted down a publicly financed stadium, NM United Soccer organization will fund the building of the actual stadium.
