These funds can only be used for the projects listed and enhancements would include not only parks, but also streets, sidewalks, drain systems and sports facilities. This fund would generate over 80 million dollars and save us millions more in inflation costs."
  - "Establish a practice in which every park employee has, on his/her/their desk, a list of
    work projects they plan to focus on for the next few months. I suggest that they share
    this information with the ONC and let them put that information into their newsletter.
    Make it clear that plans are subject to change, but this will let residents know that PRD
    is aware of needs and have them in their plans. Transparency is important."
