• Each artist may submit up to three (3) paintings or field studies, executed in any medium.

• Work must not have previously been shown at OSVC.

All work must be for sale. Maximum price: \$325.00, including applicable Gross Receipts Tax as of Sept. 2012 [i.e. \$ 303.74 + \$21.26 (7% GRT) = \$325]
Open Space Alliance (OSA) will retain 35% of the

pre-tax painting price as a charitable contribution.

SIZE & FRAMING REQUIREMENTS:

Image: 4" x 6", 5" x 7", 6" x 8" maximum (square format allowed, 48 sq. in. maximum). Frame: 14 x 16 max. outside dimensions. Simple or plein air style frames requested. Work must be sturdily framed and ready to hang. No sawtooth hangers.

DIGITAL REQUIREMENTS: 700 pixels longest side, 72 dpi. Title each jpg image as follows: First 4 Letters of Last Name, First Initial, Painting Title.

DELIVERY & RETRIEVAL:

Hand-deliver by the artist, or a representative, to Open Space Visitor Center on Wednesday, Sept. 5, from 9 am - 12 noon.

All unsold paintings must be picked up by the artist, or a representative, on Saturday, Oct. 27 between 9 am - 12 noon. (*Please mark your calendar, OSVC is not responsible for work remaining after the pick up date.*)

Or, paintings may be shipped directly to the Open Space Visitor Center, as long as prepaid return shipping documents and carton(s) are supplied when paintings are delivered to the show. Cost of shipping painting(s) to and from the show is the responsibility of the artist.

AGREEMENT OF ENTRY & LIABILITY:

All reasonable care will be taken with paintings. However, neither OSA, nor City of Albuquerque is responsible for any artwork displayed or left at Open Space Visitor Center gallery. Insurance is the responsibility of the artist.
