It is that time again to start thinking about Group Use with the City of Albuquerque! Pools are available for Group Use from **June 3rd to August 2nd 2019**. **We will begin to process group requests starting January 29th at 9 AM – February 5th 2019**. Any requests by email or fax sent in before 9 A.M. on Monday January 29th will be returned and asked to be re-sent at the appropriate time. **Please remember that this is a first- come first-serve basis**. We have thirteen sites all together, seven outdoor, five indoor and one outdoor Spray Pad. The times** and days you may choose from these pools will be on weekdays only from 12:30-2:00 PM or from 2:30-4:00 PM for **Eisenhower, Los Altos, Valley, Rio Grande, Sunport Sandia, Montgomery, Sierra Vista and Highland pool**. **West Mesa Aquatic Center's** shift times will be 12:30-2:30 pm or 3:00-5:00 PM. **Wilson and East San Jose Pool's** shift times will be 12:30-2:00 PM & 2:00-3:30 PM. **The Cesar Chavez Spray Pad** will be available for an 11:30-1:00 shift or a 1:30-3:00 shift.

The cost for children is \$1.00 – leaders do not pay.

The total number per group will be a maximum of 30. This number includes group leaders, so please plan accordingly**. Scheduling at each pool varies, so please clearly indicate the day and time your group would like to come. It is possible to request more than one day a week. If this is something you are interested in please indicate which days on your request form and the pool will do their best to accommodate you. Please keep in mind that summer is our busiest season and there are numerous activities conducted at all of our sites. We will do our best to honor your first request. However, due to the high number of requests we may not be able to accommodate the exact day of the week or time you prefer, so please fill in your alternate preferences.

In order to maintain the safety of your group, **CHILDREN MUST BE ABLE TO STAND ON THE POOL BOTTOM** with their heads above the water. This is very important! The shallow end of most pools is **THREE (3) FEET DEEP with the exception of Los Altos pool where the shallowest end is 4ft 6-8 inches**. We require that you have leaders **in the water** with your participants with **1 leader to every 10 children OVER 8 YEARS OLD and 1 leader to every 5 children who are 6 & 7 YEARS OLD****. **Group leaders are required to accompany the children, with no exception. WADING POOLS ARE OFF LIMITS FOR GROUP USE BECAUSE OF THEIR LIMITED SIZE**. All children must

be 6 years of age or older to participate in the Group Use program. Also, be advised that children should come dressed ready to swim. This will eliminate the distraction of watching personal belongings. **ALL CHILDREN AND ADULT SUPERVISORS MUST WEAR PROPER SWIMMING ATTIRE: bathing suits with liners - no gym shorts, bike shorts or street clothes.**

There are several options for the submission of your Group Use request. A blank request form is attached so that it can be filled out and sent back to our aquatics staff. You can email, fax or mail the form. Our newest form of submission can be found on the City of Albuquerque's Aquatics website. Here you can find a copy of this letter as well as an online request form. You can fill out the information so that it can be sent directly to our aquatics staff for processing. As it has been stated before, our pools fill up quickly as this is a first-come first-serve program. We recommend sending your requests via email or via the online form as to make this process more efficient.
