Summary of Analysis

The purpose of this request is to provide text amendments to the Uptown Sector Development Plan (USDP) to help clarify specific language in the Plan that is either unclear or inconsistent with other City requirements. The proposed amendments do not affect established zoning or uses and are basically a "cleanup" of the 2009 Plan.

Staff continues to work with the Uptown Progress Team and other stakeholders in the Uptown area in order to address comments/concerns. Due to this effort, the applicant is asking for a 30-day deferral.

Findings for Deferral:

- 1. This is a request for a recommendation of approval to be forwarded to the City Council for amendments to the Uptown Sector Development Plan (USDP).
- 2. The applicant is working with stakeholders in the Uptown area to address comments and concerns.
- 3. The applicant is requesting a 30-day deferral in order to continue discussions with property owners and other stakeholders in the area and the Uptown Progress Team.
