Dear Property Owner or Current Resident:

The City of Albuquerque recently initiated an update of the West Route 66 Sector Development Plan (SDP), a land-use plan that was originally adopted in 1987 and has undergone minor updates over the years. The current effort is a major update to the plan, one that will directly engage property owners and other stakeholders in discussions about revisions to zoning, changes to the transportation system, and improvements to public infrastructure and facilities to help the West Route 66 corridor reach its fullest economic development potential and better serve residents and visitors.

The original boundaries of the West Route 66 SDP included properties that front Central Avenue from the Rio Grande River on the east to I-40 on the west. Your property is not currently included within the boundaries of the West Route 66 SDP but is in either the Huning Castle/Raynolds Addition SDP (south side of Central), the Old Town SDP (north side of Central), or the Rio Grande Corridor Plan (Central/Rio Grande intersection). However, given the importance of the Route 66 corridor and the fact that there exists a great deal of synergy and market potential to be captured between east and west in this area, we are proposing to extend the boundaries of the West Route 66 SDP to include properties on the east side of the river up to Rio Grande Boulevard (see map below), which would also remove these properties from the respective Plans within which they are currently included.
