1<sup>st</sup>/Central RFP

The questions asked by potential proposers and answered by the City and its partners are as follows:

## 1. How confident are you on the timeline for Bus Rapid Transit (BRT)?

The City is confident they can meet the milestones.

### 2. Where will the BRT route be near the Subject Site?

The City is looking to "square off" the corner of 1<sup>st</sup> Street and Central Avenue. Heading west along Central Avenue, BRT buses will turn right on 1<sup>st</sup> Street and continue along Copper Avenue through Downtown Albuquerque. The exact location of the BRT stop in this area has not yet been determined.

## 3. Where will the BRT route be through Downtown Albuquerque?

Heading west along Central Avenue, BRT buses will turn right on 1<sup>st</sup> Street and continue along Copper Avenue through Downtown Albuquerque then return back to Central Avenue at 10<sup>th</sup> Street. Heading east along Central Avenue, BRT buses will turn at 8<sup>th</sup> Street and continue along Gold Street through Downtown Albuquerque, then return back to Central Avenue at 1<sup>st</sup> Street.

## 4. Where is the soil contamination on the Subject Site?

The petroleum hydrocarbon soil impacts are located in shallow soils on the east portion of the property and are deeper as you head west.

#### 5. Who will be the responsible party for the removing the contamination?

The Burlington Northern Santa Fe (BNSF) is the responsible party (RP) for cleaning up the ground water contamination. They are technically responsible for the soil impacts, but if a developer or property owner removes the soils, that entity becomes responsible for the disposition of the soil (proper hauling and disposal). The New Mexico Environment Department (NMED) requires RPs to clean up contaminated ground water, and BNSF has stated that they will propose a monitored natural attenuation strategy (monitor the ground water until it meets standards) for this plume.

#### 6. Will there be a pedestrian crossing along Central Avenue at the tracks?

The TIGER grant application includes plans to create an at-grade crossing along Central Avenue at the railway tracks.

7. There appears to be two pedestrian crossings in the TIGER grant elevations. Is this correct? If the City receives a TIGER grant, we are contemplating using some of the funding for an above grade pedestrian walkway between the Subject Site and the proposed Innovate ABQ site.

## 8. Will the Subject Site be replatted? Yes. When a developer is selected, the City expects the developer to replat the Subject Site.

#### 9. Is the Subject Site subject to flooding?

The Subject Site is generally not affected by the flooding sometimes seen below the railroad tracks on Central Avenue. However, this could change over time.
