COMMERCIAL RE-ROOF PERMIT
Requirements & Fee Information

- Commercial re-roof permits may be obtained from the Building Permit Office One Stop Shop, 600 2nd St., N.W
- Only New Mexico licensed contractors may obtain permits for commercial re-roofs.
- Inspections - When work is at least 50% complete, the contractor must request inspections by calling (505) 924-3320 or (505) 924-3326 or faxing (505) 924-3970 to the Building Section. A one (1) day notice is required for inspection requests. Failure to obtain a permit prior to starting a job may result in a stop work notice and a double fee.
 - Access will be required.
 - A core sample may be required to determine how many roofs have been applied.
- Commercial jobs will require three (3) copies of a scaled drawing of the roof with dimensions and drainage plan. Provide roof system specifications.
