SO 14-70 Response to Apparent Natural Deaths

2-21-1 Purpose

The purpose of this policy is to outline the procedures for Albuquerque Police Department (Department) personnel when responding to and investigating apparent adult natural deaths and suicides.

2-21-2 **Policy**

It is the policy of the Department to investigate any adult apparent natural death or suicide to document the cause(s) of such deaths and to ensure that no evidence is lost or concealed.

A. Next of Kin

The nearest relative, spouse, child, parent, or sibling of person who is under investigation.

- A. Apparent Natural Death
 - 1. For all apparent adult natural death calls, except calls for service where a death occurs in a hospital, hospice, or nursing home, sworn personnel shall:

- a. Check for signs of life;
- b. Investigate the incident;
- c. Complete a Uniform Incident Report;
- d. Complete the Apparent Natural Death Worksheet;
- e. Call the Office of the Medical Investigator (OMI) for all unattended deaths, including apparent overdoses; and
 - Sworn personnel shall call a Crime Scene Specialist (CSS) to the scene if OMI verifies the death to be suspicious.
- f. Coordinate with the OMI to make the next of kin/death notification and document that they coordinated with the OMI in their Uniform Incident Report.
 - i. An officer shall only make a next of kin/death notification when accompanied by another officer.
 - ii. Sworn personnel may request that the Emergency Communications Center (ECC) dispatch a Chaplain to assist in the next of kin/death notification.
 - 1. Telephonic next of kin/death notifications do not require a second officer.

B. Apparent Suicide

- 1. For all apparent suicides, sworn personnel shall:
 - a. Secure the scene;
 - b. Conduct a preliminary investigation;
 - i. Sworn personnel shall take statements from witnesses if witnesses are present.
 - c. Request that a CSS respond to the scene;
 - i. After confirming through OMI that the death is by suicide, only the investigating CSS shall make arrangements with the Evidence/Disposition Unit for the release of evidence to the family, consistent with SOP Submission of Evidence, Confiscated Property, and Found Items (refer to SOP Submission of Evidence, Confiscated Property, and Found Items for sanction classifications and additional duties).
 - d. Request that OMI respond to the scene; and
 - i. Sworn personnel shall coordinate with OMI to make the next of kin/death notification and document that information in their Uniform Incident Report.
 - e. Make the next of kin/death notification when accompanied by another officer.
 - Sworn personnel may call a Chaplain to assist in the next of kin/death notification.
 - 1. Telephonic next of kin/death notifications do not require a second officer.
- 2. The dispatched supervisor shall ensure that the investigation is comprehensive and complete.

- 1. CACU Detectives shall not respond to the scene or investigate the suicide of juveniles between the ages of thirteen (13) to seventeen (17) unless suspicious circumstances exist.
- 2. CACU Detectives shall investigate all suicides of juveniles twelve (12) years old or younger.
- 3. FSB sworn personnel shall conduct a full investigation and remain the case agent for non-suspicious suicides of juveniles between the ages of thirteen (13) to seventeen (17) in the same manner as the suicide of an individual eighteen (18) years of age or older.

B. Apparent Suicide

 - a. Be responsible for sSecureing the scene;
 - a. and conducting the investigation;
 - b. Conduct a preliminary investigation:
 - i. <u>Sworn personnel shall Take take</u> statements, <u>from witnesses</u> if witnesses are present,
 - c. Request that OMI a CSS respond to the scene;
 - i. After confirming through OMI that the death is aby suicide, only the investigating CSS shall make arrangements with the Evidence/Disposition Unit for the release of evidence to the family, consistent with SOP Submission of Evidence, Confiscated Property, and Found Items (refer to SOP Submission of Evidence, Confiscated Property, and Found Items for sanction classifications and additional duties).
 - d. Request that OMI respond to the scene; and
