The purpose of this policy is to outline the procedures that seek to protect the privacy rights of community members while completing criminal background investigations.

2-62-2 Policy

It is the policy of the Albuquerque Police Department (Department) to conduct background investigations that are related to active case investigations, to maintain the confidentiality of case investigations, and to destroy case files for investigations once their relevance is no longer needed.

A. Criminal Background Investigation

The collection of information about individuals, businesses, or organizations based on known or suspected criminal activity.

- A. Criminal Background Investigations
 - 1. Department personnel shall generate a Computer-Aided Dispatch (CAD) number before beginning a criminal background investigation.

- 2. Department personnel shall conduct criminal background investigations on their initiative only when the following circumstances exist:
 - a. The criminal background investigation is part of their normal job duties or when directed by a supervisor;
 - b. When information is received that individuals or businesses are believed to be involved or are about to engage in criminal activity;
 - c. As necessary for licensing of business or persons, when required by law or regulation:
 - d. When the subject of the investigation has consented in writing to a criminal background investigation; or
 - e. As necessary for Internal Affairs Professional Standards (IAPS) Division investigations as directed by the Chief of Police.
- 5 B. Criminal Predicate for Criminal Background Investigation
 - 1. Department personnel shall only conduct a criminal background investigation on individuals, businesses, addresses, or other personnel when they have identifying information related to a possible criminal offense.
 - 2. If Department personnel do not know or believe the information is related to a crime, they shall terminate their investigation.
- 3 C. Confidentiality of Criminal Background Information
 - 1. Department personnel shall maintain strict confidentiality of criminal background information collected as part of the investigation.
 - 2. Department personnel shall keep criminal background information classified due to its sensitive nature.
- 5 D. Requests from Outside Agencies

Department personnel shall not perform criminal background investigations at the request of an outside agency if it is clear from the request that the criminal background investigation would violate constitutional rights or would be a violation of the law.

4 E. Use of Information

Department personnel shall only use information obtained during the criminal background investigation for the intended purpose of the investigation or to follow-up on identified criminal activity.
