Subject: EEOP Short Form Reporting for U.S. DOJ Contracts

BACKGROUND

An Equal Employment Opportunity Plan or EEOP is a workforce report that some organizations must complete as a condition for receiving Justice Department funding authorized by the Omnibus Crime Control and Safe Streets Act of 1968. The purpose of the EEOP is to make sure that recipients of financial assistance from the Justice Department are providing equal employment opportunities to men and women regardless of sex, race, or national origin. The federal regulations establishing the EEOP requirement also link a diverse workforce to effective law enforcement.

The requirement is for grantees to track and report on employee composition by ethnicity and gender under each job classification and compare to relevant labor market statistics. The results are reported, and where necessary, the Human Resources Department has identified intended plans to remedy the results.

The EEOP Short Form submitted in 2009 was signed by the City's Chief Administrative Officer; therefore, I am requesting your signature on the attached EEOP so it can be submitted to the Office of Justice Programs.
