## CRIMINAL COMPLAINT- ARREST WARRANT AFFIDAVIT

The	undersi	gned, under penalty of perjury, complains and says that on or about the	27th	day of	April	
20	_15	, in the County of Bernalillo, State of New Mexico, the above-named de	efendant(s)	did (here	state the essential facts):	

The affiant, Tommy L. Benavidez, is a full-time, sworn law enforcement officer with the Albuquerque Police Department. I have been a full time, sworn law enforcement officer since October 2009. I attended and completed the basic police academy offered by the Albuquerque Police Department. Since my commission, I have served in the Field Services Bureau, Patrol Division. For the last five years, I have been assigned to bicycle patrol in the Foothills Area Command. Currently, I am assigned on a temporary assignment to the Foothills Impact Team.

During my tenure as a career police officer, I have received training and on-the job experience related to the investigation of numerous types of crimes including, but not limited to, investigation of crimes against persons and property, to include; homicides, assaults, child abuse, weapons offenses, burglaries, various types of thefts, narcotics and narcotics-related crimes. I have received training related to the identification of many different types of controlled substances, including marijuana, methamphetamine/amphetamine, heroin, cocaine/crack cocaine, as well as other various drugs, along with the methods of use, sales, delivery, concealment, possession and manufacture these controlled substances.

On 04/26/2015, Ofc. J. Brionez and I were dispatched to a traffic accident with injuries at the intersection of Juan Tabo and Southern. The call stated there were three vehicles involved, with possible air bag deployment. A silver Buick SUV, tan Toyota Camry and a maroon Honda were the vehicles reported to be involved. Callers advised that a male driver ran north bound Juan Tabo, wearing a long sleeve button down shirt.

Ofc. Brionez arrived on scene first, advising a 30 yr old female was pregnant and complaining of wrist injuries. Ofc. Brionez advised a Bernalillo County Sherriff Deputy was on scene. Ofc. Brionez started a tow truck for three vehicles.

I arrived on scene and observed three vehicles, which seem to be disabled. I made contact with the two remaining drivers, who refused transport by rescue. I made contact with the female driver, identified as Vanessa Sonnenberg, who stated, "my husband will take me to the hospital." Vanessa stated she was driving east on Southern, and was crossing through Juan Tabo, on a green light. As she was crossing through, the driver of the silver SUV ran the red light, and hit her on the driver's side. I asked Vanessa if she was going to go to the hospital. Vanessa replied "I am pregnant and I feel like I am going to pass out. My arm is hurting all the way up and my husband is going to take me to the hospital." I spoke with the driver of the tan Toyota, identified as Falsen Cambre. Falsen explained he was at a red light, facing north on Juan Tabo at Southern. He observed the Honda, attempting to go through the green light east at Juan Tabo. Falsen observed the silver Buick turn directly into the red Honda crashing into her driver's side. Falsen advised the Honda was pushed into his vehicle, damaging the front end and the silver Buick came to a stop just east.

I contacted a witness, identified as Bruce Benson, who left his information with officers at the scene before he left. Bruce advised he stopped to check on the driver of the Buick, who he observed as a black male in the driver's seat. Bruce repeatedly asked the driver if he needed any help. Bruce stated "the driver continued to ignore him over and over." Eventually the driver got out of the silver Buick and jogged on top of the dirt hill to the east. Bruce observed the male slouch over; however, a few minutes later, the driver came back to the vehicle. Bruce stated he told the driver "You should sit down in case you're hurt. Police are on their way." The driver continued to ignore him retrieved cash from the vehicle and shoved it into his pockets. The driver fled the area, running past Bruce, north into the gated community.

The off duty deputy, K. Woods, advised he was driving east on Southern approaching Juan Tabo. Deputy Woods observed a traffic accident and stopped to check on injuries. Deputy Woods blocked traffic to protect the scene, exited the patrol unit and checked on the driver of the maroon vehicle. After checking on the driver he contacted the witness, Bruce Benson, who was parked in front of the silver Buick. Bruce told Deputy Woods the driver of the silver Buick was a black male, and was wearing a white shirt with slacks. Deputy Woods remained on scene until field units relieved him.

I was contacted by Ofc. J. Sullivan. Ofc. Sullivan explained he was off duty driving north on Juan Tabo approaching Southern. He was preparing to turn east on Southern from Juan Tabo, when he was slowed due to a car in front of him. Ofc. Sullivan came to a complete stop behind another vehicle in the east bound turn lane, just east of the silver Buick. Ofc. Sullivan observed the traffic accident scene and noticed a male standing at the driver's door area of the Buick. Ofc. Sullivan immediately recognized the male to Mixed Martial Arts (MMA) fighter Jon Jones. Ofc. Sullivan stated "Jon Jones was wearing a nice white polo style shirt, with either dark jeans or slacks on." Ofc. Sullivan thought to himself "oh man, that's Jon Jones." He observed Jon Jones jog in front of the vehicle stopped in front of him, and up the dirt hill on the south east corner of Juan Tabo and Southern. After a few minutes, Jon Jones jogged back to the silver Buick, and entered the vehicle from the driver's door. I asked Ofc. Sullivan how he knew it was Jon Jones, to which Ofc. Sullivan replied, "I watch UFC all the time, I know what Jon Jones looks like."

I attempted several phone calls to Jonathan Jones from the foothills substation. I left two voicemails advising Jon Jones to call dispatch and ask for me to call him back. I did not receive any phone calls or messages from Jonathan Jones.

I contacted Vanessa to get an update on her injuries. Vanessa stated she went to Kaseman hospital and was told she had a fractured arm and wrist. Vanessa advised me she is in a sling now and that she receives her cast tomorrow. Vanessa stated she was on her way to get an ultra sound today.
