## APD Notables...

### Field Services Bureau

#### Field Services Bureau - East

#### Southeast Area Command...

- In February, the Southeast Area Command had 10,606 calls for service, wrote 2,060 reports, and issued 430 citations. There were 219 felony arrests, 312 misdemeanor arrests, and 37 driving while intoxicated (DWI) arrests. Twelve community meetings were attended.
- In February, Officer M. Fisher arrested two convicted felons in possession of firearms during two separate incidents and located a moderate amount of cocaine under the seat of a vehicle he was towing incident to arrest. Officer Fisher also arrested a female on transferring and receiving stolen property. He was able to link her to a recent residential burglary.
- In February, officers were dispatched to a car accident. Upon arrival, they made contact with the driver who had her five-year-old son in the vehicle and had just rear ended another vehicle. The driver appeared to be under the influence. Officers determined alcohol was not a factor and a Drug Recognition Expert (DRE) officer was called to the scene to conduct further tests. She was later booked for child abuse.
- On February 21, Officers Montoya, McBrayer, Endres and Sergeant Barraza responded to a call stating there was lots of foot and vehicle traffic coming and going from a mobile home at all hours of the day. The caller was concerned there was drug dealing going on at the mobile home. Officers arrived and contacted the owner. He was advised of the reported concerns called in to police. The owner agreed to allow officers to enter his home and conduct a welfare check. Officers located several subjects inside that appeared to be under the influence of narcotics. One individual was found sleeping with a firearm and narcotics hanging out of his clothing. The narcotics were identified as methamphetamine and heroin. The firearm was found to be stolen. The suspect was on probation and it was confirmed that he was a convicted felon. Probation and Parole was contacted and the suspect's probation officer issued an arrest warrant. The suspect was booked on several charges including felon in possession of a firearm, receiving and transferring a stolen firearm, possession of a controlled substance, possession of methamphetamine, and a felony warrant. Three other subjects were found to have outstanding misdemeanor and felony warrants and were booked without further incident. The case was submitted to the District Attorney's Office for prosecution.
- On February 23, a driver of an older model vehicle shot towards officers. The vehicle was last seen driving westbound and had no license plate. Southeast officers saturated the area and located the vehicle. Officers attempted to conduct a traffic stop but the offender ran into a courtyard of an apartment complex. The offender eventually surrendered and was taken into custody along with his girlfriend who was attempting to enter the offender vehicle. The vehicle was sealed pending a search warrant.
- In February, Officer DeHerrera attended a community meeting at a local child development center in reference to providing children with safety tips and the responsibilities of police officers.
- On February 22, Southeast Impact Detective T. Hotle opened a case regarding a felon in possession of a firearm. Detective Hotle was contacted by Southeast field officers in reference to the arrest of an individual who was found passed out in a stolen vehicle at a motel. Officers observed a firearm in the vehicle. He was taken into custody and found to have a felony warrant. The firearm and vehicle were queried through the National Crime Information Center (NCIC) and were both found to be stolen. Detective Hotle checked the suspect's criminal history and found him to have five felony convictions. The suspect faces ten years in federal prison if convicted.
- On February 22, Officers Z. Kesner, A. Suarez, J. Sandoval and L. Henckel were dispatched to a report of a possible drunk driver who had gotten into a traffic accident with her two kids. During the traffic accident an 11 month old child was ejected from the vehicle and left on the freeway. Officers proceeded to the area and located the vehicle and the female driver. The female was found to be intoxicated and was charged with felony child abuse and leaving the scene of an accident with injuries.
- On February 3, Officer A. Vargas and other officers were dispatched to a call involving a subject armed with a metal pole and striking several people. Information provided by dispatch indicated one subject was bleeding from the head. When officers arrived, they encountered a male subject armed with a pole.

He reacted to police presence by asking them to shoot him. Officers utilized time, distance and cover, and were able to take the suspect into custody. Officer Vargas determined there were three victims who were struck and suffered injuries at the hands of the suspect during his aggressive acts. The suspect was booked on several counts of aggravated battery.

- On February 26, Officers C. Bisagna and K. King were conducting patrol and noticed multiple subjects loitering in a park after hours (posted closing time is 10 p.m.). Officers contacted the individuals and found one to have an outstanding misdemeanor warrant and the other to be in possession of methamphetamines. Both subjects were placed under arrest and transported to the Prisoner Transport Center where they were booked without incident.

### **Northeast Area Command...**

- In February, the Northeast Area Command had 9,038 calls for service, wrote 1,628 reports, and issued 914 citations. There were 89 felony arrests, 218 misdemeanor arrests, 42 driving while intoxicated (DWI) arrests, and 127 warrants issued. Fourteen community meetings were attended.
- On February 15, Officers R. Garnand and J. Lopez-Shook were dispatched to a domestic violence call. When the officers arrived, they learned that the victim's girlfriend hit him in the head with a beer bottle during an argument. The blow caused the victim to sustain a significant laceration to the side of his head. The offender fled the scene before officers arrived. During the investigation, officers learned the offender's location and arrested her. The couple's three-year-old son was present and had an old cut on his foot that was infected. Rescue was called to examine the child and he was transported to the hospital for treatment for his infected foot. The child was placed into the custody of family members.
- On February 16, Public Service Aide (PSA) Lanz was dispatched to a car that was parked blocking an alley way. When PSA Lanz arrived, he noticed the vehicle was occupied so he called for an officer to assist. Officer T. Griego arrived and checked the vehicle's license plate and found it was stolen out of Utah. Officer Griego arrested the vehicle's driver and occupant. When Officer Griego searched the vehicle, he located a significant amount of methamphetamines in the car. The driver was

booked for auto theft and narcotics charges.

- On February 26, Officer J. Lopez-Shook was dispatched on a welfare check call. The caller stated that a female did not show up for work which was out of the ordinary. The caller said the female had been depressed lately and was exhibiting odd behavior. When Officer Lopez-Shook arrived, she found the female's car present but the female was not answering the door. Based on the information, Officer Lopez-Shook made her way into the apartment and found the female inside barely breathing. The female had apparently stabbed herself four times in the chest in an apparent suicide attempt. Rescue was called and the female was transported to the hospital by ambulance.
- In February, Team 1 patrolled the area command targeting areas that were experiencing a high number of residential and commercial burglaries. Team 1 made contact with 8 individuals and issued 19 moving citations. The team also contacted 28 people and educated them on the risks of leaving their running vehicles unattended.
- On February 20, Officers J. Lucero and S. Cerasia were dispatched to a motel to assist Officer J. Hollier with a possible stolen car. Upon arrival, Officer Lucero located another suspicious vehicle and a male matching the description as the possible offender walking towards the vehicle. After the male moved the suspicious vehicle, he entered the room where officers had been advised the offenders were staying. Officer J. Lucero made contact with two males inside the room. Both were detained while officers continued their investigation. Two stolen vehicles were located and returned to their owners. Both offenders were interviewed and arrested.
- On February 3, Officers T. LaForce, A. Malkovich, L. Stallings and Sergeant J. Perez were dispatched to a business regarding a male who threatened the occupants with a firearm. The store manager advised he had previously had an altercation with this subject regarding a transaction over a motorcycle. The male had armed himself with a rifle and handgun and was seen walking towards the business. The store owner quickly locked the doors while officers approached on foot. The male realized the doors were locked and attempted to leave the area in his vehicle. With the assistance of Tactical Officer Z. Cancilla, officers conducted a felony stop behind the business and took the male

into custody without incident. The male was booked on felony charges. Both firearms were recovered inside the vehicle.

- On February, 24, Officers from Team 5 were dispatched to an auto burglary in progress. Officers flooded the area and located the suspected offenders with the assistance of air support. The offenders were attempting to steal a vehicle after arriving in another stolen vehicle. All offenders were found to have outstanding warrants for their arrest. A firearm was also found in the vehicle near a subject that was found to be a convicted felon. Officer J. O'Guin interviewed one of the suspects, gaining substantial knowledge on their operation. A total of three stolen vehicles were recovered.
- On February 1, Officer M. Kelly was dispatched to a domestic dispute. The ex-husband was inside the residence, refusing to leave and had an active restraining order against him. Upon arrival, Officer Kelly saw the male standing outside the doorway. Once the male saw officers, he ran back inside the home and was seen a short time later trying to exit out the back door. Officer Kelly took the male into custody and discovered the male had seven outstanding warrants for his arrest, both felony and misdemeanor. He was booked into the Prisoner Transport Center on his warrants and for violating his restraining order.

### **Foothills Area Command...**

- In February, the Foothills Area Command had 5,978 calls for service, wrote 765 reports, and issued 804 citations. There were 70 felony arrests, 118 misdemeanor arrests, and 15 driving while intoxicated (DWI) arrests. Sixteen community meetings were attended.
- On February 3, officers were dispatched to an in-progress residential burglary. Information was provided from a neighbor that a white male subject wearing a brown jacket had been going into yards and checking windows at homes around the neighborhood. As officers were responding, information was received that the male subject had entered a residence through a window in the back of the house. Upon arrival, first responding Officers Lampiris-Tremba and Marquez noticed an open back door to the residence and a screen lying on the ground next to a back bedroom window. Officers Lampiris-Tremba and Marquez established visual containment around the residence while waiting on the assistance from air support. Air

5 arrived on scene and located the male subject matching the description given by the neighbor. Air 5 advised officers that the male subject had left the scene and was walking out of a nearby arroyo and into a local business. Officers arrived, waited for the male subject to exit the business, and made contact with him. The male subject had a pouch containing approximately \$600 worth of jewelry on his person. Officers also located other property belonging to the victim under the bridge in the arroyo amounting to more than \$2,600. In total, the officers recovered approximately \$3,220 worth of stolen goods.

- On February 25, Officer L. Garcia was dispatched to a local bank in response to a male subject attempting to cash a fraudulent check in the amount of \$2,400. Upon arrival, officers made contact with the subject and conducted an investigation. Officer Garcia contacted the victim who lived in Florida. Officer Garcia obtained confirmation from the victim that she didn't know the suspect and had never issued him a check. Officer Garcia arrested the subject for fraud, conspiracy to commit a felony and forgery. Officer Garcia completed a felony case and submitted it to the District Attorney's Office for further investigation and prosecution.
- In February, Officer M. Martin Smith conducted a tactical plan in the area of Beats 524, 531, and 532. The tactical plan focused on the rash of residential burglaries that had been plaguing the area for several weeks along with the increase of stolen vehicles. Officer Smith saturated the area with vehicle patrols and informed residents not to keep their garage doors open. As a result of the tactical plan, Officer Smith recovered 15 stolen vehicles, made four felony arrests, and with the help of Safe City Strike Force boarded up five nuisance properties.
- On February 14, officers were dispatched to an aggravated assault. When they arrived, they observed an adult straddling a fourteen-year-old subject. The adult seemed to be holding down the teenager who had blood running from his nose. There was also blood on the street. The victim had red bloodshot eyes and swelling to his face and forehead. After speaking to numerous parties at the scene and based on the investigation, officers arrested the adult subject on child abuse.
- On February 12, Officer Friedfertig was on patrol when he observed a vehicle with an expired tag. He ran the plate and found it was

not on file. He initiated a traffic stop and made contact with the driver. Officer Friedfertig observed a strong odor of an alcoholic beverage emanating from the driver. The driver denied drinking any alcohol and refused field sobriety tests. Officer Friedfertig also observed open cans of beer on the vehicle floor on the passenger side and an open case of beer spilling out of a bag on the passenger seat. Officer Friedfertig found the vehicle had not been registered since 2007, was not registered to the license plate on the vehicle, and the driver was not the registered owner. Also, the driver did not have a valid driver's license or insurance. The vehicle was towed and the driver was arrested.

- On February 7, officers were dispatched to a diagnosed schizophrenic subject walking in the middle of traffic at an intersection. Several officers attempted to make contact with him to get him out of traffic as it appeared he was having a mental health episode. After about thirty minutes of trying to speak with the subject, Officers Urioste and Friedfertig were able to peacefully place him into handcuffs and into the back of their unit. Officers learned there was an active misdemeanor warrant for the subject's arrest and he was booked. The subject was also taken for a medical evaluation.
- On February 6, Officers Vanderlip and Bludworth were dispatched to a suspicious male and female jumping into dumpsters. Upon officers arrival, they made contact with a male and female matching the description of the individuals provided by the caller. Investigation revealed both subjects had confirmed outstanding felony warrants for burglary. Both subjects were subsequently taken into custody and booked into the Metropolitan Detention Center (MDC) without incident or injury.

### **Field Services Bureau - West Valley Area Command...**

- In February, the Valley Area Command had 6,335 calls for service, wrote 1,246 reports and issued 661 citations. There were 122 felony arrests and warrants, 141 misdemeanor arrests and warrants, and 44 driving while intoxicated (DWI) arrests. Ten community meetings were attended.
- On February 19, Team 8 officers were dispatched to a possible commercial burglary in progress. When officers arrived, they located a male subject outside the property who was intoxicated. He explained that several of his

friends were inside and then attempted to walk away. He was detained and a search of the property was done. No one else was found. Sergeant Wheeler interviewed the male and he admitted to gaining entry into the property unlawfully, entered several vehicles which were on the property, and stole numerous vehicle parts and items from inside of the vehicles. He was arrested without incident.

- On February 26, Officer J. Chafin arrived at a bar in the Downtown Entertainment District and noticed some type of dispute occurring in a nearby parking lot. He approached and found a subject who had been stabbed multiple times. Officer Chafin requested additional units, identified the suspect who was still armed, and established a perimeter. Sergeant Wheeler took over first aid until rescue arrived. The male was transported to the hospital where he was in stable condition after surgery. The male offender confessed to the stabbing.
- On February 9, Officer J. Bowe responded to a shooting call. Officers learned that two cousins were drinking alcohol and playing with a gun. While manipulating the firearm, one of the cousins shot the other in the face at close proximity. The victim was taken to the hospital and was listed in stable condition. The suspect was booked on negligent use of a deadly weapon.
- On February 29, Officer Smith was dispatched to a possible drug overdose. When he arrived there was an individual laying on the ground next to a vehicle in the parking lot. The male was breathing hard and sporadically. While waiting for rescue, the male stopped breathing and Officer Smith could not find a pulse. He started CPR and continued until rescue arrived. The subject was transported to the University of New Mexico Hospital. Officer Smith received a phone call from UNM Hospital later that evening stating the male had survived and was in the intensive care unit.
- In February, Sergeant N. Wheeler and Officer M. Jones were given a letter of commendation from Chief Eden.
- On February 3, Impact detectives worked with the Bureau of Alcohol, Tobacco, Firearms and Explosive in response to an auto burglary at a local motel where approximately 70 firearms were stolen. Two felony arrests were made and four of the guns were recovered. One individual was indicted.
- On February 9, detectives responded to a

stolen vehicle being tracked through its global positioning system. Detectives spread out and checked various hotels and businesses in the area of the last transmission. The vehicle was eventually located. During the investigation, detectives cleared the vehicle and discovered a loaded sawed off shotgun and rifle inside the car. Located inside the room where the suspects were staying, officers located the stolen vehicle keys, a semi automatic weapon, additional guns, an ounce of heroin, a scale with methamphetamine on it, a stolen passport, and five high end watches. One of the watches was confirmed as stolen from San Francisco and worth \$45,000. Also recovered was a stolen driver's license, credit cards and gift cards. The vehicle and belongings were returned to the victim. Detectives arrested three individuals and cleared six felony warrants. One of the offenders was charged with three counts of felon in possession of a firearm. The suspect also admitted to several auto burglaries which are still being investigated by detectives. It was later learned that the two suspects detectives had in custody were suspects in two homicides. They were also booked on the homicide charges.

- On February 16, Officer Heitzman was on random patrol when he observed a vehicle driving recklessly and almost running over several pedestrians. Officer Heitzman attempted to stop the vehicle but it refused to stop. Officers disengaged and lost sight of the vehicle. Several minutes later, Officer Heitzman located the vehicle in the front yard of a house. The driver was standing on the side of the house talking on his cell phone. When the suspect saw Officer Heitzman, he got in his vehicle and backed up at a high rate of speed almost hitting Officer Heitzman who was out of his vehicle. The suspect wrecked into Officer Heitzman's patrol car but kept going. The suspect sped off and swerved into oncoming traffic almost hitting Officer Herrera who was in route to scene. Officers lost sight of the suspect and an attempt to locate was put out for the suspect. Southeast Area Command officers and Air 1 located the suspect after he had been in an accident at the airport. The suspect was arrested for driving while under the influence (DUI) and aggravated fleeing.

### Southwest Area Command...

- In February, the Southwest Area Command had 5,187 calls for service, wrote 1,114

reports, and issued 733 citations. There were 64 felony arrests, 78 misdemeanor arrests, 39 driving while intoxicated (DWI) arrests and 70 misdemeanor and felony warrants issued. Five community meetings were attended.

- On February 22, Team 9 officers responded to a shots fired call. Upon arrival, officers made contact with a male walking towards them. The subject was hallucinating and under the influence of narcotics. After interviewing the subject, he advised that he had a gun and hid it prior to contacting officers. The subject was detained in handcuffs and he escorted officers to the location of the firearm. The suspect was found to be a felon and arrested for being a felon in possession of a firearm. After placing him under arrest, the subject's mother made contact with officers and advised that her son had threatened her with the gun and shot near her three times inside her apartment. Officers went with the mother to her apartment and found three impact rounds inside the apartment. The suspect was booked for aggravated assault with a deadly weapon, felon in possession of a firearm and a felony warrant.
- On February 3, Officer C. Chavez was dispatched to a gas station in response to an unconscious female subject who had possibly overdosed on drugs. When Officer Chavez arrived on scene, he located the female subject, pulled her out of the vehicle and started CPR. Officer Chavez continued CPR until paramedics arrived and transported the subject to the hospital. The female subject survived.
- On February 23, Officer J. Garcia was on patrol when he noticed a vehicle without a plate. He engaged his emergency equipment to stop the vehicle but the vehicle fled and began to drive recklessly. Officer Garcia backed off but continued looking for the vehicle in the area. Officer Garcia located the vehicle in the front yard of a residence and the driver was still in the vehicle. Officer Garcia called for backup and they got the driver out of the vehicle and took him into custody. The vehicle was stolen and the driver was found to be in possession of a controlled substance.
- On February 26, Officer J. Garcia was dispatched to a domestic violence call where the caller stated her ex-boyfriend was causing damage to her vehicle. When Officer Garcia arrived, the subject had entered his vehicle and was in the process of leaving the scene. Officer Garcia attempted to stop the vehicle but it fled.

The subject was later located and taken into custody. The subject was under the influence of alcohol and was arrested and booked on several charges.

- On February 12, Sergeant C. George, Officers C. Carter, S. Miera, M. Vallejos, and B. Sanchez were dispatched to a call regarding a man who wanted to kill himself by jumping off a freeway overpass and getting hit by a car. Officer Carter distracted the individual and Officer Sanchez grabbed him off the ledge and prevented him from harming himself.
- On February 13, officers were dispatched to a priority one family dispute call. Comments on the call stated a male was preventing a female from leaving the location and was hitting the window of her vehicle. As officers were arriving, they were advised the male left the location. Officers were provided the male's description and located the subject around the corner from the dispatched location. The male was acting erratic and emotional. He was detained due to his belligerent behavior and for further investigation. Officers made contact with the female and confirmed a domestic dispute occurred. Ultimately the suspect was arrested and booked on domestic violence charges. The offender was also referred to the physiological services unit at the Metropolitan Detention Center due to suicidal statements he made.
- In February, officers responded to a roommate dispute. Upon arrival, they learned one of the parties involved was diagnosed with a mental illness and highly intoxicated. As they attempted to contact the subject to investigate the battery allegation, he rapidly closed distance on the officers and was aggressive in nature. Officers were able to control the individual by compliance holds and working as a team. The subject only increased in agitation as the investigation continued. At this point, he started threatening the life of the calling party as well as others. Because of the subject's mental state and unknown quantity of narcotics/alcohol consumed, officers had the subject assessed by medical personnel and subsequently transported to the hospital pending a mental health evaluation.
- In February, officers responded to a call where a subject had been holding a female hostage and raping her on multiple occasions. Officers located and contacted the female who was entered into the National Crime Information Center (NCIC) as endangered. The male

barricaded himself inside the apartment knowing the police were present. The officers successfully negotiated with the offender and solicited a peaceful surrender.

- In February, Team 6 conducted tactical plans in an area which is known for criminal activity. Several stolen vehicles were recovered and subjects with outstanding felony warrants were apprehended.

### **Northwest Area Command...**

- In February, the Northwest Area Command had 3,991 calls for service, wrote 638 reports, and issued 662 citations. There were 36 felony arrests, 83 misdemeanor arrests, 23 driving while intoxicated (DWI) arrests; and 30 warrants issued. Four community meetings were attended.
- On February 4, Officers Morant and Carrillo were dispatched to a bank in response to a woman attempting to cash a stolen check. Upon arrival, they took the female into custody. Officer Morant found the check had been stolen in a residential burglary. The female had also concealed her identity with a New Mexico identification card that was found to be stolen as well. Officer Morant also found methamphetamine on the female. The suspect was booked on several felonies.
- On February 18, Officer Morant was dispatched to a fast food restaurant in response to an attempted robbery. Upon arrival, he spoke with the employees who stated a male subject came to the restaurant and told the employee to open the cash register. As the male subject stood at the counter, another employee recognized the male, at which time the male left the store and ran south in the parking lot. Approximately 15 minutes later, another robbery occurred at a nearby store. The description matched the male who had attempted the robbery at the fast food restaurant. Officer Morant obtained the identify of the offender. The same male struck several different locations that same day. On February 20, officers were dispatched to a restaurant in response to a robbery where two men armed with a hatchet stole money. The offenders fled the scene in an older vehicle. Officer Saladin located the vehicle and it was registered to the same suspect who was on a robbery spree two days earlier. A felony stop was initiated. Four suspects were taken into custody and one of the offenders was identified as the same offender as in the previous robberies. The Robbery Unit

- took over the investigation and they connected twelve separate robberies to the same offender.
- On February 6, Officers H. Alvidrez and A. Lewis and Sergeant Hilger responded to an auto burglary in progress. The victim was inside a business when he came outside and noticed the suspect in his vehicle. The victim confronted the suspect and punched him in the face. A struggle ensued and the victim's friend assisted in detaining the suspect until officers could arrive. The suspect was in possession of two knives when he committed the burglary and was arrested for aggravated burglary (auto) as well as possession of burglary tools.
- On February 28, Officers T. Barnhill and J. Trujillo were dispatched to a single car vehicle accident. Comments on the call stated the driver of the vehicle was possibly intoxicated and had walked into a nearby store. Officers arrived on scene and located and detained the driver pending an investigation. Officers determined the driver had parked his vehicle at a gas station. While he was away from the vehicle, it rolled away from the pumps and got stuck on the median. Officers also found the vehicle the suspect was driving was reported stolen. The vehicle was searched and a syringe loaded with methamphetamine was located inside a backpack. The suspect was arrested for the auto theft as well as possession of a controlled substance.
- On February 1, Northwest Impact detectives observed a vehicle parked in a driveway that had been recently reported stolen from a fitness gym. Two females attempted to enter the stolen vehicle, but fled on foot as detectives approached them. Detectives caught both offenders and arrested them.
- On February 4, Officer R. Perea was on random patrol when he observed a suspicious vehicle casing other vehicles in a business parking lot. Officer Perea attempted to conduct a traffic stop but the driver fled the scene. Officer Perea kept an eye out for the vehicle and on February 20, he located the suspicious vehicle again. He identified the driver and issued citations for traffic-related offenses.
- On February 2, Officers J. Wharton and E. Ibarra responded to a domestic call where an out of control juvenile was destroying property. Upon their arrival, the offender was still destroying property and resisted officers by walking away. Officer Wharton used his crisis negotiation skills and deescalated the situation.

The offender was charged with felony criminal damage and assault.

- On February 19, Officer D. McCracken handled a fatal traffic accident. When Officer McCracken responded to the scene, he determined the driver was a father of a two-year-old old who may have been inside the vehicle. Officers checked the vehicle and surrounding area and located an empty car seat. Officer McCracken worked quickly to identify next of kin and conduct a welfare check to ensure the safety of the child. The child was found with its mother.
- On February 26, Officer T. Carman responded to an accident involving a motorcycle. He arrived on scene and immediately began rendering aid to the driver of the motorcycle. Officer Carman also secured the scene allowing the Lifeguard helicopter to land and extract the injured motorcyclist. Sadly, the motorcyclist did not survive the accident.

## Special Services Bureau Special Operations Division...

### Tactical...

- In February, the K-9 Unit answered 224 calls for service, conducted 85 searches and had four SWAT activations.
- In February, the K-9 Unit had eight handlers. Two handlers were transferred to other divisions. Two new handlers tested and were selected. They will attend the Alderhorst Basic Handler course in March.
- On February 9, K-9 officers responded to an area search call. The suspect was wanted for a series of armed robberies in Albuquerque. The K-9 team conducted the area search and located the suspect on top of a commercial building.
- On February 2, K-9 officers responded to a shooting. While in route, the suspect carjacked an individual in a nearby area. The suspect then went on a crime spree where he placed the citizens of Albuquerque in great danger. The suspect then crashed into an innocent civilian and shot at the person. He fled the scene on foot and carjacked another individual. K-9 officers located the vehicle and called for air support. The vehicle's tires were eventually disabled and the suspect crashed his vehicle. The suspect then attempted to carjack another civilian. The suspect was shot in a confrontation with Bernalillo County Sheriff's deputies and APD officers. The suspect was transported to the

- hospital where he later died from his injuries.
- On February 29, K-9 officers responded to an area search call. The suspects were last seen running from a stolen motor vehicle. Field officers established a perimeter. Upon arrival, K-9 officers took both suspects into custody without injury while giving the K-9 warning announcements.
- On February 4, SWAT assisted the Vice Unit with a high risk search warrant involving a subject dealing high levels of narcotics and armed with an assault weapon. The team conducted a “breach and hold” tactic and called out all occupants from the residence. Three subjects were taken into custody at the residence and numerous narcotics and firearms were recovered.
- On February 4, SWAT assisted the Bureau of Alcohol, Tobacco, Firearms, Explosives, and Narcotics (ATF) with a high risk search warrant involving a subject who had stolen a trailer loaded with firearms. The subject was believed to be selling the firearms to individuals on the street. The team conducted a “surround and call-out” tactic and took one male subject into custody for ATF agents. The residence was cleared and turned over to ATF agents.
- On February 8-17, SWAT assisted the APD Academy staff with teaching Cadet Officer Survival Training. The first week involved reality based scenarios with simunitions. The scenarios covered a variety of situations an officer may encounter in the field. The scenarios covered the use of force spectrum, from situations being resolved by verbal de-escalation to situations requiring deadly force. The second week involved conducting advanced firearm training at the Tactical Range. The firearm training covered not only shooting but how to maneuver utilizing cover and concealment and not unnecessarily exposing yourself to a potential deadly threat.
- In February, the Bomb Squad responded to four bomb callouts.
- On February 13, APD’s Bomb Squad responded to a call in which a mechanic located a steel pipe bomb with a digital kitchen timer attached to the device. The device was attached to the undercarriage of the car by a large magnet. APD’s Bomb Squad utilized a robot to remove the device and open it. It was revealed there was no explosive material inside.
- In February, The Bomb squad assisted with two SWAT activations to include robot support,

armored vehicle support, and explosive breaching support.

### Office of Emergency Management... (OEM)...

- OEM is applying for a mass notification system grant to mitigate the lack of effective and centralized public warning capabilities.
- OEM is the lead agency for a hazard mitigation grant application for a \$7.2 million dollar levee construction project. Partners include the Department of Municipal Development, Albuquerque Metropolitan Arroyo Flood Control Authority (AMAFCA), Middle Rio Grande Conservancy District (MRGCD), and Bernalillo County as additional partners.
- In February, OEM tested the 38 primary and 24 alternate Emergency Operations Center Personal computers’ software for operational readiness. All systems were functional.
- On February 25, OEM staff met with representatives from the Department of Homeland Security (DHS) Center for Faith-Based and Community Partnerships, Federal Emergency Management Agency (FEMA), city department directors and the Mayor regarding planning for a ‘Building Resilience with Diverse Communities’ project. This initiative will engage the community on disaster preparedness activities and organize the faith-based community with the Office of Emergency Management response process.

### Homeland Security...

- In February, Homeland Security conducted five active threat classes for private businesses and the City of Albuquerque. These classes were conducted at University of New Mexico’s Speech and Hearing Clinics and the City of Albuquerque Cultural Services.
- On February 23-25, Lieutenant Walton attended the 24 hour operational course for the Department of Homeland Security Emergency Operations Center at the Albuquerque Fire Department Academy.

### Open Space...

- On February 6, Open Space Search and Rescue (OS SAR) was contacted by the Bernalillo County Fire Department in response to a search and rescue on the La Luz Trail. Two young men had attempted to hike the trail but were only wearing tennis shoes, jeans, and cotton sweatshirts. They had encountered significant snow along the trail, but continued with the hike.

They became very cold, their clothes had frozen, and they didn't believe they could continue.

They called 911 and requested help. OS SAR, Albuquerque Mountain Rescue Council (AMRC), and Cibola Search and Rescue made a coordinated effort and developed a rescue plan to hike up the mountain to locate the hikers. When the two hikers were located, they were provided with warm clothing, food and water. Once the hikers received the necessary assistance required to proceed, the team of rescuers escorted the men off of the mountain and released them to medical personnel.

- On February 7, a call was received from a mother indicating her son had not returned from a hike in the Sandia Mountains. She had last seen her son earlier in the day. She provided them with the trails the son had said he would be hiking. The mother stated he was wearing a green day pack, grey sweat shirt, camouflage pants and red flannel shirt and she was unsure if he had any food or water in the day pack. Due to the wide area to be searched, Bernalillo County Sheriff's Office (BCSO) Metro 2 and New Mexico State Police Search and Rescue (NMSP SAR) was requested to assist. Metro 2 began to search the vast area with infrared cameras and night vision and quickly located the subject on top of a peak flashing a light. Metro 2 was able to land, but due to the snow depth they were unable to make contact with the subject by foot. They could tell he was in severe distress and in need of immediate rescue. Technical teams were needed to extract him because he could not make it to the landing zone. Due to the challenging conditions and the necessity to get the subject off the mountain, two OS SAR officers were airlifted to within a half mile of the subject. The officers hiked the half mile through two to four feet of snow eventually making contact with the subject. The officers provided the subject proper hydration, food, and dry warm clothing. OS SAR outfitted him with snow shoes and he was eventually able to hike back to the landing zone. Metro 2 picked up the subject and the officers and transported them to an awaiting ambulance.
- On February 8, Officers Candelaria and Harvey responded to a call that someone was camping out near one of APD's substations. Officers Candelaria and Harvey located a female and a male camping out near the rear door of the substation. Both parties were ran through the National Crime Information Center (NCIC) and

negative warrants were located. The officers advised the subjects they could not camp out at the substation and learned that the subjects were homeless. Officer Candelaria called a homeless shelter and found they had room for both of them. She transported them to the shelter.

- On February 22, Open Space officers were called to assist Homicide detectives. Open Space provided scene security at a remote location until detectives were able to adequately process the evidence.

### **Horse Mounted Unit (HMU)...**

- On February 5, the HMU was requested for the American Heart Association at Civic Plaza. This is an annual event headed up by the Mayor to kick off awareness for women's heart issues. The unit provided four horses.
- On February 17, the HMU was requested by Onate Elementary to participate with their annual career day. Officers Breeden and Montoya worked the event and contacted approximately 450-500 kids throughout the morning.
- On February 22, the HMU was requested to participate in a press conference with the Mayor and other supporting agencies in regards to the recent fires being set in the Bosque. The Unit provided two horses.

### **Metro Traffic Division...**

- In February, the Traffic Division responded to 461 calls for service.
- In February, the division had 118 driving while intoxicated (DWI) arrests; eight felony arrests; eleven misdemeanor arrests/warrants; and issued 17 misdemeanor citations.
- In February, the division issued 995 moving citations; issued two cell phone citations; investigated 137 crashes; towed 143 vehicles; had 33 DWI vehicle forfeitures; and recovered one stolen vehicle.
- In February, the DWI Seizure Unit checked in 81 vehicles; returned 15 vehicles; booted 31 vehicles; and removed seven boots.
- In February, 192 vehicles were ready for auction and 143 were auctioned.
- In February there were three hundred eighty four vehicles on the seizure lot.

### **Prisoner Transport Unit (PTU)...**

- In February the Prisoner Transport Unit (PTU) processed 1,201 prisoners through the Prisoner Transport Center. The Albuquerque Police

Department arrested 890 prisoners and other outside law enforcement agencies arrested 311 prisoners.

- In February, PTU made 213 trips to the Metropolitan Detention Center and accepted two walk-in prisoners at the Metropolitan Detention Center.
- In February, PTU worked four hospital guard duty assignments for a total of 16 days.

### **Metro Court Protection Detail (MCPD)...**

- In February, 70 individuals were remanded by the court and booked and 6 were remanded but bonded out on site.
- In February, 47 individuals were booked with arrest warrants and 52 were booked with arrest warrants but bonded out on site.
- In February, seven juvenile warrants were cleared.
- In February, 93 misdemeanors and six felony warrants were cleared.
- In February, MCPD had a total of 880 calls for service and self-initiated activities.

### **Investigative Bureau**

#### **Scientific Evidence Division...**

- In February, the Major Crime Scene team responded to seven primary call-outs.
- In February, Field Investigations responded to 1,052 calls for service and 182 primary burglary calls.
- In February, Field Investigations collected 830 latent fingerprint cards; completed 812 reports; tagged 602 evidence items; and tagged 388 photograph CDs.
- In February, Crime Scene Specialist O'Connell instructed a crime scene course at a local high school.
- In February, the Photo Lab worked on 421 cases resulting in 10,118 prints and 430 discs.
- In February, the Evidence, Identification and Disposition Unit supported the following backgrounds: 121 case dispositions, 63 employment, 30 firearms, 161 FBI and 24 CODIS requests. Fifty-six RAPs and photos were distributed, 13 new APD applicants were finger printed, 1,104 fingerprints were classified in AFIS and 1,326 new and old arrests were processed into APD's criminal history records.
- In February, the Evidence, Identification, and Disposition Unit received 9,724 evidence items, duplicated 4,720 audio/video recordings and supported 19 pretrial viewings. Efforts to reduce inventory resulted in 314 items returned to owners; 7,352 items disposed; and \$6,087.13

received as auction proceeds. The unit also processed 1,450 case disposition transactions into evidence history.

- In February, an acceptance test plan v1.0 for MorphoTrak, the latent fingerprint work station was approved and available.
- In February, the New Mexico DNA Identification System (NMDIS) received 507 new convicted offender/arrestee DNA samples, with a cumulative total of over 110,000 collected. 499 samples were analyzed, uploaded, and searched in CODIS, with a cumulative total of almost 103,000 searchable DNA profiles. As a result of these convicted offender/arrestee samples, 26 unsolved cases were matched to convicted offenders/arrestees, 11 case-to-case matches were made, with a resulting total of 35 investigations being aided.
- In February, the Controlled Substance Unit completed 44 drug cases (31 were APD and 13 were Bernalillo County Sheriff's Office).
- In February, the Biology Unit completed 11 APD cases.
- In February, the Latent Fingerprint Unit completed nine APD cases.

### **Criminal Investigations Bureau Property Crimes Division...**

#### **Auto/NITe Unit ...**

- In February, the Auto/NITe Unit detectives located two stolen vehicles that had activated stolen vehicle recovery systems along with 30 additional recovered stolen vehicles.
- In February, the Auto Theft Garage Unit conducted 36 free vehicle identification number (VIN) inspections which resulted in positive citizen contacts.
- On February 4, Auto/NITe detectives located a known repeat offender. He had a confirmed felony warrant and is a prolific car thief that has a history of being armed when contacted by officers. Detectives watched him enter what was later found to be a stolen vehicle from the parking lot of his apartment. Detectives followed him until he stopped at a pizza parlor. As he exited the business, detectives contacted him in the parking lot and took him into custody. The vehicle he was driving was confirmed stolen and two handguns and ammunition were located inside the vehicle. He was booked into the Metropolitan Detention Center and the vehicle was returned to the owner.
- On February 8, Auto/NITe Detective T.

Economidy located a stolen vehicle. Auto/NITE detectives followed it until the vehicle stopped at a motel. At this point, detectives tried to make contact with the occupants but they all fled on foot. They were eventually apprehended and the driver was booked for receiving and transferring stolen property. The passenger was booked for a felony warrant. The car was returned to its owner.

- On February 16, Auto/NITE Detective T. Economidy located an occupied stolen vehicle. The vehicle was located next to a crowded park full of pedestrians. Detectives continued to watch the vehicle until the driver got out of the vehicle. At this time, he was taken into custody without incident. The driver was identified and booked into the Metropolitan Detention Center. The vehicle was returned to its owner.
- On February 17, Auto/NITE Detective A. Hernandez located an occupied stolen vehicle. Auto/NITE detectives followed the vehicle from the Foothills Area Command to the Southeast Area Command. As soon as the driver exited the vehicle, the detectives took him into custody. The offender was identified on scene and was found to be in possession of methamphetamines. He was booked into the Metropolitan Detention Center. The vehicle was returned to its owner. The truck was taken as a “warm-up” with the owner leaving the keys in it unattended.
- On February 20, Auto/NITE conducted a citywide bait car operation. Detectives watched as a vehicle circled the block and dropped a male offender at the bait car. The offender jumped in and detectives watched him steal the car. The car was electronically tracked to an area and shut down. The offender was taken into custody without incident. Detectives immediately secured the scene and found the vehicle that dropped off the offender at the bait car. It was determined that vehicle was also stolen. Southeast field units assisted in conducting a felony stop on the vehicle and took the female offender into custody without incident. When the offender was asked to throw the keys out the window she threw out the screwdriver she was using to start the van. Both offenders were booked into the Metropolitan Detention Center. This bait car operation concluded with three arrests.
- On February 28, detectives received notification that a city owned bait car was taken. The bait car was placed at a local motel that was reporting high amounts of criminal activity related to

auto theft and burglaries. The vehicle was remotely disabled and officers from the Valley Area Command assisted Auto/Nite detectives in taking the offender into custody. The offender used a shaved jiggle key to start the car. He was booked into the Metropolitan Detention Center without incident.

### **Burglary and Organized Crime Unit ...**

- In February, the Burglary Unit cleared 32 cases.
- In February, the Burglary Unit focused on working AFIS and CODIS cases generated by the Albuquerque Metropolitan Crime Lab. Detective K. Treece obtained two arrest warrants for a serial residential burglar. The Fingerprint Unit in the Crime Lab completed two new fingerprint (AFIS) cases on the subject. The subject was in custody and booked into the Metropolitan Detention Center (MDC) on four felony cases stemming from other burglaries. It appeared he was likely to be released due to the lowering of his bonds. Detective Treece completed both AFIS cases rapidly and obtained two new felony arrest warrants against the offender. He was also able to obtain high bonds for the new warrants which prevented the offender’s release from MDC.
- In February, Detective T. Nicko completed four AFIS cases on burglary offenders identified by the Fingerprint Unit at the Crime Lab. Arrest warrants were obtained for all of the cases and submitted to the District Attorney’s Office for review.
- In February, Detective E. Jojola reactivated a felony shoplifting case in the Northeast Area Command. He was investigating a residential burglary with tentative suspect information. Detective Jojola learned his possible burglary offenders were identified as offenders from a felony shoplifting case last year. The victim had used social media to help identify them. Detective Jojola obtained arrest warrants for two female offenders. On February 23, Burglary detectives placed them both in custody. The offenders admitted to the shoplifting.
- In February, Detective D. Moore obtained an arrest warrant for a male offender from a Financial Institution Security Officers Association (FISOA) partnership case. The victim was working at a credit union and left his wallet unattended. The offender was working for a moving company that was moving items at the same credit union. The offender took the victim’s wallet and proceeded to use the credit

cards at various businesses. Detective Moore identified the offender and obtained an arrest warrant for multiple felony counts. The case was submitted to the District Attorney's Office for review and prosecution.

- In February, the White Collar Crimes Unit cleared 17 cases and submitted six cases to the District Attorney's office.
- In February, the Pawn Shop and Metal Theft Unit recovered three stolen firearms, 13 pawned items totaling \$25,250 and recovered \$12,000 in metal.
- In February, Crimestoppers received 156 tips which lead to two arrests.
- In February, Detective V. Natewa worked a case involving the embezzlement of over \$100,000 from a large self-storage company. The offender was the manager for one of the company's properties. The company had recently instituted a policy where all payments had to be check or credit card. No cash payments were to be accepted. The offender continued to take in cash payments and actively solicited renters to pay by cash despite the new rules. Company officials conducted an audit and noticed the discrepancy in the accounts. The offender was contacted about the issue and he resigned. Detective Natewa interviewed him and he admitted to the thefts. Detective Natewa subpoenaed his bank accounts but unfortunately could not locate the embezzled funds.
- In February, a male offender stole a bronze dog statue in front of a museum which was worth about \$12,000. The incident received significant media attention. The offender took the statue to a local recycler and sold it for \$55. The owner of the recycling business recognized the statue as being stolen and called an inspector with the State of New Mexico Regulation and Licensing Division to take custody of the item. The inspector called Detective D. Champine and the offender was identified from the recycling ticket. Detective Champine obtained a felony warrant for the offender's arrest. The suspect turned himself in after his picture was sent to local media outlets.

### **Criminal Investigations Division...**

- In February, the Homicide Unit responded to five call-outs. Two of the call-outs were homicides and the other three were major crimes.
- On February 13, officers were dispatched to a shooting call. Upon arrival officers located a

male juvenile who appeared to have been shot in the head. The subject was transported to the University of New Mexico Hospital where he later died as a result of his injuries. Through investigation, detectives learned the incident was a result of an accidental shooting involving three juvenile males.

- In February, the Homicide Unit sent four cases to the District Attorney's Office for review and/or prosecution.
- In February, the Armed Robbery Unit responded to six robbery call-outs and cleared 40 cases. Of those 40 cases, 27 were sent to the District Attorney's Office for prosecution. The Unit also made three in-custody arrests and wrote five arrest warrants. Furthermore, they wrote and conducted nine search warrants. The Robbery Unit had 40 new cases assigned this month and now has a total 123 active cases.
- In February, Detective K. Church was named the Non-Uniformed Officer of the Month.
- The Sex Crimes Unit responded to six sex crime call-outs this month. They also cleared 18 cases with ten of those going to the District Attorney's Office. The unit also wrote 15 search warrants as well as an arrest warrant. There were 24 new cases assigned for investigation and they now have a total of 95 active cases.
- On February 3, Detective A. Wild responded to a sex crimes call-out and found the victim had been brutally assaulted in her vehicle. As she escaped, the offender stole her vehicle and fled. Detective Wild issued an arrest warrant for the subject and subsequently recovered the victim's car when the subject was arrested the next day. Detective Wild received an email from the family of the victim expressing their appreciation for her compassion and diligence in the case.
- The FASTT Unit cleared 19 cases this month with five of them going to the District Attorney's Office. A total of 182 cases were reviewed.
- In February, the FASTT Unit assisted the Victim Assistance Unit with 30 cases which included follow-up with victims.
- In February, the FASTT Unit assisted victims with obtaining seven restraining orders and conducted follow-up investigations and assisted with 19 phone calls from officers in the field.
- In February, Detective M. Moya worked a case where a male subject violated a restraining order four times in a two-week period. After talking with the victim, Detective Moya obtained an arrest warrant for the suspect and he was

arrested by field officers.

- There were 112 new runaways/missing persons reported to the Missing Persons Unit this month. The unit cleared 92 total runaways/missing person cases. The unit currently has 103 active cases.
- In February, Detective Alvarez found a female who was reported missing under suspicious circumstances. Several tips suggested the female was being held against her will and being sexually assaulted by the offender. Detective Alvarez assisted field units who eventually located both the offender and victim. Detective Alvarez worked with Sex Crimes detectives and completed a warrant and several interviews specific to the case. The offender was arrested for bribery/intimidation of a witness, aggravated assault with a deadly weapon, kidnapping, and criminal sexual penetration.
- In January, the Crisis Intervention Unit (CIU) provided 76 hours of training. CIU assisted 65 individuals and 44 mental health consumers. CIU referred 118 people to services and conducted 43 home visits.
- There are currently 459 officers, or 98%, in the field that are Crisis Intervention Team certified.
- In February, the Crimes Against Children Unit (CACU) received 1,086 referrals from the Children, Youth, and Family Department. Detectives were assigned 68 new cases to be investigated and on-call detectives responded to 30 call-outs.
- In February, CACU executed 13 search warrants and generated three arrest warrants.

### **Special Investigations Division (SID)...**

- In February, SID completed 615 surveillance hours.
- In February, SID had eight misdemeanor arrests and issued five misdemeanor warrants.
- In February, SID had 19 felony arrests and issued six felony warrants.
- In February, SID submitted 23 cases to the District Attorney's Office.
- In February, SID seized 22 pounds of marijuana, 37 grams of methamphetamine, three grams of cocaine; six grams of heroin; and 10 grams of prescription drugs.
- In February, the Gang Unit was notified that a known gang member had a warrant for robbery and aggravated battery. Detectives were informed the suspect was armed and threatening to "shoot it out" with police. Detectives spent several days looking for him. Utilizing

investigative techniques, he was located and taken into custody. His passenger in the vehicle was found to be in possession of cocaine and was also booked.

- In February, the Gang Unit was notified that a known gang member had a robbery warrant for his arrest. The Gang Unit located him and took him into custody for his warrant.
- On February 4, Vice detectives served a search warrant at a residence as a result of an ongoing narcotics investigation. Detectives recovered a large amount of methamphetamine, heroin and a firearm. The suspect of the investigation was arrested.
- On February 22, Vice detectives identified a female escort who was suspected of robbing "Johns". Detectives cross referenced the phone number on an advertisement and located an online blog where a "John" stated she and an unidentified male robbed him when he met with the female. Detectives obtained a hotel room and set up a date with the female. When the female arrived, detectives assigned to parking lot surveillance observed a male passenger in the vehicle. The female exited the vehicle and went in to the booked hotel room. After a brief conversation with the undercover detective, the female said she wanted to get her cigarettes from her vehicle. The female went to her car and eventually returned to the room with the male passenger. Safety/ surveillance detectives immediately placed the male and female into custody. The offenders admitted to going to the hotel room with the intention of robbing the undercover detective. Detectives also recovered a firearm. Vice detectives received assistance from APD Intelligence, Narcotics, Homeland Security, and the Attorney General's Office.
- On February 4, Air 5 responded to a possible crime in progress. Air 5 circled the residence as the field units searched the interior. At this time, a male subject was observed climbing out of an arroyo behind the residence and walking away. Field units were directed to the subject and he was taken into custody with the victim's property in his possession.
- On February 9, Air 5 assisted Gang detectives in a surveillance of a residence of a known felony warrant suspect. He was observed leaving the residence in a vehicle. Air 5 followed the vehicle, updating detectives to its location and activity until it could be safely stopped. The offender was taken into custody and a firearm was recovered

- On February 9, Air 1 observed a vehicle driving in a reckless manner. As the vehicle turned from southbound to westbound, the vehicle spun out of control and came to a stop. Air 1 crew was unable to see if the vehicle hit anything when it spun out. Air 1 contacted the Bernalillo County Sheriffs Department and units were dispatched to the area. Air 1 updated the vehicle's location until a unit caught up with the vehicle. When the unit attempted a traffic stop, the vehicle fled, nearly hitting the deputy's vehicle. The vehicle fled at a high rate of speed and lost control on a turn and crashed into a front yard (the deputy was not pursuing at this time). Air 1 observed three subjects exit the vehicle and flee on foot. Air 1 stayed with the driver and updated locations until units were able to detain him. Once detained, a search was started for the other subjects. A second occupant was immediately located hiding in a backyard. Units were directed to the subject and he was detained without incident. The vehicle was returned to the owner (family member).
- On February 24, Air1 was requested to assist on a call involving offenders attempting to steal a vehicle from a residence. Upon arrival, Air1 noticed several subjects in front of the residence who were later determined to be the victims. As officers approached, they were advised that the offenders fled on foot. Air1 conducted several sweeps of the area alerting ground units to a suspicious vehicle driving at a high rate of speed northbound one street east of the target street. Air1 provided the description of the vehicle to field units and they intercepted the vehicle. A field unit conducted a traffic stop and determined the offenders in the vehicle were related to the call. Three suspects were taken in custody.
- In February, the Central Narcotics Unit served four search warrants, recovered three firearms, and conducted two undercover buy bust operations.
- In February, Officer J. Hill obtained a search warrant after undercover detectives purchased crack cocaine from the residence. This residence had been a location with several calls for service in reference to narcotics trafficking. On February 4, detectives served the search warrant and seized a small quantity of marijuana and other miscellaneous drugs along with a firearm. A felony arrest warrant for dangerous drug possession was obtained. The suspect was arrested on the warrant. The Safe City Strike Force responded to the scene and condemned the

property due to numerous code violations.

- In February, the Central Narcotics Unit received information that a subject was trafficking heroin and methamphetamines in both the Southeast and Southwest Area Commands. Detectives located the suspect and arranged to buy quantities of both heroin and methamphetamines. On February 23, undercover detectives purchased the drugs from the suspect. The subject was immediately taken into custody without incident and arrested on multiple felony counts of narcotics trafficking. A search warrant was obtained for the subject's vehicle due to additional quantities of drugs being inside of the vehicle.

### **Real Time Crime Center (RTCC)...**

- In February, the Bridge assisted in 2,992 calls for service. About 82% of those were intervention from the operators in the Bridge. The Crisis Intervention Case Management System, which was developed by the RTCC and now has more than 3,000 cases, was utilized 2,429 times. About 61% of the calls worked were suicide, mental health or domestic disturbance calls. The video network was also utilized a total of 320 times.
- In February, Operator F. Moralez was recognized for his involvement in identifying a male subject that was at the residence of an ex-girlfriend. There was a concern the female was being battered by the male. The caller advised that he was on the phone with the female when the subject arrived and the caller then heard a loud "no" and the phone was disconnected. Several attempts to contact the female were made but there was no response. Operator Moralez located and supplied the ex-boyfriend's information. Because of his hard work, Operator Moralez was presented with the RTCC Top Operator Challenge Coin.

### **Professional Accountability Bureau Communications Division...**

- In February, the APD Emergency Communications Center staff answered 70,718 incoming calls. There were 29,238 calls answered for 911 and 41,480 calls answered for 242-COPS. 911 Operators answered 88.36% of the 911 calls within 10 seconds (national standard is 90%, APD's standard is 92.0%); operators also answered 92.29% of the 242-COPS calls within 30 seconds (APD's goal is

90% answered within 30 seconds).

- Incoming calls have increased as compared to last year for the month of February. 9-1-1 calls increased by 6.81% and 242-COPS increased by 9.17%. The overall increase was 8.18%.
- In February, the training manager and an administrator attended the Albuquerque Metropolitan Planning Area (AMPA) Regional Intelligent Transportation System (ITS) Architecture Stakeholder Workshop.
- In February, the manager attended a demonstration of a mass notification system sponsored by the Office of Emergency Management.

### **APD Academy...**

- In February, 231 interest cards were received (181 cadets, 41 public service aides (PSAs); and nine laterals).
- In February, background folders were assigned for 23 cadets, four PSAs, one lateral, three PTU and four civilians.
- The February 5-7 testing consisted of 41 individuals scheduled to test; 22 attended City entrance; 15 attended Saturday testing; and six were passed to background.
- The February 19-21 testing consisted of 44 individuals scheduled to test; 14 attended City entrance; 15 attended Saturday testing; and 11 were passed to background.
- As of February, nine cadets and three PSAs are seated for 116th class.
- In February, the physical test (PT) program and wellness education for the 115th cadet class continued to progress as 32 cadets achieved a score that placed them in the 71st percentile.
- In February, field training officer (FTO) selections were held and out of 32 applicants, 25 were chosen.

### **Administrative Support Bureau Planning Division...**


- In February, the grants management staff met with the new Department of Transportation Grant Manager.
- In February, the Planning Division staff began working on the department's annual report which will be published in May 2016.
- In February, the Planning Manager continued to oversee the renovation project which will house the Tactical Unit. The estimated completion date is May 2016.
- In February, the Planning Manager began

planning for renovation work at the Foothills, Northwest, Southeast and Northeast Area Commands. The work is estimated to be completed by end of summer 2016.


### **Central Records Division...**

- In February, the Public Information Unit received 1,127 requests totaling \$7,425 in revenue generated from citizen requests/registers.
- In February, the Report Review Unit completed the following: 1,843 Automated Reporting System (ARS) transfers; 364 ARS supplements; 1,144 National Crime Information Center entries; 1,183 accidents; 2,411 officer calls; and 639 Unified Crime Reports (UCR).
- In February, Court Services completed the following: 95 pretrial hearings scheduled; 275 arraignments processed; 347 felony cases submitted to the District Attorney's Office; and 364 summonses submitted to the Metropolitan Court.
- In February, the False Alarm Reduction Unit collected \$96,545 in fees and fines. There were 1,295 false alarms in February which was an increase of 3.9% from the previous year.
- In February, the Telephone Report Unit generated 599 original reports and 165 supplemental reports for a total of 764. This resulted in a savings of 1,987 hours of field services time and a savings of \$30,560.
- In February, the Telephone Report Unit processed 495 on-line (Cop Logic) reports resulting in a savings of 1,287 hours of field services time and a savings of \$19,800.
- In February, the Inspection of Public Records (IPRA) received 153 requests; completed 131 requests; and collected \$2,892 in revenue.

TOP 10 PROPERTY CRIMES FOR FEBRUARY COMPARED WITH JANUARY




TOP 10 PERSON CRIMES FOR FEBRUARY COMPARED WITH JANUARY


