### **MEETING MINUTES**

**Monday 1 February 2016      6:00pm – 7:50pm**

**1. Call to order—Carolyn Wilson, Chair**

The meeting was called to order at 6:02pm.

**2. Introductions of Members and Visitors**

This meeting was attended by many area residents. For most of them, this was their first time to experience a CPC meeting.

**3. Review/approval of agenda**

The agenda was approved unanimously, upon motion by Brosveen, seconded by Layden.

**4. Review/approval of minutes from January 4th meeting**

The minutes were approved unanimously, upon motion by Brosveen and seconded by Trujillo.

**5. APD Communications—**

**a. “Snapshot” of Area activities**

The number of preventable vehicle thefts and residential burglaries continues to be a significant proportion of all such crimes. During the APD presentation, several neighbors reported efforts to encourage neighbors to close garage doors and keep doors and windows locked—often to no avail. The January snapshot includes a lengthy list of items stolen from vehicles, including firearms and ammunition (mostly from unsecured vehicles), keys and garage door openers, and a wide variety of personal identification and personal items.

There was discussion of a robbery which occurred after snowfall, in which there was clear evidence to burglars that the home was unoccupied. They stole vehicles and much of the contents of the residence. (Fortunately, much of the stolen property was recovered by APD.) The recommendation is to have people look after a house if residents plan to be gone for long periods.

Thanks to alert officers and citizens, APD was able to break a theft ring responsible for many of the auto thefts in the area. Lt Jordan emphasized that, since APD has limited resources, citizens can really help reduce preventable crimes. He also encouraged citizens to communicate right away when they see something unusual; officers will respond when called.

**6. Recommendations**

**a. Mental Health Resolution Draft 9.8**

For the benefit of citizen newcomers, Council VP Brosveen described the work of the CPC in crafting and forwarding recommendations to the Chief. This resolution supports APD involvement in future planning for combined mental health program oversight. A few more suggestions came

forward; a final version will be available for a Council vote at the March 7<sup>th</sup> meeting. Lt Jordan noted that although the participation of mental health professionals in working with APD is mandated in the DOJH settlement, it is helpful for the CPC to make such a recommendation, to indicate community support.

**7. Pulse of the Neighborhoods—reports from CPC members**

Representatives of Stand True 4 Blue described their organization, which seeks to foster vocal and visible public support for APD. They encourage volunteers to assist at each APD substation. In addition, their organization will be sponsoring a fundraiser for the family of Officer Grant. Their website is <http://www.standtrue4blue.com/>

In discussion of volunteers to aid APD, it was noted that persons wishing to volunteer should contact Marci Hackett at Valley Area Command (761-8800). Foothills Area Command is currently vetting and using volunteers who have special skills.


