## 7. Featured Speaker—TBD (Street Safe New Mexico did a volunteer presentation)

#### Kathleen Burke, Street Safe NM:

Street Safe NM started up about 8 years ago for women who have experienced...... this is a volunteer run program. The bulk of our work is done in the International District. We deliver support of items to woman who are living in the International District. We have made our recommendations to Mayor Keller and Chief Geier and she would be happy to share them with the CPC board. We help women who have been a part of Prostitution, who were raped and we advocate for victims in these crimes. 90% of the women walking the streets in the International District have been exposed to human trafficking. Any time there is force, fraud or coercion involved when selling sex means that is sex tracking. Anytime a human under the age of 18 is selling sex it is automatically considered sex trafficking. We are fortunate to be partnered with APD, The Attorney General office, the FBI, etc.

• Q'S: How can we make a recommendation to the Chief of police for this sort of thing?

- Kathleen stated to contact your City Councilor. She stated there are 140 of Asian massage parlors that are in existence known as a sex trafficking location. These are organized crimes out of China.
- Q's: Do you have an access to the hotels along central that are being used for prostitution?
- Recommend to the Chief on getting more officers in the Vice Unit. When you are talking about trafficked individuals these people are not doing this voluntarily, they are drugged to do what they have to do, and it is hard for them to get out because they are under threat. We have rehabilitation programs for women who are rescued from human trafficking.
- o Suggested a list of questions for the Chief and give to Chris Sylvan to expose to the Chief. We want to know about the men who have taken advantage of this little girl.
