

FIELD SERVICES BUREAU-EAST Southeast Area Command...

- In July, the Southeast Area Command had 15,140 calls for service, wrote 2,261 reports and issued 539 citations. There were 237 felony arrests/warrants, 268 misdemeanor arrests/warrants and 33 driving while intoxicated (DWI) arrests. Eight community meetings were attended.
- In July, Officer C. Chavez located a stolen vehicle. After observing the driver walk into a convenience store, officers established a perimeter and took the female driver into custody without incident.
- On July 6, Officer Herbst was on patrol when he observed a suspicious parked truck with an occupant inside. Officer Herbst ran the plate and the vehicle came back stolen. When Officer Herbst attempted to make contact, the driver jumped out of the vehicle and fled the scene. Officers saturated the area and the offender was located. He was found to have an outstanding felony warrant for his arrest.
- On July 7, officers were dispatched to a domestic dispute where gunshots were reported. Upon arrival, officers made contact with the victim who stated her ex-boyfriend arrived unannounced and brandished a firearm pointing it at her head. He then proceeded to force his way into the house where he fired several rounds at a teen. The teen ran to a room where he armed himself with a shotgun and exchanged fire causing the offender to flee the scene. Southeast Impact detectives were called to assist and the offender later turned himself in.
- on July 17, officers were dispatched to a call in response to two subjects who were seen breaking a window to a residence and attempting to gain entry. Officer arrived on scene and saturated the area. They located the two subjects who were later identified by the witness. Both subjects were arrested and later booked into the Metropolitan Detention Center (MDC).
- on July 21, Officer Herbst was on patrol when he ran a license plate which came back as stolen. Officer Herbst conducted a traffic stop and made contact with the driver and passenger. The passenger was found to have an outstanding warrant for his arrest. While conducting an inventory search of the vehicle, Officer Herbst located a firearm under the passenger seat. The passenger admitted to the firearm being his. He was also found to be a felon.
- On July 4, Southeast units were dispatched to a

- stolen city owned bait vehicle. The vehicle was tracked and monitored by an electronic tracking system. The stolen vehicle was located by officers and had one occupant. The vehicle was disabled remotely as it stopped at a red light. The auto theft offender fled from the vehicle on foot and was apprehended without incident a short distance from the vehicle. The offender was arrested and booked for unlawful taking of a motor vehicle and possession of burglary tools. On July 11, Officers McBrayer and Nogales were dispatched to an auto burglary. The witness advised that two subjects, one female and one male, entered a vehicle using some type of pipe or metal bar and removed belongings from the vehicle. The witness gave descriptions of the two offenders and their direction of travel. Officers McBrayer and Nogales located the two offenders in a nearby apartment complex courtyard. The subjects were detained pending police investigation. Officer McBrayer located the owner of the vehicle who provided a statement that he did not give anyone permission to enter his vehicle and remove his belongings. The suspects were booked on burglary and conspiracy charges.
- On July 22, Officers T. Ivie and J. DeHerrera were dispatched to a motor vehicle crash with injuries involving a motorcycle and an automobile. Upon investigation, the rider of the motorcycle requested that officers take his belongings to him from the saddle bag of his motorcycle. Officer DeHerrera inventoried the bag and located a firearm in the saddle bag. The firearm was confiscated and tagged as safekeeping. Officer Ivie arrived at the hospital and contacted hospital personnel who turned over packaging and a film canister which contained illegal narcotics. Officer Ivie recognized the white powdery substance to be cocaine. A field test of the white powdery substance revealed a presumptive positive for cocaine. Officer Ivie completed a criminal case and submitted it to the District Attorney's Office for prosecution.
- On July 29, an anonymous caller with Fugitive Recovery called police to report that he had observed a stolen vehicle occupied by two males. Officers J. Montoya and Z. Herbst located the stolen vehicle. The officers requested K-9 Officer J. Richards and a high risk stop was conducted. The driver and passengers of the vehicle were detained. The driver was charged with one count of receiving/transferring

a stolen motor vehicle and possession of burglary tools. The suspect's arrest history included previous arrests for receiving/ transferring stolen motor vehicles, felon in possession of a firearm, narcotics charges which included distribution, and probation violation warrants.

• On July 6-7, Detectives D. Garcia, V. Barela, P. Moya, and T. Hotle participated in a federal warrant round up with the Bureau of Alcohol, Tobacco, Firearms and Explosives. The dectives were all deputized under the flag of the U.S. Marshals to assist with the above operation. At the conclusion of the operation, 40 subjects were arrested and large amounts of narcotics and firearms were seized.

Northeast Area Command...

- In July, the Northeast Area Command had 11,196 calls for service, wrote 1,988 reports and issued 660 citations. There were 146 felony arrests, 234 misdemeanor arrests, 30 driving while intoxicated (DWI) arrests and 157 felony and misdemeanor warrants issued. Eight community meetings were attended.
- On July 1, Officer S. Cerasia was dispatched to an auto theft in response to a caller who located his stolen truck. The caller stated he witnessed two males placing items inside the vehicle.
 Officer S. Cerasia confirmed the vehicle was stolen and called for back-up. The officers took the suspects into custody and returned the stolen vehicle to its owner.
- In July, Officer J. Lopez-Shook took three juvenile calls where she found that the children were not safe. She got the Children, Youth and Families Department (CYFD) involved and put a 48 hour hold on the children to ensure that CYFD had time to place the children in safe homes
- In July, officer concentrated on city parks due to numerous quality of life complaints. Officers increased their patrol due to aggressive panhandlers. Three citations were issued along with 20 citizen contacts with verbal warnings. They also made contact with three homeless individuals that declined help and located one empty tent. Officers contacted the city to clean up the tent. In one of the parks, officers issued five citations for parking and speeding in the area.
- On July 4, Officers A. Henry and C. Garcia were dispatched to a male subject under the influence of an intoxicating narcotic and acting

irrational. The male subject was breaking windows of several businesses in the area with a rock. Upon initial contact with the subject, he took off running. Officers caught the offender and took him into custody without incident. Due to his irrational behavior and being under the influence, he was transported to the hospital for further evaluation. Once released from the hospital, he was transported to the Northeast substation where he became verbally and physically aggressive and uncooperative with officers. The subject was booked on several charges.

- In July, Detective L. Neil was assigned follow-up investigation into a domestic violence incident where the offender held the victim against her will on two separate occasions. The offender repeatedly sexually assaulted and caused physical harm to the victim while being armed with a handgun. Detective L. Neil got an arrest warrant for the offender and with the help of Bernalillo County Sheriff's Office (BCSO) deputies, took him into custody. He was charged with false imprisonment, kidnapping, criminal sexual contact and aggravated assault on a household member with intent to commit a violent felony.
- In July, Detective J. Carter worked several related cases in reference to high end makeup theft at a local pharmacy. Detective Carter identified and charged the suspects with shoplifting \$500-\$2,500 and conspiracy on multiple counts. Detective J. Carter was able to recover some of the stolen merchandise from conducting a search warrant on the offenders' vehicle. In addition, officers located heroin during the search and the offenders were charged with possession of a controlled substance.
- In July, Community Resource Officer M.
 Benavidez, T. Percival from the Crisis Outreach
 and Support Team (COAST) and representatives
 from St. Martin's conducted outreach in areas
 experiencing chronic issues with homelessness,
 needles, trash and camping in a public park.
 Many subjects were contacted and some took
 advantage of the services offered.
- In July, a Northeast Auto Burglary tactical plan was revamped based on the most upto-date statistics. The program evolved from a surveillance operation to community outreach. Detectives were in contact with property managers, hotel/motel managers, and neighborhood organizations. The Northeast Impact team and Auto Theft detectives worked

together to address the growing issues of auto theft in the area. Several burglary and auto theft bait cars were deployed. In addition, two uniformed officers were recruited to assist with direct patrol in hot spot areas during the graveyard shift. During the 24-hour tactical plan, only two auto burglaries took place in the area command.

- On July 5, Officer D. Sprague was dispatched to a domestic dispute. Officer D. Sprague made contact with the alleged victim who was badly injured during the dispute with her husband. The injuries rose to the level of a felony charge. Officer D. Sprague was concerned the situation would escalate so he wrote an arrest warrant rather than sending the case to the Impact Unit. The victim was assisted with medical treatment and shelter. Several days later, the alleged offender was taken into custody.
- On July 1, Officers J. O'Guin and S. Lopez were dispatched to a shopping center in response to a male trying to either burglarize or steal a vehicle. Officers located the male and he attempted to flee on foot. O but officers apprehended him after a short foot pursuit. Once apprehended the male was found to be in possession of a handgun. He was arrested on multiple felony charges for property crime.

Foothills Area Command...

- In July, the Foothills Area Command had 7,268 calls for service, wrote 1,314 reports and issued 583 citations. There were 104 felony arrests, 156 misdemeanor arrests and 12 driving while intoxicated (DWI) arrests. Fifteen community meetings were attended.
- On July 23, Officer T. Schmelzer was dispatched to an aggravated assault with a deadly weapon. Officers Mayfield and Schmelzer made contact with the victim who advised that he had found a subject lying on the sidewalk in front of a business sleeping. The victim woke up the subject and was threatened with a knife. The offender was arrested for aggravated assault with a deadly weapon and a misdemeanor warrant.
- On July 26, Officers D. Byrd and L. Jaramillo were dispatched to a domestic violence call. Upon arrival, officers made contact with the caller/victim. The victim stated that her and her boyfriend got into an argument over messages with other people on their cellphones. The victim indicated that her boyfriend became physically aggressive with her. He punched her, grabbed her around her neck and pushed her

while she was carrying her one-year-old son, causing her son to hit his head on the wall. At one point, the offender pulled out two knives and gave one to the victim and stated, "we can do this." The victim dropped the knife and the boyfriend held his knife to her throat. The victim was able to distract the offender by asking him to get her son's bottle from the car because he was crying. When the boyfriend left, the victim ran to her neighbor's apartment and called the police. The offender was arrested on felony domestic violence charges.

- On July 31, Officer Mayfield was dispatched to a store in response to a shoplifting. Upon arrival, the suspect gave officers a false name and date of birth. Officers were able to find his real identity by taking him to the APD Identification Section. The male was identified and it was discovered that he had six felony warrants and one misdemeanor warrant. He was arrested on the warrants and given citations for concealing identity and shoplifting.
- On July 15, Officer Trujillo was dispatched to a welfare check. The caller lived out of town and was concerned that he had not heard from his friend who was very sick. Sergeant Dosal and Officer Trujillo knocked on the door with no response from inside the residence. Officers made telephone calls to the residence and spoke with three different neighbors who advised they had not seen the occupant in a few days. One neighbor advised they had keys for the residence and officers gained entry. The occupant was found inside the apartment badly injured from a fall and unable to stand up on his own. He was transported to Presbyterian Hospital for his injuries. The occupant was found to have broken ribs, a severe head wound, leg injuries and other medical issues.
- On July 8, T. Percival, Officer Urioste and the Crisis Outreach and Support Team (COAST) made contact with four subjects who had been generating high calls for service. They offered services and scheduled a follow up visit for an individual.
- On July 8, Officer B. Garcia responded to a welfare check on an elderly female who had a restraining order on her 29-year-old son. The elderly female stated her son was hiding in the back of her home and she was afraid of him. The son fled from Officers Garcia and Bludworth when confronted. The subject was apprehended at a nearby park and was arrested for a felony warrant.

- In July, Officers Tartaglia and Bludworth were dispatched to a suspicious person call at a local hotel. As Officer Tartaglia was working on the suspicious person call, Officer Bludworth located a vehicle nearby that matched the description of a vehicle from a commercial burglary the day before. It was determined the vehicle was also related to the suspicious person call Officer Tartaglia was investigating. The male and female subjects were identified and the stolen property was recovered.
- On July 10, Officer Vanderlip responded to a domestic violence call. The caller stated his stepfather battered him in the face and threw him against a wall. Officer Vanderlip conducted the investigation which led to the arrest of the stepfather for felony child abuse.
- On July 11, Detective Clipp was notified of a shooting incident. The offender had fired approximately 40-50 rounds during the incident. During the investigation, impacts were found and detectives conducted a canvas of the neighborhood identifying two homes that had been struck by three rounds. An arrest warrant was obtained for the offender. Detective Clipp noticed the offender's vehicle was at his residence and that it had not been there earlier in the day. The Investigative Support Unit was contacted to assist in attempting to apprehend the subject. The subject was apprehended and evidence was recovered from the residence to assist in prosecution.

FIELD SERVICES BUREAU-WEST Valley Area Command...

- In July, the Valley Area Command had 8,786 calls for service, wrote 1,531 reports and issued 479 citations. There were 104 felony arrests, 147 misdemeanor arrests and 35 driving while intoxicated (DWI) arrests. Thirteen community meetings were attended.
- on July 5, Sergeant T. Apodaca observed a vehicle without its headlights on and extensive front end damage to the vehicle. Sergeant Apodaca initiated a traffic stop on the vehicle and discovered, through the driver's own admission, that he had struck a vehicle in the neighborhood. He had left the area because he was meeting up with friends. Other officers arrived on scene and located the secondary unoccupied vehicle which had extensive damage due to the collision. Driving While Intoxicated (DWI) Officer J. Brown arrived on scene and conducted a field sobriety test on the driver. He

- was found to be intoxicated and was booked for DWI and leaving the scene of an accident.
- On July 06, Officer D. Heshley assisted Auto Theft Detective D. Taylor on a traffic stop for an erratic driver. Detective Taylor witnessed the vehicle fail to stop for several red lights narrowly causing several crashes. She initiated a traffic stop and made contact with the female driver who was found to be extremely intoxicated. Due to signs of intoxication, a driving while intoxicated (DWI) officer was called to the scene. Officer M. Chavez took over the investigation. During his investigation, Officer Chavez had his face spit on by the female. She was arrested and taken to the Prisoner Transport Center where she kicked another officer. She was arrested for two felony counts of battery upon a peace officer and driving while intoxicated.
- on July 13, Sergeant Wheeler was dispatched to a male subject possibly trying to break into a building. Sergeant Wheeler arrived and located a male subject exiting a vehicle that was stuck on a large boulder. The male subject was interviewed and it was determined the male broke the ignition, started the vehicle and stole it. As he backed out from where the vehicle was originally parked, he ran over the boulder and could not move. Auto Theft detectives took over the investigation and found the male had just been released from the Metropolitan Detention Center (MDC) after being booked for auto theft.
- On July 17, Team 8 officers assigned to the downtown entertainment district were briefed that a male subject wanted for aggravated stalking was recently seen walking around downtown. They obtained a photograph of the male and began looking for him. The male was located and taken into custody. The Family Abuse Stalking/Training Team (FASST) had been searching for the male but had been unable to locate him.
- On July 19, Officer D. Shrouf responded to a call of a man being chased by several subjects who were shooting at him. Upon arrival, Officer Shrouf made contact with a male. He stated he was the person being chased by the other men with weapons. He stated that he broke a window to a building and a vehicle in an attempt to get away from the other men. Officer Shrouf located the video of the incident and confirmed that no one was chasing the man but he had smashed the windows to the building and a vehicle in the parking garage. Officer Shrouf placed him under

- arrest and also found he had a misdemeanor warrant for his arrest.
- On July 21, Officer Gumble was dispatched a store in response to an in-progress auto burglary monitored by security cameras. The store's loss prevention officers monitored the two suspects until they left in a vehicle. A high-risk felony stop was attempted but the suspects fled. Air Support was contacted and followed the suspects as they drove around the city and the officers did not pursue. Eventually, the suspects crashed head-on into a vehicle and then attempted to flee from the crash on foot. The driver was apprehended shortly thereafter.
- On July 22, Officer V. Santillanes responded to the Southeast Area Command to provide traffic control on a suicide call. Upon arrival, she was informed the suicidal subject had threatened suicide before and would only respond to female officers. After CIT detectives and another female officer failed to persuade the subject to move from the overpass, Officer Santillanes' assistance was requested. Utilizing her CIT training, Officer Santillanes convinced the subject to move to a safe location and be transported for a psychiatric evaluation.
- On July 17, an unidentified subject broke into a bait vehicle. The bait property was not taken, but video of the subject was obtained. Detectives identified the subject and found that he was tied to numerous burglaries in the area. Detectives obtained a warrant for his arrest.
- On July 9, Officers Jochum and Beem responded to an alarm call. Upon arrival, they noticed a broken window. They established a perimeter and called for a K-9 team. When a K-9 warning was announced, a suspect exited the business. He was taken into custody and booked for burglary.

Southwest Area Command...

- In July, the Southwest Area Command had 6,594 calls for service, wrote 1,030 reports and issued 587 citations. There were 65 felony arrests, 96 misdemeanor arrests, and 27 driving while intoxicated (DWI) arrests. Three community meetings were attended.
- On July 16, Officer J. Foulk was dispatched to a male subject passed out in a vehicle. The male was found to have a gun on his lap. Officer Foulk secured the weapon and determined the male was a convicted felon. The subject was arrested for being a felon in possession of a firearm.

- On July 17, Officers J. Luchetti and J.
 Deatherage responded to an assault and battery call involving a subject armed with a knife.
 Officer Luchetti was able to build rapport with the suspect and convinced him to surrender peacefully. The suspect was arrested on felony charges.
- On July 14, Officer T. Cravens was dispatched to a bank robbery where the offender implied they had a weapon. The offender and his accomplices were apprehended a short time later. The Federal Bureau of Investigation (FBI) took over the investigation and discovered they had been looking for the same subjects. Three misdemeanor warrants were cleared with the arrest.
- In July, Officer T. Cravens conducted a tactical plan in response to individuals drinking in public. He patrolled the area and enforced any violations. As a result Officer Cravens issued three citations for drinking in public and issued five criminal trespass orders.
- On July 23, Officer C. Bailey was investigating a domestic violence call when she observed a suspicious vehicle make a U-turn to avoid passing officers. Officer Bailey thought the vehicle may be involved in the domestic violence call she was investigating, so officers followed the vehicle. When officers caught the vehicle, it was discovered that it was reported stolen. The two occupants were detained and the driver was arrested.
- On July 24, Officers E. Place and V. Martinez were on patrol when they observed a male whom they knew had a felony warrant. After approaching the subject, officers confirmed the male had two felony warrants. He was booked into the Metropolitan Detention Center.
 - On July 22, Officers B. Sanchez, C. Luthi and J. Brionez were dispatched to a suspicious person call where the subjects had parked in front of a home and attempted to gain entry. When officers arrived, they located the described vehicle broken down in the area along with several subjects seated inside it. The investigation showed that the vehicle was stolen and a male and female were arrested for transferring and receiving a stolen motor vehicle in addition to felony warrants.
- In July, Officer R. Graves conducted random checks of known areas for stolen vehicles.
 Officer Graves located and recovered eight stolen vehicles and cleared one felony warrant.
- On July 26, Officer R. Graves was dispatched to

a rape call. Upon arrival, Officer Graves made contact with the elderly victim who stated she knew the offender. Officer Graves provided the necessary treatment to the victim and also identified a safe place for her to stay. The offender was located and the case turned over to detectives.

- On July 21, Team 7 responded to a residential burglar. Officer Martinez ended up in a foot pursuit with the offender. With the assistance of Officer S. Torres, Officer Martinez took the offender into custody. The entire team assisted in getting statements and helping with the investigation. The Burglary Unit arrived on scene and took case responsibility.
- On July 26, Sergeant L. Armijo located a stolen vehicle at a residence. Two offenders were taken into custody and one stolen vehicle was recovered.

Northwest Area Command...

- In July, the Northwest Area Command had 3,352 calls for service, wrote 596 reports and issued 415 citations. There were 55 felony arrests, 76 misdemeanor arrests, nine driving while intoxicated (DWI) arrests and 76 felony and misdemeanor warrants issued. Three community meetings were attended.
- On July 8, Officers Apodaca and Enyart were dispatched on a domestic call. Through their investigation it was discovered a minor had been a victim of criminal sexual penetration by their older sibling. The offender was arrested and booked into the Juvenile Detention Center. The Children, Youth and Families Department (CYFD) was apprised and assisted with the investigation.
- On July 8, Officer Landavazo located and recovered a stolen vehicle in the parking lot of a golf course. This area had been the location of several burglaries. Officer Landavazo contacted the Real Time Crime Center (RTCC) and facilitated a video trailer to be placed in the area.
- In July, Officer Aragon conducted a park saturation tactical plan in response to persons occupying the park after hours, drinking alcohol and creating disturbances The purpose of the tactical plan was to provide high visibility and enforce park ordinances and laws. Officer Aragon made four contacts and issued four citations.
- In July, Officer Harp responded to an assault that occurred in the Bosque. Officer Harp and other officers located the offender who had battered

- two women. The male offender threatened to shoot police officers but was taken into custody without incident.
- On July 1, Officers Mares and Holmes were dispatched to a fight in progress. The males involved in the fight were not on scene but officers were able to obtain vehicle information. Upon further investigation it was discovered that the incident was an auto burglary in progress and the males involved in the fight were the victims attempting to apprehend the male offender. A short time later, officers located a male subject matching the description of the possible offender. The male was taken into custody without incident and was found to have an extensive criminal history. The victims were also contacted and positively identified the offender. On July 28, Officer Mares was conducting an investigation on a stolen truck when he observed
- investigation on a stolen truck when he observed a suspicious male walking in the area. He recognized the male who was inside another stolen car that fled from officers the day prior. Officer Mares contacted the male who admitted to being inside the stolen car. He also admitted to having methamphetamine on him. The male was arrested without incident and provided officers with the names of offenders in other crimes in the Northwest Area Command.
- On July 23, Officer Hoisington was dispatched to a possible stolen vehicle and runaway call. The caller's daughter was not home and his vehicle was also missing. The caller stated that his daughter had never run away from home and did not have a driver's license. Officer Hoisington listed the daughter as a runaway and the vehicle as stolen with National Crime Information Center (NCIC). Officer Hoisington later received information that the daughter may be at a local high school. An officer was dispatched and located the daughter and the
- vehicle. The daughter was arrested for auto theft.

 On July 26, Open Space Officer Harvey was flagged down in response to a female that was being battered. The offender matched the description of a suspect of a felony battery that had occurred in the same area. Officer Harvey contacted the subject and he told Officer Harvey he had a .357 and was going to shoot him. The subject walked towards the rear of his vehicle and began getting inside. Officer Harvey immediately closed the distance and stopped the subject from possibly grabbing a weapon from inside the vehicle. A short struggle ensued and Officer Barnhill arrived to assist Officer Harvey.

- Both officers were able to detain the subject and he was arrested for felony battery.
- In July, Officer A. Hoisington conducted a speeding tactical plan. Officer Hoisington issued 11 moving citations.
- On July 19, Northwest Impact detectives investigated a stabbing. During the investigation it was learned the offender pointed an assault weapon towards two APD officers who were responding to a different call on a different day. Northwest Impact detectives attempted to get an arrest for the assault. However, the District Attorney refused the warrant. Detectives then focused on the stabbing case and were able to secure an arrest and search warrant for the offender. The offender was charged with several felony charges including attempted murder. SWAT assisted in the arrest and the subject was booked into the Metropolitan Detention Center (MDC). An officer safety bulletin was put out city-wide and the computer aided dispatch (CAD) system was flagged for future calls associated with this address.
- on July 1, Officer S. Arias was completing a down and out call when he was flagged down by the victim of an auto theft who had just located his vehicle. He told Officer Arias that the offenders had just gone into a nearby business. Officer Arias made contact with the subjects and located a second stolen vehicle at the same location. Two male subjects were taken into custody. The investigation resulted in the recovery of two stolen vehicles, two felony arrests and a recovered high powered rifle.
- On July 12, Officer S. Arias responded to a call where the victim reported that a male subject had pointed a gun at him. Through his investigation, Officer Arias discovered the offender left a gun barrel mark on the victim's shirt. The offender was arrested for aggravated assault with a deadly weapon.

SPECIAL SERVICES BUREAU APD Academy...

- In July, the Recruiting and Selection Unit received the following: 369 interest cards including 293 cadets, 61 public service aides (PSAs), 11 laterals and four military certification by waiver.
- The July 8 10 testing consisted of 80 individuals scheduled to test; 21 attended city entrance; 12 attended Saturday testing and nine were passed to background.
- The July 22-24 testing consisted of 96

- individuals scheduled to test, 17 attended city entrance, ten attended Saturday testing and seven were passed to background.
- In July, nine cadets were seated for the 117th Cadet class.
- On July 30, the 115th Cadet Class graduated and started on-the-job training.

Special Operations Division... Tactical

- In July, the K-9 Unit responded to 251 calls for service and were called out 86 times. The K-9 Unit conducted 53 building searches and six area searches. The K-9 Unit responded to four SWAT activations and conducted two K-9 demonstrations for the public.
- On July 9, K-9 officers responded to an alarm call at a local business. Upon arrival, K-9 officers made announcements for anyone inside the business to exit. A male subject exited and was taken into custody without incident.
- On July 10, K-9 officers responded to the area where a subject had fled from an electronic system activation. The activation was a department-owned vehicle. The subject was tracked to an apartment. Upon making contact, the subject armed himself with a knife and threatened to hurt himself or others. K-9 officers set up containment and react teams and convinced the subject to exit the residence without incident.
- On July 16, K-9 officers assisted the Auto Theft Unit and Investigative Support Unit in taking a career criminal into custody. The subject was located in a stolen vehicle and officers spike belted the vehicle causing it to become inoperable. The subject fled on foot and was apprehended by a police service dog. The subject was wanted for ramming multiple police vehicles throughout the day and multiple counts of auto theft.
- On July 29, K-9 officers conducted a K-9 demonstration for the Wesley Kids Daycare and the 1st Presbyterian Church. The demonstration provided officers a great opportunity for community outreach.
- On July 29, K-9 officers assisted Southeast Area Command officers in apprehending two auto theft suspects in a stolen vehicle. K-9 offices responded to the area and took the subjects into custody without incident. The subject stated they did not run due to the presence of the police service dogs.
- In July, SWAT conducted six tactical activations.

- On July 7, SWAT was called to assist the New Mexico State Police SWAT in response to a subject barricaded inside a residence and wanted for violent felony warrants. APD SWAT assisted with surrounding the residence and holding containment as well as attempting to have the subject surrender via public address announcements. This continued until the Federal Bureau of Investigation tactical units took over the scene.
- officers in response to a male subject inside a local grocery store threatening to stab a customer. As officers attempted to take him into custody, the subject threatened the officers and told them he would do something to make them shoot him. The subject sat on a sidewalk in front of the business and refused to comply with orders to surrender. When SWAT officers arrived, the subject appeared to be affected by their appearance and agreed to surrender. He was taken into custody without further incident.
- On July 19, SWAT was called to assist the Investigative Support Unit with a male subject wanted for attempted murder. The subject was known to have a violent criminal history and had made numerous threats to shoot at law enforcement officers with high-powered rifles and a shotgun. SWAT surrounded the subject's residence and gave orders for him to surrender to police. After approximately 20 minutes, the subject exited his residence and surrendered. He was taken into custody without incident.
- On July 26, field officers responded to a domestic violence call where a female stated her boyfriend battered her and threatened her with a knife. Officers attempted to take the male subject into custody, however he refused to exit the apartment and surrender to police. The subject was believed to be armed with a handgun. SWAT arrived and gave public announcements for the subject to exit the apartment. When the subject refused to exit, a noise flash distraction device was deployed outside of the apartment to gain the attention of the subject and compel him to surrender. A few minutes later, the subject exited the apartment and was taken into custody without incident. SWAT cleared the apartment for detectives to conduct a search warrant.

Office of Emergency Management... (OEM)...

• In July, the OEM Director attended the Balloon Festival public safety meetings.

- On July 22, OEM convened a gathering for 175 faith leaders to provide disaster awareness and present the partnership with the opportunity to work with OEM.
- In July, the Community Emergency Response Team (CERT) had 20 volunteers donating 224 hours of service for the Bosque Fire Patrols project, the 4th of July Fireworks Hotline and the Faith Based Emergency Preparedness Workshop.

Open Space...

- On July 2, Open Space Search and Rescue (OS SAR) was called to assist with a search for a female with mental health issues who was missing. The woman's parents told field officers the woman was between group homes and did not like living in them. The female told her parents she was going camping in the mountains. The mother got a text from her daughter saying she was going to relocate from the Sandia Mountains, where it is illegal to camp, to the Manzano Mountains. Her mother logged into the cell phone bill a couple of days later and noticed that on the night her daughter relocated camps, she had called 911. OS SAR requested a forensic history on the phone but the company could not pull any helpful details on the 911 call and the phone had since died. OS SAR searched for the missing person but had to suspend the search because they didn't have any additional information to pursue and could not locate the woman's vehicle. Missing Persons was advised so that they could follow up with the family.
- On July 9, Open Space officers discovered a stolen truck in the Rio Grande River. The recovery was a technical, two-day operation involving multiple agencies. Heavy equipment was brought in and a path to the river was made. The truck was hauled up the steep bank of the river and transported to an awaiting flatbed tow truck. Environmental monitoring groups were notified of the fuel and oil contaminants that were leaked into the river.
- on July 13, Open Space officers were requested in response to a lost hiker. The hiker stated he was cold, out of water, and did not have a light to guide himself off the mountain. APD's Real Time Crime Center did a history on the subject and found he uses methamphetamine, is often armed and fights with officers. The subject would not respond to phone calls and would only text Sergeant Bassett. The texts were confusing and he stated he could hear people

talking about money. He also said he had taken drugs. Officers located a small, faint light that appeared to be coming from his phone. Due to his agitated, drug-induced state, only the law enforcement SAR team were sent to retrieve him. After hiking for two hours, officers reached the subject. He was given water, food and a quick medical assessment. Officers hiked him back down the mountain and he was transported to the hospital.

On July 23, OS SAR assistance was requested by the Bernalillo County Fire Department (BCFD) in response to a nine-year-old female who had gotten separated from her family during a hike in the East Mountains. The female had asked permission from her parents to walk a short distance from their resting spot to a lookout on the edge of a cliff. The girl did not return and was not at the spot when her parents went looking for her. OS SAR, BCFD, United States Forest Services (USFS) and the Albuquerque Mountain Rescue Council (AMRC) scoured the area. After three hours of searching, the girl was safely located by a BCFD search team. The girl had gotten turned around and ended up walking the wrong direction.

Horse Mounted Unit (HMU)...

- On July 4, HMU participated in the Fiesta 4th Celebration at Balloon Fiesta Park.
- On July 7, HMU gave a tour of the stables to a Senior Center.
- On July 14, HMU participated in a multi-agency emergency response training at the State Fair Grounds with the Bernalillo County Sheriff's Office (BCSO), New Mexico State Police and Rio Rancho Police. The unit participated in two scenario-based exercises.
- On July 17, HMU participated in the 2016
 Matchbox gathering. This was a national event that attracted citizens from across the United States.
- On July 23, HMU participated for a stone placement ceremony at the Veterans Memorial Park in Rio Rancho for Officer Daniel Webster.
- On July 24, HMU was requested by the Guardians of the Children for a stable tour with a 13-year-old girl that had been sexually assaulted. As part of her therapy and reward for good grades, she was brought to interact with the officers and horses.

Homeland Security...

• In July, Homeland Security officers coordinated

with the City of Albuquerque's Cultural Services Department on the Freedom 4th Event attended by approximately 50,000 people. APD utilized uniformed law enforcement presence, video surveillance, and radiological/nuclear detection equipment to deter criminal activity and provide safety throughout the event.

- In July, Detective Brokaw attended an instructor course "Civilian Response to Active Shooter Events" (CRASE) sponsored by Texas State University.
- In July, Homeland Security officers attended an initial working group meeting for the Army National Guard Vigilant Guard operation scheduled for August 2017.

Metro Traffic Division...

- In July, the Traffic Division responded to 459 calls for service.
- In July, the division issued 784 moving citations.
- In July, the division wrote 263 reports, had 84 driving while intoxicated (DWI) arrests, ten felony arrests, 19 misdemeanor arrests/warrants and issued one felony warrant.
- In July, the division investigated 194 crashes and investigated seven hit and run cases.
- In July, the DWI Seizure Unit checked in 55 vehicles, returned 17 vehicles, booted 12 vehicles and removed 16 boots.
- In July, 361 vehicles were on the seizure lot.
- No vehicles were auctioned in July.

Prisoner Transport Unit (PTU)...

- In July, PTU processed 1,114 prisoners through the Prisoner Transport Center. The Albuquerque Police Department arrested 858 prisoners and other outside law enforcement agencies arrested 256 prisoners.
- In July, PTU made 196 trips to the Metropolitan Detention Center and accepted eight walk-in prisoners at the Metropolitan Detention Center.
- In July, PTU worked one hospital guard duty assignment for a total of 31 days.
- In July, the Public Inebriation Intervention Program (PIIP) worked 20 days in the Valley Area Command generating 102 computer-aided dispatch (CAD) calls. PIIP also worked 20 days in the Southeast Area Command generating 132 CAD calls.

Metro Court Protection Detail (MCPD)...

• In July, 56 individuals were remanded by the court and booked and three were remanded but

- bonded out on site.
- In July, 41 individuals were booked with arrest warrants. An additional 55 were booked with arrest warrants but bonded out on site.
- In July, 98 misdemeanors and 17 felony warrants were cleared.
- In July, 155 individuals were in police custody.
- In July, MCPD had a total of 855 calls for service and self-initiated activities.

INVESTIGATIVE BUREAU Scientific Evidence Division...

- In July, the Major Crime Scene team responded to seven call-outs.
- In July, the Evidence, Identification and Disposition Unit supported the following backgrounds: 71 case dispositions, 51 employment, 34 firearms, 153 FBI and 15 CODIS requests. 72 RAP's and photos were distributed, 13 new APD applicants were finger printed, 1,240 fingerprints were classified in AFIS and 1,643 new and old arrests were processed into APD's criminal history records.
- In July, the Evidence, Identification and Disposition Unit received 10,346 evidence items, duplicated 6,573 audio/video recordings and supported 23 pretrial viewings. Efforts to reduce the inflated inventory resulted in 398 items returned to owners, 5,350 items disposed of and \$2,779.26 received from auction proceeds. The Evidence Disposition Team coded 8,859 case disposition transactions into evidence history.
- The New Mexico DNA Identification System (NMDIS) received 523 new convicted offender/arrestee DNA samples for July with a cumulative total of nearly 112,700 collected. 480 samples were analyzed, uploaded and searched in CODIS with a cumulative total of over 106,000 searchable DNA profiles. As a result of these convicted offender/arrestee samples, 30 unsolved cases were matched to convicted offenders/arrestees and three case-to-case matches were made, with a resulting total of 34 investigations being aided.
- In July, the Controlled Substance Unit completed 50 drug cases (39 were APD and 11 were Bernalillo County Sheriff's Office).
- In July, the Biology Unit completed 22 APD cases.
- In July, the Latent Fingerprint Unit completed seven APD cases.
- In July, the New Mexico DNA Identification System completed 523 new offender samples;

- the APD Crime Laboratory completed six forensic samples; and the Department of Public Safety Laboratory completed 62 forensic samples.
- In July, Major Crime Scene Investigations had seven primary call-outs; four secondary call-outs; completed four cases; and had seven pending cases.
- In July, the Photography Unit completed 6,698 case prints; received 616 CDs; had 398 cases requested and produced 379 CD copies.
- In July, the Evidence Unit received 9,374 APD and 972 BCSO items.

Property Crimes Division...

Auto/NITe Unit ...

- In July, the Auto Theft Unit had 36 cases assigned to them; cleared 28 cases; completed 16 self-initiated felony arrests; completed 20 in-custody felony arrests; and completed two search/arrest warrants.
- In July, the Auto Theft Unit conducted 58 free vehicle identification numbers (VIN) inspections.
- In July, the Auto Theft Garage provided 49 free Level III vehicle identification inspections (VIN) to those individuals referred by the New Mexico State Motor Vehicle Department.
- In July, the Auto Theft Garage assisted the Homicide Unit in the identification of a vehicle involved in a homicide that was burned and could only be identified through secondary means.
- In July, the Auto Theft Unit recovered 27 stolen vehicles worth an approximate \$463,000.

Burglary and Organized Crime Unit ...

- In July, the Burglary Unit had 24 new cases assigned to them; cleared 21 cases; sent 14 cases to the District Attorney's Office; cleared 14 cases by arrest; completed ten felony arrests; and recovered items valued at \$4,000.
- In July, Detective Glynn arrested a suspect who was recently involved in a residential burglary in which over \$8,00 worth of property was stolen (electronics, tools, and Oxycodone). Detectives utilized surveillance video and social media to identify the suspect and assist in the overall investigation. The suspect was a well-known repeat property crimes offender and was featured on local news stations both before and after his arrest.
- In July, Detective Moore completed his

investigation into a recent aggravated burglary in which multiple firearms and several thousand dollars worth of property was stolen. Detective Moore utilized information from Pawn Shops to recover property and file charges on two suspects. He also used the Automated Fingerprint Identification System (AFIS) as well as surveillance video to assist with the identification of the suspects. The first of the two suspects was arrested early in the investigation. The second suspect was featured on the Daily 49 and Crime Stoppers and soon apprehended from the tips received.

- In July, Detective Jojola executed a search warrant at a storage facility. The owners of a storage unit were suspected of breaking into adjacent units. Detective Jojola seized \$2,000 worth of stolen property and returned it to the rightful owners. He identified two offenders and obtained arrest warrants for both.
- In July, the White Collar Unit had 11 new cases assigned to them; cleared four cases, completed three search warrants; sent four cases to the District Attorney's Office and completed four felony arrests.
- In July, Detective Natewa continued her investigation into three suspects involved in defrauding and embezzling from a non-profit organization. The amount of money defrauded is now over \$50,000. Additional charges will be filed on the three offenders. The suspects created and opened several bank accounts for several false rental companies funded with money from the non-profit agency.
- In July, Detective Candelaria worked a fraud and extortion case in which a doctor hired a subject who falsely represented himself as an advertisement independent contractor. The doctor incurred a monetary loss of \$150,000. Detective Candelaria completed the investigation and is forwarding the case to the District Attorney's Office for review.
- In July, the Pawn Shop and Metal Theft Unit completed seven felony arrests/warrants; one misdemeanor arrest; cleared 14 cases; recovered 37 pawned items valued at \$19,000; recovered metal valued at \$1,000; and recovered three stolen firearms.
- In July, Detective Moore with the Pawn/
 Burglary Unit recognized a pawner with
 warrants. This suspect had three outstanding
 felony warrants and had been pawning stolen
 items on a routine basis valued at over \$2,000.
 Detective Moore took the subject into custody

- and discovered a small amount of narcotics in her possession.
- In July, Detective Santistevan recovered \$19,000 worth of stolen property which was returned to its rightful owners. The recovery included taking three stolen firearms off the streets.

Criminal Investigations Division...

- The total number of Uniform Crime Reporting (UCR) homicides in Albuquerque through the end of July were 40.
- In July, the Homicide Unit responded to six callouts and has 46 active cases.
- On July 14, officers were dispatched to a shooting call. Upon arrival, officers located a deceased female. Officers also located a male juvenile who stated he had shot his sister. The scene was secured pending more investigation, and would later result in a Violent Crimes call-Out. Detectives interviewed the male juvenile and he was arrested for the death of his sister. This case is considered solved/closed and will be carried as a homicide.
- In July, the Armed Robbery Unit responded to 4 call-outs and cleared 27 cases. All 27 cases were submitted to the District Attorney's Office for prosecution.
- In July, the Armed Robbery Unit made 12 incustody arrests and wrote five arrest warrants.
- In July, the Armed Robbery Unit had 22 new cases for a total of 147 active cases.
- In July, the Sex Crimes Unit responded to three sex crimes call-outs They also cleared 17 cases with four of those going to the District Attorney's Office. The unit also wrote five search warrants. There were 29 new cases assigned for investigation in July. The unit currently has 111 active cases.
- In July, Family Abuse Stalking/Training Team (FASST) had 102 new cases assigned to them and cleared 119 cases. They currently have a 117 open cases.
- In July, FASTT received and reviewed 115 reports.
- In July, FASTT assisted the Homicide Unit with two call-outs.
- In July, Detective Alvarez from the Missing Persons Unit recovered two juveniles who been considered runaways.
- In July, the Crisis Intervention Unit (CIU) provided 74 hours of training and conducted 66 meeting hours. The unit contacted 173 individuals and assisted 49 mental health consumers with services. They referred 115

- individuals to services and received 112 referrals.
- In July, CIU took 77 calls for service and was assigned 13 high risk cases. The unit completed 41 home visits with mental health clinicians and wrote four pick up orders.
- As of July, there are 459 officers in the field, including sergeants and lieutenants that are certified in Crisis Intervention Training (CIT). This represents 98% of the officers in the field.
- On July 19, B. Wils received a phone call from 911 Operator C. Kirk. The operator advised a male had called frustrated with his care system not giving him his medication and wanting to set the health care building on fire if he did not receive the medication. The operator expressed empathy, care and compassion for this young man and asked if a Crisis Intervention Unit (CIU) detective could contact him. She helped facilitate a place where the young man would feel comfortable meeting with detectives. With the help of C. Kirk, CIU detectives were able to assist the man in getting the care he needed.
- In July, an individual climbed the water fountain in Civic Plaza and threatened to commit suicide by jumping off the fountain. Detectives from CIU responded to the call and talked with the individual for several hours. They finally got the individual to come down with assistance from the Albuquerque Fire Department who provided a ladder. Once the individual was brought off the fountain, he was transported by ambulance to the University of New Mexico Hospital. This was the second time this month the individual had threatened to commit suicide.
- In July, the Community Outreach and Support Team (COAST) was contacted regarding an individual who was living in a park and wanting to get off the streets. D. Hovey-Thomas met with the individual and went over resources that could help her situation. She also had two small dogs that made it challenging for her to get assistance. D. Hovey-Thomas gave her dog food and informed her that Noon Day had a veterinarian that did exams monthly. She left the client with food, water, hygiene items, and a bus pass so she could meet with someone from St. Martins to conduct a coordinated assessment.
- The Crimes Against Children Unit (CACU)/ Child Exploitation Detail (CED) received 853 referrals from the Children, Youth and Family Department (CYFD) for review.
- CACU/CED responded to 41 call-outs and executed nine search warrants.

• The Sex Offender Registry Detail (SORD) conducted 86 address verifications on offenders to include photographs of their vehicles and residences to add to the database.

Special Investigations Division (SID)...

- In July, SID had 53 felony and 11 misdemeanor arrests.
- In July, SID made 23 controlled buys and 19 buy busts.
- In July, SID had 34 call-outs for APD and seven for outside agencies
- In July, SID submitted 18 cases to the District Attorney's Office for prosecution.
- In July, SID seized 19 pounds of marijuana; 22,470 grams of methamphetamine; 45 grams of cocaine; 43.5 grams of heroin; and 18 grams of prescription drugs.
- In July, the Gang Unit received several complaints of gang activity and narcotics sales in an area. After conducting surveillance, a confidential informant was sent to the location and purchased a specific amount of methamphetamine. This purchase along with surveillance resulted in detectives obtaining a search warrant for the residence. The warrant was executed and 3.5 grams of methamphetamine was seized.
- In July, the Gang Unit worked with the Safe Streets Task Force in an investigation into a specific gang. Several confidential informant purchases were made which resulted in a search warrant. Ten ounces of heroin was recovered as a result of this investigation.
- In July, Vice detectives observed an occupied stolen vehicle traveling westbound. Vice detectives followed the vehicle and conducted a high risk traffic stop and detained three occupants. At the conclusion of the investigation, detectives arrested a suspect for unlawful taking of a motor vehicle, possession of burglary tools and possession of methamphetamine. The vehicle was returned to the owner.
- On July 18, Air 5 took over observation of an armed robbery suspect's vehicle as it fled from detectives. The vehicle drove at high speeds and made multiple lane changes through traffic before entering the interstate. Air 5 followed the vehicle but when officers approached, the vehicle fled again at a high speed. Air 5 continued to follow the vehicle and observed the driver and occupant park in a backyard and attempt to cover the vehicle with a tarp. They

- changed their minds and got in the vehicle and drove away before officers spike belted the vehicle. The driver parked the vehicle at an apartment complex and walked away. Detectives arrested him and he was positively identified as the offender in an earlier armed robbery.
- On July 21, Air 5 was dispatched to a business in response to a male subject breaking into a vehicle in the parking lot. Once on scene, Air 5 located the offender. Field units attempted to make contact and arrest the male driver but he fled. Air 5 conducted a tactical follow of the offender. The offender stopped at an apartment complex dumpster, where he and the female passenger dumped several items from the vehicle. The vehicle continued at high speeds into on coming traffic displaying complete disregard for traffic safety. The vehicle was spike belted and it crashed into another vehicle. The offender ran from the scene and was taken into custody in a parking lot after a foot pursuit. The second offender in the vehicle, a female, was taken into custody as well.
- On July 26, Air 5 was requested by Foothills field units who were attempting to stop a vehicle. Once in the area, Air 5 located the target vehicle and performed a tactical follow. After driving through numerous residential streets with disregard for public safety, the offenders drove into an underground parking structure of an apartment complex. Air 5 instructed field units to establish a perimeter around the apartment complex. After several minutes, the offenders were located running and were taken into custody without incident. The stolen vehicle was recovered.
- In July, the Central Narcotics Unit served five search warrants, conducted three undercover buy busts, and recovered 11 firearms. Cocaine, methamphetamines, heroin, prescription pills and marijuana were also seized.
- In July, the Central Narcotics Unit investigated a suspect who was selling prescription opiates. On July 6, an undercover buy bust operation was conducted and the suspect was taken into custody. Search warrants were served on the subject's vehicle and residence where a large quantity of various different prescription opiates were located
- In July, the Central Narcotics Unit received information from U.S. Customs that narcotics were being trafficked out of two residences. For several weeks, detectives conducted surveillance and monitoring the traffic. On July 6, Central

Narcotics detectives arrested four suspects on felony narcotics charges. A search warrant was served and methamphetamines, heroin, and numerous prescription pills were seized. Two firearms were also seized during the search warrant.

• In July, the K-9 Interdiction Unit responded to 20 call-outs. As a result, more than 50 pounds of methamphetamine and over \$250,000 in cash were seized.

Real Time Crime Center (RTCC)...

- In July, operators participated in a facial comparison and identification training. The Federal Bureau of Investigations conducted the training for ten officers. They completed the week long training and received certifications to assist with potential future investigations.
- In July, RTCC operators assisted with six SWAT activations by supplying the field with subject work-ups, photos and pertinent information.
- In July, the RTCC received a sixth mobile video unit. The sixth trailer will help with deployment requests throughout the city.
- In July, multiple databases were used to assist operators with supplying pertinent information to the field. The Crisis Intervention Training (CIT) Case Management System was utilized approximately 1,750 times, video network was utilized approximately 245 times and more than 2,300 logs were generated.
- In July, Crime Stoppers received 154 tips. Of those tips, eight arrests were made including a homicide and a sex crime case.
- In July, The Crime Analysis Unit (CAU) visited the Chicago Police Department to analyze a model they have developed that identifies people who have a high risk of being victims of violence. CAU will be working to develop similar models here in Albuquerque.

PROFESSIONAL ACCOUNTABILITY BUREAU Communications Division...

• In July, the APD Emergency Communications
Center staff answered 93,298 incoming calls.
There were 39,447 calls answered for 911 and
53,851 calls answered for 242-COPS. 911
Operators answered 86.18% of the 911 calls
within 10 seconds (national standard is 90%,
APD's standard is 92.0%); operators also
answered 91.45% of the 242-COPS calls within
30 seconds (APD's goal is 90% answered within

- 30 seconds).
- In comparison to last year for July, 911 call volume increased by 7.74% and 242-COPS call volume increased by 3.67%. This represents an overall increase of 5.35%.
- In July, renovations on the National Crime Information Center space began. This will allow for an additional office.
- In July, applicants for Telecommunications I and II are completing their pre-hire requirements for a September 6, 2016, target start date.
- In July, the Communications Manager attended a Mobile Police Department (PD) project kickoff meeting. Mobile PD was created to help public safety agencies better connect with the community. Mobile PD allows push notification alerts to disperse important information in the event of an emergency and allows citizens to submit real-time tips with photos, GPS, and text.

ADMINISTRATIVE SUPPORT BUREAU


Planning Division...

- In July, a new Management Analyst I, Sergio Sotelo, began working with the Grants Management Unit.
- In July, the work began to install a fence at the Academy.
- In July, the Planning Manager sat in an interview committee to hire two Quality Assurance Auditors.

Central Records Division...

- In July, the Public Information Unit received 1,012 requests totaling \$6,372.75 in revenue generated from citizen requests/registers.
- In July, the Report Review Unit completed the following: 2,997 Automated Reporting System (ARS) transfers, 1,283 ARS supplements, 1,404 National Crime Information Center entries, 1,834 accidents, 2,789 officer calls and 146 Unified Crime Reports (UCR).
- In July, Court Services completed the following: 131 pretrial hearings scheduled, 339 arraignments processed, 286 felony cases submitted to the District Attorney's Office and 483 summonses submitted to the Metropolitan Court.
- In July, the False Alarm Reduction Unit collected \$103,382 in fees and fines for a total of \$1,301,394 for the fiscal year. The unit entered 644 new accounts and mailed 11,485 pieces of correspondence. There were 1,833 false alarms

- which was an increase of 12.4% from last year's 1.631.
- In July, the Telephone Report Unit generated 673 original reports and 120 supplemental reports for a total of 793. This resulted in a savings of 2,062 hours of field services time and a savings of \$31,720.
- In July, the Telephone Report Unit processed 627 on-line (Cop Logic) reports resulting in a savings of 1,630 hours of field services time and a savings of \$25,080.
- In July, the Inspection of Public Records (IPRA) received 132 requests, completed 86 requests, and collected \$2,308 in revenue.
- In July, the Inspection of Public Records (IPRA) billed 25 IPRA requests for a total of \$644.25.
