APD Notables...

Field Services Bureau

Field Services Bureau - East

Southeast Area Command...

- In March, the Southeast Area Command had 11,412 calls for service, wrote 2,132 reports, and issued 562 citations. There were 214 felony arrests/warrants, 312 misdemeanor arrests/warrants, and 40 driving while intoxicated (DWI) arrests. Nineteen community meetings were attended.
- On March 6, officers were on patrol when they observed a suspicious vehicle. Officers conducted a traffic stop and ran a search on the vehicle identification number (VIN). The VIN did not match the plate and the vehicle had been reported stolen. The male subject was arrested and transported to the Metropolitan Detention Center.
- On March 9, officers were dispatched to a call of a male who had gained entry into a vehicle and was possibly attempting to steal it. Officer arrived on scene and observed the male subject inside. The suspect was placed in custody and found to have damaged the steering column in an attempt to steal the vehicle. The subject was transported to the Metropolitan Detention Center where he was booked.
- On March 5, officers were dispatched to an abandoned building where the caller located a male subject inside and was holding him at gun point. Officers arrived and made contact with the owner and another male subject on the ground. As soon as the owner saw the officers, he put his gun down. The suspect was detained and officers requested the assistance of a K-9 team to clear the building of any additional subjects. The owner indicated he had received a call from his alarm system. When he arrived, he observed forced entry. Upon further inspection, he found the suspect inside his business at which time he held him at gun point. The suspect indicated he entered the building to escape the environment and admitted to dismantling some boards to gain access to the business. During the search, officers located two small clear zip lock bags in the subject's pockets. The substance inside the bags was field tested and found to be methamphetamine. The subject was arrested for possession of methamphetamine, breaking and entering, and criminal damage to property.
- On March 20, Southeast Impact detectives were notified of a domestic violence incident. The suspect was reported to have a violent history and was on parole for armed robbery. Field units obtained information that the suspect was possibly armed with a weapon and had made threats of suicide by cop if contacted by the police. Detective Moya responded to the scene and contacted the victim. An arrest warrant for aggravated assault with a deadly weapon and false imprisonment was drafted. Southeast Impact detectives conducted surveillance on the victim's residence and the suspect was located. Detective Moya contacted the suspect via telephone and negotiated his peaceful surrender.
- On March 12, Detective V. Barela responded to a domestic violence stabbing. Upon arrival, he learned the suspect had stabbed the victim twice in her chest and tazed her in the face multiple times leaving her in critical condition. During the investigation, it was found that the offender had stabbed the victim because "God told him to kill the devil". The suspect then proceeded to cut the victim's mom with a knife. Another witness intervened and helped subdue the suspect until officers arrived on scene. The suspect was transported to the Metropolitan Detention Center and was booked on the charges of attempt to commit a first degree felony (murder) as well as aggravated battery. On March 25, Detective Barela obtained a Grand Jury indictment and the case is currently awaiting a scheduled trial date.
- On March 15, Southeast Impact Detective T. Hotle was asked by the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) to assist with an arson investigation in Carlsbad, New Mexico, where a hotel under construction had been burned to the ground. The damage was \$2.2 million. Detective T. Hotle conducted several interviews and investigated several leads related to the incident. Through the combined efforts, one of the suspects admitted to starting the fire and is being charged with the federal offense.
- On March 10, Officers A. Suarez and Z. Kesner were dispatched to a fight in progress. Upon arrival, officers located a victim who had a severe laceration to the back of his head. The victim advised that his vehicle was being burglarized by another male. When the victim confronted the burglar, he was hit in the back of his head with a metal bar. Officers obtained a description of the male offender and located him. The male was taken into custody and charged with aggravated burglary, possession of

a deadly weapon, and aggravated assault with a deadly weapon.

- On March 21, Officers W. Kesler and C. Ledford were flagged down by a citizen stating a stabbing had just occurred. The two officers located the suspects matching the description given by the witness. A bloody knife was discovered in a trash can near where the subjects were detained. Sergeant Cabrera located the victim walking away from the scene. The victim was stabbed in the ribs and bleeding significantly. Sergeant Cabrera rushed the victim to the University of New Mexico Hospital where he underwent surgery. It was determined the victim would survive. The investigation showed that one suspect had stabbed the victim while the other was kicking him while he was on the ground.

Northeast Area Command...

- In March, the Northeast Area Command had 9,245 calls for service, wrote 1,897 reports, and issued 720 citations. There were 132 felony arrests, 262 misdemeanor arrests, 27 driving while intoxicated (DWI) arrests, and 106 felony and misdemeanor warrants issued. Eleven community meetings were attended.
- On March 2, Officer E. Burchell was dispatched to a stolen vehicle call. The caller noticed a van that had been stolen from a local pet rescue organization. While responding to the call, Officer Burchell noticed the van driving several blocks away. Officers B. Arbogast, T. Griego, and R. Garnand quickly arrived to assist. The officers placed three people in custody. The van was loaded with a significant amount of other stolen items. One of the offenders also had an outstanding felony arrest warrant. The van was returned to the pet rescue group and the offenders were booked into the Metropolitan Detention Center.
- On March 8, Sergeant S. Frick and Officer G. Ronzone were dispatched to assist the Crisis Outreach and Support Team (COAST) and the Safe City Strike Force with serving an administrative warrant for a home deemed to be unsafe. Sergeant Frick and Officer Ronzone attempted to contact the homeowner, but she refused to open the door or comply with the warrant. Therefore, officers forced entry into the home and secured the location. Upon entry, they found the home full of cats. There was cat urine and feces covering the entire floor causing a health hazard. Officer Ronzone assisted

Animal Control with capturing the cats. In total, over thirty living cats and two deceased cats were recovered from the home. The homeowner was arrested and booked for an outstanding arrest warrant.

- On March 26, Officers A. Cook, S. Drobik and Lieutenant J. Burke were dispatched to a suspicious car where the passengers were throwing beer cans out of the window. It was confirmed that the vehicle was stolen. Lieutenant Burke located the vehicle and the officers performed a felony stop. Three people were taken into custody and charged with felonies.
- In March, Detective C. Baker was called to assist field units regarding a juvenile breaking windows to businesses. Through his investigation, Detective Baker linked the juvenile to a commercial burglary and previous vandalism in a residential area. The juvenile was also intoxicated. The juvenile was booked into the Juvenile Detention Center.
- In March, Detective J. Carter was assigned a case which began as an auto burglary in the Foothills Area Command, but expanded to an identity theft/forgery/fraud case in the Northeast Area Command. The loss was about \$250,000 with multiple victims. Detective Carter identified three suspects and obtained arrest warrants for all of them. The suspects were linked to and arrested for several other burglary crimes.
- On March 1, Officers L. Stallings, A. Malkovich, T. Cochran, T. LaForce and Sergeant J. Perez were dispatched to an apartment complex regarding a shooting. A male subject was shot multiple times and was lying in the parking lot. Officers quickly secured the scene, separated witnesses, and requested the assistance of the Northeast Impact Team. The scene was large and contained multiple witnesses. With the assistance of Team 4, detectives determined the alleged offender's identity as well as his location.
- On March 4, Officer T. Cochran was dispatched to a call regarding a male subject allegedly smoking narcotics at a nearby city park. Officer Cochran made contact with the subject and noticed a large amount of marijuana in a trash bag next to the subject. The male fled on foot but Officer Cochran was able to catch and take him into custody. The marijuana was estimated at over a pound. A small quantity of heroin and paraphernalia were also located on the subject.
- On March 8, Sergeant J. Perez, Officers A. Malkovich, T. Cochran and other officers were

dispatched to an apartment complex regarding a domestic dispute. A male had allegedly pulled a knife on his girlfriend and refused to allow her or her children to leave the apartment.

Officers negotiated with the male through the door for over an hour until he agreed to exit the residence. He was taken into custody without incident. A protective sweep of the residence was conducted and officers located a firearm in a closet. The male was found to be on parole and a felon in possession of a firearm. The firearm was confiscated via a search warrant.

- On March 11, Officer A. Malkovich and Team 5 members were dispatched to a vacant property regarding a male allegedly trespassing. Officers located the subject and apprehended him. The National Crime Information Center (NCIC) revealed the male had several felony warrants for his arrest in regards to residential and auto burglary. He was also found to be in possession of a large amount of heroin, a digital scale and paraphernalia consistent with distribution.

Foothills Area Command...

- In March, the Foothills Area Command had 6,200 calls for service, wrote 1,139 reports, and issued 846 citations. There were 150 felony arrests, 67 misdemeanor arrests, and 16 driving while intoxicated (DWI) arrests. Thirty-five community meetings were attended.
- On March 8, Officer J. Rogillio was dispatched to assist Impact detectives with locating an auto theft suspect who ran from them. Shortly thereafter, a homeowner came running out of her house advising the subjects were in her backyard. With the assistance of two detectives, Officer Rogillio took two of the suspects into custody. Both suspects were later found to have multiple felony warrants and the vehicle they were in was confirmed to be stolen.
- On March 21, Officer M. Carpenter was dispatched to assist Officer A. Mayfield in response to a suspicious vehicle, partially covered with a sheet. The vehicle was found to be stolen. As the officers were waiting for the registered owner to arrive, a male and female drove up near the vehicle. Officer Carpenter checked the license plate of the vehicle they drove up in and found the vehicle to be stolen. Both subjects were taken into custody and transported for questioning.
- On March 29, officer were dispatched to a call in which a female was holding a gun under her chin. According to witnesses, the female was

seen arguing with a security guard and holding a gun pointed to her chin. She was located and safely apprehended. She was subsequently transported to a medical facility for a mental health evaluation.

- In March, Officer J. Jaramillo conducted a tactical plan where residents had expressed concerns regarding suspicious persons and traffic in the area. As a result, Officer Jaramillo conducted seven traffic stops, conducted nine consensual encounters, issued 11 traffic citations, two parking citations, had one graffiti referral, recovered a stolen motor vehicle, and towed a vehicle.
- In March, Officers Camp and Aragon were dispatched to a suicide call. Officers used verbal de-escalation to get the subject to come out of a shed he had barricaded himself in. After many failed attempts and requests, officers opened the shed which was unlocked and safely got the subject into custody. He was taken for a mental health evaluation. The officers also worked with the subject's brother and he allowed all firearms to be taken away from the home.
- In March, Officers J. Blutworth and B. Garcia were dispatched to an apartment in response to a claim that a prison escapee was at the location. Officers apprehended the subject and placed him into custody without incident.
- On March 23, Officers Friedfertig and Simmons were dispatched to a family fight. When they arrived, they met with the owner of the home who indicated her adult son had been served a restraining order and removed from the residence the day before. According to the homeowner, she had opened the rear sliding glass door to let her dog out and saw her son hiding in the rear porch. He then entered the home without permission. She told officers she told him he could not be there at which time he went to a downstairs bedroom and locked himself in it. At that point, the mother called police. The homeowner gave the officers permission to break the door if needed. The officers identified themselves as police and attempted to speak with the suspect, but he did not answer repeated knocks and announcements. The officers then attempted to open the door but realized that the suspect was pushing against the door from inside the room. Officers could hear the suspect moving items in the room and barricading the door. Officers eventually established verbal communication with the subject who was hostile and refused to come out.

He threatened the officers and indicated they would have to break down the door because he wasn't opening it. He also said he would slit his throat and overdose on medication. At this point, officers secured all access points to the room and called for a supervisor. Sergeant A. Anaya arrived and communicated with the subject. After a period of negotiation and discussion of possible treatment for mental health issues, the subject exited the room and was taken into custody. Upon the search of the room, officers found a large kitchen knife. The suspect was arrested for violation of a restraining order, criminal trespass, and refusing to obey a police officer. He was transported to the Metropolitan Detention Center where he was referred to the Psychiatric Services Unit.

- On March 4, Officers B. Garcia and J. Bludworth were dispatched to a local store in response to an unruly customer who had barricaded himself inside the business and was reportedly not allowing employees or customers in or out of the business. Upon arrival, officers immediately went to the rear of the business and made contact with the store employees. Officers ensured all employees were evacuated to safety prior to making contact with the subject. Officers negotiated with the suspect for several minutes. The subject continued to verbally resist and stated he was armed with a knife. Officers eventually subdued the subject and he was taken into custody. Several days after the incident, both officers were contacted by the subject thanking them for their professionalism in handling the incident. He also apologized to the officers for his actions.

Field Services Bureau - West Valley Area Command...

- In March, the Valley Area Command had 6,851 calls for service, wrote 1,303 reports and issued 742 citations. There were 86 felony arrests and warrants, 68 misdemeanor arrests, and 39 driving while intoxicated (DWI) arrests. Eight community meetings were attended.
- On March 9, Sergeant T. Apodaca located a stolen vehicle. Before he could make a stop, the vehicle fled. Sergeant Apodaca was informed by Air Support that the vehicle had been located nearby. Air support called out directions of travel while officers responded. Air Support indicated after operating the vehicle recklessly, the driver crashed into a house. The driver then exited the vehicle and fled on foot into a neighboring

industrial area. Officers from Team 7 established a perimeter and contained the subject on a rooftop. After lengthy negotiations, the suspect exited the rooftop using the Albuquerque Fire Department's equipment and was safely arrested on several felony charges and two outstanding felony warrants.

- On March 27, Officers J. Bowe, J. Crouch, A. Dehne, Acting Sergeant. C. Knight and Lieutenant F. Simmons conducted a high risk stop after receiving information that the occupants of the vehicle had pointed a firearm at the security staff of a nearby bar. Officers took two suspects into custody for negligent use of a firearm. The suspects were also found to be in possession of cocaine which had been hidden in their wallets. They were booked into the Metropolitan Detention Center.
- In March, Sergeant Patterson conducted a tactical plan at the five points most frequented by individuals who participate in illegal street racing. During the operation, Sergeant Patterson issued six citations and handled numerous calls for service.
- On March 22, Officer Landavazo was dispatched to a domestic violence call. The victim was found with head injuries and fractures to her arm and hands. An arrest warrant was issued for her boyfriend who was subsequently arrested and booked on kidnapping, aggravated burglary and aggravated battery with great bodily harm.
- On March 11, Valley day and swing shift officers responded to an assistance call from the New Mexico State Police (NMSP). NMSP initiated a traffic stop in Albuquerque when the driver fled on foot. Officers were informed the suspect had felony narcotics charges and had run into traffic on the freeway with total disregard for his or the safety of others. He was struck by a vehicle but continued to flee. Valley officers saturated the area and located the subject at a local business where he continued in his attempt to elude apprehension. The officers were able to catch the suspect and he was taken into custody and turned over to NMSP.
- On March 8, Officer Montano was on random patrol when he observed a vehicle without its headlights on. Officer Montano ran the vehicle's plate and it came back stolen. Officer Montano requested back-up and followed the vehicle as it pulled into a parking lot. When the other officers arrived, they conducted a high risk traffic stop. Officers got the driver and two passengers into custody even though the driver

of the vehicle repeatedly refused to follow commands. Several edged weapons were found in the driver's possession. The passengers of the vehicle were interviewed by auto theft detectives and released. The driver of the vehicle was booked into the Metropolitan Detention Center.

- On March 14, officers were dispatched to a park in response to a shooting call. Upon arrival, officers located a female victim that had an apparent gunshot wound to her neck. Officers rendered assistance until rescue arrived and transported the victim to the University of New Mexico Hospital. While officers were securing the crime scene, they were advised an off-duty New Mexico State Police officer was following the offender. APD officers were dispatched to the area and assisted in taking the suspect into custody. Officers located the gun, which was hidden under some rocks next to the railroad tracks. The doctors advised officers that the victim's injuries did not appear to be life threatening, but did say she was possibly going to be paralyzed. The offender was interviewed by detectives and booked into the Metropolitan Detention Center.

Southwest Area Command...

- In March, the Southwest Area Command had 5,549 calls for service, wrote 1,150 reports, and issued 724 citations. There were 80 felony arrests, 125 misdemeanor arrests, 32 driving while intoxicated (DWI) arrests and 97 misdemeanor and felony warrants issued. Thirty community meetings were attended.
- On March 14, officers were dispatched to a male with a gun hiding in a shed. The male told the caller that another male sitting in a red truck on the street was armed with a gun and looking for him. Once officers arrived, the subject fled the scene on foot. A perimeter was established and both individuals were detained. Officers received information that the male subject had a felony warrant for his arrest. The subject was arrested and booked for possession of narcotics.
- In March, Team 8 officers conducted a tactical plan following numerous loud party and disturbance calls within one week. Officers patrolled the area, particularly on weekends, and took enforcement action for all violations. The results included: 27 parking citations, two minor in possession citations, three summons for unreasonable noise, one towed vehicle, one recovered stolen vehicle, and one field briefing.
- On March 28, Officers Arndt, Deatherage,

Luchetti responded to an apartment complex in response to a stabbing. The victim was transported to the University of New Mexico Hospital. During the investigation, the victim refused to cooperate with police despite having the offender in custody. The suspect was arrested for two felony warrants. During Officer Arndt's investigation, two children were found abandoned by a witness on scene. The Children, Youth, and Family Department (CYFD) was contacted along with the Crimes Against Children Unit (CACU).

- On March 7, Officers A. Michaud and T. Cravens responded to assist Officer S. Apodaca on a stolen vehicle call in which the owner/victim was following it. The officers witnessed a male subject flee from the stolen vehicle on foot and jumping a nearby wall. The officers pursued the offender on foot and after a brief foot pursuit, he was taken into custody.
- On March 22, Officer Garcia was dispatched to a stolen vehicle that was being tracked by a Global Position System (GPS) device and then went stationary. As Officer Garcia arrived, he observed two male subjects exit the stolen vehicle and enter a residence. A perimeter was established and announcements were given. Two offenders exited and were arrested for auto theft and possession of a stolen motor vehicle. At the same time, Officers Hinson and Michaud dealt with another subject attempting to enter the perimeter. He was found to have a felony warrant and was arrested. The stolen vehicle was recovered and returned to its rightful owner.
- On March 14, Officers F. Baca and S. Apodaca were dispatched to an audible alarm call. Further information obtained by a neighbor stated they observed a male subject kicking in the front door. The offender left the residence prior to officers' arrival. Several calls came in providing updated information as to the offender's last known location. The offender was taken into custody at a different location and all the stolen property was returned to the rightful owners.
- On March 28, Officer Y. Martinez was dispatched to a motel in response to a domestic violence call. During the investigation, it was discovered the victim was pushed to the ground by her boyfriend and he pointed a gun at her. The offender proceeded to damage the residence with a baseball bat. Information obtained from the victim indicated the offender may be suffering from posttraumatic stress disorder (PTSD) from the Iraq war and he also owned

several firearms, to include an assault weapon. The offender was taken into custody without incident after a two hour standoff with police.

- On March 4, officers responded to a local park where citizens were yelling that an altercation was taking place at the lower section of the park. Officers observed a male matching the given suspect description carrying a metal pipe/bar in his hands. As soon as the male saw the officers, he dropped the weapon to the ground. As soon as the suspect was detained, he began yelling that his child and family were locked in the trunk of a vehicle located at the park. Citizens approached the officers and identified the male as the suspect they saw smashing the vehicle's windows while yelling his family was inside. Based on his irrational and strange behavior and the minor cuts on his hands, medical personnel were summoned. The suspect was assessed and ultimately he was admitted for ingesting methamphetamines. He was transported to the hospital via ambulance to be observed.
- On March 31, Officers Higgs and Navarro were dispatched to a hit and run accident. Officers were able to locate the vehicle as it was driving on rims and smoking heavily due to damage from the accident. After interviewing all occupants of the vehicle, it was determined that the male passenger had purchased alcohol for his underage daughter and was allowing her to drive his vehicle. The parent was arrested for contributing to the delinquency of a minor and child endangerment.

Northwest Area Command...

- In March, the Northwest Area Command had 5,430 calls for service, wrote 1,057 reports, and issued 987 citations. There were 58 felony arrests, 123 misdemeanor arrests, 18 driving while intoxicated (DWI) arrests; and 46 felony and misdemeanor warrants issued. Four community meetings were attended.
- In March, Officer R. Rodriguez responded to a domestic violence call. Upon arrival, Officer Rodriguez made contact with the husband and wife. A passerby stated that the female was being held on the ground by the male. After an investigation, the male was arrested and booked for an outstanding warrant.
- In March, Officer R. Moore responded to a call of a missing child. Officer Moore along with several other officers responded to help locate the seven-year-old child that had wandered from his residence. Officers and volunteers swarmed

the area trying to locate the young boy. The boy was located by officers several miles away from his residence. He was safe and sound and returned to his family.

- In March, Officer R. Moore conducted traffic tactical plans in an area near a local high school due to recent complaints from residents about vehicles being parked illegally and blocking driveways and curbs. Officer Moore frequented the area and observed several violations and issued 55 parking citations.
- On March 31, Officers Romero and Holmes were dispatched to a call where an individual was making suicidal statements. Upon arrival, they made contact with family members who indicated the subject was not home and had been taken to the Veterans Administration (VA) Hospital for counseling. Earlier in the day, the family had received texts from the subject stating he wanted to kill himself. The VA Hospital had also called the family indicating the subject had called them saying he wanted to kill himself. Officers requested his phone to be pinged and it was located in the vicinity of the VA Hospital. A request for the Veteran's Administration Police and Southeast Area Command officers was initiated to check the area. Unfortunately, they were unable to locate the subject. Officers Romero and Holmes arrived at the VA Hospital and located the suspect's vehicle. The subject was slumped over the steering wheel. They made contact with the subject and learned he was sleeping. He was taken inside the VA Hospital.
- On March 14, Team 3 officers and Animal Control officers assisted the Safe City Strike Force serving an administrative warrant. According to the warrant, a female was living in the residence without any utilities. She was lighting numerous items inside for heat and the residence was considered unsafe to live in. Inside the house was a large and aggressive dog. The female occupant was also found to have a felony warrant for her arrest. The house was secured with a wrought iron fence and the occupant did not answer the door. After numerous announcements were made, officers had to force entry into the residence using entry tools. Just as the officers were opening the front door, the occupant came to the front door and was taken into custody for her warrant. Animal Control officers took possession of the aggressive animal and the patrol officers cleared the rest of the house. The Safe City Strike Force

Special Services Bureau Special Operations Division...

Tactical...

- took over the investigation and boarded up the residence and declared it a biohazard.
 - On March 27, Officers Barnhill and Lewis were dispatched to assist Valley field units. Upon arrival, officers contacted the homeowners and learned early that morning someone knocked on their front door and when one of the homeowners answered the door, he was hit in the face with a pistol. Two offenders entered the residence and tied the homeowners up and placed them in the shower. One of the homeowners was able to untie himself, and as he freed himself he heard one of their vehicles start up and drive away. The homeowner went to a neighbor's house and called police. Officer Barnhill placed an attempt to locate on the vehicle. Southwest Area Command officers located the stolen vehicle, established a perimeter, and were making announcements when Officer Barnhill arrived to assist. A male was asleep inside the vehicle and was taken into custody. The suspect was found to have an active warrant for homicide. He was also arrested for the warrant along with robbery, aggravated assault and aggravated battery.
 - On March 21, Northwest Impact detectives investigated a series of mail thefts that were occurring at a specific post office. Detectives identified the subject using surveillance videos. The subject was using personal information stolen from the post office to obtain credit cards and lines of credit. He was charged with numerous counts of identity theft, fraudulently obtaining credit cards, and other crimes.
 - On March 20, Sergeant A. Sedler initiated a traffic stop on an erratic driver. Sergeant Sedler requested assistance with a driving while intoxicated (DWI) investigation after he contacted the driver. Officer D. Carr responded to the scene and took over the investigation, He placed the offender under arrest for DWI. The offender also had her minor daughter in the vehicle as a passenger. The daughter thanked Sergeant Sedler for initiating a traffic stop on the vehicle as she was scared due to the dangerous manner in which her mother was operating the motor vehicle. The offender was charged with felony abuse of a child. The driver had a pending misdemeanor domestic violence/child abuse case. This arrest violated conditions of her release and the New Mexico Children, Youth, and Families Department (CYFD) was informed of the incident.
- In March, the K-9 Unit answered 232 calls for service, conducted 102 building and 10 area searches, and had six SWAT activations.
 - On March 3, K-9 officers responded to a SWAT situation in response to a suspect who was wanted for kidnapping and aggravated assault. After multiple attempts to get the suspect to exit the residence, a decision was made to send in a K-9 unit. The suspect was located and taken into custody without injury.
 - On March 8, K-9 officers responded to a hostage situation in the Northeast Area Command. Upon arrival, K-9 officers moved field officers away from the residence to a position of cover and concealment. This move de-escalated the situation and the suspect exited the residence. He was taken into custody without incident.
 - In March, K-9 officers conducted their annual recertification with Alderhorst International.
 - On March 17, K-9 officers responded to an area in response to a subject who ran from police. A perimeter was established and an area search was conducted by K-9. The suspect was wanted for kidnapping and criminal sexual penetration. The suspect was located and apprehended in a backyard.
 - In March, the SWAT conducted five tactical operations.
 - On March 10, the SWAT assisted the Vice Unit with a high risk search warrant in reference to a subject dealing high levels of narcotics from the residence. Due to the size of the property, wrought iron fortification, and numerous other individuals living on the property, SWAT was called to assist. Numerous individuals were taken into custody along with the main suspect. The property was cleared and turned over to the Vice Unit.
 - On March 30, SWAT was called to assist the Investigative Support Unit (ISU). There were numerous suspects barricaded inside of a residence who had just committed an armed bank robbery. One of the subjects had fled the residence and was believed to be barricaded in another residence down the street. New Mexico State Police SWAT assisted to secure both residences. Using crisis negotiation techniques and public address announcements, all subjects existed the residences, were taken into custody without incident, and turned over to ISU.

- On March 31, SWAT was called to assist the Homicide Unit with a high risk search warrant. Homicide detectives had a search warrant for a handgun used in a recent homicide. SWAT conducted a “surround and call-out” tactic and had all occupants exit the residence. They were taken into custody and turned over to detectives. The residence was then cleared of any other occupants and turned over to Homicide detectives.
- On March 23, Officers D. Lujan and J. Jones conducted a SWAT demonstration for a local school. The demonstration showed the student the various equipment that SWAT deploys on a given call out. The officers also educated the student on various tactics and reasons SWAT would be utilized to protect the community and resolve situations peacefully.

Office of Emergency Management... (OEM)...

- OEM continues to assist the Albuquerque Cultural Services Department with multi-hundred thousand dollar mitigation and restoration planning activities to repair past flooding damages and prevent future flooding on the Casa San Ysidro historic site.
- OEM is in the process of applying for a mass notification system grant to provide effective and centralized public warning capabilities.
- OEM is coordinating with the Sunport Operations Manager regarding the Cities Readiness Initiative (CRI)/Strategic National Stockpile Program and their closed Point of Dispensing (POD) involvement in delivering medical counter measures.
- OEM’s remodeling construction project is nearing completion. More than \$500,000 in improvements to the Emergency Operations Center is being funded primarily entirely from grant sources. Approximately 98% of the project is complete.

Homeland Security...

- In March, Homeland Security taught four active shooter classes for the following business and City of Albuquerque departments: one for Planning; two for Parks and Recreation; and one for PNM.
- On March 21-25, Lieutenant Walton attended a pilot project course for Incident Response for Terrorist Bombings at New Mexico Institute of Mining and Technology in Socorro.
- In March, Homeland Security had two meetings with Albuquerque Health Care for the Homeless

about safety and conducting an active shooter training class in April.

Open Space...

- In March, Open Space increased its patrols of the Bosque in response to the dozens of man-made fires that have occurred this year. The joint efforts on prevention and investigation between law enforcement and fire fighters have led to the apprehension of several arsonists. All indications point to a significant threat of wildfires this summer.
- On March 7, Officer S.Candelaria was walking out of the Dwyer Substation when she saw a mother and son walking away from the front doors. Officer Candelaria asked them if they needed assistance. The young boy stated that while he was hiking the Piedra Lisa Trail he found a purse with a New Mexico driver’s license and cell phone. The young boy stated he did not want to just leave it on the trail so he asked his mom to take him to a police station. Officer Candelaria took custody of the purse and utilizing the Real Time Crime Center obtained the current address for the owner of the purse. Officer Candelaria went to that location and found no one to be home so she left her business card. Later that evening, the owner of the purse called her and stated that she went hiking and lost her purse on the Piedra Lisa Trail. The owner was extremely grateful for the boy that found the purse and for Officer Candelaria taking the time to locate her and return the purse.
- On March 7-11, the Open Space Dive Team was in Santa Rosa, New Mexico in response to a request for assistance from the New Mexico State Police Dive Team. Both teams worked together to dredge build-up around the Blue Hole in order to prevent a system clog and to prepare for the installation of a new, and much safer cover to block access to the deep caverns. Divers have gained access to, and one diver perished in the maze of tunnels beneath the recreational diving area. The Blue Hole was also inspected for loose boulders that could break free and the safety structures that were built underwater were also inspected. Items needing repair or intervention were brought to the attention of Santa Rosa officials.
- On March 22, Officer Candelaria and Sergeant Patterson were patrolling the Bosque when they noticed an unattended dump truck parked under a bridge. Sergeant Patterson advised dispatch and it was learned the dump truck was stolen

earlier in the morning from the city yards. Sergeant Patterson called the reporting party to advise them that the dump truck was located. They arrived on scene and informed officers that a trailer and bobcat were also stolen. Officer Candelaria and Sergeant Patterson tried to locate tracks to get a direction of travel of the stolen bob cat and trailer but none was located.

- On March 26, Open Space Search and Rescue received a call about a woman that had been missing since March 10. A note was discovered that outlined her intentions to take her own life on the east side of the mountain. Open Space officers joined Bernalillo County Sheriff's Office (BCSO) deputies in searching the area before the sun set but did not locate her. Search dogs were called in and they spent the next day searching the area without success. BCSO continued the search and located the deceased woman. She was recovered from the mountain and turned over to the Office of Medical Investigations (OMI). The family was appreciative of the closure gained despite the tragedy.
- In March, officers attended the 40 hour use of force class and two days of Problem Oriented Policing (POP)/Community Oriented Policing (COP) class.

Horse Mounted Unit (HMU)...

- On March 2, HMU was on patrol when they encountered a male subject near a fast food restaurant. The male subject was in possession of several large knives and a kit containing needles, tourniquets, and heroin. The male subject was arrested and booked on felony possession charges.
- On March 10, Officer Breeden was interviewed by Channel 7 news in regards to a felony arrest made by HMU. This interview highlighted the patrol activities of the unit and showed APD in a positive light.
- On March 22, HMU was invited to the United States Marine Corps Toys 4 Tots luncheon. The Unit was honored with an appreciation/award at the ceremony for its participation in past events. The unit was also recognized for attending all Toys 4 Tots functions including KRQE's toy pickup and toy drop off at multiple locations throughout the city.

Metro Traffic Division...

- In March, the Traffic Division responded to 289 calls for service.
- In March, the Traffic Division issued 967

moving citations.

- In March, the division wrote 249 reports; had 83 driving while intoxicated (DWI) arrests; two drug recognition experts (DRE) arrests; 61 felony arrests; 20 misdemeanor arrests/warrants; and issued 18 misdemeanor citations.
- In March, the Traffic Division assisted with two escorts.
- In March, the division investigated 154 crashes; towed 79 vehicles; had 18 DWI vehicle forfeitures; and recovered one stolen vehicle.
- In March, the DWI Seizure Unit checked in 77 vehicles; returned 24 vehicles; booted 23 vehicles; and removed 14 boots.
- In March, 95 vehicles were ready for auction.
- In March, 335 vehicles were on the seizure lot.

Prisoner Transport Unit (PTU)...

- In March, PTU processed 1,206 prisoners through the Prisoner Transport Center. The Albuquerque Police Department arrested 867 prisoners and other outside law enforcement agencies arrested 339 prisoners.
- In March, PTU made 219 trips to the Metropolitan Detention Center and accepted 23 walk-in prisoners at the Metropolitan Detention Center.
- In March, PTU worked four hospital guard duty assignments for a total of 20 days.

Metro Court Protection Detail (MCPD)...

- In March, 77 individuals were remanded by the court and booked and two were remanded but bonded out on site.
- In March, 50 individuals were booked with arrest warrants and 49 were booked with arrest warrants but bonded out on site.
- In March, two juvenile warrants were cleared.
- In March, 108 misdemeanors and 19 felony warrants were cleared.
- In March, MCPD had a total of 956 calls for service and self-initiated activities.

Investigative Bureau

Scientific Evidence Division...

- In March, the Major Crime Scene team responded to four primary call-outs.
- In March, Field Investigations responded to 1,227 calls for service and 244 primary burglary calls.
- In March, Field Investigations collected 885 latent fingerprint cards; completed 901 reports; tagged 563 evidence items; and tagged 462 photograph CDs.

- In March, the Photo Lab worked on 447 cases resulting in 10,501 prints and 412 discs.
- In March, the Evidence, Identification and Disposition Unit supported the following backgrounds: 127 case dispositions, 52 employment, 56 firearms, 204 FBI and 48 CODIS requests. Sixty-nine RAPs and photos were distributed, 22 new APD applicants were finger printed, 1,180 fingerprints were classified in AFIS and 1,615 new and old arrests were processed into APD's criminal history records.
- In March, the Evidence, Identification, and Disposition Unit received 11,134 evidence items, duplicated 5,882 audio/video recordings and supported 22 pretrial viewings. Efforts to reduce inventory resulted in 697 items returned to owners; 5,233 items disposed; and \$2,551.13 received as auction proceeds. The unit also processed 2,614 case disposition transactions into evidence history.
- In March, Manuel Gomez passed the American Board of Criminalistics certification test, making him the APD Crime Laboratory's first certified forensic drug chemist.
- In March, the New Mexico DNA Identification System (NMDIS) received 646 new convicted offender/arrestee DNA samples, with a cumulative total of over 111,000 collected. 469 samples were analyzed, uploaded, and searched in CODIS, with a cumulative total of almost 104,000 searchable DNA profiles. As a result of these convicted offender/arrestee samples, 42 unsolved cases were matched to convicted offenders/arrestees, 14 case-to-case matches were made, with a resulting total of 61 investigations being aided.
- In March, the Controlled Substance Unit completed 99 drug cases (63 were APD and 36 were Bernalillo County Sheriff's Office).
- In March, the Biology Unit completed 25 (21 were APD and four were Bernalillo County's Sheriff's Office) cases.
- In March, the Latent Fingerprint Unit completed three APD cases.

Criminal Investigations Bureau Property Crimes Division...

Auto/NITe Unit ...

- On March 8, Auto Theft detectives received an alert that a city-owned bait vehicle had been stolen. The vehicle had been placed at a local hotel that was experiencing a rash of auto thefts and auto burglaries. The detectives followed

the vehicle from the Northeast Area Command to the Northwest Area Command where they disabled the vehicle. They took the offender into custody.

- On March 9, Detective Lovato located a stolen vehicle in the Valley Area Command, while detectives were working a vehicle warm-up tactical plan. Detectives conducted surveillance on the vehicle and arrested two offenders. One of the offenders had both felony and misdemeanor warrants.
- On March 14, Auto Theft detectives responded to a call in the Northeast Area Command where an offender driving a stolen vehicle almost struck a Field Service Bureau unit that was attempting to make contact with the offenders. Auto Theft detectives located and followed the vehicle to Bernalillo, and with the help of the Bernalillo Police Department, placed the driver into custody.
- On March 21, Auto Theft detectives recovered a stolen truck that was tracked by Lojack, a stolen vehicle system activation. The truck was stolen via fraud and identity theft from a dealer in Los Lunas. Detectives recovered the truck within 20 minutes after it was entered into the National Crime Information Center (NCIC), by the Los Lunas Police department.
- On March 20, Auto Theft conducted a Bait Car tactical plan. Two offenders entered the vehicle and took unlawful possession of it. Detectives tracked the vehicle and disabled it. Both offenders were taken into custody and booked into the Metropolitan Detention Center.

Burglary and Organized Crime Unit ...

- In March, the Burglary Unit cleared 30 cases; sent ten cases to the District Attorney's Office; cleared eight cases by arrest; and completed 11 felony arrests.
- On March 9, Burglary detectives conducted a commercial burglary tactical plan in the Northeast and Foothill Area Commands. This area had seen a spike in commercial burglaries. During the operation, Detective D. Moore made contact with a male subject who was loitering in a commercial district. Additional personnel arrived on scene and placed the vehicle under surveillance. The occupant of the vehicle appeared to be driving under the influence of alcohol and/or drugs. A traffic stop was completed and the driver, a known property crimes offender, was found to have warrants and was taken into custody. Methamphetamines were

located on the offender as well. An inventory of his vehicle was performed prior to tow and a counterfeit post office mailbox key was found. United States Postal Inspectors were called and took over case investigation.

- In March, Detective E. Jojola worked on a case where a female offender cashed several checks creating a loss of over \$10,000 for local banks and credit unions. Detective Jojola identified the offender through investigation and obtained a warrant for her arrest. Burglary detectives arrested and interviewed her. She stated she obtained the checks through mail theft. She provided detail information on mail theft rings active in the city. She provided information on subjects manufacturing and using keys to postal cluster boxes. Postal Inspectors were contacted to assist in the investigation. She was booked into the Metropolitan Detention Center.
- On March 30, Detective K. Treece completed his investigation regarding a residential burglary in which a safe was stolen and multiple firearms were taken. This case received a significant amount of media attention. Detective Treece wrote a search (DNA) warrant and arrest warrant for a male subject regarding the burglary. The male offender had left his blood at the scene. It was collected by Crime Scene Specialists and the blood returned a hit through the CODIS database. This was the second arrest warrant filed in this case. A female offender had already been identified and arrested by Detective Treece.
- On March 31, Detective D. Moore arrested two offenders and identified three more in reference to a long term commercial burglary case. The offenders were part of a crew implicated in over a dozen commercial burglaries mainly in the Northeast and Foothills Area Commands. The offenders would steal a vehicle prior to the burglaries. They would shoot out a window with a handgun to gain entry into the business. The crew targeted wireless phone, bicycle, motorsport and tool stores. The offenders would steal large amounts of merchandise. Each burglary resulted in the loss of thousands of dollars to the business. At one commercial burglary, crime scene personnel recovered DNA which was later identified through the CODIS database. Using this information, Detective Moore executed search warrant on the offender's apartment. As a result, the Burglary Unit recovered approximately \$20,000 worth of property including bicycles, power tools, and electronics. Also seized were

several firearms including a sawed off shotgun. Pawn Shop Detective V. Santistevan assisted in identifying stolen items sold through local pawn shops. This led to the identification of a second offender. Three more offenders were identified during the investigation. The case was submitted to the District Attorney's Office.

- On March 1, SWAT and K-9 units along with Pawn Shop and Burglary detectives executed a search warrant. This location is a known fencing operation of stolen property and a narcotics distribution point. Detective D. Champine identified the location through his investigation of stolen property being sold at pawn shops. The primary offender would steal moving trucks and trailers at hotels and empty the contents at his residence. A large number of victims were out of town travelers. Detectives recovered approximately \$30,000 worth of stolen property in the backyard which included a stolen box trailer, two motorcycles, electronics and other items. The owner of the property was arrested. An arrest warrant was filed for the primary offender who was the property owner's nephew. The residence was also deemed substandard by Safe City Strike Force personnel.
- In March, homicide charges were filed in San Juan County against a male offender. The charges were part of a white collar crimes investigation in Albuquerque. White Collar Crime Detective V. Natewa completed an investigation in 2014 which led to the arrest of three people. During the investigation, a search warrant was executed at a local hotel. Three firearms were recovered and tagged into evidence. One of the three offenders was implicated in a homicide that occurred previously in San Juan County, New Mexico. Detectives from the San Juan County Sheriff's Office had ballistics conducted on the firearms recovered by Detective Natewa. One firearm was confirmed to be the murder weapon. This new evidence allowed homicide charges to be filed.

Criminal Investigations Division...

- In March, the Homicide Unit responded to four callouts. All four were homicide.
- On March 5, officers were dispatched to a shooting call. Upon arrival, officers discovered a deceased male subject. Detectives determined the male victim was shot by a female after an altercation. She was later booked on an open count of murder. This case is considered solved

and will be carried as a homicide.

- On March 11, officers were dispatched to a female outside yelling and a neighbor stating there were two possible suicides inside the apartment. When officers arrived, they located two deceased subjects inside. It was determined the subjects died as a result of a murder/suicide. This case is considered solved and will be carried as a homicide.
- In March, the Armed Robbery Unit responded to two robbery callouts and cleared 26 cases. Of those 26 cases, 15 were sent to the District Attorney's Office for prosecution. The unit also made three in-custody arrests; wrote five arrest warrants; and wrote and conducted three search warrants. The Robbery Unit had 24 new cases assigned this month for a total of 124 active cases.
- In March, the Sex Crimes Unit responded to four sex crime callouts this month. They also cleared 28 cases with eight of those going to the District Attorney's Office. There were 26 new cases assigned for investigation for a total of 93 active cases.
- In March, Detective Wild assumed case responsibility for a possible kidnapping and sexual assault that spanned multiple jurisdictions over a period of weeks. Detective Wild's efforts resulted in an overnight SWAT standoff and subsequent arrest of a repeat offender who had made threats to law enforcement. Detective Wild completed 16 total search warrants on the case for locations, cell phones, and social media accounts.
- In March, the FASTT Unit was assigned 15 new cases; cleared 15 cases; received and reviewed 90 reports; and supported the Victim Assistant Unit with 26 cases.
- The Victim Liaison, A. Lucero attended the Community Professional Sexual Assault training on March on 24 - 25 and March 31- April 1.
- In March, 126 cases were assigned to the Missing Persons Unit.
- In March, the Missing Persons unit cleared 111 cases.
- In March, Detective Alvarez worked a case of an individual who was reported missing in December by family and friends. She received several tips that the missing individual could not be located. Detective Alvarez completed a warrant for his e-mail and phone number. Using this information, she reached out to the missing individual. He contacted Detective Alvarez and advised her that he was okay and did not want

- contact with his family. The case was closed
- In March, Detective Wiebe worked a missing person case for two weeks. The individual was reported missing by family and it was reported she had threatened to harm herself. The missing person's deceased body was located by the Bernalillo County Sheriff's Office. Detective Wiebe attended the autopsy and remained in contact with the family.
- In March, the Crisis Intervention Unit (CIU) provided 28 hours of training. CIU made contact with 62 individuals and assisted 50. They also assisted 33 mental health consumers and referred 66 people to services.
- In March, there are currently 459 officers, or 98%, in the field that are Crisis Intervention Team certified.
- In March, the Crimes Against Children Unit (CACU) received 1,181 referrals from the Children, Youth, and Family Department. Detectives were assigned 67 new cases to be investigated and on-call detectives responded to 20 callouts.
- In March, CACU executed seven search warrants and generated three arrest warrants.

Special Investigations Division (SID)...

- In March, SID completed 462 surveillance hours.
- In March, SID had ten misdemeanor arrests and issued five misdemeanor warrants.
- In March, SID had 27 felony arrests and issued 20 felony warrants.
- In March, SID submitted 19 cases to the District Attorney's Office.
- In March, SID had 14 buy busts and recovered 11 firearms.
- In March, the Gang Unit conducted an operation in which detectives seized two grams of cocaine, one gram of heroine, one handgun and one stolen vehicle. Detective made several contacts with known local gang members.
- In March, the Gang Unit was requested to assist Property Crimes detective with locating a known gang member. The suspect had several felony warrants for his arrest. The unit located him after conducting surveillance and they took him safely into custody. He was also found to be in possession of \$20,000 of stolen property. He was then booked into the Metropolitan Detention Center without incident.
- On March 10, The Vice Unit served a search warrant in response to an ongoing narcotics investigation. At the completion of the

warrant, detectives made three felony arrests, cleared one felony warrant, seized 11.3 grams of methamphetamine, seized four types of prescription narcotics and marijuana. SWAT, Central Narcotics Unit and Safe City Strike Force assisted with the investigation.

- On March 15, the Vice Unit conducted an operation at a local hotel. Detectives made three prostitution arrests and one promoting prostitution arrest. The Central Narcotics Unit assisted the Vice Unit.
- On March 9, Air 1 responded to a stolen vehicle. Air 1 located the vehicle stopped on a side street. A field officer attempted to make contact with the vehicle when it fled at a high rate of speed with no units in pursuit. The vehicle failed to make a turn and crashed into a tree. The driver fled on foot into an industrial yard. The subject eventually climbed on the roof top of a building near the rail road tracks. The subject refused to follow commands and started making suicidal threats. The situation was eventually made into a SWAT call-out. After several hours, the subject eventually gave up and was taken into custody on felony warrants and new charges for the stolen vehicle and pursuit.
- On March 12, Air 1 and Bernalillo County Sheriff's Office Metro 1 helicopters flew a formation flight for the opening ceremonies at the Police Motorcycle Competition held at Intel in Rio Rancho.
- On March 17, Air 1 landed at the APD Academy for the Citizens Police Academy. Air 1 was shown to approximately 35 attendees. Sergeant Taylor explained what the air unit does and how it benefits the officers on the ground and the citizens of Albuquerque.
- On March 30, Air 1 assisted Investigative Support Unit (ISU) detectives with the apprehension of several suspects involved in a bank robbery. On arrival, Air 1 located a male suspect running through backyards and entering a residence. A field unit was directed to the location to help secure the residence. After making announcements, the suspect exited the residence and surrendered. He was identified as the armed robber at the bank.
- On March 30, Air 1 observed a motorcycle flee from a Rio Rancho Police Department field unit who was attempting a traffic stop on the vehicle. A Rio Rancho dispatch advised they had received several calls of the vehicle driving recklessly. Air 1 performed a "tactical follow" of the vehicle as it left Rio Rancho and entered the

City of Albuquerque. Air 1 advised Northwest Area Command dispatch of the information and field units were sent to assist in case the vehicle came to a stop. No units were engaged or were ever in sight of the vehicle. The vehicle continued driving at normal traffic speeds and eventually entered a gas station parking lot where it stopped. Field units contacted the driver and took him into custody without incident. The primary Rio Rancho unit was advised and came to the scene and arrested the subject.

- In March, the Central Narcotics Unit conducted room clearing training with the Vice Unit. They also conducted two undercover buy bust operations; seized seven firearms; conducted three search warrants; processed one methamphetamine laboratory; and conducted one controlled delivery.
- On March 1, the Central Narcotics Unit and the Southeast Impact Team conducted undercover operations in several identified high crime areas within the Southeast Area Command. The results of the operation included four felony arrests, two misdemeanor arrests, and three outstanding warrants were cleared. A known property crime offender with several arrests for commercial burglary was arrested for trafficking methamphetamines and heroin, and conspiracy. Another known drug trafficker was also arrested on felony drug trafficking charges.
- On March 2, a clandestine methamphetamine laboratory was located. Central Narcotics detectives responded and confirmed the methamphetamine laboratory. The laboratory was processed by detectives and safely disposed of.
- On March 8, the Central Narcotics Unit was conducting surveillance in the Foothills Area Command. Detectives observed a vehicle in which the driver and passenger were acting suspicious by appearing to be casing several businesses. Based on the suspicious behavior, detectives had a reason to believe that the subjects were possibly going to commit a robbery or larceny. Detectives confirmed that the license plate was not registered to the vehicle. Foothills Swing Shift officers followed and stopped the vehicle without incident. During the investigation, a Narcotics K-9 unit responded to the scene and alerted on the presence of a controlled substance inside of the vehicle. Central Narcotics obtained and served a search warrant on the vehicle. Detectives seized a quarter ounce to a half ounce of heroin,

trafficking paraphernalia, and an assault rifle. Both subjects were arrested on felony trafficking charges and conspiracy.

- On March 11, Homeland Security Investigations (HSI) received a package in San Francisco coming from the Philippines. The package was addressed to an Albuquerque address. The package was screened and it was determined it contained controlled substances, prescriptions, and dangerous drugs. HSI contacted the Central Narcotics Unit who assumed case agent for the investigation. Central Narcotics detectives coordinated a controlled delivery of the narcotics to the Albuquerque address. During the controlled delivery, the narcotics were successfully delivered to a licensed registered nurse. Detectives made contact with the subject who was subsequently detained during the investigation. A search warrant was obtained and served on the residence. During the search, detectives seized additional quantities of controlled substances and located what appeared to be several unknown substances and chemicals. Detectives recovered ledgers which detailed instructions on how to make bombs and machine guns. The Federal Bureau of Investigation (FBI) and the APD Bomb Squad responded and confirmed there were the necessary precursors needed to make an explosive/bomb. The APD Bomb Squad seized all of the precursors that were in the residence. Central Narcotics Detectives also seized seven firearms from the residence. Central Narcotics secured a warrant for the suspect's computer, which also contained links for bomb making instructions as well as known terrorist networks. The subject was booked on numerous felony narcotics charges.

Real Time Crime Center (RTCC)...

- In March, the Bridge assisted in 2,096 calls for service. About 70% of those were intervention from the operators in the Bridge. The Crisis Intervention Case Management System, which was developed by the RTCC and now has more than 4,000 cases, was utilized 1,515 times.
- In March, RTCC assisted in providing information and creating work-ups on individuals and locations that were involved in seven different SWAT callouts.
- On March 9, New Mexico Probation and Parole visited the RTCC requesting assistance with information in regards to two dangerous fugitives who had escaped from custody and

believed to be in the in the Albuquerque area. The RTCC assisted by accessing their video network in attempt to locate both subjects. The RTCC provided a possible location of a family member of one of the fugitives. The RTCC staff worked for three days to identify leads, locations, associates, vehicles, and social media accounts.

Professional Accountability Bureau Communications Division...

- In March, the APD Emergency Communications Center staff answered 77,566 incoming calls. There were 31,834 calls answered for 911 and 45,732 calls answered for 242-COPS. 911 Operators answered 85.72% of the 911 calls within 10 seconds (national standard is 90%, APD's standard is 92.0%); operators also answered 90.41% of the 242-COPS calls within 30 seconds (APD's goal is 90% answered within 30 seconds).
- In comparison to last year for March, 911 call volume decreased by 2.6% and 242-COPS call volumes increased by 1.9%. This represents an overall increase of .02%.
- A New Hire Training Class began on March 21 which included six Telecommunicator Operator I (C1) and four new Telecommunicator Operator II (C2) employees.
- On March 29, the Communications Division manager attended a 911 Affiliate meeting to discuss funding issues and the status of Next Generation 911 in the State of New Mexico.

APD Academy...

- In March, 368 interest cards were received (241 cadets, 117 public service aides (PSAs); and ten laterals).
- In March, background folders were assigned for 29 cadets, seven PSAs, one lateral, eight PTU and 12 civilians.
- The March 4-6 testing consisted of 185 individuals scheduled to test; 31 attended City entrance; 22 attended Saturday testing; and 21 were passed to background.
- The March 18-20 testing consisted of 55 individuals scheduled to test; 20 attended City entrance; 15 attended Saturday testing; and 13 were passed to background.
- In March, twelve cadets and three PSAs were seated for the 116th Cadet class.
- The 114th Cadet class graduated March 3.

Administrative Support Bureau Planning Division...

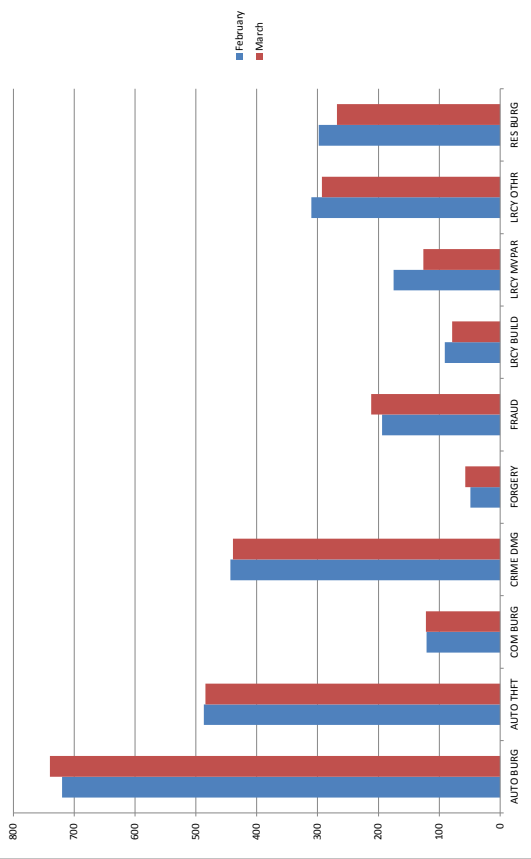
- In March, the grants management unit submitted a proposal for the 2017 Paul Coverdell grant.
- In March, the Planning Division in conjunction with the Division of Municipal Development began a renovation project at the Northeast Area Command. The work consisted of adding a holding cell, installing polished concrete floors and other miscellaneous repairs.
- In March, the Planning Manager continued to oversee the renovation project which will house the Tactical Unit. The estimated completion date is May 2016.
- In March, the Planning Manager continued planning for renovation work at the Foothills, Northwest, and Southeast Area Commands.
- In March, the Planning Division facilitated the transport of a storage container that was donated to APD from Fort Bliss. The container is being used by Open Space for equipment storage.
- In March, the Planning Division continued to work on the APD Annual Report. The draft will be submitted to the Chief in April for review and publishing will occur by May 2016.

Central Records Division...

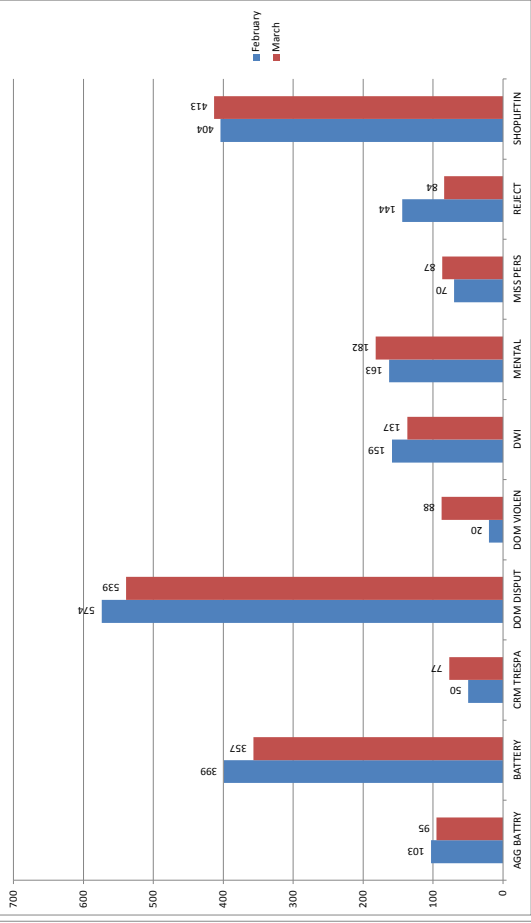
- In March, the Public Information Unit received 1,212 requests totaling \$9,028 in revenue generated from citizen requests/registers.
- In March, the Report Review Unit completed the following: 2,663 Automated Reporting System (ARS) transfers; 899 ARS supplements; 1,424 National Crime Information Center entries; 2,770 accidents; 2,591 officer calls; and 537 Unified Crime Reports (UCR).
- In March, Court Services completed the following: 105 pretrial hearings scheduled; 313 arraignments processed; 385 felony cases submitted to the District Attorney's Office; and 448 summonses submitted to the Metropolitan Court.
- In March, the False Alarm Reduction Unit collected \$99,575 in fees and fines for a total of \$896,067 for the fiscal year. The unit entered 572 new accounts and mailed 10,734 pieces of correspondences. There were 1,419 false alarms processed which was a decrease of 5.7% from last year.
- In March, the Telephone Report Unit generated 591 original reports and 175 supplemental reports for a total of 766. This resulted in a savings of 1,991.60 hours of field services time and a savings of \$30,640.

- In March, the Telephone Report Unit processed 518 on-line (Cop Logic) reports resulting in a savings of 1,347 hours of field services time and a savings of \$20,720.
- In March, the Inspection of Public Records (IPRA) received 146 requests; completed 128 requests; and collected \$6,736 in revenue.
- In March, the Inspection of Public Records (IPRA) billed 24 IPRA requests for a total of \$1,022.

TOP 10 PROPERTY CRIMES FOR MARCH COMPARED WITH FEBRUARY

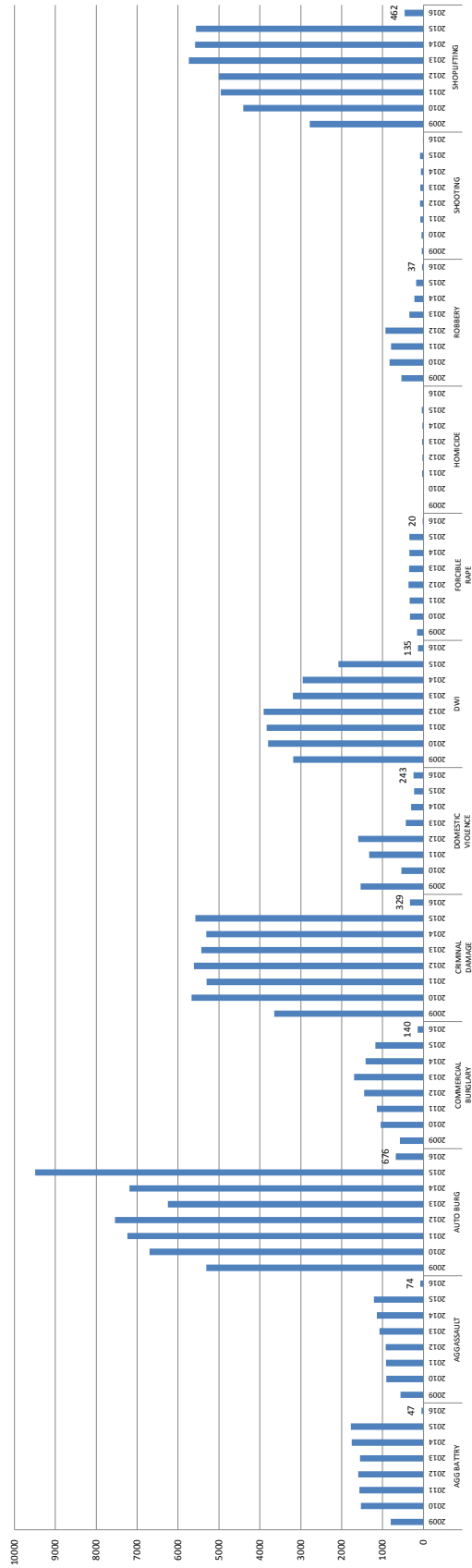


TOP 10 PERSON CRIMES FOR MARCH COMPARED WITH FEBRUARY

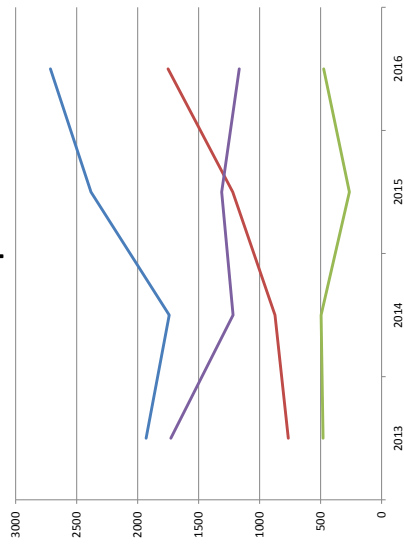

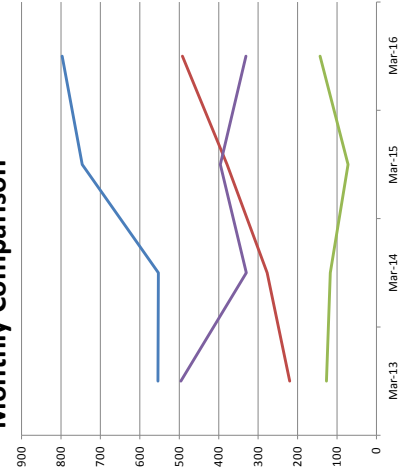

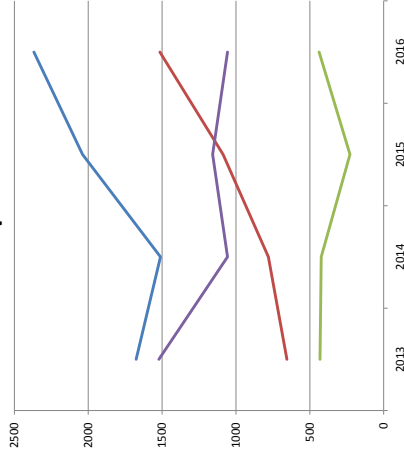
Year-To-Date Comparison
