
An Analysis Of Arrest And Disposition Data Related To The McClendon Settlement Agreement: Data Gathered Between January 1 And December 31, 2022

# **Executive Summary**

The McClendon Settlement Agreement required the City of Albuquerque to make a number of changes in policies and practices aimed at improving the way that police officers interacted with individuals who were unhoused or who appear to have a mental disability. The impact of these changes were to be documented by creating course of business records including:

- Bookings on citable non-violent misdemeanor offenses, not to include DWIs;
- Disposition data for individuals involved in Crisis Intervention Team (CIT)-related incidents;
- Arrests arising from calls for service involving domestic violence; and
- The notation of phone numbers and email addresses on the Uniform Traffic Citation Form.

The purpose of this report is to examine the data contained in those course of business records in 2022. Here are the key findings presented as text here and in tabular forms on Slide #4:

- APD made approximately 9,961 custodial arrests in 2022. 122 (1.2%) of those were for cases only involving charges for non-violent misdemeanors (NVMD); 145 (1.5%) were for cases where officers completed CIT Contact Sheets, referred to herein as behavioral health cases (BH); and 1,313 (13.2%) were for individuals in cases involving domestic violence (DV).
- 1,747 cases were categorized as NVMD, meaning that all the charges related to that case were classified as non-violent misdemeanors in cases involving custodial arrests, summons or citations. APD issued citations in 803 (46%) of those cases; summons in 822 (47.1%) of those cases and made custodial arrests in 122 (7%) of those cases.

# **Executive Summary (Continued)**

- 5,900 cases were classified as BH, meaning that officers completed CIT Contact Sheets in addition to regular case reports. APD issued citations in 14 (.02%) of these cases; summons in 160 (2.7%); and took individuals into custody in 145 (2.5%) of these cases. The majority of these cases resulted in voluntary mental health transports (1,914 or 32.4%); involuntary mental health transports (1,207 or 20.5%).
- 4,229 cases were classified as DV, meaning that the case involved domestic violence charges. APD issued citations in 3 (.01%) of those cases; summons in 2,913 (68.9%) cases; and made custodial arrests in 1,313 (31%) cases.
- Both the business records themselves and the analysis of data trends in this report indicate that the City of Albuquerque has fulfilled the requirements of the McClendon Settlement Agreement.

# Background

On March 28, 2017, the City of Albuquerque settled a decades-old class action lawsuit primarily involving allegations of poor jail conditions, including overcrowding, as well as issues related to arrests and arrest procedures.

The suit was filed in 1995 and was named after Jimmy (Billy) McClendon who was arrested on a non-violent misdemeanor and was jailed for several days. The suit alleged that Mr. McClendon, who was suffering from medical issues, faced poor conditions because the Metropolitan Detention Center (MDC) was overcrowded by more than 300 inmates. The City and Bernalillo County were named as defendants in the suit. Mr. McClendon passed away in 2001.

The McClendon Settlement included a number of provisions and stipulations but the ones most relevant to this report focused on ensuring that the Albuquerque Police Department (APD) developed policies and procedures that reduced the unnecessary arrest and incarceration of individuals who were unhoused or individuals with mental disabilities. In particular, the Court ordered *"APD officers to issue citations whenever appropriate and explain "that persons alleged to have committed non-violent misdemeanor offenses (not to include DWIs) will not be arrested when there are no circumstances necessitating arrest."" (McClendon, et al v. Albuquerque, City of, et al (Doc. 1326; Case No. 95 CV 024 JAP/KBM)* 

# Settlement

The City agreed to terms intended to address concerns with overcrowding at the Metropolitan Detention Center and to comply with Court Orders. These terms included:

- Consistent with the requirements set forth in a Court Order, the City agreed to provide direction to law enforcement officials to issue citations, where appropriate and to encourage use of the booking window at Metro Court, where appropriate.
- The City agreed to continue to work on jail diversion strategies, especially for persons with psychiatric or developmental disabilities, mental illnesses or developmental disabilities consistent with requirements in a Court Order.
- Additionally, to help reduce jail overcrowding, the City agreed to obtain phone numbers from people they stop and arrest or cite and release, and to write the phone number(s) on the face of the arresting/citing document, so that the courts can send reminders of hearings and communicate regarding warrants.
- Finally, the City agreed to evaluate whether APD detains and arrests individuals with mental illnesses or developmental disabilities for the sole purpose of sweeping them from the streets.
- The City agreed to issue a final summary report July 30, 2018 on these key records and any follow-up measures taken. That first report was issued on July 30, 2018.

# Records

As part of the City's settlement, the City has created course of business records documenting the following:

(a) Bookings on citable non-violent misdemeanor offenses, not to include DWIs;

(b) Disposition data for individuals involved in CIT-related incidents;

(c) Arrests arising from calls for service involving domestic violence; and

(d) The notation of phone numbers and email addresses on the Uniform Traffic Citation Form, (phone numbers and email addresses were added to the Form in order to better inform individuals of their court dates and reduce the number of bench warrants issued);


The City began compiling these key records on April 28, 2017, which was 30 days from the signing of the settlement. Data used to compile these records is obtained from the Albuquerque Police Department's Computer Aided Dispatch System, CIT Contact Sheets, Mark43 computer system and the TraCS system. Data are subject to change as reports are approved, investigations concluded and amendments to reports are made.

# The NVMD Arrest, Citation and Summons Data Set


The data set used for this analysis was downloaded from Mark43 on June 6, 2023. The charges identified as The Non-Violent Misdemeanor (NVMD) are listed in Appendix 1. The NVMD cases were selected using the following methodology:

- The case number was combined with Arrest\_full\_name to create a CaseName variable to ensure that individuals were counted in instances where several individuals were arrested, cited or summoned in one case.
- CaseNames with any Felony, Felony Warrant, or Misdemeanor Warrant as the top charge or any additional charge were removed from the NVMD data set.
- CaseNames with any top charge or any additional charges were that were not included on the McClendon list of offenses were removed from the NVMD data set. The McClendon list of offenses is included in the appendix of this report.
- It is important to note that the top booking charge may not be the most serious charge. Top charges in the Mark43 system may be listed in order of severity or in order of occurrence to align with the incident report narrative.
- The final NVMD data set included 1,747 CaseNames who were arrested, cited or summoned between January 1, 2022 and December 31, 2022


## The Location And Number Of NVMD Cases By APD Beat In 2022



# The Behavioral Health Data Set

The data set used for this analysis was downloaded from Mark43 on May 25, 2023. The behavioral health data come from the CIT Contact Sheets completed by officers in the field:


- The CIT behavioral crisis id is the number of the CIT Contact Sheet. This is the key variable to use so that individuals were counted in instances where CIT Contact Sheets were completed but no case number was generated.
- A number of APD units completed the CIT Contact Sheets. Those sheets completed by CIU detectives and COAST were removed because the focus of this analysis is on initial interactions with officers in the field rather than on follow-up visits and planned outreach.
- The final Behavioral Health data set included 5,900 incidents between APD field officers and individuals with a variety of disposition that occurred between January 1, 2022 and December 31, 2022

# The Location And Number Of CIT Contact Sheets By APD Beat In 2022






#### **Dispositions Over Time For CIT Contacts In 2022**



# **CIT Contact Sheet Disposition Definitions**

- No action required: officers arrived on the scene, spoke to the individual, and determined that no actions were necessary in the circumstances.
- Voluntary mental health transportation: when an individual experiencing a Behavioral Health Issue, or a Behavioral Health Crisis is transported voluntarily to a hospital.
- Involuntary mental health transportation: when an individual experiencing a Behavioral Health Issue, or a Behavioral Health Crisis is transported involuntarily to a hospital.
- **Disengagement:** situations where an officer ceases contact with an individual. This may occur when an individual refuses to talk with officers. Officers attempt to leave appropriate resources and CIU/MCT will often follow up as necessary.
- **Summoned:** when an individual experiencing a Behavioral Health Issue, or a Behavioral Health Crisis is summonsed by an officer without further law enforcement action.
- Non-engagement: situations where an officer does not engage with the individual. In these circumstances, officers should notify appropriate resources if necessary.
- Arrested: when an individual experiencing a Behavioral Health Issue, or a Behavioral Health Crisis is taken into custody by an officer.
- Incident transfer to ACS: when an individual experiencing a Behavioral Health Issue, or a Behavioral Health Crisis is connected with Albuquerque Community Safety.
- **Citation:** when an individual experiencing a Behavioral Health Issue, or a Behavioral Health Crisis is cited by an officer without further law enforcement action.
- Died by suicide: when an individual experiencing a Behavioral Health Issue, or a Behavioral Health Crisis died by his/her own means.
- Verbal warning: when an individual experiencing a Behavioral Health Issue, or a Behavioral Health Crisis receives a verbal warning by an officer without further law enforcement action.
- Incident Transfer to Fire MCT: when an individual experiencing a Behavioral Health Issue, or a Behavioral Health Crisis and the individuals is transfer to Bernalillo County Fire Department mobile crisis team.

## The Domestic Violence Data Set

The data set used for this analysis was downloaded from Mark43 on June 2, 2023.


- The case number was combined with Arrest\_full\_name to create a CaseName variable to ensure that individuals were counted in instances where several individuals were arrested, cited or summoned in one case.
- The Domestic Violence cases were selected if the case had any of the charge code names listed to the right associated with it. Please note that these DV charge codes could be the top booking charge or associated charges.
- The final DV data file had 4,229 casesnames with Arrest Dates in 2022.







# The Analysis Of Phone Numbers And Emails On Traffic Citations

The following steps were taken to collect data and analyze the inclusion of phone numbers and email addresses on traffic citations:

- Data about traffic citations from January 1, 2022 to December 31, 2022 was obtained from the TRACs system.
- The data set for this analysis included 57,629 citations written by APD officers during this time frame.
- A data query was developed to identify all citations where a valid phone number had been entered in the designated area of the citation.
- A second query was developed to identify all citations where an valid email address had been entered in the designated area of the citation.
- The number of citations was then compared with the number of citations that noted a valid phone number and the number of citations that noted an valid email address and a percentage was determined for each month.

## Summary

The McClendon Settlement Agreement required the City of Albuquerque to revise policies and practices aimed at changing the way that police officers interacted with individuals who were unhoused or who appear to have a mental disability. The Settlement Agreement also required the City to track the impact of these changes by creating course of business records including:

- Bookings on citable non-violent misdemeanor offenses, not to include DWIs;
- Disposition data for individuals involved in CIT-related incidents;
- Arrests arising from calls for service involving domestic violence; and
- The notation of phone numbers and email addresses on the Uniform Traffic Citation Form.

Both the business records themselves and the analysis of data trends in this report indicate that the City of Albuquerque has fulfilled the requirements of the McClendon Settlement Agreement.

The issues of homelessness, behavioral health, and domestic violence are complex. Addressing those issues compassionately and effectively takes the best efforts from the City, APD, community and health agencies, families, advocates and so many other partners. The changes in APD's policies, training and practices; and other initiatives including the establishment of the Albuquerque Community Safety Department (ACS) have had a demonstrable impact on keeping the number of arrests low for individuals in the population identified in the McClendon Settlement.
