APD Notables...

Field Services Bureau

Southeast Area Command...

- Southeast Impact Team members initiated a tactical plan in response to residential burglaries. A vacant house was occupied by the Southeast Impact Team at the permission of the home owner. The house was baited with City-owned property and monitored with cameras. On August 6 at 1109 hours, an activation was received, alerting detectives that the house had been burglarized. The property was tracked to a recycling materials buyer. Detective M. Rael was the first to arrive on scene and was able to identify the offenders while they were in the process of recycling City-owned copper tubing that had been baited. The offenders were placed under arrest. Video evidence was obtained that confirmed the offenders had unlawfully entered the bait house and removed the baited copper. Both subjects confessed to the crime and were booked for residential burglary, conspiracy, larceny over \$500, and tampering with evidence. Both offenders have prior arrests for burglary, and are known copper thieves.
- On August 15, the Southeast Impact Team initiated a tactical plan in reference to several commercial burglaries at a business under renovation. Detectives placed baited City property inside the structure with video surveillance. On August 17, detectives were alerted that the property had been stolen. Southeast Impact, Southeast graveyard shift Officer J. Dear and Valley graveyard shift Officer J. McDonnell located the offender. The property was tracked and Officer Dear observed a subject hiding the item in a back bedroom through an open sliding door. Detectives contacted four subjects inside the apartment. One of the men was arrested for commercial burglary and another was arrested for possession of methamphetamine.
- On August 21, the Southeast Impact Team conducted an operation at an apartment complex. Detectives located numerous amounts of heroin throughout the apartment as well as an extensive surveillance system. Five individuals were arrested on felony charges, and a felony arrest warrant was obtained for a sixth individual. One of the individuals arrested on felony charges was confirmed to have two felony warrants which were cleared.
- Officer J. Schwartz was dispatched to a

southeast location in reference to a possible subject burglarizing vehicles. Upon arrival, officers contacted the subject and placed him in custody. After interviewing the subject, officers were able to identify two other offenders who assisted with five burglaries, unlawful taking of motor vehicles, receiving/transferring stolen vehicles, and possession of stolen property.

- Officers Apodaca and Baca were dispatched to a domestic violence situation where a daughter had choked her mother with a phone charger. The mother told officers that she had difficulty breathing and she had deep bruises on her neck from the constriction. The daughter was taken into custody without incident and charged with aggravated battery on a household member.

Foothills Area Command...

- Team 1 officers conducted several field briefings in the area of Beat 531. Officers continued to concentrate on quality of life issues such as graffiti, vandalism, inoperable vehicles, and abandoned/vacant houses.
- The Singing Arrow Community Center held an officer appreciation cookout for the Foothills Area Command officers and civilians.
- Officer M. Aragon, along with CACU detectives, arrested a juvenile who was sexually assaulting his younger sister.
- Officer T. Benavidez completed 22 felony arrests in August. Officer T. Benavidez recovered five stolen vehicles along with five in-custody suspects. The subjects arrested for receiving and transferring were known property crime offenders in the Foothills. Several of the recovered vehicles had stolen property and burglary tools inside.
- On August 5, Officer H. Gunderson responded to a suspicious situation at an apartment complex. Officer Gunderson found an excessive amount of blood near an empty apartment. Officer Gunderson followed a significant blood trail to an injured male subject. The injured subject was severely intoxicated and had a large laceration needing medical attention.
- On August 13, Officer C. Souers responded to a disturbance call and made a felony arrest for kidnapping, robbery, and aggravated assault with a deadly weapon.
- Officer J. Meyer responded to an Bomb Squad call-out at the Mayor's Office. A suitcase was dropped off by a suspicious individual at the front desk of the Mayor's Office. Officer Meyer,

along with the rest of the Bomb Squad, Mayor's Detail, and the Tactical Commander rendered the suspicious package safe.

- Foothills Team 3 personnel responded to a domestic violence call resulting in a SWAT activation at an apartment complex. The SWAT activation resulted in the arrest of a domestic violence offender for aggravated battery on a household member, kidnapping, and aggravated assault with a deadly weapon. Bomb Squad personnel were also on-site and rendered safe bomb making material located in the apartment.
- On August 14, Officer Altman observed a man attempting to enter numerous cars in a Northeast Heights parking lot. Officer Altman contacted the man and subsequently arrested him for outstanding warrants.
- On August 16, officers were dispatched to Coronado Mall in reference to a domestic violence call. Upon arrival, officers contacted a female who had bruises and swelling to her face. The woman advised that she, her boyfriend, and his other girlfriend, had been staying with two females at an apartment complex. The female and male were involved in an argument, during which time the male struck the female twice in her face with his hand. The offender's violence escalated when he used a handgun to strike her in the face. The victim advised she was in fear of being shot by the offender. The offender pointed the gun at both the victim and another woman. The offender prevented the females from leaving for several hours. The two women were eventually able to escape, at which time they contacted police. Foothills Impact Detective J. Jones responded and assumed case responsibility. An arrest warrant for the offender and a search warrant for the apartment were prepared. SWAT was called and the offender was subsequently arrested on the charges of two counts of kidnapping, aggravated battery against a household member with a deadly weapon, and aggravated assault against a household member with a deadly weapon.
- On August 27, Officers J. Allred and C. Maxon were on bike patrol in the parking lot of a large retailer when they observed a hand-to-hand drug deal. While on their bikes, officers were able to stop a vehicle that attempted to flee from them. The officers took two subjects into custody and recovered 22 grams of heroin. Both subjects were placed under arrest.

Valley Area Command...

- On August 14, officers were dispatched to a southwest location in response to a shooting. Officers responded quickly and were able to get the victim (who had a gunshot wound to his chest) away from the scene and to a location where rescue could intervene. The offender was taken into custody without incident. The Valley Impact Team assisted in the investigation. The offender was charged and booked on a count of aggravated battery on a household member. The victim did not sustain life threatening injuries.
- On August 21, Sergeant Carr initiated a traffic stop on an erratic driver. The subject was arrested for aggravated DWI 3rd offense and driving with a revoked license.
- On July 2, Officers B. Melendrez and H. Sennett responded to a call for service near 4th and Central in regard to a battery. Officers proceeded to make contact with the victim, who was bleeding from his mouth and was disoriented. The victim advised that he was involved in a verbal altercation with another male and female over the female demanding that he give her his phone. When the victim refused, the other male blind-sided him with a punch to his face which knocked him to the ground. The subjects then fled the area and the victim was transported to the hospital. The following week, Officer Melendrez was contacted by another officer who advised that they were dispatched to the hospital due to the victim's injuries being more serious. According to the medical staff, the victim had sustained several fractures in his jaw and orbital bones which required him to have surgery to repair the damage. Officers Melendrez and Sennett proceeded to follow up on the case and found that it was possibly the same subject involved in similar incidents where the subject would ask to borrow a phone and charge the victim if they wanted it returned. The officers forwarded their findings to the Valley Impact Unit which was later able to identify the offender. An arrest warrant was later issued and the offender was booked on August 12 on a \$75,000 bond.
- Officer B. Melendrez responded to a domestic violence call. Upon making contact with a participant, officers determined that he was under the influence of some form of narcotic. A check through NCIC revealed that the subject was also on probation for a previous incident. Contact was made with the subject's probation

officer and he was remanded into custody on a felony charge for probation violation.

- Officer H. Sennet responded to a traffic accident at Broadway and Lead involving two vehicles. According to the call, a vehicle was traveling eastbound in a westbound lane of traffic and ran a red light, colliding with another vehicle. Upon arrival to the area, officers determined that three subjects had serious injuries. A full fatal call out was conducted and the Motors Unit responded to the scene. The driver of the offending vehicle was found to be highly intoxicated and later booked into the MDC. One of the victims later died at the hospital due to the injuries sustained in the collision.
- On August 8, Officer M. Elrick arrested a man who had brandished a weapon and robbed a subject. Officers J. Armijo and J. Quade assisted Officer Elrick in apprehending the suspect. The suspect had reached for a weapon as Officer Elrick tased him. The suspect later advised the officers that he wanted to pull his gun out and have officers on scene shoot him. Their action led to the apprehension of a dangerous offender before a deadly force situation was necessary.
- Officer M. Hannum was dispatched to a call where a baby was not breathing. Once on scene, he noticed that the father was acting suspiciously. The baby was transported to UNMH where it was discovered that he had bleeding on the brain and other injuries. Officer Hannum called CACU detectives who came to the scene. During the course of their investigation, it was discovered that the father had been abusing the baby. The case resulted in a felony arrest of the father.

Southwest Area Command...

- On August 7, Officer Llamas responded to a domestic violence call. Officer Llamas made contact with the victim and she had been beaten severely and held against her will. Officer Llamas was able to locate the male offender and arrest him for felony domestic violence charges including kidnapping and aggravated battery on a household member.
- On August 8, Officer Chacon was dispatched to a southwest location. Officer Chacon made contact with a subject. Upon investigation, it was determined that the individual had a felony warrant for violating conditions of release and was arrested and taken to the MDC.
- On August 30, Officers Bailey and Vallejos

conducted a follow up investigation regarding a residential burglary. Through that investigation, they were able to identify several offenders and take them into custody. They were also able to retrieve most of the property that was taken from the victim which included three laptops, a game console and several pieces of jewelry.

- Officer Romero conducted a school zone tactical plan at Valle Vista Elementary in reference to parents stopping outside of school and causing traffic problems by blocking access to residents in the area. Officer Romero made contact with the school's principal in reference to the problem. The principal advised Officer Romero that she would be sending out a newsletter to parents to remind them to drop off students in the designated location.
- On August 11, Officers L. Monte, K. Maes, and H. Landavazo made a felony arrest on a federal probation violation from the U.S. Marshals. The warrant was designated as "no bond". Officer L. Monte was patrolling the Central and Coors corridor and located a suspicious vehicle. A history of the license plate was obtained and it was determined that the driver of the vehicle had fled from a vehicle crash in the southeast two months prior. The call provided personal information and physical descriptors for the subject driving the vehicle. Officer L. Monte determined that the driver of the vehicle was the same individual that escaped from officers. Officer L. Monte advised responding units about the circumstances and the individual was taken into custody without incident.
- On August 25, Officer F. Duran was on his way to briefing and was in the area of Coors Blvd. NW and Hanover Rd. Officer Duran observed a vehicle leave an exit of a gas station at a high rate of speed. The vehicle pulled out directly in front of several vehicles, including Officer Duran's. Officer Duran engaged his emergency equipment to conduct a traffic stop with the listed vehicle. Officer Duran noticed the license plate was partially covered by a piece of paper. Several other officers were in the area and arrived quickly. As Officer Duran approached the vehicle, he observed a female employee of the gas station standing on the median. The employee told Officer Duran the occupants in the vehicle had just done a "beer run." When Officer Duran made contact with the driver, he observed two 30 packs of beer on the front passenger floor board. The driver and

the passenger were taken into custody without incident. The two men were charged with embezzlement of a motor vehicle, shoplifting, and reckless driving.

- On August 28, officers were dispatched to a large retailer in reference to a shoplifting call where the suspect was armed with a weapon. When officers arrived, they took the suspect into custody. During their investigation, the suspect advised officers that her 10-year-old son ran out of the store when she was detained by loss prevention staff. Officers were dispatched to the area to attempt to locate the missing child. The child was located at a relative's house. The suspect was found to have criminally trespassed at the store and was arrested for commercial burglary. When the suspect's purse was searched, a pill bottle containing about 10 individually packaged pieces of crack cocaine was located.

Northwest Area Command...

- Officers conducted a tactical plan at a large retailer due to thefts and burglaries, resulting in two misdemeanor arrests and four criminal trespass citations.
- Utilizing historical data, all Watch II officers dedicated much of August ensuring safety at all of the schools in the area command. Numerous tactical plans and high visibility patrols were conducted.
- On August 3, Officer H. Alvidrez responded to a domestic violence incident involving a mother and her son. The son had left the residence prior to police arrival. Officer Alvidrez received a description of the event from the mother and generated a report. Hours later, the mother called back to say her son had returned. Officer Alvidrez responded to the home and arrested the suspect on an outstanding felony warrant.
- On August 5, Officers M. Acata and B. Paige responded to a residential burglary in progress call. The officers set up a perimeter on the house and took two offenders exiting through a back window into custody. All stolen property was recovered and the offender's vehicle was impounded.
- On August 7, Officer M. Acata responded to a call regarding a metal theft. Upon arrival, the offenders were not located, but Officer Acata did note what appeared to be two homeless males on the property. The property manager asked Officer Acata to remove the two males, citing

posted "no trespassing" signs on her property. Officer Acata noted that one of the males had a syringe sticking in his arm. When Officer Acata approached, the male tried to throw it away. One of the men was arrested for possession of heroin and another was arrested on two misdemeanor warrants.

- On August 10, Officers L. Borunda and M. Acata were dispatched to a northwest location regarding a report that a vehicle was erratically chasing another. Officers located both vehicles and several individuals who had been involved in a domestic-related physical altercation. The event resulted in the car chase and criminal damage to the vehicles. After interviewing all participants, the officers arrested a female on charges including felony criminal damage to property and aggravated assault involving a motor vehicle.
- On August 18, Officers L. Borunda and B. Paige responded to a northwest location as a follow up to a felony domestic violence report Officer G. Ronzone took earlier. Officers located the offender still inside the victim's apartment. Based on the victim's statement to Officer Ronzone, the male was taken into custody and arrested on felony domestic violence and false imprisonment charges.
- The Northwest Impact Team conducted an auto burglary tactical plan in the Coors/I-40 corridor. Utilizing Smart Policing Division data and analysis, detectives conducted surveillance in the area of concern and noticed a suspicious vehicle. Detectives followed the vehicle to a large retailer in the area. Detectives contacted the occupants. A NCIC check revealed both subjects were wanted on felony property crimes. An inventory check of their vehicle revealed several burglary tools and a fresh cut out ignition switch to a vehicle. The Northwest Impact Team sent all of the information to the Auto Theft Unit for a follow up investigation.
- The Northwest Impact Team served a search warrant at a southwest location and recovered a stolen dismantled motorcycle engine. Detectives conducted an interview with the offender, who admitted the engine was stolen and planned on reselling it. The offender was arrested and charged with possession of stolen property.
- On August 12, Officer Hardy responded to call at a northwest location in response to a suspicious person. Upon arrival, he assisted security to identify a subject who also was

shoplifting. The subject was found to have an outstanding felony warrant and was placed into custody. While escorting the subject to his car, the subject broke away and a foot chase ensued. With the assistance of fellow officers and a K9 unit, a perimeter was quickly established and the subject was found hiding in a drainage culvert. The subject was booked on his felony warrant and an additional escape from custody felony charge.

- Officer B. Calt initiated a tactical plan specific that targeted a local grocery store. The focus of his effort was to combat the problem of increasingly frequent trespassers and panhandlers that had been harassing the store's customers in the area. His efforts resulted in 16 contacts with suspicious subjects, three of which had misdemeanor warrants. He issued 16 criminal trespass notifications and completed five arrests.

Northeast Area Command...

- On August 21, Officer Casias was dispatched to a northeast location in response to a disturbance on a City bus. Officer Casias contacted the subjects that were involved and determined that the male subject physically abused a child. The Crimes Against Children Unit was called out and took over the investigation.
- Team 3 officers worked with Game and Fish officers in the tracking and apprehension of a large female bear running through the Tanoan community and nearby residential areas. After approximately two hours, a solid perimeter was secured and the animal was safely taken by Game and Fish personnel without incident.
- Detective Gerald Roach cleared nine cases from a stolen purse ring throughout the city. The suspects injured two people in the process. All offenders were charged accordingly.
- The Northeast Impact team assisted the Organized Crime Unit with a tactical plan at the Coronado Mall. The plan yielded 30 arrests and involved 12 hours of surveillance in a two day period.
- Officer Sprague was dispatched to a larceny call at a northeast hotel where the offenders had taken televisions and other valuable items from several rooms. Through his follow-up investigation, Officer Sprague learned that the offenders were staying at another hotel. Officer Sprague quickly located the offenders at that hotel with the stolen items. In addition, his investigation led to the seizure of over 100 grams of methamphetamine with a street value over \$11,000, along with numerous stolen identification cards, stolen property, and deadly weapons.
- On August 25, Officers Munoz and Poccia were dispatched to a northeast location in response to a call regarding a purse snatching where a bystander had held the offender down. Officers arrived on scene and detained a teenager. The offender stated that he was at a park in the area of Corona and Wyoming when he was contacted by another male who told the offender that he had to steal a purse for him or he would hurt him. The offender gave officers a description of the other male. As they were talking to the purse snatcher, a vehicle drove near the officers. The male driving the vehicle matched the description of the offender. The vehicle was stopped and three occupants were taken into custody. All of the subjects were taken to the Northeast Substation were interviewed by Detective Sweitzer and Officer Munoz. The ringleader was arrested for extortion and contributing to the delinquency of a minor.
- Officer A. Garcia assisted Officer J. Stout with a vehicle crash, possibly involving a drunk driver. A male had rear-ended another vehicle. A two-year-old child was discovered not to be restrained at the time of the collision. Officers were able to determine this by locating the child's car seat in the trunk of the vehicle. The child was unhurt during the collision, but the male could not give a reason to why the child was not properly restrained. The male blew a .20 blood alcohol content and did not have a valid driver's license. The male was charged with felony child abuse.
- On August 12, Officers Cervantes and Danius were dispatched to a northeast motel in response to an armed robbery. Upon arrival, they made contact with a victim. The victim stated that a male subject in a room at the motel had threatened her with a knife and taken her New Mexico identification card. Officers approached the back of the motel, during which time they observed the male offender. The offender saw officers and ran. Officers Cervantes and Danius captured the suspect in the arroyo west of the motel, during which time he was placed in custody. The victim's identification card and a knife were found in the suspect's pockets. The offender was arrested for robbery and evading/

eluding police on foot. Robbery Unit detectives were contacted and took over the investigation.

Investigative Bureau

Scientific Evidence Division...

- The Major Crime Scene Team responded to five call outs in August.
- The Field Investigator Unit responded to 1,327 calls, wrote 1,202 reports, and collected 1,246 latent fingerprint cards during August.
- The New Mexico DNA Identification System (NMDIS), received 1,019 new convicted offender/arrestee DNA samples in August, with a cumulative total of over 92,000 collected. 973 samples were analyzed, data uploaded and searched in CODIS, with a cumulative total of over 86,600 searchable DNA profiles. As a result of these convicted offender/arrestee samples, 33 unsolved cases were matched to convicted offenders/arrestees, three case-to-case matches were made, with a resulting total of 34 investigations being aided.
- The Latent Unit amassed 378 AFIS entries in August, with 156 of them being hits. Out of 645 latents examined, 309 were identified.
- The Firearm Unit conducted an in-depth shooting reconstruction of an APD officer involved shooting.
- The Alcohol Unit began a process to integrate upgraded Intoxilyzer 8000s into APD substations.
- In August, Identification Technicians and 1 rehire officer supported the following backgrounds: 82 case dispositions; 64 employment; 28 firearms; 89 FBI and 26 CODIS requests. 260 RAPs and photos were distributed; 27 new APD applicants were fingerprinted; 1,541 fingerprints were classified in AFIS; and 2,346 new and old arrests were processed into the Tiburon criminal history record.
- In August, Evidence Technicians and one rehire officer received 4,300 evidence items, duplicated 1,695 audio/video recordings and supported 49 pretrial viewings. Efforts to reduce inventory resulted in 407 items returned to owners, 2,495 items disposed, and \$1,441.37 was recovered from auction income. Staff processed 4,747 case disposition transactions into the evidence history.

Property Crimes Division...

- On August 7, the Auto Theft Unit conducted

a patrol in the Southeast Area Command and located a vehicle traveling west on Gibson Boulevard from San Pedro SE. A check through NCIC revealed that the vehicle was stolen. Detectives followed the vehicle and relayed its location to Air 1. Air 1 followed the vehicle to a location where the occupants exited the vehicle and fled on foot. Auto Theft Unit detectives, along with members of the K9 Unit and NITE detectives, were able to take all the subjects into custody without incident. Four subjects were identified and booked into the MDC. A male admitted to the theft of the vehicle and was also found to have six felony warrants for his arrest.

- On August 21, Auto Theft Unit detectives located a stolen SUV traveling north on Coors Boulevard from Central Avenue. Detectives were unable to get the vehicle to stop as it fled the area. An attempt to locate was placed on the vehicle. On August 22, Officer J. Garcia contacted detectives and advised he found the vehicle at a northwest location. Detectives arrived in the area and established surveillance. A short time later, a male and female entered the stolen vehicle and attempted to drive away. Detectives were able to stop the vehicle and take both subjects into custody. Both offenders were booked into the MDC.
- On August 14, the Auto Theft Unit was called to assist with a recovered stolen vehicle. Officer Stockton had responded to a report of a vehicle theft. When he arrived, he located the stolen vehicle and attempted to stop it. The vehicle fled and struck a vehicle as it left the scene. The vehicle was later found abandoned at a southeast location. Detectives later identified the driver. On August 15, Auto Theft Unit detectives were able to locate the suspect nearby. The Auto Theft Unit, along with NITE Detectives, set up surveillance and the suspect was taken into custody. The suspect admitted to driving the stolen vehicle and he was also found to have two felony warrants for his arrest.
- The Auto Theft Unit conducted three VIN etchings in August. A total of 364 vehicles were etched during these three events.
- Two men were arrested for residential burglary after they forced entry into a home that was occupied. The occupant notified police of the situation via telephone while remaining undetected and the two men were arrested upon exiting the house. Over \$2,000 in property was recovered.

- A male was arrested for residential burglary after witnesses identified him as one of three offenders involved in burglarizing a house. Forced entry was observed and the suspects attempted to flee in a vehicle. Officers located the suspect vehicle with the help of witnesses nearby and attempted to pull it over, at which time the male fled on foot. He was ultimately apprehended. The male is a known residential burglar.
- Two suspects were arrested for residential burglary after information obtained from witnesses identified them as the offenders that burglarized a house. One of the men attempted to flee on foot but was apprehended by officers on scene. The other male attempted to flee in a vehicle but was apprehended by officers on scene. The driver was also found to have an outstanding warrant for residential burglary. All property, totaling over \$3,000, was recovered.
- Five additional offenders were identified in a major burglary ring case. The case cleared 39 residential burglaries that occurred in the Southeast and Southwest Area Commands. Two of the men in the ring signed plea agreements, agreeing to testify against the other offenders in the case. The case was turned over to the Assistant District Attorney who advised that she would be setting the case up for a Grand Jury as soon as possible.
- On August 21, Burglary Unit detectives received an email from a representative with Lojack for Laptops. The email stated that a suspect was possibly in possession of a stolen laptop. Unit detectives were able to contact the suspect who advised that she had purchased the laptop from a local pawn shop and agreed to meet with detectives to return the laptop. On August 27, Unit detectives contacted Detective V. Pacheco with the APD Pawn Unit and were able to recover the stolen laptop from the woman at the pawn shop. Unit detectives arranged to return the stolen laptop to the victim.
- Officers were able to take two of the four offenders into custody during a burglary at a northeast location. The two in custody were an adult and a juvenile. During interviews, Unit detectives were able to positively identify another juvenile. The juvenile was on probation for burglary as well as other charges. After talking to his Probation Officer, his probation was revoked, a warrant issued, and the Chief Probation Officer's recommendation to the court was that he does two years in the Juvenile Correctional Facility.
- A man was shot while entering a home at a northwest location and was transported to the intensive care unit at UNMH. He will be booked into the MDC upon his release from the hospital. A felony warrant was written for his wife who was also at the scene, but fled prior to the arrival of officers. She is still currently outstanding.
- On August 7, two males and a female broke into a bait car. They stole City property and were tracked and located as they continued to drive around the Southwest Area Command. Detectives followed them into a dead end street and took the subjects into custody. A search warrant was written to recover the City property from the vehicle they were driving.
- On August 12, two men broke into an APD bait car at and stole APD property. As detectives were en route to track the property, the two men stopped at a northeast location and committed another automobile burglary. The vehicle they were driving was tracked by NITe detectives and Officers J. Dear and J. McDonald. The vehicle was stopped near Chico and Eubank Boulevard. Both subjects admitted to both auto burglaries.
- On August 11, a bait car was broken into at a southeast location. A suspect was identified. The suspect then went to another location and broke into another car before NITe detectives were able to track and locate him. Detectives were able to arrest him and charge him with both auto burglaries.
- On August 14, NITe detectives responded to assist with a stabbing call at a large northeast retailer. Detectives set up surveillance on the suspect's house, and later observed him there. He was there for a few minutes, then left. Detectives followed him until it was safe to do a felony stop, at which point he was taken into custody. The case was turned over to Homicide Unit detectives.
- Detectives from the Organized Crime Unit, Pawn Shop, Burglary, Auto Theft and Northeast Impact initiated and conducted a three day Organized Retail Crime Tactical Plan at the Coronado Mall. Detectives also worked with private sector partner loss prevention specialists. The tactical plan resulted in four felony arrests, eight misdemeanor arrests, the clearance of ten misdemeanor warrants and one felony warrant. Recovered property was valued at approximately \$1,500.

- OCU detectives were called out to a hotel in the area of University and Menaul Boulevards in reference to suspicious activity in one of the hotel rooms. OCU detectives contacted the occupants. Also present was a sixteen year old female. Detectives learned that the subjects were involved in prostitution-related activities. One of the occupants was arrested on an outstanding felony warrant. Vice Unit detectives and Probation and Parole officers were called out to the scene. Vice Unit detectives assumed responsibility for the investigation for possible human trafficking.
- Working with the FISOA partnership, OCU detectives were able to identify two females, who were “washing” checks and subsequently cashing them at financial institutions. They were working independently of each other. On June 19, one of the females cashed a fraudulent check at a credit union. On June 29, the other female cashed a fraudulent check at another credit union. OCU detectives assumed case responsibility, resulting in the submission and filing of an arrest warrant for both. On August 8, OCU detectives, with assistance from the Santa Fe Police Department, were able to locate and arrest both females at separate locations in Santa Fe.
- During a review of pawn transactions, Pawn Shop Detail detectives located and recovered a 55” television valued at approximately \$800 from a pawn shop. The television had been taken as part of a residential burglary which occurred on April 30. Detectives learned that a male and female had pawned the television without the knowledge or approval from the owner. An arrest warrant was filed and submitted for the pair.
- Pawn Shop Detail detectives recovered approximately \$1,400 in stolen property from a pawn shop. The property was taken during a larceny that occurred on June 20. Detectives were able to submit and file an arrest warrant for a female on charges of larceny, and receiving and transferring stolen property.
- On August 25, Detective Sandoval worked as a member of the Secret Service Task Force and completed an investigation that resulted in the seizure of a motorcycle valued at \$11,000.
- Between August 26-29, Detective Natewa assisted Captain Shaw from the Department of Veteran Affairs in an investigation of fraud. The suspect was able to hack into the victim’s

payroll account and transferred funds from two paychecks into a fraudulent account. The investigation led Captain Shaw to Albuquerque, NM. Detective Natewa assisted Captain Shaw with following up leads, conducting interviews, and assisting Captain Shaw with other investigative tools.

- On August 30, Detective Crawford acquired an arrest warrant for a suspect. The suspect obtained a New Mexico driver’s license using a fake name and Social Security number. The warrant was filed at the Bernalillo County Metropolitan Court.
- During August, the value of cases cleared by the White Collar Crime Unit was \$152,496.90.
- The Criminal Nuisance Abatement Unit posted 19 properties as substandard in August. CNAU identified 16 problem properties and visited 327 properties.

Criminal Investigations Division...

- The Homicide Unit responded to five call outs in August. Of the five, three were homicides and two were major cases. This brings the total number of UCR homicides in Albuquerque to 24 through the end of August. Twenty-two of these were adult homicides and two were CACU homicides from 2012 that became homicide cases for 2013 from the resultant investigation. The total amount of police actions for 2013 is four. The Unit currently has 17 active cases.
- The Armed Robbery Unit responded to nine robbery call outs, and cleared 21 cases in August. Six cases were sent to the District Attorney’s Office for prosecution. Unit detectives completed 11 arrests, wrote one arrest warrant and served four search warrants. The Robbery Unit had 37 new cases assigned in August and has 101 active cases.
- The Robbery Unit worked citywide robbery tactical plans, focusing on serial robbery offenders. The unit completed over 200 hours of surveillance in response to the serial ATM robber.
- The Sex Crimes Unit responded to three sex crimes call-outs in August, cleared 26 cases, and sent 12 of the cases to the District Attorney’s Office for prosecution. There were 26 new cases assigned in August. The Unit currently has 81 active cases.
- The FASTT Unit cleared 23 cases in August. FASTT Detectives reviewed 209 cases in August. The Unit generated 26 cases and made

two in-custody arrests. The Unit also worked a joint tactical plan with Probation and Parole officers that resulted in the clearance of five warrants, four of which were felony warrants. The Unit has nine active cases.

- There were 109 new runaways/missing persons reported to the Missing Persons Unit in August. The Unit cleared 111 total cold case / runaways / missing person cases. The Unit currently has 106 active cases.
- 721 CYFD referrals were received in August. Average is approximately 800 per month. CACU detectives were assigned 92 new cases to be investigated.
- Detective Walsh assisted the BCSO SORT Unit with a search warrant. Walsh also assisted HSI on a search warrant and federal arrest in Rio Rancho. Detective Walsh went to trial on a solicitation arrest and the suspect was found guilty on all charges, setting a great precedent for future solicitation cases.
- Officers from both Eastside and Westside SRO Units were assigned to provide law enforcement duties as well as traffic control during the first six games (three days) of the Community Stadium opening. Officers identified problem areas and devised a traffic control plan for future activities at the stadium. In addition, officers made three arrests, including the arrest of an offender who was using heroin in the parking lot. The individual was determined to have two warrants for his arrest and was in the possession of a loaded firearm.
- Former COAST Specialist Joe Chavez was recognized for his great work by receiving the Mayor's Hero of the Week award for work he did with a family in their time of need.

Special Investigations Division...

- Intelligence Unit detectives fabricated technical equipment to assist the Northwest Impact Team with electronic surveillance. The electronic surveillance was monitored by the Intel Unit all month long. The Unit also assisted other units within SID and the department with court ordered surveillances and monitoring.
- There was a shoot out involving outlaw motorcycle gangs that resulted in two individuals being shot (one of which was killed). The Intel Unit reached out to other departments across the country in order to further the investigation. Unit detectives spent most of August monitoring the potential for retaliation

and monitored the safety of the funeral service attendees. The Unit conducted several briefings to law enforcement agencies and a coalition of chiefs of police and city mayors/commissioners.

- The Intel Unit assisted the Gang Unit and Narcotics Section several times with the setup and monitoring of technical equipment during undercover operations. Unit detectives also assisted other units in the surveillance of a homicide offender and several other felony cases.
- The Intel Unit conducted an investigation into a death threat to a high-profile citizen in Albuquerque. The investigation took a week and it was determined that the death threat was unsubstantiated.
- On August 1, the ROP Unit located a suspect who was wanted for an outstanding felony warrant for aggravated assault. The suspect was also known to be armed. He was taken into custody without incident and his vehicle was sealed for a pending search warrant. The vehicle was later searched and found to contain a handgun. The suspect is a convicted felon.
- On August 12, ROP Unit detectives responded to a call for service in the Southeast Area Command. The call was related to an individual armed with a handgun at a local pharmacy. The armed individual had threatened store employees. The male subject fled to a nearby church. ROP Unit detectives, SWAT and Field Services officers were able to safely put a nearby school on lock down. The offender was taken into custody without incident when he exited the church. His vehicle was sealed for a pending search warrant. The man was arrested on aggravated assault charges. His vehicle was later searched pursuant to a search warrant and a handgun was located.
- On August 13, ROP Unit detectives responded to a violent crimes call out at a northeast location. While responding, ROP Unit detectives assisted field officers with a felony stop in the area of Eubank and Constitution NE. The suspects were taken into custody and turned over to Violent Crimes detectives. Both vehicles being used by the suspects were sealed for a search warrant.
- On August 16, ROP Unit detectives located a vehicle in the area of Sage and Coors. The vehicle was displaying a stolen license plate. The vehicle was followed to a residence where the occupants of the vehicle were contacted by officers. Three adult occupants were located

in the vehicle along with a two-month-old child. The vehicle was determined to have been altered, and was reported as stolen. Syringes and methamphetamine were also located in the vehicle. One of the occupants was found to have a felony warrant for their arrest. All three occupants were arrested.

- On August 26, ROP Unit detectives located a male who was known to have an outstanding felony warrant for his arrest. The male was taken into custody without incident.
- On August 29, ROP Unit detectives were contacted by Valley Area Command field officers in reference to a possible stolen vehicle in the area of 4th Street NW. ROP Unit detectives established surveillance and confirmed a stolen pickup at the location that had been taken from Los Lunas, NM. The residents of the location were contacted. The suspect was found to have a felony warrant for his arrest. A female at the location was found to have a misdemeanor warrant and was arrested for receiving/transmitting a stolen motor vehicle.
- On August 30, ROP Unit detectives assisted with a call in the Foothills Area Command in regards to a stolen vehicle. A finance company called in the location of a stolen vehicle in the area of Central and Dorado SE. The vehicle was located; however, at the time it could not be confirmed as stolen. ROP Unit detectives followed the vehicle with the assistance of Air Support. A felony stop was attempted by Foothills Area Command field officers and the vehicle fled the area. Field Services units immediately disengaged. ROP Unit detectives and Air Support continued to monitor the vehicle's location and it was eventually abandoned. Both offenders were arrested by ROP Unit detectives and Foothills Area Command officers.
- On August 10, Gang Unit detectives responded to a homicide call out. Through a joint investigation between Homicide Unit detectives and Gang Unit detectives, the offender was identified. A warrant was issued, and Gang Unit detectives located the suspect in Sacramento, CA. The suspect was taken into custody with the assistance of U.S. Marshals.
- On August 10, Gang Unit detectives responded to a homicide call out at a jewelry buyer. Homicide and Gang Unit detectives identified the suspect. Within hours of the warrant being issued, the suspect was taken into custody

without incident.

- Also on August 10, Gang Unit detectives responded to an attempted murder of a female. A suspect was identified as the offender and a warrant was issued. The suspect is a known gang member. Detectives received information that the suspect was staying at a local hotel. Detectives set up surveillance and positively identified the suspect as he attempted to leave the hotel. He was taken into custody without incident.
- On August 13, Gang Unit detectives arrested a suspect without incident in connection with a homicide that occurred on April 30. The suspect had a warrant for an open count of murder, trafficking a controlled substance, conspiracy, tampering with evidence, and unlawful taking of a motor vehicle.
- During August, Vice Unit detectives completed 20 felony arrests; located 21 felony warrants; made 23 misdemeanor arrests; located 14 misdemeanor warrants; and made 18 prostitution arrests. The Unit also conducted 40 undercover operations through the city, resulting in numerous arrests.
- On August 29, the Vice Unit received a complaint from the City Council regarding illegal activity occurring in a massage parlor. Detectives from the Unit investigated the complaint. After conducting several undercover operations at the massage parlor, detectives were able to permanently shut the establishment down.
- The DEA Task Force conducted a knock and talk in Santa Fe. During the encounter, a consent to search was granted. During the search, 60 kilos of marijuana was seized along with \$52,000 of grow equipment.
- The DEA Task Force conducted a search warrant and two arrest warrants in reference a spice shop in Rio Rancho. The owner was indicted, 20 pounds of spice was seized, along with \$106,000 cash.
- DEA Task Force officers Lopez and Garcia seized three kilos of cocaine and arrested two suspects. One of the suspects was wanted for a homicide in Georgia.
- DEA Task Force officers Lopez assisted on a search warrant where 118 pounds of marijuana was seized.
- Homeland Security Investigation Task Force Officers Irwin and Sinclair handled a controlled delivery in Socorro County, resulting in two

pounds of methamphetamine and a truck being seized. Irwin also assisted U.S. Postal Inspectors in checking a flagged package. Four pounds of marijuana was seized.

- Task Force Officers seized three pounds of GBL, a precursor for the drug Ecstasy.
- Task Force Officer Walsh conducted several narcotics interdiction operations at the Greyhound Bus Station/Amtrak Train station resulting in the seizure of \$49,040.

Chief's Staff

Communications Division...

- The APD 911 Communications Center staff answered 74,724 incoming 911 and 242-COPS calls in August. There were 28,880 calls answered for 911 and 45,844 calls answered for 242-COPS. 911 Operators answered 88.83% of the 911 calls within 10 seconds (the national standard is 90%; APD's standard is 92.0%); operators also answered 93.45% of the 242-COPS calls within 30 seconds (APD's goal is 90% answered within 30 seconds).
- On August 8, the Communications Center Administrators attended a Cassidian Product Showcase Day. The showcase was designed for stakeholders who are part of the emergency communications organizations within local communities to see first-hand the latest technologies available, including mobile radio infrastructure, NG 9-1-1 call taking system, LTE push-to-talk capability and several radio console solutions.
- Several Communications employees attended the initial new feature walkthrough of the Tiburon CAD system the week of August 12, in anticipation of the software/hardware upgrade scheduled for December 2013.
- A Power of Positive Confrontation seminar was held at the APD Academy on August 15 and 16 for all civilian APD supervisory and management personnel. All 911 Communications Center supervisors and management staff attended the seminar conducted by Barbara Pachter, a nationally renowned keynote speaker and author.
- An APD 911 Communications administrator participated in the Leadership in Police Organizations course the week of August 19, the first of the three week long training.
- A much needed remodel of the second floor kitchen was completed at the Communications

Center for a deserving staff of over 130 employees. The remodel included freshly painted walls and the replacement of old cabinets, appliances and counters.

- On August 28, APD 911 Communications hosted the quarterly NMAC 911 Directors Affiliate Board Meeting. The agenda included a PSAP annual report recap, updates, and planning for 2014 and beyond.

Planning and Policy Division...

- Division staff met with the FBI and on-call contractor representatives to discuss the installation a microwave tower that will improve communications between the FBI and the Real Time Crime Center.
- The Old Main third floor break room construction was begun in August. The half wall was completed, as well as new flooring. A janitor closet was converted to a small kitchen area.
- Division staff formed a committee to help with the implementation of the Limited English Proficiency (LEP) requirements. The LEP recommendations from the USDOJ will impact many facets of APD operations.
- Division staff from Planning and Smart Policing submitted the development of the Real Time Crime Center for consideration by the International Association of Law Enforcement Planners for Project of the Year.
- Staff from the Planning Section and the Inspections/Accreditation Unit have contacted the other neighboring law enforcement agencies about co-hosting the Commission on Accreditation for Law Enforcement Agencies (CALEA) conference, slated for November 2014. The Bernalillo County Sheriff's Office, New Mexico State Police, and Farmington Police Department have all pledged to help and participate in the conference.

Support Services Bureau

APD Academy...

- The Advanced Training Unit is a quarter of the way through Phase II MOE. The classes being taught this cycle are Taser Refresher, Excited Delirium, Open/Concealed Carry, and Emergency Medical Care. After reading the evaluations, staff are getting a high approval rating of the Carry and the Emergency Medicine class. These classes are extremely important because it can help reduce liability. Even better,

the knowledge can save lives.

- The 109th Cadet Class completed their 21st week of training in August. Cadets completed Phase Three of reality-based scenarios. Phase Three scenarios included domestic violence calls, disturbance calls, and traffic accidents. Cadets also utilized the Academy's firearms and training simulator during their scenario training. Class 109 completed 48 hours of emergency vehicle operations, which included eight hours of Safe Pursuit Act. They completed sixteen hours of crisis management training, which included eight hours of scenario training. Cadets completed one day of firearms training, and one day of defensive tactics training. Class 109 completed their DWI certification training, including certification on the IR8000 and Wet Lab testing.
- The physical training program for the 109th Cadet Class continued as 18 cadets scored in the 92nd percentile on their fourth physical training assessment. The Wellness Unit continued to work closely with Albuquerque Public Schools in implementing the PSA curriculum program within their educational system. The Wellness Unit also completed and submitted a new single standard physical fitness assessment for entrance into the Department.

Metro Traffic Division...

- The Traffic Unit issued 2,235 citations in August.
- The DWI Unit completed 213 DWI and three DRE arrest in August.
- The Seizure Unit confiscated 128 vehicles in August, totalling \$51,697.
- In August, the Motors Unit completed four misdemeanor arrests. The Unit issued 1,105 moving citations, including 73 for cell phone use while driving. The Unit conducted tactical plans in July that produced 288 citations.
- On August 7, Air 1 was requested to assist APD Auto Theft units who were following a stolen vehicle near Gibson/Yale. Air 1 observed a vehicle driving at a high rate of speed and intercepted it at Gibson and I-25. Air 1 continued to follow the vehicle and update its location as it drove through a residential area, running stop signs and red lights. The vehicle eventually drove to the Presbyterian Hospital parking lot, where it parked and four occupants exited the vehicle. Air 1 directed units to the front seat occupants, while the other two

occupants fled northbound on foot. They were later found by ground units. The stolen vehicle was recovered in the parking lot.

- Also on August 7, Air1 responded to the area of Isleta SW to assist BCSO Deputies in a search of a subject who fled from a stolen vehicle. The subject was last seen southbound from the location. During a FLIR search of the area, Air1 located a subject hiding in a bush near the intersection of Isleta and Monique. Air1 directed deputies to the subject and he was detained without incident. The subject was identified as the offender.
- On August 9, Air1 overheard a unit advise of a motorcycle traveling eastbound on Interstate 40 near Interstate 25. The unit advised that the vehicle was traveling in excess of 100 mph. Air1 immediately observed the vehicle and started a tactical follow of the vehicle. The motorcycle proceeded southbound on Interstate 25 to the Lead/Coal exit still at a high rate of speed. The vehicle then exited and went through the area and eventually proceeded southbound on Broadway to Highway 147. The motorcycle then traveled westbound on Highway 147. The vehicle eventually came to a stop and the driver fled from the vehicle on foot. Units were directed to the location and the driver was eventually taken into custody. A Bernalillo County Sheriff's Deputy who observed the vehicle northbound on Coors near Rio Bravo, got it on radar at 125 mph and booked the driver on several misdemeanor charges.

Professional Standards Division...

- The Telephone Report Unit generated 538 reports and 178 supplemental reports, resulting in a savings of 1,817 hours of Field Services time and a savings of \$28,640.
- In addition, the Telephone Report Unit processed 419 on-line (Cop Logic) reports resulting in a savings of 1,089 hours of Field Services time and a savings of \$16,760.
- Year to date savings for 2013 on-line (Cop Logic) reports are 8,424 hours of Field Services time and a monetary savings of \$129,600.
- Court Services staff scheduled 135 pretrial hearings and processed 449 arraignments. Staff submitted 256 felony cases to the District Attorney's office for prosecution and submitted 343 summons to Metro Court.
- The Alarm Unit collected \$114,175 during August. The Alarm Unit prepared 14,916 pieces

of correspondence during August.

- Metro Court officers assisted 129 individuals who were remanded by the court and booked; and nine individuals who were remanded and assisted with bonding out. 26 individuals were booked with misdemeanor warrants; 58 individuals who were found to have misdemeanor warrants were assisted in bonding out; and 225 individuals were in police custody in August. Metro Court officers responded to 1,067 total calls for service in August.
- On August 21, Officers Garcia and Harvey participated in the "Homeless Court" program. Ten homeless defendants had their cases heard before Judge Valdez at St. Martins.

Homeland Security Division...

- The Office of Emergency Management continued to work with APD Planning to dispose of inactive grants from the administrative system and other grant reconciliation activities. Numerous planning meetings across the program initiatives and stakeholder cohort included the Local Emergency Planning Committee; the Metropolitan Medical Response System; the Community Emergency Response Team Program; and the Cities Readiness Initiative.
- Staff participated in an alternate EOC (A-EOC) facility readiness project in anticipation of an A-EOC Balloon Fiesta activation. The project will identify facility improvements necessary for a viable A-EOC.
- The OEM Director led an effort to develop a new City of Albuquerque Comprehensive Emergency Management Plan. The plan is expected to be completed within 90 days.
- The OEM Director participated in inter-agency coordination meetings with Sandia Labs, resulting in agreements for enhanced coordination and notification between respective EOCs.
- OEM staff participated in the power outage incident at the Presbyterian Healthcare facility on August 31.
- The Smart Policing Division continued its progress on the third phase of the Real Time Crime Center project in August, making major strides to add cameras in schools and to expand the real-time intelligence it provides to officers. The Video Unit played a key role in assisting the capture of a serial ATM bandit.
- The Crisis Intervention Team's case management system designed by the RTCC

grew to more than 1,200 cases.

- The Crime Analysis Unit played a key role in identifying serial pawnners with extensive criminal backgrounds.
- APD-TV produced and delivered 22 Daily 49's to officers and police personnel. In addition, it assisted detectives with enhancing, editing and copying more than ten surveillance videos; assisted five officers with lapel camera video issues; directed, filmed, and edited three training videos. APD-TV also participated in four weekend events, including Kutz 4 Kidz, the Westside community concert, the swearing in of the Chief and a mayoral press conference.
- Photographer Troy Simpson had produced several stories about a serial ATM robber who had victimized several people throughout the city. Troy had seen surveillance video so many times and had a good location of the suspect. On his way home from the RTCC, Troy stopped to fill up his gas tank when he recognized the suspect at the gas station, wrote down the license plate number, and immediately passed it on to his chain. It led to an arrest.
- The Video Unit met with St. Pius, Sandia Prep, Hope Christian Middle School and Hope Christian High School to participate in the RTCC video network. All of the schools have indicated they want to participate. The schools have already reached out to vendors to purchase equipment. In August, the RTCC worked to get cameras installed at the State Fair. The cameras will be operational in time for Fair and will be accessible in the RTCC Video Trailer. New Alvarado Transportation Center cameras are online and will be accessible in the RTCC. The project included 30 cameras in and around First Street and Central Avenue to Silver.
- APD finished in the top twenty percent for the POP Goldstein Award. It is the first time APD got that far for this particular award.
- Operators in the bridge were active in 550 calls for service in August and in more than 70 percent of the calls, the RTCC communicated vital information to the officers. In addition, there were 32 requests for video from the APD Video Network and operators were monitoring the air for more than 910 hours. In those calls, the CIT case management system was checked 61 percent of the time. Domestic violence calls accounted for 20 percent of the bridge's activity in August.
- On August 14, Officer R. Garza was working in the Northeast Area Command when he assisted in a stabbing call at a large retailer. The male offender had fled south on Carlisle towards Menaul on foot

and was spotted getting into a pickup truck. Witnesses were able to get a plate number. Officer Garza cross-referenced it to a motor vehicles database and cross referenced it with MDC records. Officer Garza located a picture of the offender, and sent it to field officers who then able to recognize and locate the suspect.

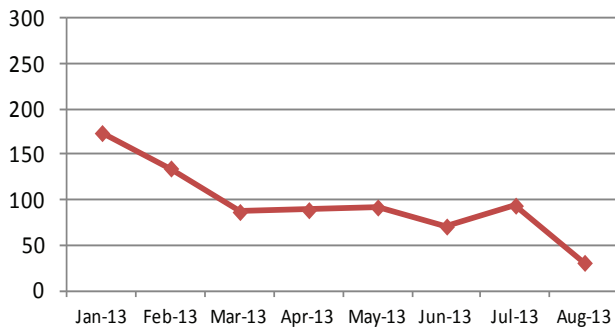
Special Operations Division...

- In August, APD's Bomb Squad responded to nine total call outs. Two were SWAT support, and seven were EOD specific.
- On August 5, the Bomb Squad responded to a call at a northeast location. A male subject was being investigated by Narcotics Unit detectives, when they located numerous chemicals in his apartment. The Bomb Squad identified the chemicals as aluminum powder and potassium chlorate. They are both common chemicals to make homemade explosives. The chemicals were taken and destroyed.
- On August 8, the Bomb Squad provided robot support to APD's SWAT Team at a northeast location. A barricaded subject had been making suicidal threats and was on his bed under a blanket. The robot was able to reach in through the bedroom window and remove the blanket, thus exposing the subject. The action allowed the entry team to get information confirming that the subject was not holding a weapon in his hand. He was taken into custody within moments of entry.
- On August 9, the Bomb Squad responded to a suspicious package at the Mayor's Office. A woman placed a suitcase on the front desk and walked out. Bomb Techs took an x-ray of the suitcase and determined it to be empty.
- Also on August 9, the Bomb Squad responded to assist APD's SWAT Team with a barricaded subject wanted on felony charges. The subject made claims that he had explosives training and had placed devices in his yard. After the subject surrendered, the Bomb Squad placed a robot in through a window and cleared the house of any obvious booby traps that may have been placed. Once deemed safe for entry, the Bomb Squad made entry with SWAT and cleared the house. While inside, Bomb Techs saw evidence of homemade explosives throughout the home. Bomb Techs, along with ATF agents seized a homemade explosive powder that was sent to the ATF crime lab for testing. Two PVC pipe bombs were also seized. Items also located were

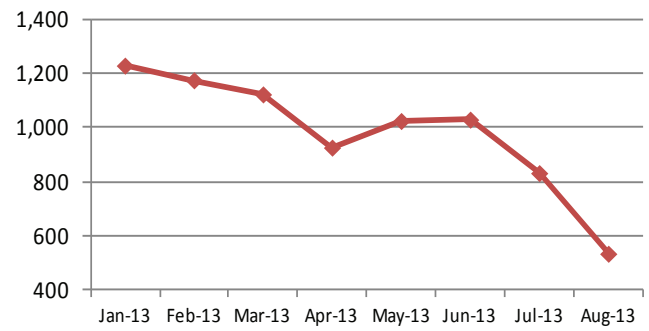
booby trap switches made from clothes pins tied to electric wire, and empty bottles of peroxide and acetone were located.

- APD's Bomb Squad participated in approximately 50 hours of training in August. The team participated in approximately 15 hours of training with Sandia National Labs and the FBI on defeating radiological dispersal devices. The Phoenix Police Department Bomb Squad came to Albuquerque to participate in the training, as Albuquerque is the only city in the country offering these advanced courses. The K9 portion of the Bomb Squad passed their recertification course which keeps them certified for the next year.
- APD's Bomb Squad also assisted Field Services Bureau throughout August by responding to 120 calls for service. The team was responsible for two felony arrests, two recovered stolen vehicles, and one misdemeanor arrest.
- During August, the K9 Unit responded to 78 call outs, conducted 74 building searches, 12 area searches and 6 K9 apprehensions. The officers of the K9 Unit also assisted in 264 calls for service, and had 11 felony assists. The officers of the K9 Unit also participated in 105.5 hours of SWAT activations.
- In August, the Albuquerque Police Department's Prisoner Transport Unit processed 1,751 prisoners through the Prisoner Transport Center. The Albuquerque Police Department arrested 1,425 prisoners and other law enforcement agencies arrested 326 prisoners. The Prisoner Transport Unit made 256 trips to the MDC and accepted 10 walk-in prisoners at the MDC.
- The PTU continued in August with the Mobile Transport Operations Sunday through Tuesday for approximately six hours a day. In August, the PTU generated 140 mobile transports to the MDC.
- The PIIP Team worked Tuesday, Thursday, Friday and Saturday for approximately eight hours a day in August. The PIIP Team generated 197 public inebriant transports to the MATS facility. APD is finalizing the MOU with MATS to receive \$50,000 in grant overtime funds for the operation.
- The savings in hours and fuel costs for August was \$23,577.

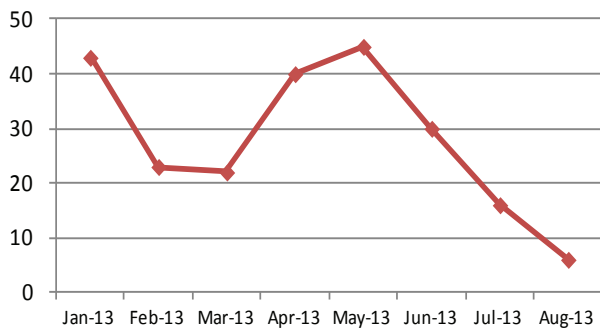
