APD Notables...

Field Services Bureau

Special Operations Division...

- On August 5 SWAT Officers were assigned to provide City Council protection.
- August was busy for SWAT officers because of the police academy and firearms range request for instructors..
- SWAT officers were requested to assist the Open Space Unit with rope training. This was an advanced course which included some climbing.
- SWAT activations this month were more violent than usual. Three activations involved the suspects actually firing weapons. All were handled successfully and professionally. SWAT worked a lot of the month with the ROP team.
- SWAT assisted the Sheriff's Department with Officer S. Key's funeral. Assignments included traffic control and covering the county for any SWAT response. APD also worked with BCSO on a tactical situation in the NW. The call was a large scale response which included some Federal Agencies.
- In August APD's Bomb Squad responded to bomb related call outs.
- APD's two explosive detection K9s completed their annual certification through NNDDA (National Narcotics Detector Dog Association) on August 23.
- APD's Bomb Squad participated in 60 hours of training. Topics covered were rope and pulley rigging, x-ray through barriers, and a Radiological/ nuclear tabletop exercise with agencies throughout the state. The team also trained on blast pressures from different size explosive shots at the bomb range.
- Sgt. Gallegos attended a three day Bomb Squad Commanders Conference at Redstone Arsenal. The conference provided updates on current issues concerning Bomb Squads across the nation, as well as upcoming training that will be available.
- APD's Bomb Squad conducted two demos during the month of August. The first was Officer Appreciation Day at the Northeast Sub, and the other was a Static display for the Homeland Security Conference.
- APD's Bomb Squad continued to assist Field Services Bureau throughout the month by taking 20 calls for service.
- APD's Bomb Squad is currently operating with three full time certified bomb technicians (two

of which are also K9 handlers), and currently has two vacancies. The Bomb Squad has had vacancies since October 2011 without any replacement. The last full time opening was in 2007. With the increase in specialized equipment the Bomb Squad has been receiving from federal grant funding (over \$1,000,000 dollars) along with the increase in call outs this year, it is very difficult for the team to manage their numerous responsibilities. The part time team now has three certified Bomb Technicians. J. Wolffbrandt and M. Oates both graduated from HDS in April 2014.

- The K-9 Unit's highlights for the month of August centered on three core areas: mandated training, outside agency training and in service certification training. The team is also in the process of conducting an internal review of our procedural and policy guidelines, documentation of monthly performance and training objectives.

Metro Traffic Division...

- The DWI Unit completed 181 DWI and four DRE arrests in August
- The DWI Seizure Unit confiscated 133 vehicles in August, totalling \$182,700.
- In August, the Traffic Division issued 2,183 citations and 4 cell phone violation citations.
- The Traffic Unit completed 11 DWI arrests, ten misdemeanor arrests, and seven felony arrests
- The Traffic Unit wrote 1,078 citations.
- The Traffic Unit responded to 215 calls for service in August.

Field Services Bureau - East

Southeast Area Command...

- On August 10 Officer M. Kelly was dispatched in reference to a traffic accident. Officer Kelly was told by dispatch that the driver involved in the crash was attempting to leave the scene. Officer Kelly arrived, contacted the driver, and determined that the vehicle needed to be towed for not having insurance. During an inventory search, a marijuana pipe with residue in the center console was located. The driver was arrested the on drug paraphernalia charges.
- On August 22 Officers F. Hernandez and D. Yurcisin arrested E. Crane for felon in possession of a firearm & possession of controlled substance charges (heroin & marijuana). Officer Hernandez and Yurcisin observed a Pontiac G6. The vehicle had a skip plate and a traffic stop was conducted. Due

to the nervous behavior of the driver and a gun holster that was observed in plain sight, all subjects were asked to exit the vehicle for further investigation. It was later discovered that the driver was a convicted felon. The inventory search of the vehicle located 3 firearms, 8 grams of marijuana, and 3 grams of heroin.

- On August 22 Officers F. Hernandez and D. Yurcisin arrested A. Woody & W. Grassrope for receiving/transferring a stolen motor vehicle. The officers observed a white Ford and ran the license plate through MVD/NCIC. It was returned as a stolen vehicle. Officers conducted a High Risk Stop and both individuals in the vehicle were taken into custody without incident.
- On August 26 Officer S. Saenz arrested L. Diaz and F. Diaz for receiving/ transferring a stolen motor vehicle. The officer observed a red Chevrolet parked in a parking lot. The vehicle was backed into a covered parking space, sitting on blocks. Believing the vehicle to be stolen, he approached and observed a male exiting the passenger door with hand tools in his hand. A second male exited the back of the vehicle. Officer Saenz checked the Vehicle Identification Number through NCIC which confirmed the vehicle was stolen. Both offenders were taken into custody without incident.
- On August 28 Officer M. Fisher arrested A. Garcia for possession of a controlled substance: methamphetamine, misdemeanor warrant and driving while suspended/ revoked. The officer observed a male on a scooter, slamming on his brakes when he saw the officer. The suspect did not have eye protection and the officer conducted a traffic stop. The rider appeared nervous and Officer Fisher observed a glass pipe sticking out the subject's pants pocket. A search of the subject found a plastic baggy with a white rock type substance inside, being Methamphetamine. The offender was arrested and booked without incident.
- During a tactical plan Officer R. Holets and Officer J. Bonet were on bike patrol. While patrolling they observed a drug deal in which a subject had the controlled substances on a scale in small baggies and was dealing to another subject. The officers stopped and made contact with the subject who started to throw the drugs on the ground. Officer J. Bonet handcuffed the suspect. The seller and buyer were arrested for distribution, possession of controlled substance

and tampering with evidence.

- On August 5th Officer Z. Kesner was dispatched in reference to a shoplifting occurrence. Upon arrival he made contact with the lost prevention department. He was advised that two suspects were in custody for unlawfully taking clothing from the business. After reviewing the evidence, Officer Kesner confirmed the shoplifting charge. Through further investigation Officer Kesner ascertained that the two subjects had prior Criminal Trespass Notifications issued to them from the same business. At the conclusion of the investigation Officer Kesner charged both subjects with commercial burglary and conspiracy.

Northeast Area Command...

- On August 1, an offender shoplifted two laptop computers. The driver, who did not want to be part of the theft, called police and updated Officers on his and the offender's location. Officer Potter located the offender, who exited the vehicle and was on foot. Officer Potter found the offender, who was concealing his identity and had three felony warrants and two misdemeanor warrants for his arrest. The offender was turned over to the Organized Crime Unit, who located where the offender dropped off the computers. OCU later served a search warrant on that location.
- On August 8, Officers Hoffman and Bazan were dispatched to a shooting. They were the first on scene and found that four females had been shot. They immediately rendered aid, called for rescue, and secured the scene. One female died and the offender subsequently committed suicide during a separate incident when he shot at police.
- On August 10, a mother entered her daughter's residence without authorization and took \$500 worth of items to presumably support her drug addiction. A felony case was submitted to the District Attorney's Office for prosecution. The daughter also had an outstanding felony warrant for her arrest and she was booked into MDC.
- On August 15, a female stole a computer from a retailer. When approached by Asset Protection, she fled, leaving the computer in the shopping cart. The female was recognized as a previous shoplifting offender, who was issued a criminal trespass notice in April 2014. A felony case was submitted to the District Attorney's Office for commercial burglary.

- On August 10 Officers S. Drobik and A. Cook were dispatched to a commercial robbery call. As officers were en route to the call, they learned that shots were fired and one subject was down. As officers arrived on scene, they set a perimeter around the business. Officers learned there was a subject who was injured inside the business. Officers determined it was necessary to make entry into the business to render aid to any injured subjects. As Officer Drobik, Cook, Saavedra and recruit officer made entry, they observed a male subject lying face up on the ground, surrounded by a pool of blood. The male subject appeared to be deceased. After attempts by rescue to revive the male subject, they eventually pronounced him dead. Officers secured the scene, separated the witnesses, and conducted traffic control. Before Violent Crimes units arrived, the officers on the scene identified witnesses, obtained written statements, conducted a canvass of the area, and checked for surveillance video in the area.
- On August 11 Detective Kees was assigned a kidnapping case. A woman randomly approached a man and child at a local park. The woman took the child and ran off. The father, who is a double amputee, ran after the woman to try to get his son back. The woman abandoned the son and while the father located his son, she stole his truck, ran over his legs, and attempted to strike the young child. The father's legs were crushed by the vehicle. Using police databases, the CIT Unit, as well as the RTCC, Detective Kees was able to apprehend the offender, and arrest her on several felony charges.
- On August 30 officers responded to a shooting call. When officers arrived on scene they located a dead victim from gunshot wounds. The apartment was unsecured and the location of the offender was unable to be determined. Officers cleared the apartment. The scene was secured and the shooting was determined to be a gang-related. The Gang Unit was called to assist at the scene. The victim, J. Lucero, also known as 'Crazy' from the Duranes Street Gang, was shot by D. Martinez from the West Side Locos. During the initial FSB investigation prior to Homicides arrival on scene, the identity of the offender was discovered by Officer R. Whitten. The suspect D. Martinez was arrested by the Gang Unit.

Foothills Area Command...

- Officers were dispatched to a residence in reference to a domestic violence call between a boyfriend and girlfriend. The girlfriend, B. Frey, had been held against her will after being choked several times along with being threatened with a handgun. The offender identified as G. Montoya ran back in the house refusing to cooperate with officers commands. After several minutes on the phone he was successfully talked out of the residence and taken into custody on numerous felony charges.
- On August 17 officers responded to a suicide call. A man threatening suicide with a gun. Officer K. Burt made contact with the subject who was standing on the balcony of his second story apartment. He was unarmed but said he did want to kill himself. After a period of time the subject said he was going to exit the apartment armed. He exited the front door with a gun to his head. From a distance, and behind cover, Officer Burt was able to talk the subject into putting the firearm down and surrendering peacefully.
- On August 30, Officer Friedfertig was dispatched to a domestic violence call involving a mentally ill female subject who was threatening her mother. Officer Friedfertig was able to locate the subject by banging on her mother's window attempting to gain entry. After two hours of unsuccessful talks and intervention with CIT, a plan was formulated to take the subject into custody for a mental health evaluation. Officers were able to take her into custody without use of force and end the confrontation peacefully.
- On August 31 Officer Powers responded to a domestic violence call in reference to a male subject who had choked his wife. The subject had fled and the officers could not locate the subject. Officer Powers was later dispatched because the victim thought she saw him near the property. Officer Powers and Friedfertig conducted a thorough search of the area and located the subject. He was taken into custody and searched. He was found to be in possession of thousands of dollars and packaged bags of cocaine. Upon further investigation the subject was determined to have an extensive history of trafficking drugs. ICE was notified and later arrived on scene to take custody of the subject.
- On August 19 officers responded to a call where unknown subjects were carrying several guns and creating an unknown disturbance. Once

on scene officers were able to determine that the subjects had stated they were U.S. Marshals and that there was about to be a shoot out. The apartment was identified where the subjects went and officers quickly set up a perimeter and slowed the investigation down. It was quickly determined that the U.S. Marshall Service was not on the property. As it appeared that the unknown subjects were impersonating U.S. Marshals, U.S. Marshall then arrived on the scene to assist in the investigation. Tactical considerations were made and officers began making announcements. Subjects quickly exited and were detained pending the investigation. One subject, J. Rector, was arrested for an outstanding felony warrant. Another subject, W. Binford, was later arrested for impersonating a Federal Agent and for a felon in possession of a firearm.

Field Services Bureau - West Office of Emergency Management (OEM)...

- Continued to work on creating a new Hazard Mitigation Plan. OEM will spearhead and coordinate the creation of the City/County Hazard Mitigation Plan with the County. This federally required document will create disaster mitigation goals and objectives intended to eliminate or lessen the consequences of disasters.
- Continued to work on creating a new Hazard Mitigation Plan. OEM will spearhead and coordinate the creation of the City/County Hazard Mitigation Plan with the County. - Created and posted mitigation plan advisory for request of public opinion on the OEM web page. FEMA requires community involvement in the plan development process and these activities will provide for FEMA compliance and also provide public engagement and transparency.
- OEM attended Balloon Fiesta organizational meetings.
- Coordinated the creation of an emergency management and homeland security capabilities assessment which will be used to establish priorities for enhancing the preparedness and

response ability of the city. OEM is the only jurisdiction is New Mexico to develop this assessment.

- Numerous meetings regarding program components including Metropolitan Medical Response System (MMRS), Cities Readiness Initiative (CRI), Local Emergency Planning Committee (LEPC), CERT, grants, special projects, and department meetings.

Valley Area Command...

- On August 17 Officers Drager, White and Shrouf were dispatched to a domestic dispute and one gun shot was heard from inside the house. Officers contacted a possible offender outside the apartment and found that he was highly intoxicated and was in possession of a stolen firearm. The firearm was located in his front pocket. The female involved in the domestic dispute was not located and could not be contacted. The subject was arrested for receiving/transferring stolen firearms. Due to the male having a prior felony conviction from over 10 years ago, the case was forwarded to the ATF division for follow up.
- On August 23 officers were dispatched in reference to a possible burglary in progress. Officers Drager and Wickens arrived on scene first and witnessed two male subjects run from the residence. Gun shots could also be heard in the area. Officers Shrouf, Foulk, and Kesler responded to the area and took one suspect into custody. During a safety sweep of the immediate area, officers located a firearm near where the subject was taken into custody. Another suspect was located hiding in a bush on the north side of the property and was taken into custody. Both suspects were positively identified by the victims. Both suspects were charged with multiple felonies including residential burglary, aggravated assault with a deadly weapon, possession of controlled substance, and kidnapping. Officer Jones took primary on the call until a Burglary detective took over the investigation.
- On August 24 Officers Foulk and Shrouf were dispatched in reference to a male in a white pickup checking door handles in the area. Once on scene the officers determined that the vehicle was stolen. Officer Shrouf located the vehicle and attempted a traffic stop. When the vehicle stopped a female passenger jumped out and the vehicle sped off. Officer Foulk located the

vehicle abandoned and did not witness where the driver went. Shortly after dispatch began receiving calls of a male subject on roofs and running through backyards in the area. A perimeter was set up and the subject was taken into custody with the help of K-9 units. The suspect was arrested for receiving/transferring stolen motor vehicle and a detective with the auto theft unit assumed case responsibility

- August 4 Officer D. Roberts was dispatched to a residential burglary. As she and other officers arrived on scene, the offender quickly fled the residence. The officers set up a perimeter, and saw J. Romero hiding on top of a roof top close to the victim's house. He was taken into custody and identified by the victim as the person who broke into his house.
- Officers Michaud and Armijo teamed up with the Outreach Program during the month of August. This program identifies homeless individuals in need and refers them to the appropriate medical or financial resources.
- On August 23 Officer Luttrell responded to a report of criminal damage and stalking by the victim's husband. Upon further investigation, a witness was identified. The off-duty officer witnessed the suspect drive his car alongside of the victim's vehicle causing over \$1000 in damage. The suspect had previously been arrested for violating a restraining order, holding a gun to the victim's head and telling her he would kill her if she left him. Officer Luttrell contacted the FASTT unit supervisor and wrote an arrest warrant for the suspect. The suspect was located, arrested and served with an Emergency Restraining Order. The victim commended officer Luttrell for "saving her life."
- On, August 28 Officers T. Melvin and D. Padilla, responded to a road rage incident in which the caller stated a subject fired shots from his vehicle. Within minutes officers located the suspect vehicle and conducted a felony stop. The victim positively identified the occupant of the vehicle as the offender and a firearm was located in the vehicle. A history check of the suspect revealed at least two other similar incidents of road rage and shots fired from a motor vehicle. Impact Detective L. Monte responded to the scene and assumed case responsibility.

Southwest Area Command...

- On August 2 Officer Anzo arrested offender of a kidnapping against his girlfriend. The case has already been sent to the Grand Jury and received a True Bill. The Grand Jury added additional charges in reference to the case.
- On August 23 Officer Anzo was dispatched to the hospital in reference to a subject that had been shot in the stomach area. The officer made contact with the victim's girlfriend, who drove him to the Hospital. Officer Anzo obtained several names of individuals who were involved in the incident. The victim was in surgery and could not be interviewed. A shell casing was collected by a field investigator at the scene. The case was turned over to Impact Detectives.
- On August 16 Officers S. Apodaca and L. Canales were dispatched to a family fight where a female stated that she had been assaulted with a sledgehammer. When officers arrived the victim described an incident where she had been arguing with her boyfriend, when he ultimately smashed her vehicle windows with a sledgehammer and chased after her with it. Officers then received a phone call from the male to give a statement. The male was taken into custody and he was booked for aggravated assault with a deadly weapon against a household member.
- On August 10 officers were dispatched in reference to a stabbing call. Upon arrival they were able to control a chaotic scene coordinating AFD rescue while simultaneously investigating the crime. The suspect was identified and Officer Bailey was able to speak to him on the telephone and convinced him to surrender. The suspect was taken into custody without incident.
- On August 10 Officer Wesselink responded to a priority one down-and-out subject. A female subject was unconscious and not breathing. Officer Wesselink immediately requested rescue and then began to perform CPR. Officer Chacon assisted Officer Wesselink in performing CPR while other officers began to secure the scene and interview witnesses for proper identification of the subject. The subject was transported to the hospital after showing signs of life.
- On August 15 Detective Zambrano responded to a case in which J. Elycio forced his girlfriend into a vehicle and began punching her several time in the head and face, causing her to lose consciousness. When she awakened, Elycio told her to get out or he would kill her. The victim

ran to a restaurant where she contacted Officer Gallegos. The officer attempted to stop Elycio, but he drove off at a high rate of speed. Det. Zambrano obtained an arrest warrant for the suspect and attempted to locate him at several different addresses. He was eventually located and taken into custody without incident.

- On August 24 Officer Bustillos responded to a call where a male subject was shooting at a house. As officers arrived they located a victim outside the house. The victim stated that the offender and walked into their house unannounced and confronted his girlfriend. The two began to argue and the offender started to commit battery against his girlfriend. The mother heard this and came to a bedroom door and unlocked the door. As the door opened the offender stated he would kill her as he pulled out a handgun from his waist. The offender aimed the gun and fired one shot at the mother, missing her. The father then came from another room and was jumped by the offender and others that came with him. The offender then fled the area only to turn around and fire three more shots at the house. Impact Detectives responded to the scene and a warrant for the offender's arrest was obtained that night.

Northwest Area Command...

- On August 18 Officer J. Brown responded to a forgery in progress at a bank. He arrived and detained the suspect. Through his investigation it was found that the suspect was attempting to cash a check belonging to a person who was deceased.
- On August 5 Officer Hsu conducted a traffic stop which resulted in four felony arrests and the recovery of a large amount of narcotics.
- On August 18 Officer Poccia responded to a gas station in reference to a subject brandishing a gun and threatening the store clerk. Officer Poccia was able to identify the subject and eventually take him into custody. The gun was recovered and a subsequent search warrant was executed leading to the recovery of stolen property from several auto burglaries.
- On August 8 Officer Maes was dispatched to a suicidal subject. The subject had left the residence before officers arrived but they were advised by dispatch that the suspect left with several firearms and threatened to kill his ex-wife in Arizona and his co-workers at a local business. Officer Maes was able to arrange for notification

of the wife in Arizona as well as the call center on Central. He also put out an ATL on the subject and had dispatch notify Rio Rancho PD. Several hours later the subject was located and taken into custody in Rio Rancho.

- From August 1 through the 31, graveyard officers continued to monitor and respond to activity on the West Side. There have been ongoing neighbor disputes as well as other disturbances on this street for a few years. Team 7 officers conducted 17 periodic watches of the street during the month. Additionally, there were five calls for service involving disputes between the residents, primarily handled by the swing shift.
- On August 13 Officers Enyart and Perea responded to a suicide call. The caller stated a female family member had made references to wanting to end everything. She then left the house in a vehicle. When the caller checked the house safe, he noticed the 9 mm gun missing. Officers and dispatch were unable to get the female to answer any phone calls. The female was located in her vehicle in at the corner of a parking lot by Officer Poccia. The handgun was on the passenger seat next to the female. Through excellent use of CIT skills, the female surrendered to Officer Poccia. She was subsequently transported to UNMH, and the gun and vehicle were turned over to family who stated all guns inside the house would be moved to a relative's house until this situation was resolved.
- On August 26 Officer C. Romero responded to a suspicious subject in the yard of a residence. The male subject was pounding on both the front and back doors of the residence. Upon arrival the and appeared to be on some type of drug. An AFD paramedic was attempting to administer aid. The subject was booked for battery on a health worker.
- On August 21 officers were dispatched to a family fight where the husband reported that he and his wife were in a dispute. The wife was out of control and was stabbing herself in the stomach with a knife. Officers located the female identified as E. Pickup. Sergeant Norris ordered her to drop the knife and stand up. She appeared to be in a manic mind set and did not follow directions but did drop the knife. She was frantically searching for her medical marijuana until Sergeant Norris pulled her purse away from her in order to empty her hands of any other possible weapons. She

then responded with anger towards him and would not obey any directive. Officer Enyart and Sergeant Norris placed her into hand cuffs until medical assistance could arrive. According to her husband, she had been diagnosed with schizophrenia, Bi-polar and personality disorder and was self-medicating. She had multiple scarring about her neck and arms that were visible from other suicide attempts.. While being treated by AFD she became combative and required being placed in gurney restraints for transport. She was transported to for treatment and evaluation.

Investigative Bureau

Scientific Evidence Division...

- The Major Crime Scene Team responded to eight call outs in June.
- The Field Investigator Unit responded to 1,189 calls, wrote 860 reports, and collected 642 latent fingerprint cards during June.
- The New Mexico DNA Identification System (NMDIS) received 471 new convicted offender/arrestee DNA samples in August with a cumulative total of just under 101,000 collected. 804 samples were analyzed, data uploaded and searched in CODIS, with a cumulative total of over 95,000 searchable DNA profiles. As a result of these convicted offender/arrestee samples, 79 unsolved cases were matched to convicted offenders/arrestees, 19 case-to-case matches were made, with a resulting total of 84 investigations being aided.

- The Evidence Unit received 6,482 evidence

Property Crimes Division...

- The Auto Theft unit conducted VIN etch programs at the Wells Fargo Bank, National Night Out at the SW Community Center and the Target located at I-25 and Paseo Del Norte. A total of 66 vehicles were etched for the month of August.
- On August 1, Auto Theft conducted a bait car operation in the FH area command at the behest of the FH Chain of command request. The suspect later identified as D. Mayo took the car and left the deployment area. He was taken into custody a short time later and booked into MDC. The video obtained from the operation made National television and requests from as far away as Spain were received.
- On August 16, Auto Theft conducted a bait car operation in the NE area command. The location was chosen given the most recent crime trends from the Crime Analysis Unit which showed a rise in property crimes in the NE area. Two subjects were arrested for unlawful taking of a motor vehicle. The driver J. Leekkya and the passenger W. Castillo were taken into custody and booked into MDC.
- On August 25, Auto Theft detectives spotted a stolen car at a local motel. The car was unoccupied and they sat on the car until an occupant of the hotel exited and returned to the car. As he entered the car and gained control of the vehicle, he was arrested by detectives. He was identified as D. Valencia who also had two outstanding felony warrants.
- NITe detectives assisted the Foothills area command with a month tact plan for two nights a week. Detective Pholphiboun did a two week TDY to assist with building bait cars. Sgt. Gamboa and Det. Taylor received 40 hours of CIT training. All the detectives received and are now qualified to carry the new department rifle.
- On August 8, NITe Detectives received information that M.Lozano was in the area command at Central Hotels and was known to have a felony warrant for his arrest. He was located and taken into custody.

- On August 8, NITe Detectives located and arrested K. Clark for a felony warrant while working Foothills tactical plan.
- On August 11, NITe Detectives observed a male driving a motorcycle on the side walk of a motel. The subject went into a room and detectives were able to confirm the bike was stolen. The room was verified, and the driver, R. Martinez, was arrested. His girlfriend was also located; A. Palomino was in possession of an embezzled vehicle.
- On August 18, A. Parra stole a city owned trailer that was connected to a city owned truck. Parra began to dismantle the trailer as detectives arrived to arrest him.
- On August 23, D. Lawrence broke into a city vehicle and stole city property. He attempted to elude officers on a bicycle but was eventually caught and taken into custody.
- On August 26, NITe Detectives were contacted by Federal Probation and Parole with a request to locate an absconder that they feared was going to hurt a family member. He was located, arrested, and turned over to federal agents.
- On August 29, N. Gonzales entered a city owned bait car and drove it to a motel. Gonzales then took city owned property and took it into his hotel room. The items were tracked and the suspect was taken into custody.
- On August 31, a DWI officer observed a motorcycle being driven. The motorcycle eluded police and the passenger, T. Morales, jumped off the back and ran, but was later located. He admitted the bike was stolen and stated he was a passenger and they were actively looking for another bike to steal.
- On August 7 Burglary Detectives were conducting a residential burglary tactical operation in the Southwest Area Command when Officer Bailey called out with an armed robbery involving an elderly woman that just occurred. Detectives responded to the area immediately and were able to locate a suspect and vehicle matching the description in the parking lot of a nearby apartment complex. The detectives converged and took the suspects into custody. They obtained a full confession from both offenders. The detectives took case responsibility and the offenders were booked on robbery with a deadly weapon, aggravated assault, false imprisonment, and conspiracy.
- On August 8, J. Wieck was arrested for a commercial burglary. Wieck, who was an employee of the business, was interviewed by Burglary Detectives and later confessed to committing three burglaries at that business as well as two additional burglaries at the business owner's residence.
- On August 14, the unit was contacted by Detective C. O'Neil in regards to a home invasion involving an elderly male who sustained minor injuries during the incident. O'Neil was able to get fingerprints that were taken from the scene and identify them quickly. The following morning Burglary Detectives met with the victim and showed him a photo array and he positively identified the suspect. A arrest warrant for R. Chavez was obtained. Due to Chavez's violent history, ROP was contacted to assist with the apprehension of Chavez. On August 16 information on Chavez's whereabouts was obtained and given to ROP Detectives. Chavez was taken into custody and the unit responded to the scene. A warrant was obtained for the residence and the hand gun that was used in the crime was located. Chavez was booked on numerous felony charges to including kidnapping, aggravated assault with a deadly weapon, and tampering with evidence.
- On August 5 Detective Weber was contacted by Pretrial Services in District Court. Subject L. Luna arrived at his scheduled meeting with his probation officer, but was found to be in possession of a stolen driver's license and stolen credit cards. The items were traced to an automobile burglary in the Foothills Area Command with occurred the night before. The suspect broke into the vehicle and then fraudulently used the victim's identification and credit cards at a nearby store.. He was booked into MDC on multiple felony charges.
- On August 22, Detectives J. Weber and V. Natewa travelled to Pueblo, Colorado to interview A. Gutierrez. She had been arrested by the Pueblo Police on multiple felony charges. She was in possession of a large number of stolen checks from an apartment complex at the time of her arrest. The rental office at the facility had been burglarized earlier in the month. Altered checks, originally for rent payments, began to appear at local FISOA member banks. Detective Weber was already working the case. Ms. Gutierrez admitted to the commercial burglary and stolen checks to Detective Weber. She was booked on local felony warrants on top of the charges she had

in Pueblo. She implicated another individual in the commercial burglary. The investigation is ongoing.

- On August 28, Detective M. Sandoval obtained a felony embezzlement warrant for local attorney C. Kelly. Mr. Kelly represented the victim in a civil suit against the City of Gallup. The victim won damages totaling \$130,000.00 and the judgment was paid by the city. Mr. Kelly never paid the victim and deposited the settlement into his own checking account. In the past four months he spent all the money. His whereabouts are unknown.
- In August 2014, the value of cases cleared by the White Collar Crime Unit totaled \$525,291.04.
- On August 6, Sergeant R. Barraza joined White Collar Crimes on a TDY assignment. He served in that capacity through the month of August. Detective J. Weber was serving as acting sergeant.
- Sergeant T. Hoffman was selected to be the new White Collar Crimes sergeant. She will start her tenure on September 6.
- Detective J. Weber completed interviews on KRQE and Daily 49. She addressed ID Theft and Mailbox Theft respectively.
- On August 12, Detectives Natewa and Detective J. Weber attended the monthly FISOA (Financial Institution Security Officers Association) meeting.
- On August 15, White Collar Crimes received two new interns from the University of New Mexico Anderson Business School. Detective J. Weber is responsible for supervising the interns provided by Professor W. Broody. This collaboration has been in place for a number of years now.
- On August 20, Sergeant R. Barraza and Detective M. Sandoval attended the Lenders Exchange partnership meeting.
- On August 21, Detective C. Frank was assigned to White Collar Crimes on a part time (20 hour) basis. She is also the State of New Mexico DRE Coordinator. These duties will consume the second half of her weekly duties. She is also still conducting polygraphs for APD and BCSO.
- On August 27, Detective M. Sandoval was assigned full-time to the United States Secret Service Task Force at the request of Special Agent-in-Charge R. Ferretti.
- On August 28, Sergeant Barraza, Detective J. Weber and Detective C. Frank participated in the White Collar Crime workshop at the Foothills

- Substation. The program was successful. It has been offered to all area commands.
- OCU detectives conducted a tact plan at a local business. During the tact plan two females were apprehended on separate incidents. G. Traub was arrested after a short foot pursuit after stealing a drill kit. F. Fuentes was arrested for the theft of liquor. She is on active probation for residential burglary.
 - NW Impact along with OCU, Northwest Impact and Valley Impact worked a joint investigation in reference to a repeat property offender. The offender identified as T. Romero used stolen checks and credit cards obtained from an auto burglary to purchase several 1000 dollars of items throughout the city. An arrest warrant and search warrant were served which resulted in the seizure of over 100 stolen checks and the recovery of the victim's property. A background check revealed OCU had recently arrested Mr. Romero for committing multiple residential burglaries.
 - OCU detectives conducted a search warrant on the residence of N. V. Lozano, a known fencing location in the metro area. Detectives had apprehended P. Crowl after he shoplifted over \$1000.00 in laptop computers from a local retailer. Crowl had sold the computers to Lozano prior to his arrest. Crowl was wanted on three felony warrants and three misdemeanor warrants for his arrest. A search warrant and arrest warrant were obtained for Noe Lozano, and he was taken into custody. During questioning he admitted to purchasing new and used stolen property, and selling it for profit at local flea markets. Over \$6,000.00 in new stolen merchandise was recovered.
 - OCU conducted a tactical operation in the area of Wyoming and Menaul to curb the spike in crime in that area. Detectives made contact with E. Ortiz and C. Elledge who was armed with a handgun. Elledge is a known associate of Arian Brotherhood, and Ortiz is a gang member from Pamona, California. Detectives observed a handgun on the seat of the subject's vehicle. During questioning Ortiz admitted to being a convicted felon, and knew the gun was in the vehicle. The truck was sealed and a search warrant was obtained; the gun was confirmed stolen. An arrest warrants for Ortiz was filed.
 - Organized Crime detectives initiated and completed several ARAPA, Hospitality and CICA initiated tact plans throughout the month

resulting in numerous arrests and the clearance of outstanding warrants.

- Detective Pitzer was on military orders for the first three weeks of August.
- OCU detectives attended all monthly meetings involving ARAPA, Hospitality, FISOA and CICA.
- For the month of August a total of 21 Firearms were recovered from a local pawn shop. Nine of the listed firearms were recovered from repeat offender L. Garcia. Garcia has been charged with multiple auto and residential burglaries. K. Molina and his girlfriend J. Kisinger have been positively identified as working together to hit large retail stores for high end new property. Our partnerships such as two additional retailers have been hit several times by the suspects or taking high end products such as Go Pro's, Beats, speakers and GPS then selling them to local pawnshops.
- Metal Theft detectives arrested C. Tsattie for possession of stolen property. This arrest resulted in the recovery of a stolen engine. This investigation started as a result of a metal theft report submitted to the unit.
- Metal Theft detectives conducted an investigation at South Valley Recycling and identified numerous violations resulting in the "shut down" of the business. Violations were also identified by City Zoning, Fire Marshal and New Mexico Department of Agriculture.
- C. Chavez was the primary offender involved in the theft of industrial grade electrical wire from three locations within the City of Albuquerque. These thefts were committed within a one month period. Casey was located and booked on the three outstanding cases. The value of the wire taken was approximately \$7,200.00 and the criminal damage as a result of the thefts was over \$12,000.00. Metal Theft detectives had previously named Casey as a Most Wanted Property Crime Offender and identified him as a suspect in numerous other pending metal theft investigations.

Criminal Investigations Division...

- The Homicide Unit responded to 8 call outs during the month of August, of the eight, three were Homicides, three were Major Cases and two were In Custody Death Investigations. This brings the total number of UCR homicides in Albuquerque to 17 through the end of August. This total includes 14 adult homicides and 3

juvenile homicides. The total amount of police actions for 2014 is 12. The Homicide Unit currently has 29 active cases.

- The Armed Robbery Unit responded to six robbery call outs, and cleared nine cases this month, with two of those going to the DA's Office. They made four arrests, and wrote nine arrest warrants as well as six search warrants. The Robbery Unit had 27 new cases assigned this month and now has a total 90 active cases.
- The Sex Crimes Unit responded to seven sex crimes call-outs the month, and cleared 18 cases with seven of those going to the DA's Office. The unit also wrote three arrest warrants, 10 search warrants and made two in custody arrests. There were 24 new cases assigned for investigation. The unit currently has 64 active cases.
- The FASTT Unit cleared 20 cases this month with none of them going to the DA's Office. FASTT Detectives reviewed 252 cases this month. The FASTT Unit currently has three active cases.
- There were 92 new runaways/missing persons reported to the Missing Persons Unit this month. The unit cleared 98 total runaways / missing person cases. The unit currently has 84 active cases.
- Juvenile Section: The Sexual Offender Registration Detail (SORD). Detective Peers' case load is at 146. There are 81 city registered sex offenders under ASORNA. Detective Peer assisted probation and parole on the arrest of two individuals for violating their conditions of release.
- The Child Exploitation Detail (CED) was assigned 10 new cases in August. The Unit cleared seven cases with one case being submitted to the District Attorney's Office for prosecution. Three search warrants were obtained in August. The Unit completed three computer/cell phone forensic examinations. The Unit currently has 60 active cases. CED also conducted five missing persons investigations. The Unit conducted 16 background investigation as well as 22 FSB assists. CED wrote two arrest warrants and arrested one subject for criminal sexual penetration charges.
- Detective Storey received a report from CACU in reference to an allegation that a maintenance man at an apartment complex was touching children. Detective Storey was able to identify the maintenance man and two victims.

Safehouses were completed and the subject confessed to touching the children. The subject was arrested for CSC and CSP on a nine year old and a 12 year old. Additional victims are trying to be identified.

- Sergeant Peterson attended the Crimes Against Children Conference in Dallas, Texas. The conference was the host of over 3,500 attendees. Sergeant Peterson along with The Department of Homeland Security taught a class on corroboration between local and federal agencies. This is a true testament to the results that APD and HSI have accomplished through the formation of SPEED.
- The Crimes Against Children Unit (CACU) gave CYFD 897 referrals this month; this is down by 38 referrals from July. The average is approximately 1094 per month year to date. In eight months CACU has received 8,523 referrals. CACU Detectives were assigned 99 new cases to be investigated.
- Officers from both Eastside and Westside SRO Units continue to be of great assistance to their respective Area Commands by handling 119 calls for service and 165 on-site activities in August. 28 referrals were made by the SROs and 109 truancy investigations were conducted. Quality of Life enforcement activities (Criminal Trespass, Panhandling, Red Tag, Graffiti Referrals, Parking/Moving Citations) were at 108 for August. The SRO Units cleared 20 total Felony/Misdemeanor arrests and/or warrants. In addition, the SRO Units arrested two DWIs and assisted by CACU by taking seven CYFD referrals to check on suspected abuse.

Special Investigations Division...

- On August 3 ROP Detectives were called out to assist with a robbery that occurred at a local drugstore. The suspects' description along with a vehicle identification was provided. The suspect R. Christopher was found at a motel later. Robbery Detectives took over the investigation.
- In August 8 ROP assisted the Violent Crimes Unit with a homicide; the offender was identified as M. Delgado. Air Support located the vehicle and ROP detectives moved into the area in an attempt to identify the passenger. The passenger began firing a weapon at the detectives. A perimeter was established and it was learned that the M. Delgado committed suicide.
- On August 15 the ROP unit responded to assist

with a homicide investigation. M. Marquez was located with an outstanding felony warrant related to this investigation.

- On August 1 Air Support, Air 5, located a vehicle that matched the vehicle involved in a commercial burglary of computers. Air support was able to relay information to ground units, and the merchandise was recovered. The suspect was taken into custody.
- Air 5 located a male subject matching the description of an offender from an auto burglary on August 15. Information was relayed to ground support where responding units took him into custody. The stolen property was recovered.
- On August 31 Air 1 assisted a perimeter around a suspect who had shot a business owner. The suspect was apprehended at his home after two hours, and he was taken into custody.

Professional Accountability Bureau Communications Division...

- The APD 9-1-1 Communications Center staff answered 75,130 incoming 911 and 242-COPS calls in August. There were 29,423 calls answered for 911 and 45,707 calls answered for 242-COPS. 911 Operators answered 89.84% of the 911 calls within 10 seconds (national standard is 90%, APD standard is 92.0%); operators also answered 94.29% of the 242-COPS calls within 30 seconds (APD goal is 90% answered within 30 seconds).
- Training sessions for all Communications Personnel were held at numerous times to prepare staff for the upgrade of the Tiburon CAD (Computer Aided Dispatch) system. The upgrade, which occurred August 12th, provided additional functionality and system enhancements along with new computer terminals being placed into production to increase system speed and performance. Ongoing meetings with Tiburon personnel continue to flush out the remaining system issues.
- A core group of Communications personnel participated in a week long session to continue the ongoing rewrite of the Communications SOP along with the review of general departmental orders which impact Communications.

APD Academy...

- The 111th Cadet class completed week 11 of 26 in the month of August. They had three

large blocks of instruction in this month. The first large block of instruction was Officer as a First Responder/Patrol Procedures. The second large block of instruction in the month of August was the Cadet's instruction on Collision Investigation. The remainder of the month was spent in Firearms Training. Only two cadets out of 37 failed to pass their NMDPS firearms qualification. These failures will receive remedial training in preparation for their final opportunity to qualify in September.

Planning and Policy Division...

- Division objectives and priorities were reviewed with staff.
- Department staff attended weekly team meetings.
- The Grants Team Meeting at the FAC was held on August 7. The VAWA Grant was discussed.
- Grant Reconciliations for PCCAO OEM Grants were completed. Analysts are waiting for AJEs, revenue from the Grantor, and the City Clean-up Resolutions to close existing grants.
- Analysts worked on reconciled old APD Grants and are awaiting June allocations to run prior to closing them.
- A conference call with John O'Donnell was held on August 13 to discuss federal grants.
- APD's CIP presentation was attended on August 21.
- The department coordinated and attended the Grants Team Meeting with the the Office of Emergency Management to discuss grants. The meeting was held on August 28.
- The Grant Dashboard pivot for the month ending July 31 was completed.

Recruiting and Background Division...

- A total of 291 interest cards were received, 234 being male, and 37 female. Of the total, 203 cards were for the cadet position, 80 for PSA, and eight were for lateral applications.
- Of the background folders assigned out, 25 were for cadets, one was for a lateral position, three were for PSA positions, and nine were for civilian applications
- For the 112th cadet class, 19 people were seated.
- Eight PSAs were seated as well as one lateral hire.
- In August, an exhibit at the NM Black Expo Career Fair was presented.
- Weekend testing was held August 08 - 10. 156

people sat for the examination.

- 57 people attended the City Entrance exam.
- 37 people attended the Saturday testing, and 28 individuals passed to the background check procedure.
- 138 individuals are signed up for the September 12 - 14.
- The October 17 - 19 testing will seat 123 individuals.


Professional Standards Division...

- The Public Information Unit collected revenue of \$7,743 from 845 requests in August.
- The Alarm Unit noted 1,350 false alarms in August. The Unit collected \$112,000 in August
- Court Services staff scheduled 110 pretrial hearings and processed 416 arraignments. Staff submitted 322 felony cases to the District Attorney's office for prosecution and submitted 412 summons to Metro Court.
- The Telephone Report Unit processed 449 reports which resulted in a savings of 1,536 hours of Field Services time and an estimated savings of \$23,640.
- In addition, the Telephone Report Unit processed 410 on-line (Cop Logic) reports, resulting in a savings of 1,066 hours of Field Services time and an estimated savings of \$16,400.
- Metro Court officers assisted 94 individuals who were remanded by the court and booked; and six individuals who were remanded and assisted with bonding out.


Prisoner Transport Unit...

- In August the Prisoner Transport Unit processed 1,461 prisoners through the Prisoner Transport Center. The Albuquerque Police Department arrested 1,192 prisoners and other local law enforcement agencies arrested 269 prisoners. The Prisoner Transport Unit made 229 trips to the MDC and accepted five walk-in prisoners at the MDC.
- The APD/AFD PIIP Team continued to work Tuesdays, Thursdays, Fridays, and Saturdays for a total of 18 days in August. The PIIP Team transported 42 public inebriates to MATS; 23 public inebriates were transported by EMS; 36 public inebriates refused services; and five public inebriates did not meet the MATS criteria.
- The savings in hours and fuel costs for June was \$22,533.


Residential Burglary by Area Command Jul-Aug 2013/2014




Auto Burglary by Area Command Jul-Aug 2013/2014




Auto Theft by Area Command Jul-Aug 2013/2014




Commercial Burglary by Area Command Jul-Aug 2013/2014




Domestic Violence by Area Command Jul-Aug 2013/2014




Robbery by Area Command Jul-Aug 2013/2014




Aggravated Battery by Area Command Jul-Aug 2013/2014




Criminal Damage by Area Command Jul-Aug 2013/2014




Battery by Area Command Jul-Aug 2013/2014




Criminal Damage by Area Command Jul-Aug 2013/2014




Disturbance by Area Command Jul-Aug 2013/2014




DWI by Area Command Jul-Aug 2013/2014




Felony Warrants by Area Command Jul-Aug 2013/2014




Misdemeanor Warrants by Area Command Jul-Aug 2013/2014




Narcotics by Area Command Jul-Aug 2013/2014
