Field Services Bureau - East Southeast Area Command...

In December, the Southeast Area Command had 10,324 calls for service, wrote 1,953 reports, and issued 448 citations. There were 192 felony arrests, 196 misdemeanor arrests, and 23 driving while intoxicated (DWI) arrests. Three community meetings were attended. On December 1, Officers Holets and Bonet ran the plates on a vehicle and discovered the registered owner had an outstanding misdemeanor warrant. The vehicle sped away and the officers engaged their emergency equipment. The vehicle refused to stop and continued north toward Central Avenue. The officers disengaged and approached Central Avenue through another street. They observed the vehicle in the parking lot of a fast food restaurant. Both officers proceeded to clear the vehicle and discovered an infant in the vehicle. Citizens at the restaurant stated the driver had run into the business. Officers proceeded in the business and the manager stated the driver was hiding in the back. Officers discovered the driver and took him into custody. Officers placed him under arrest for aggravated fleeing and child abuse. He was aware of the warrant and stated that was the reason he fled. Officers also discovered a firearm and drug paraphernalia in the vehicle.

In December, Officer Quillman conducted a tactical plan to address higher than average incidents of auto burglaries and auto thefts at local motels and apartment complexes. Officer Quillman conducted periodic checks of the parking lots. He ran vehicle checks through Motor Vehicle Division looking for stolen vehicles or suspicious activity. This tactical operation resulted in the recovery of four stolen vehicles, the arrest of two individuals, and the clearing of three felony and one misdemeanor warrants.

On December 8, Officers Nagy, Quillman, Werner and Mccumber responded to a suspicious person/activity call at a local pharmacy. An employee telephoned police after a male entered the store wearing a Santa Clause hat. The employee recognized the clothing description as someone who held up another pharmacy the previous day. Upon entering, the male asked the

female employee for a piece of paper and a pen. He walked directly to the pharmacy department which was not open yet and sat in a chair. As officers were in route, the caller was advised not to open the pharmacy. When officers arrived, all employees were directed to exit the store and there were no customers except for the male waiting at the pharmacy. The male suspect was taken into custody without incident. Through investigation, the male was found to be a suspect in three robberies in the Albuquerque area. A hand written note was located near the male that read "I have a gun. I will shoot you", and a list of six narcotics.

On December 15, Officer Groff was dispatched to a local business regarding a female attempting to cash a forged check in the amount of \$1,800. Officer Groff arrived and detained the female suspect and conducted an interview. She gave information about a deal she made with a male to cash the check and return to a certain location. In addition, the owner of the checking account was contacted. The owner also had a trailer stolen from a local hotel. Officer Carlson assisted in the investigation and located the stolen trailer at the location the two suspects were to meet. The stolen trailer was returned to the victim. The female was arrested for forgery. On December 17, Officer Marquez was dispatched to a local credit union in reference to a male who had cashed \$20,400 in fraudulent checks over a two week span. The male was detained and identified. Officer Marquez contacted Organized Crime Detectives Moore and Percival who arrived on scene. The suspect was interviewed by detectives and admitted to cashing the checks. Once he was placed under arrest, the suspect was found to have an envelope with \$2,800 hidden under his shirt. The money was returned to the credit union. The suspect was also found to have an ounce of a black tar like substance, which was discovered to be presumptive positive for heroin. The suspect was booked into the Metropolitan Detention Center.

On December 17, Southeast field patrol officers received a dispatch to a stabbing. Upon arrival, they learned a female subject had just been stabbed numerous times including serious stabs wound to her neck. The subject's right ankle was also found to be broken. Detective Barela arrived on scene and drafted a search warrant for the premises and prepared a photo line-up for witnesses who had observed the offender running out of the victim's apartment. Witnesses identified the suspect which was also confirmed by video surveillance showing the suspect running and changing clothes away from the scene. Southeast Impact detectives conducted an undercover surveillance operation and observed the suspect. He was taken into custody without incident. After an extensive in-depth interview, the suspect admitted to stabbing his girlfriend after a domestic dispute. He then led detectives to where he had thrown the weapon he used to stab the victim. Detectives recovered the weapon and the suspect was booked into the Metropolitan Detention Center on charges of attempted murder and tampering with evidence. On December 23, officers responded to a bank robbery call. The caller advised the offender was armed with a silver hand gun and wearing a multi colored beanie and blue jeans. The caller also advised the subject left on foot with an unknown amount of cash. A second call was received from a customer who indicated he was following a male who had held up the bank. As the caller followed from a distance, he provided dispatch with an updated location. Officers located the male and took him into custody without incident. During a pat down, a silver hand gun was located in the waist band of the subject. A bag of cash was also located. The Federal Bureau of Investigation (FBI) arrived and took over the investigation.

In December, officers were dispatched to a park where a male subject was attacking a female. The caller advised the male was last seen running from the location. Officers arrived on scene and the female indicated she had been in a fight with her boyfriend over their relationship. The two pulled over next to the park and the male pulled the female out of the vehicle by her arm and hair. He dragged her from the parking lot into the grass area of the park and punched and kicked her several times. Rescue was called to evaluate the victim and she was later transported to the hospital for treatment. Southeast Impact Detective Lueckenhoff wrote an arrest warrant for the male subject. The detective also contacted the male's probation officer, who wrote a felony warrant for probation violation. The suspect was called into the probation office and arrested on both felony warrants.

On December 27, Detective Moya was called to assist in the investigation of a road rage incident that escalated into an aggravated assault with a

deadly weapon. Detective Moya found probable cause to charge the suspect with leaving the scene of an accident with injuries, aggravated assault with a deadly weapon, firearm enhancement, tampering with evidence, two counts of possession of a controlled substance with intent to distribute, and possession of a firearm by a felon. Detective Moya executed a search warrant on the vehicle and recovered a shotgun, multiple shotgun rounds and miscellaneous drug paraphernalia used in the trafficking of narcotics. This case has since been sent to United States Attorney's Office for possible charges under the "Worst of the Worst" initiative.

On December 27, Officers Small and Schroeder were on patrol when they observed a vehicle with heavy damage chasing another vehicle. Shortly thereafter, the first vehicle hit a curb and became disabled and the driver fled. Officers made contact with the driver of the second vehicle. He explained that the first vehicle hit him at another location and as he was calling the police, the driver pulled a gun on him and fled. He then followed the first driver at which time they came across Officers Small and Schroeder. With information provided by a family, Officer Schroeder was able to locate the driver of the first vehicle and place him in custody. Upon further investigation, officers discovered a firearm in the first vehicle with a large amount of heroin. The suspect also had a substantial amount of heroin on his person. The suspect was charged with aggravated assault with a deadly weapon, leaving the scene of an accident with injury, and trafficking controlled substances.

Northeast Area Command...

In December, the Northeast Area Command had 8,995 calls for service, wrote 1,882 reports, and issued 898 citations. There were 155 felony arrests, 347 misdemeanor arrests, 30 driving while intoxicated (DWI) arrests, and 79 warrants issued. Twelve community meetings were attended.

On December 1, Officer Candelaria was
dispatched to a call in response to a female
subject attempting to cash a fraudulent check.
Upon arrival, an employee advised him that the
female had left but forgot to take the fraudulent
check and driver's license. The name on the
license matched the name on the check, but
when Officer Candelaria scanned the barcode on

the license it came back to another female which matched the person seen on store video cameras. The amount of the check was for \$2,500. Officer Candelaria drafted an arrest warrant for the female.

On December 3, Officer Lopez-Shook observed a father panhandling with his 13 year-old son. When Officer Lopez-Shook contacted the father and son, she discovered the father was under the influence of narcotics. The father said they were homeless and the child's mother was currently at a local motel. Officer Lopez-Shook found the father had an outstanding felony arrest warrant. Officer Lopez-Shook arrested the father for the warrant and later transported the child to his mother at the motel. Officer Lopez-Shook contacted the Children, Youth, and Family Department (CYFD) to ensure the child's safety. Officer Lopez-Shook also coordinated with the Crisis Outreach and Support Team (COAST) to obtain motel and food vouchers for the family. On December 6, Officer Benavidez participated in the annual Cops For Kids program. He spent the day with a little girl and her family taking her to breakfast, lunch, and a local retail outlet. Officer Benavidez purchased items for the little girl that were on the list submitted by her mother. Officer Benavidez also contributed his own money to purchase additional items and toys that were not on the list.

On December 8, Officers Keiper and Maycumber responded to a robbery of an individual at a truck stop. The alleged offender had fled the scene prior to the officers' arrival, but was located a short distance away by Commander Remiker. Officers LaForce and Keiper, with the assistance of the Robbery Unit, conducted an investigation. It was determined the offender had been implicated in a series of other robberies including a home invasion. On December 13, Officer Kelly was dispatched to the Northeast Substation in response to a male who was tracking the person who stole his tablet. The victim's vehicle had been burglarized earlier in the evening and the victim informed Officer Kelly that he had been following a black truck which he believed had his property inside. Officer Kelly located the vehicle and conducted a traffic stop. During his investigation, the stolen tablet was recovered along with other items belonging to the victim. The driver of the pickup was arrested for felony possession of stolen property and booked into the Metropolitan Detention Center.

On December 19, Officer Madrid was on patrol when she observed a vehicle run a red light. The vehicle proceeded at a high rate of speed. Officer Madrid caught up to the vehicle and as she attempted to conduct a traffic stop, the driver parked the car and fled on foot. Additional units arrived to help search for the subject. It was found that the vehicle was reported stolen. The subject was located a short distance from the scene and taken into custody.

On December 19, Officer Forsberg teamed up with a local mall's security officers, in an effort to catch offenders in the act of stealing vehicles in the parking lot. During the operation, Officer Forsberg apprehended a male attempting to steal a vehicle that was parked at the mall.

On December 23, Officer Burchell and Sergeant Frick were dispatched to an in-progress residential burglary call. The caller was inside his home when a male offender entered the home through a back window. The caller was hiding inside the garage while he called the police. Officer Burchell arrived on scene and noticed a suspicious female standing outside the home. He detained the female and then noticed a male flee the area in a truck. According to the victim, the female was with the male offender prior to the male entering the home. By interviewing the female, Officer Burchell identified the male suspect. The female was arrested on residential burglary charges.

Foothills Area Command...

- In December, the Foothills Area Command had 5,932 calls for service, wrote 1,153 reports, and issued 590 citations. There were 114 felony arrests, 101 misdemeanor arrests, and 26 driving while intoxicated (DWI) arrests. Fifteen community meetings were attended.
- On December 5, Officers Freidfertig and Bludworth were dispatched in response to counterfeit bills being used at a gas station. As they arrived on scene, they encountered the subject in a pickup truck with a firearm on the front seat. After further investigation, it was determined the subject was a convicted felon and he was booked for felon in possession, as well as fraud and forgery.

On December 6, Officer Garcia was dispatched in response to one-year-old twins locked inside a running vehicle. The young children were extremely upset and could be heard crying. Officer Garcia arrived on scene within three minutes of dispatch. He used a coat hanger

until he was able to disengage one of the locked doors. He freed the frightened children in less than five minutes. The children were assessed and found to be unharmed.

On December 6, Officers Freidfertig and Bludworth were dispatched to a shooting call. Two males were breaking into vehicles at a residence and eventually pointed a gun at the homeowner who returned fire. After further investigation, it was determined the homeowner shot five rounds into the suspect who was later located at a local hospital.

On December 8, Officer Bludworth was dispatched in response to found items left behind in a motel room. Upon arrival, Officer Bludworth discovered a multitude of checks, New Mexico driver's licenses and manufacturing equipment. Officer Bludworth conducted an investigation which resulted in a response from the Secret Service due to the magnitude of the found items. Officer Bludworth handed over \$50,000 worth of fraudulent checks and identification items to the Secret Service. The items were subsequently found to be directly related to a repeat offender who had been targeting numerous businesses in the Foothills Area Command.

On December 12, Officer Shultz was dispatched to a domestic violence call. Officers were advised the adult son lived with his mother and her granddaughter. The victim told her son to leave the home after he was drinking alcohol all day. When the victim walked down stairs to tell her son to leave, he grabbed her ankles and pulled causing her to fall on her back on the stairs. The offender then grabbed the victim by her wrists and told her he was going to kill her. At this time the granddaughter called police, but the offender subsequently pulled the phone from her. The victim and granddaughter left the house and waited outside for officers. Once officers arrived, they searched the home and located the son in a closet and placed him under arrest for domestic violence, battery upon a household member, interference with communications, concealing identity, and a child abuse-situation. On December 12, Officer Simmons was dispatched to a call in response to a subject who was stealing metal from a vacant business. Sergeant Geha located the suspect and his vehicle at a nearby scrap metal yard. Officers took the subject into custody after the reporting party positively identified him. The owners of the business were located and advised of the

situation. They took back the stolen property. The subject was transported to the Prisoner Transport Center where he was booked. On December 18, Officers Garcia and Aragon were dispatched to a wanted person call involving a 15 year-old that had two active felony warrants. The caller was the subject's father. Upon arrival, the subject ran into his room and threatened to hurt himself because he did not want to be arrested. Officer Aragon took over dialogue with the subject in attempt to get him to come out of his room with no weapons. After some time, the subject willingly came out of his room and officers had the subject evaluated by paramedics on scene and transported to a local hospital for evaluation. He was booked at the Juvenile Detention Center for his pending warrants.

On December 26, officers were dispatched to a call involving a home owner who discovered two subjects breaking into his vehicle. The home owner confronted the subjects in front of his house. The encounter turned violent and the home owner was stabbed and subsequently died as a result of his injuries. Homicide detectives suspected a subject who had just been arrested for unlawful carry of a deadly weapon and possession of marijuana. After an interview, the subject was charged and booked for the homicide. Officers Rogillio and Denerstein and Sergeant Brodbeck assisted detectives in locating a second offender for the homicide. Officers and detectives established a perimeter around a house and after several public address announcements, the other offender walked out of the home and was taken into custody. The offenders were also tied to three other auto burglaries.

On December 25, Officer Smith, assisted by Team 1, captured two out-of-state fugitives who stole a vehicle from a Washington, Missouri police impound and drove it to Albuquerque where they were subsequently captured. They were booked on automobile theft charges.

Field Services Bureau - West Valley Area Command...

In December, the Valley Area Command had 5,689 calls for service, wrote 1,010 reports and issued 576 citations. There were 107 felony arrests, 117 misdemeanor arrests, and 25 driving while intoxicated (DWI) arrests. Six community meetings were attended. On December 5, officers responded to a report of an individual on the caller's porch armed with a knife. The suspect was attempting to break down the caller's door. Upon arrival, officers noticed damage to the door and that it was ajar. Officers pushed the door open and observed a male suspect standing inside of the residence. A kitchen knife was on the floor at the male's feet. When the male was ordered to walk out of the house, he crouched down as if to grab the knife. Two officers physically controlled the male and he was taken into custody. The terrified caller, who had sheltered herself in a locked bedroom, stated she had never seen the suspect before. Further investigation revealed the neighbor's door had also been kicked in and property had been removed from the residence. The suspect was booked for aggravated burglary. On December 6, a city-owned bait car was stolen. Radio control tracked the vehicle and provided updates on the vehicle's location. Officers proceeded to the area and once units were behind the vehicle, the order was given to disable the vehicle. Once the vehicle was disabled, the male driver exited and fled on foot. Acting Sergeant Molina gave chase on foot and took the male into custody without incident. A female who was in the front passenger seat was also taken into custody.

On December 12, officers responded to a shots fired call. The caller reported he had shot a male intruder at least once with a shotgun through the door of his bedroom when he discovered the male inside his house. Officers arrived on scene. established a perimeter and had the caller and his wife exit the house through the rear door. The house was cleared with assistance from the K-9 Unit and it was determined that the intruder was no longer in the residence. Through the course of the investigation, officers located an address in the Southwest Area Command that the intruder might be at. It was confirmed he was there and injured with a gunshot wound to the back of the head. The intruder was apprehended and given medical treatment for a minor gunshot wound. A stolen vehicle was also recovered at the address. The suspect was booked for breaking and entering, receiving/transferring a stolen motor vehicle and two felony warrants. On December 16, Officers Maxwell and Jacoby and Sergeant Bowie responded to a possible burglary in progress. The caller observed the suspects break the window of an apartment and enter the residence. A perimeter was

established and announcements were made for the occupants to exit. A male and female suspect exited the front door and were taken into custody. The legal resident of the apartment was contacted and stated he did not give permission for anyone to enter his apartment or to break his window. Both suspects admitted to breaking the window and entering the residence. The male suspect was found to have three outstanding felony warrants. The female was also booked for breaking and entering and conspiracy. On December 24, Officer Chavez responded to an aggravated battery call. A female was struck in the head numerous times with a rubber mallet and the offender left on foot with two small children. Officer Chavez contacted the victim who requested medical assistance and stated her niece was the offender. The altercation took place inside a vehicle which also contained the two children, ages one and four. The victim was transported to the hospital by ambulance for lacerations to her head. Officer Olivas located the offender at a nearby gas station with the small children. The suspect was arrested and booked for aggravated battery with a deadly weapon, child endangerment and tampering with evidence. The Children, Youth, and Family Department (CYFD) responded to the scene and took custody of both children.

On December 26, Officers Jones and Chafin were dispatched to a female walking in traffic. When they arrived, they made contact with the female who was crying, scared and obviously battered. The officers established a rapport with the victim who was extremely scared of the police. They made her feel comfortable enough to explain she was a victim of human trafficking. The victim described horrific events that had happened to her and described details of the same events occurring to others. The female was transported to the hospital for treatment. At the hospital, officers briefed detectives of the Vice Unit who interviewed the victim for over two hours and obtained information regarding a human trafficking operation. Arrest and search warrants were obtained and the offender was arrested. The United States Assistant Attorney's Office will assume federal case responsibility.

Southwest Area Command...

In December, the Southwest Area Command had 5,117 calls for service, wrote 1,034 reports, and issued 732 citations. There were 57 felony arrests, 82 misdemeanor arrests, 15 driving while intoxicated (DWI) arrests and 27 warrants issued. Eight community meetings were attended.

In December, various officers assisted with Santa patrol, food drives and other community service events for the holidays. Officers assisted with the holiday food drive picking up food boxes for families that are less fortunate in the Southwest Area Command. Food boxes were distributed throughout the area command making the holidays brighter for all involved. Assistance was provided to the Calvary Church in distributing toys, targeting areas where the gifts would be the most beneficial. On December 3, Officer Romero conducted a traffic stop on a suspicious vehicle. The vehicle turned out to be stolen and one of the subjects fled the scene. Officers Michaud and Cravens found the subject and got into a foot chase with him. The subject fled to a mobile home park. With the help of the Air Support and the K-9 Units, the subject was apprehended. On December 6, Sergeant Tapia conducted a traffic stop on a vehicle which did not have the correct license plate. She identified the driver who fled on foot. The vehicle was towed for a vehicle identification number (VIN) inspection, a summons was issued for the driver, and his probation officer was contacted to revoke his probation. He was subsequently arrested by the probation officer as a result of the new charges. On December 18, Officer Baca and additional Southwest Area Command officers were dispatched to a shooting. When officers arrived, several casings were located in the middle of the street along with fragments of a round embedded in the garage of a residence. During Officer Baca's investigation, he was advised through dispatch that an adult male had walked into a local hospital with a gunshot wound to his left shoulder. Officer Baca proceeded to the hospital and made contact with the victim. While speaking with the victim, Officer Baca learned he was shot by a known individual. The individual had an ongoing issue with the victim but the victim did not know why. Through his continued investigation, Officer Baca learned the victim was wanted on a warrant by Immigration and Customs Enforcement (ICE). The victim was booked into Metropolitan Detention Center for the felony warrant.

On December 19, Officers Tafoya, Sanchez and Higgs were notified of a crash with injuries. When officers arrived, they discovered one

of the vehicles empty and later stolen when checked through the National Crime Information Center (NCIC). Witnesses indicated the male had fled on foot to a nearby restaurant where he was later located by officers. The male failed to follow the orders of officers, was combative and eventually was subdued. He was booked for receiving and transferring a motor vehicle in addition to other felony charges.

On December 20, a subject was threatening suicide by cop. Members of Team 9 subdued the subject and ultimately resolved the situation. The subject was transported to a local hospital for treatment and for a mental health evaluation.

Northwest Area Command...

- In December, the Northwest Area Command had 5,110 calls for service, wrote 893 reports, and issued 654 citations. There were 74 felony arrests, 115 misdemeanor arrests, 24 driving while intoxicated (DWI) arrests; and 73 warrants issued. Five community meetings were attended.
- On December 3, Officer Poccia and Sergeant
 Norris were dispatched to a residential burglary.
 A male subject had forced his way into a
 residence and was inside the bedroom of an
 elderly female. Officer Poccia and Sergeant
 Norris made forced entry into the bedroom and
 took the suspect into custody without incident.
 The female suffered minor injuries.
- On December 3, detectives followed up on a purse snatching from an elderly woman that occurred in October. The offender had used the victim's credit card throughout the metro area. Detectives collected surveillance footage of the incident and used the local media to help identify the offender. Several tips were received and the offender was identified. Detectives arrested her on several felony charges related to the incident.
 - On December 4, detectives investigated an aggravated assault with a handgun at a local hardware store. Detectives learned two subjects entered the store and selected a nail gun valued at over \$500 and walked out the front door. A store worker confronted one of the subjects and attempted to detain him. The offender produced a handgun and pointed it at the worker. Both subjects fled the area. Detectives checked with local pawn shops and located the stolen nail gun. Surveillance footage received from the pawn shop helped identify the offenders. One offender has been arrested.

On December 9, officers were dispatched to a shots fired call. Officers arrived on scene and contacted the victim, who reported being assaulted by two male subjects. The victim stated the offender was driving recklessly through the parking lot full of high school students. The victim attempted to contact the offender who pointed a handgun at him as he fled the area in his vehicle. Witnesses reported seeing the offender fire a handgun in the air as he drove away. Detectives worked with the Gang Unit and identified the offender and arrested him without incident.

On December 13, officers conducted a felony stop on a vehicle matching an armed robbery. The vehicle was not the offending vehicle and the people were released without incident. Officer Saladin took note of a four year-old girl in the car that was crying and frightened. The following day, Officer Saladin created a gift package for the four year-old and presented her with the gift. The four year-old and her parents were shocked and grateful at the kind gesture. The family posted favorable support for the Albuquerque Police Department on social media.

On December 14, Sergeant Sanchez located a stolen vehicle while on random patrol. The vehicle was occupied by four subjects. The driver was placed under arrest with the assistance of other officers. A total of three subjects were arrested for outstanding felony and misdemeanor warrants and for being in possession of a stolen motor vehicle. The vehicle was returned to its original owner. On December 26, Officers Ibarra and McCracken were dispatched to a missing persons call. The family was concerned due to mental disabilities of the missing person and their belief the person was in the company of a criminal. The family also believed the two individuals were in a vehicle they stole from family members. Officers located the missing person and made an arrest of the subject. On December 29, officers followed multiple male subjects in a stolen vehicle from a local gun shop to a shopping mall parking lot. All four subjects were arrested for transferring/receiving a stolen vehicle and conspiracy to commit a fourth degree felony. The subjects had a total of four felony and eight misdemeanor warrants for their arrest.

On December 31, officers responded to an armed subject that had entered the caller's home.

The subject appeared to be suffering a mental episode. While on scene, officers established a perimeter at the home and saw the subject was armed with an axe. Officers were able to have the subject exit the home without harming anybody. The subject was also found to be armed with multiple knives.

Special Services Bureau Special Operations Division...

Tactical...

- In December, the K-9 Unit answered 170 calls for service. There are currently four dogs available for calls with two police service dog teams in training.
- On December 3, members of the K-9 Unit assisted the New Mexico State Police Tactical Team in the service of a high risk search and arrest warrant in Espanola, New Mexico. The warrant was part of a state-wide operation involving the Federal Bureau of Investigation (FBI), New Mexico State Corrections Department, Bernalillo County Sheriff's Office, and the New Mexico State Police. The operation targeted alleged prison gang members.
- On December 3, members of the K-9 Unit were dispatched to a commercial burglary at a local restaurant in the Southeast Area Command. The subject was located hiding in the business but refused to surrender. The call was resolved when the entry team apprehended the subject with a police service dog.
- On December 26, the Special Investigations Division (SID) was investigating a homicide in the Foothills Area Command. SID detectives believed the homicide suspect to be inside a vehicle and asked the K-9 Unit to make a traffic stop. K-9 officers made the stop and located the suspect. The suspect was taken into custody without injury.
 - In December, the Bomb Squad responded to six explosive ordnance (EOD) call-outs.

Office of Emergency Management... (OEM)...

In December, OEM completed the creation of training guides to instruct individuals on the following course titles: Emergency Operations Center 101, Planning Section Duties, Finance Section Overviews, Logistics Sections Responsibilities, and Operations Section Overview.

On December 7, OEM attended a meeting with

the State of New Mexico and Kirtland AFB to review plans for Cities Readiness Initiative (CRI)/Strategic National Stockpile Program medical dispensing program.

In December, OEM provided Emergency Management Plan overview training to the City's Transit and Parks and Recreation Departments.

On December 11, OEM coordinated a winter storm response workshop attended by City of Albuquerque departments, the National Weather Service, Albuquerque Public Schools, and the private sector.

Homeland Security...

•

In December, Homeland Security conducted six active threat classes for private businesses and schools. Presentations were conducted for PNM, the Hispano Chamber of Commerce, and several private schools.

On December 22, Homeland Security attended a briefing with the New Mexico Department of Homeland Security and Emergency Management regarding the Syrian conflict and its effect on the United States.

Open Space...

•

On December 7, the Bernalillo County Fire Department (BCFD) contacted Open Space and stated there was a man who had fallen while mountain biking after dark at a local park. The man had suffered a serious leg injury. Global positioning system (GPS) coordinates were used. The location where he had fallen required the utilization of four wheel drive vehicles and a hike to get to the patient. BCFD paramedics were transported as far as officers could drive and then everyone hiked the rest of the way. The man was treated by paramedics and then loaded onto a stretcher. He was carried out by Open Space and BCFD personnel to the four wheel drive vehicle, where he was driven out to an ambulance and transported to the hospital. On December 10, Open Space responded to a call at an arroyo on the West Mesa. A vehicle had rolled over and the occupants were stranded. Officers were able to roll the vehicle back onto its wheels. The occupants were transported home and they subsequently returned with a truck to tow the vehicle back home. On December 15, officers from the Open Space Unit conducted a search and rescue at an Open Space park. The caller became disoriented and

thought she was lost. Several officers responded and gathered information to pin point the subject's location. Officers hiked up the trail and located the subject, evaluated her condition, and ensured that she reached her destination safely. The subject did not require medical attention and departed from the scene. On December 26, a young man posted on social media that he had rolled his jeep. Officer Harvey saw the post and got global positioning system (GPS) coordinates from the picture. Officer Melvin located the young man and helped get the vehicle upright. A snowstorm came in and the temperatures were extremely cold that night.

On December 27, I-40 was shut down due to the blizzard preventing primary access to the East Mountains. Several outdoor enthusiasts tried utilizing Forest Road 165, from Placitas, to gain access to the snow play and ski area. Open Space Search and Rescue was called in to locate a family with two children who had slid off the road and got stuck in the forest. While making their way up Forest Road 165, officers found three additional families with small children stuck in the snow. Officers pulled them out in order to clear the road. After several hours of work and searching, officers located the original family. Officers recovered the vehicle, got the family back on the road and safely down the mountain.

On December 28, Officers Candelaria and Harvey were scanning the air waves and heard the Bernalillo County Fire Department (BCFD) call out with a search and rescue for a lost skier. The officers offered assistance and helped by getting better coordinates on the lost skier. The skier was located and brought down to safety.

Horse Mounted Unit (HMU)...

- The Horse Mounted Unit participated in nine special events throughout December including a number of Toys for Tots and Cops for Kids events.
- On December 3, the Horse Mounted Unit worked the Nob Hill Shop and Stroll. Four horses were utilized during this event. One call for service was taken in response to a fight in progress.
- On December 4, the Horse Mounted Unit worked the Old Town Tree Lighting/Shop and Stroll. Five horses were utilized and several thousand positive citizen contacts were made. The Mayor was in attendance at this event.

On December 5, the Horse Mounted Unit worked the Twinkle Light Parade. Seven horses were utilized for this event with thousands of citizens in attendance including dignitaries from the City of Albuquerque. The Mayor, Chief of Police and many staff members were in attendance and the event received coverage by the media. The horses were decorated and positively received by citizens. The unit responded to a disturbance along the parade route and handled the call without incident. On December 6, the Horse Mounted Unit worked the Holly Holm parade. Five horses were utilized for this event. An estimated 20,000 people were in attendance including many dignitaries from the State of New Mexico and City of Albuquerque. The horses were well received in the parade. The unit assisted with dignitary protection for Holly Holm, Governor Susana Martinez, Mayor Berry and City Council members.

Metro Traffic Division...

- In December, the unit responded to 267 calls for service.
- In December, the unit had 58 driving while intoxicated (DWI) arrests; six felony arrests; and nine misdemeanor arrests/warrants.
- In December, the unit issued 674 moving citations; investigated 129 crashes; towed 106 vehicles; and had 18 DWI vehicle forfeitures.
- In December, the DWI Seizure Unit checked in 55 vehicles; returned 15 vehicles; removed 16 boots; and had 62 vehicles ready for auction. Four hundred and eleven (411) vehicles were in the lot.

Prisoner Transport Unit (PTU)...

In December, the Prisoner Transport Unit processed 1,017 prisoners through the Prisoner Transport Center. The Albuquerque Police Department arrested 802 prisoners and other law enforcement agencies arrested 215 prisoners. PTU made 201 trips to the Metropolitan Detention Center and accepted two walk-in prisoners at the Metropolitan Detention Center. In December, PTU worked three hospital guard duty assignments for a total of 19 days.

Metro Court Protection Detail (MCPD)...

In December, 55 individuals were remanded by the court and booked; six individuals were remanded and bonded out. In December, MCPD completed 115 floor checks and 51 escorts.

Investigative Bureau Scientific Evidence Division...

- In December, the Major Crime Scene team responded to seven primary call-outs.
- In December, Field Investigations responded to 1,218 calls for service and 270 primary burglary calls.
- In December, Field Investigations collected 811 latent fingerprint cards; tagged 560 evidence items; and tagged 486 photograph CDs.
- In December, the Photo Lab worked on 344 cases resulting in 4,835 prints and 408 discs.
- In December, the Evidence, Identification and Disposition Unit supported the following backgrounds: 89 case dispositions, 86 employment, 33 firearms, 107 FBI and 32 CODIS requests. 50 RAPs and photos were distributed, 33 new APD applicants were finger printed, 1,106 fingerprints were classified in AFIS and 1,287 new and old arrests were processed into the TIBURON criminal history records.
 - In December, the Evidence, Identification, and Disposition Unit received 9,251 evidence items, duplicated 5,760 audio/video recordings and supported 20 pretrial viewings. Efforts to reduce inventory resulted in 330 items returned to owners; 6,552 items disposed; and \$2,540.14 received as auction proceeds. The unit also processed 1,982 case disposition transactions into evidence history.
 - In December, the New Mexico DNA Identification System (NMDIS) received 503 new convicted offender/arrestee DNA samples, with a cumulative total of over 109,000 collected. 489 samples were analyzed, uploaded, and searched in CODIS, with a cumulative total of almost 102,500 searchable DNA profiles. As a result of these convicted offender/arrestee samples, 12 unsolved cases were matched to convicted offenders/arrestees, ten case-to-case matches were made, with a resulting total of 22 investigations being aided. In December, the Controlled Substance Unit
 - completed 58 drug cases (36 were APD and 22 were Bernalillo County Sheriff's Office).
 - In December, the Biology Unit completed 28 APD cases.

Criminal Investigations Bureau Property Crimes Division...

Auto/NITe Unit ...

•

In December, the Auto/NITe Unit conducted training at the academy, teaching the newest class of cadets the Auto Theft Recognition Course. Personnel continued to conduct Vehicle Identification Number (VIN) inspections to identify altered vehicles. Auto/NITes also assisted the Organized Crime Unit in their tactical plans providing arrest support and proactive patrols in and around the retail shopping centers during the holiday season. In December, Detective Lovato alone, located and recovered three stolen vehicles utilizing vehicle equipped tracking systems.

On December 4, while working the holiday tactical plan, Auto/NITes detectives located a stolen/embezzled vehicle. After conducting surveillance on the vehicle, they took both the driver and passenger into custody. The vehicle was returned to its rightful owner.

On December 5, while working the holiday tactical plan near a mall, Detective Hernandez located an occupied stolen vehicle. Detectives made contact with all occupants of the vehicle when they exited and attempted to enter the mall. The driver was booked for receiving and transferring and the passengers were found to have felony warrants.

On December 6, detectives were working a holiday tactical plan near a mall when they located a stolen truck. Detectives followed the truck and conducted rolling surveillance as it met up with a second truck. Detectives followed the trucks to various department stores until they finally stopped at a home improvement store. Detectives watched as the occupants of the stolen truck ran into the store to steal a couple of drill sets worth over \$500. Detectives continued to follow both sets of trucks and watched as they transferred the stolen property from one truck to the other. After the trucks separated, the second vehicle was stopped by K-9 Officer Hernandez, and the driver was taken into custody. Detectives also stopped the stolen truck. In total, five offenders were booked into the Metropolitan Detention Center. Also located in the stolen truck were 18 swords and knives, which the offenders admitted to taking earlier the same morning in a residential burglary. On December 14, Auto/NITe Detective Economidy located a vehicle which had been

taken in a carjacking. Detectives watched as suspects got in and out of the vehicle several times, as well as, making several hand-to-hand narcotics deals in the parking lot. Detectives waited until the suspects exited the vehicle and returned to their room. Once the suspects were in their room, a perimeter was established to make contact with the occupants. The driver exited the room and attempted to flee on foot, but was caught by officers who were holding the perimeter. After public announcements were made, an additional three subjects exited and were taken into custody. Located in the center console of the vehicle was a loaded handgun. Offenders were arrested and booked on misdemeanor and felony warrants, felony parole violations and receiving and transferring a stolen motor vehicle, and possible felon in possession charges pending DNA results on the handgun. On December 17, Detectives Lovato and Marquez located an occupied stolen vehicle utilizing a vehicle location system. The female subject was placed into custody and subsequently gave detectives information to a possible "chop-shop" located in the Valley Area Command. Detectives located the "chopshop" and, after utilizing SWAT to secure the location, recovered a stolen van, two trailers and a motorcycle.

On December 22, Auto/NITe detectives responded to a bait car activation. The offender entered and unlawfully took the city owned bait car and the property within. The offender was located leaving the bait vehicle with traceable bait property and was taken into custody a short distance from the vehicle. The offender was verified via video from within the bait car and admitted to having stolen the car and property to sell for money. He was booked for unlawful taking of a motor vehicle, possession of burglary tools, possession of methamphetamines and receiving and transferring stolen property.

Burglary and Organized Crime Unit ...

The Burglary and Organized Crime Unit participated in a fourteen day holiday tactical plan in Albuquerque retail districts during the Christmas shopping season. During these fourteen days there were 21 felony arrests, seven felony warrants cleared, 21 misdemeanor arrests, ten misdemeanor warrants cleared, eight stolen vehicles recovered and 38 reports written. Also, a number of misdemeanor citations were issued, 28 criminal trespass notifications were given out

and over \$5,000 in stolen property was returned to retailers.

On December 3, Detective Jojola was assigned a fraud case in regards to a credit union taking a loss of over \$4,700. The female offender had fraudulently cashed several checks in her name. Detective Jojola obtained an arrest warrant for the offender. She was located and interviewed. She admitted to committing the crime, and gave the name of a second person involved with her. She was arrested on the charges and the case was sent to the District Attorney's Office for prosecution.

On December 8, detectives with the Organized Crime/Burglary Unit were working the holiday tactical plan when they came in contact with a subject involved in a major fraud ring affecting numerous businesses across the country. At the time, he had defrauded one department store chain in an excess of \$45,000. He was currently traveling under an assumed name and presented a false identification with his picture on it. A search warrant performed upon his vehicle led to the discovery of multiple fraudulent identifications, forged checks, and other identity theft items. He faces charges for multiple counts of identity theft, forgery, and fraud. On December 11, detectives arrested a repeat offender during the holiday tactical plan. He was observed opening a fraudulent credit account in another person's name. The offender purchased over \$1,000 of merchandise on the fake account. He had been arrested multiple times for identity theft, forgery and fraud charges. He was planning on returning to the store and purchasing appliances on the same account. The offender was booked into Metropolitan Detention Center. On December 18, officers in the Valley Area Command responded to a commercial burglary where a victim's motor vehicle was taken. Surveillance video showed a male offender inside the business. The video was turned over to Burglary detectives who worked the case. Later the same day, Southeast Area Command officers located the stolen vehicle occupied by three persons. Burglary detectives responded and recognized the driver, from the surveillance video, as the same male that committed the burglary. The male was charged with the burglary and auto theft. The other two occupants were charged with receiving/transferring a stolen motor vehicle. The stolen vehicle was still loaded with over \$7,000 of stolen property from

Criminal Investigations Division...

In December, the Homicide Unit responded to six call-outs. Two of the call-outs were homicides and the other four were major crimes. On December 11, officers were dispatched to a shooting call. When they arrived, they contacted the caller as well as a few witnesses who were attempting CPR on a male victim. Officers secured the scene and took over the rescue efforts. The male victim was transported and pronounced deceased at the hospital. The investigation showed this was a case of selfdefense.

On December 20, officers were dispatched to a stabbing. Upon arrival, officers located a male victim and he was quickly transported to the University of New Mexico Hospital. The scene was secured pending investigation and resulted in a Violent Crimes call-out. Detectives determined the offender and victim were drinking together when the incident took place. The offender was detained and eventually arrested.

On December 26, officers were dispatched to a stabbing call. When officers arrived, they located the victim who was transported to the University of New Mexico Hospital where he later died of his injuries. Officers learned the victim was attacked when he confronted two male subjects who were burglarizing his vehicle. Detectives determined the identity of the subjects and they were arrested.

On December 27, officers were dispatched to a shots fired call. When officers arrived, they discovered there had been a party where a physical fight had ensued and gunfire erupted. Three people were shot, one of them fatally. The case resulted in a full Violent Crimes callout. There were two shooters who were both identified and arrested.

The Armed Robbery Unit responded to nine robbery call-outs and cleared 41 cases during December. Of those 41 cases, 19 were sent to the District Attorney's Office for prosecution. The unit also made seven in-custody arrests and wrote seven arrest warrants. Furthermore, they wrote and conducted three search warrants. The Robbery Unit had 37 new cases assigned this month and has a total 140 active cases. The Sex Crimes Unit responded to one Sex Crimes call-out this month. They also cleared 27 cases with 11 of those going to the District

Attorney's Office. The unit also wrote eight search warrants. There were 24 new cases assigned for investigation in December. The unit currently has 92 active cases.

- The Family Abuse and Stalking Training Team (FASTT) cleared 14 cases this month with three of them going to the District Attorney's Office. The FASTT Unit reviewed 95 cases this month. The FASTT Unit currently has no active cases. There were 79 new runaways/missing persons reported to the Missing Persons Unit this month. The unit cleared 71 total runaways/missing person cases. The unit currently has 85 active cases.
- In December, Crisis Intervention/Juvenile Section held two 40-hour CIT certification classes. A total of 62 officers received certification. There is a total of 462 (97%) officers, sergeants and lieutenants CIT-certified in the field.
- CIT detectives and the Crisis Outreach and Support Team (COAST) had numerous contacts at schools, the Family Advocacy Center and offsite during the month of December. There was a total of 170 calls for service and 135 transports to the hospital.
- The Crimes Against Children Unit (CACU) received 1,014 referrals from the Children, Youth, and Family Department (CYFD). CACU detectives were assigned 55 new cases to be investigated and on-call detectives responded to 15 call-outs.

Special Investigations Division...

- In December, SID completed 747 surveillance hours.
- In December, SID had eight misdemeanor arrests and issued five misdemeanor warrants.
- In December, SID had 16 felony arrests and issued 15 felony warrants.
- On December 7, the Gang Unit worked with the Safe Streets Task Force to serve a narcotics search warrant. Fifteen pounds of methamphetamines and three gallons of methamphetamine oil were confiscated. The estimated street value on the narcotics is over \$200,000. Three suspects were arrested and booked.
 - On December 10, the Gang Unit was contacted by Northwest Impact Team to assist with the apprehension of a subject. The subject was a known gang member and the unit was advised he had a felony warrant for a shooting he was believed to be involved in. Detectives located

the subject and placed him under arrest without incident.

- On December 17, the Gang Unit was requested to assist with the apprehension of a subject who had an active warrant for homicide. The unit located him and took him into custody. During the investigation it was discovered that he was a member of a newly formed street gang that has been involved in homicides, home invasions and car jackings in the Albuquerque area.
- In December, the Vice Unit concluded an ongoing federal human trafficking investigation.
 Vice mainly assisted with surveillance and confidential informants. The investigation is currently under review by the Assistant United States Attorney's Office for prosecution.
 On December 3, an officer observed a vehicle with a stolen license plate at a gas station. As
- Air1 arrived in the area, the vehicle left the gas station and entered onto Interstate 40. As the vehicle drove west, units attempted a traffic stop and the vehicle fled. All units dis-engaged and Air1 conducted a "tactical follow". The vehicle made a turn and parked behind a building. The driver exited the vehicle and walked away. Air1 directed units to the subject and she was detained without incident. The female offender was arrested and the vehicle was recovered. On December 30, Air1 assisted units who were attempting to stop a vehicle involved in a domestic violence incident with the driver also believed to be under the influence. The vehicle did not yield to officers. Air1 arrived and started a "tactical follow" having all ground units dis-engage and back off from the vehicle. The vehicle came to a stop in an apartment complex parking lot and units were directed to the vehicle. The driver was taken into custody without incident. The driver was arrested for domestic violence, failure to yield, and driving
- while intoxicated (DWI).
 In December, the Central Narcotics Unit assisted with serving two search warrants where six firearms were recovered by detectives and 1,360 grams of heroin was also recovered and seized by federal authorities.
- The Central Narcotics Unit received information that an individual was trafficking large quantities of crack cocaine throughout the Southeast Area Command. A controlled buy of crack cocaine was made at the subject's residence. The subject was charged with felony narcotics trafficking. The Central Narcotics Unit served a search warrant at the residence and detectives located

a trafficking amount of crack cocaine and trafficking paraphernalia.

The Central Narcotics Unit received information that an individual was distributing large quantities of methamphetamines and heroin throughout several of the area commands. Detectives confirmed that the individual had absconded from Probation and Parole and had an active warrant for the probation violation. Detectives arranged a purchase of an ounce of heroin and methamphetamines from the individual at a local restaurant. The subject was taken into custody without incident. Detectives served a search warrant on the vehicle and seized 42 grams of methamphetamines and drug trafficking paraphernalia. The subject has a lengthy criminal history to include previous drug trafficking and robbery charges. He will be charged with additional counts of drug trafficking.

Real Time Crime Center (RTCC)...

- In December, The Bridge assisted in 2,917 calls. About 76% of those were intervention from the operators in the Bridge.
- The Crisis Intervention Case Management System had more than 4,000 cases and was utilized 2,354 times in December. About 41% of the calls worked were suicide, mental health or domestic disturbance calls. The video network was also utilized 363 times.
- In December, live operations deployed multiple trailers at several malls and shopping centers in order to minimize theft during the holiday shopping season. Live operations also deployed trailers in the downtown area in order to assist with critical incidents and additional coverage during the New Year's celebration. During all deployments, personnel were assigned to provide continuous monitoring of all trailers and provide field personnel with real time situational awareness of incidents that could compromise the safety of attendees.

Professional Accountability Bureau Communications Division...

In December, the APD Emergency Communications Center staff answered 76,100 incoming calls. There were 32,091 calls answered for 911 and 44,009 calls answered for 242-COPS. 911 Operators answered 89.3% of the 911 calls within 10 seconds (national standard is 90%, APD's standard is 92.0%);

operators also answered 93.19% of the 242-COPS calls within 30 seconds (APD's goal is 90% answered within 30 seconds).

- Incoming calls have increased as compared to last year for the month of December. 9-1-1 calls increased by 12.52% and 242-COPS increased by 9.53%. The overall increase was 10.77%.
- In December, a meeting was held with the Chair and Co-Chair of the Albuquerque Mental Health Commission, Emergency Communications and the Albuquerque Fire Department to discuss how to handle the dispatch of mental health calls.
- In December, tours of the Communications facility was provided to a Crime Analysis Unit and the Animal Welfare Department.
- On December 11, the Emergency Communications manager participated in a winter storm response planning session attended by other City of Albuquerque departments, the National Weather Service, Albuquerque Public Schools, and the private sector.

APD Academy...

- In December, there were 36 cadets in the 114th Cadet class.
- In December, 272 interest cards were received (214 cadets, 47 public service aides (PSAs); and nine laterals).
- In December, background folders were assigned for 52 cadets, eight PSAs, two laterals, and six civilians.
- The December 4-6 testing consisted of 112 individuals scheduled to test; 26 attended City entrance; 23 attended Saturday testing; and 13 were passed to background.
- The December 18-20 testing consisted of 259 individuals scheduled to test; 54 attended City entrance; 46 attended Saturday testing; and 36 were passed to background.
- Thirty-five cadets and eight PSAs are seated for the 115th Cadet class.

Administrative Support Bureau Planning Division...

- In December, Planning Division staff met with the City of Albuquerque Lobbyists to discuss prospective and current public safety programs.
- In December, the Planning Division completed the process of closing out fiscal year 2015 grants.
- On December 21, the Planning Manager attended a Procurement Contract Update training.

- In December, the Public Information Unit received 1,079 requests totaling \$3,826.25 in revenue generated from citizen requests/ registers.
 - In December, the Report Review Unit completed the following: 2,439 Automated Reporting System (ARS) transfers; 650 ARS supplements; 1,323 National Crime Information Center entries; 2,994 accidents; 2,599 officer calls; and 239 Unified Crime Reports (UCR).
 - In December, Court Services completed the following: 144 pretrial hearings scheduled; 323 arraignments processed; 410 felony cases submitted to the District Attorney's Office; and 403 summonses submitted to the Metropolitan Court.
- In December, the False Alarm Reduction Unit collected \$83,975 in fees and fines and entered 457 new registrants.
- In December, the Telephone Report Unit generated 635 original reports and 178 supplemental reports for a total of 813 reports. This resulted in a savings of 2,113.80 hours of field services time and a savings of \$32,520.
- In December, the Telephone Report Unit processed 532 on-line (Cop Logic) reports resulting in a savings of 1,383.20 hours of field services time and a savings of \$21,274.
 - In December, the Inspection of Public Records (IPRA) received 134 requests; completed 108 requests; and collected \$3,472 in revenue.
