## IV. Committee Reports

- Community outreach committee met with three of the morning shifts Northeast area command briefings on Monday, Wednesday and Friday, to educate them about the community policing councils and their purpose. During this time, there was quality interaction and the committee received good feedback and putting those in a package.
- Update on the recommendations- "We have decided to go through these and clean them up with the new changes in Chief and Mayor. The recommendations that will be closing are the CPC summit recommendation, submitted an APD staffing recommendation, (this should not have been closed), this is an ongoing issue and we are working on sending out some new recommendations. There are recommendations for bike patrol officer that has been made and Commander Burke has informed us of the success with getting those."

There was a motion to close the four recommendations, seconded and approved.

V. Our council has drafted a letter in regards to issues we have regarding an ongoing issue off Eric Street. A Silver Living Facility. We have heard from a number of neighbors who stress a series of concerns. More needs to be done on this from a regulatory standpoint. We are not opposed to these types of homes being in the neighborhoods but they need to be done with specific regulations in mind to facilitate and reduce the crime. We drafted a letter for City Council to look into these entities.

- Silver home issues or the ordinance:
- · Robert Vialobos, director of Hoffman hall- works for the silver living community stated, "I have no tolerance for drugs, alcohol, and violence. There are times when it is not perfect. Two months ago I put a manger in there that will not even let the folks living there, have family members come into the home if under the influence.
- Moe manager of the silver living community stated, "That place was out of hand and the first thing I did was starting to throw people out. I do not allow music outside unless with earplugs. I have a couple of neighbors I speak with on a regular basis. The place itself is only as good as his leadership, if you have any questions or concerns please reach out. I do suggest you come in and see what it going on for yourselves.
- Commander burke- We have gone out because we were not having success with the homes. I think I got 22 complaints. It is tough for us because we want them to be good neighbors but we want other neighbors to have an understanding on the importance of the home. We reached out to one of our stakeholder's probation and parole and we did find violations. We are going to give an opportunity for the Eric place to correct the issues. We are taking this away from the CPC to avoid taking up any more time. We will let you all know when we are having the meeting and have you meet at our substation. We are going to find time on the calendar hopefully next week so everyone can air some of the issues they are experiencing.

# VII. Commander Burke: Crime stats-

• We are getting ready to bid. The bid takes place in the middle of the august, so we will be having a new group of officers. My goal is to keep 80% of my current officers. We have 6 bike officers now, 4 on day shift and 2 on swing. We may be able to open up for officers that bid into the area command. Crime is going down in the NE. Our traffic stops are up. Casual encounters are up and I think it is all paying off. I think our crime stats are down across the board. If it were not for our investigations side of the house, we would not have this reduction.

# IX. Presentation from Special Investigations Division- Gangs and Narcotics

- Acting Commander Dave Jaramillo, from special investigations police department (SID)
  - Lt. Jaramillo, currently acting, I will hit my 18<sup>th</sup> year in January. I was the basic training sergeant at the academy for 5 years. After my time at the academy I promoted to a Lieutenant and spent almost a year as the graveyard watch lieutenant in the SE, what it did was get me back in touch with the uniformed officers and what the patrol officers are doing. I have about 5 months back at SID. I spent 2 years as a narcotics detective.
  - · We have 66 personal total assigned to SID. That is including admin and supervisors
  - · The division is broken up into two sections: Narcotics and Career Criminal, Gangs, Intel, Air support and ISU
  - · Narcs you have the central narcs unit, HIDTA (High intensity drug trafficking area), Vice and last and most recent is OCU (Organized Crime Unit).
- Sgt. Danny Porter-Supervises our gang unit now assigned as NIBIN unit.
  - · I was sworn in 1999, field officer until 2003, 2003 I went to SID-Gang, then went into valley narcs for 4 years....
- Det. Eric meek- started in 2003, worked field 3 years, came to valley narcs for 2 years, DEA for 1 year and came back to gangs.
- Det. Paul Jacobo -1983, I have only been with gangs since April of this year. NIBIN was one of his focuses when joining the gang unit.
- NIBIN (National Integrated Ballistic Information Network) is a machine that helps us connect certain crime scenes and their connection through the gun casing.
- Our mission is a liaison between some of the units. Criminal Investigations, Narks, ISU, Intel, Etc.... If there is a violent crime that involves a gang member, typically they call us. We also teach gang classes with civilian and sworn personnel. We used to do graffiti but we have other priorities, we have brought back our gang suppression unit. This involves field officers who want to come help identify gang members... the officers will be on duty, trained through us and when out on patrol they will be more aware of the gang members, new and old. We have 40 gang suppression officers. Out of those 40

officers, it is a collateral position. One of the operations we kicked off was for the SE area commands and we targeted the highest crime area. We had our gang unit, suppression officers and BCSO working and were able to make many contacts, which resulted in 20 arrests. The next operation is towards the end of the month and NE and valley are next. NIBIN- these casing are found throughout town and we are able to tie that to an individual gun. If there was no suspect info but we had vehicle info we are able to get a photo array, come back to the case, and connect the cases. This is not limited to APD but BCSO is involved as well. Our amount of cases have increased since April and currently from ATF there are 150 NIBIN related incidents since last year. As of last Tuesday, we are at 83 NIBIN leads. Compared to last year we were at 43. Each NIBIN case consists of at least two shootings that have occurred, which creates a NIBIN leads. We have one ATF analyst apart of our team; he is breaking it down and linking the cases. We also have an analyst reading our cases and taking the data to link cases and get us the numbers.

## (Q)Questions, (A)Answers, (C)Comments:

- o Q: how many gangs are there?
- O A: we have 260 gangs we have identified throughout New Mexico. Some of the gangs can be anywhere between 15-20, some can be hundreds. The gang suppression officers meet with gang members consensually and take down information and we gather that information for our knowledge.
- o Q: how much gang activity is international?
- o A: that is very difficult to give you an accurate number; we do not deal with many cartels. We do have some homicide investigations that involved cartel gang members.
- o Q: are there a lot of multi generational gang members?
- o A: yes. I have seen kids that were 12 and now 24 years old who I have seen as kids and they know us by name.
- O Q: how are you monitoring if you are suppressing gangs? The reduction.
- A: we went back to our reporting and officers are not documenting that. We have recently changed the way of the police report to put down if they are associated as a gang member.
- A: they do not live in the areas they do not do their crime.
