FIELD SERVICES BUREAU-EAST Southeast Area Command...

In October, Officer Martinez was dispatched to a caller who had located their stolen vehicle. Upon arrival, Officer Martinez witnessed the occupant exit the stolen vehicle and enter a restaurant. Officer Martinez took the suspect into custody. The suspect was in possession of the vehicle's keys and methamphetamine. The offender was arrested for being in possession of a controlled substance and receiving/transferring a stolen motor vehicle.

In October, Officer Wolffbrandt took a report and found that a 12 year-old's bicycle had been stolen during a burglary. Officer Wolffbrandt used his own money to purchase a new bicycle after learning it was the child's birthday. On October 11, Officer Schultz was dispatched on a robbery call. Comments on the call stated the offender was a male wearing a clown mask and black jacket. A second robbery call was dispatched with the same description of the offender. A male subject matching the description was found in the area. Air1 watched the subject as he dropped objects on the ground near an area where officers located a gun and mask. Dispatch advised of a third robbery in the same vicinity. Upon investigation, Officer Schultz determined all three robberies were committed by the same offender. The subject was charged with all three robberies and booked into the Metropolitan Detention Center. On October 19, Officer Romero was finishing a call when an "attempt to locate" a female was dispatched. The female had attempted to kidnap a child at a nearby store. Officer Romero located the subject and made contact with her. She was positively identified and was taken into custody for attempted kidnapping.

On October 28, officers were dispatched to a carjacking. Upon arrival, officers learned the vehicle was taken along with a four-year-old child by a female. A description of the vehicle was broadcast along with an "attempt to locate." Later that morning, a camper found the child at a campground in Bernalillo. The female was subsequently found and booked for child abandonment, child abuse, unlawful taking of a motor vehicle, and false imprisonment.

Northeast Area Command...

On October 7, Officer Benavides responded to an armed robbery call. When officers arrived,

the victim stated they were from out of town and had driven overnight to go to the Balloon Fiesta. The victim advised that she and her friend were taking a nap in her car when a male subject knocked on their car window and pointed a gun at them and told them to open the car door. The victim got her gun and pointed it at the offender who then fled. Officer Benavides located the offender and he was positively identified by the victim. The suspect was arrested and booked into the Metropolitan Detention Center. On October 7, Officer Fisher was patrolling a local motel when he noticed a suspicious subject sitting in a truck with a scooter in the bed of the vehicle. The subject appeared to be hiding from him. Officer Fisher along with other officers made contact with the subject who told them he did not know who the truck belonged to. After investigation, it was determined the truck and scooter were stolen. The subject was arrested for receiving/transferring stolen property and two outstanding arrest warrants.

On October 10, Officer A. Moreno responded to a suspicious person call. Upon investigation and communication with Southeast Area Command units, it was determined the suspicious person was the offender of a fatal hit and run and was booked for vehicular homicide.

On October 21, Officer J. Grady was dispatched to investigate a disturbance at an apartment complex. Officer Grady found a male had beaten his girlfriend and her children. The male left on foot but Officer Grady and assisting officers along with Air1 located the male. The man was arrested and charged with numerous violent crimes.

On October 23, officers were dispatched to a suspicious vehicle in the parking lot of an apartment complex. Security provided the license plate and said the vehicle was still occupied. Officers learned the vehicle was taken earlier that morning during a violent home invasion. Officers approached the vehicle and its three occupants. Two of the males were taken into custody at the scene. The third male fled on foot through the complex but was apprehended by Sergeant Edison. The investigation turned up an automatic handgun and it was determined the suspect who fled had committed the home invasion. During the home invasion, the offender had pushed a disabled elderly male and pointed a gun towards a female. The male also had five outstanding misdemeanor and felony warrants. On October 30, Officer J. Gumble was

dispatched to a male subject standing on the barrier wall of the freeway. Upon arrival, Officer Gumble attempted to make conversation with the male. Shortly thereafter, Sergeant Napoleone arrived and talked to the male about the reasons he was on the wall. The male stated he was planning on committing suicide by running into traffic on the freeway. Sergeant Napoleone was able to talk the male off of the wall. The male was checked by rescue and transported to the hospital for a mental health evaluation.

Foothills Area Command...

On October 9, Officer Knipprath was advised by dispatch that a victim had located their stolen vehicle being driven by a male subject. Officer Knipprath located the vehicle and conducted a traffic stop. The male driver was taken into custody and booked into the Metropolitan Detention Center for transferring/receiving a stolen vehicle.

On October 15. Officers Warwick and Urioste were dispatched to a suspicious vehicle with two occupants inside. Upon arrival, officers ran the plate and determined the vehicle was stolen. Both subjects were taken into custody and booked into the Metropolitan Detention Center. On October 21, Officers Lee and Deatherage spotted a vehicle weaving and crossing traffic lanes. Officers pulled the vehicle over and made contact with the driver. As Officer Lee was speaking to the driver, Officer Deatherage saw a handgun located by the driver's hip area. The driver and front passenger were removed from the vehicle and the handgun was secured for officer safety. The handgun was confirmed to be stolen and the driver was found to have an outstanding warrant for his arrest. The front seat passenger also had a felony warrant for his arrest and the back seat passenger had two misdemeanor warrants. During the inventory search, a shotgun was found in the back seat along with a large plastic bag containing five one ounce bags of marijuana. The driver was charged with transferring/receiving a stolen firearm and possession of a controlled substance with the intent to distribute. All three subjects were booked into the Metropolitan Detention Center on their outstanding warrants. On October 23, Officer Knipprath was dispatched on a suspicious person call. Officer Knipprath located the male who attempted to conceal his identity. Officer Knipprath

determined the male's identify and found he had a felony warrant for probation violation for the charge of murder from the United States Marshal's Office. He was arrested and booked. On October 27, officers were dispatched to a robbery in progress. When officers arrived, they found a martial arts trainer from a neighboring business holding one of the suspects on the ground. Officers took custody of the suspect. The individual was found to be one of the offenders committing a string of robberies in the Foothills Area Command. The suspects would steal a vehicle and then use it to commit robberies of businesses. The offender was booked into the Metropolitan Detention Center. On October 30, officers made contact with a domestic violence victim and observed she was bleeding from multiple head lacerations and her left forearm appeared to be broken in multiple places. The following day, Foothills Impact Detective Clipp responded to the University of New Mexico Hospital. The victim had multiple broken bones, lacerations and internal injuries. At the time it was uncertain if the victim would survive her injuries. The victim's condition stabilized and she confirmed it was her boyfriend who attacked her. She believed he had every intention of killing her. An arrest warrant was issued for the offender on the charges of attempt to commit a first degree felony, five counts of aggravated battery against a household member and child abuse. The offender was arrested and booked into the Metropolitan Detention Center.

FIELD SERVICES BUREAU-WEST Valley Area Command...

On October 1, officers were dispatched on a priority one aggravated assault call. Officers were advised that a male had threatened his neighbor with a handgun. Officers arrived on scene and established a perimeter around the mobile home. After a series of commands, the offender exited the residence and was taken into custody. Valley Impact Detective Ortiz responded to the scene and a search warrant was obtained for the residence. During the search, the firearm was located inside the house and the offender was arrested for the aggravated assault and booked into the Metropolitan Detention Center.

On October 3, Officers Nelson and Drager were working a downtown tactical plan when Officer Nelson heard multiple shots fired. He proceeded to the area and was advised by witnesses that a male had fired shots at another male after an argument. The victim was shot in the leg. While checking the area, Officer Nelson located the offender and took him into custody after a foot pursuit. He was booked into the Metropolitan Detention Center for aggravated battery. The victim received medical treatment. On October 4, officers were dispatched to assist Valley Impact detectives who were following a vehicle involved in an auto burglary. Air support was on scene and guided officers. The vehicle stopped at a dead end and the occupants fled on foot. Officers established a perimeter and detained two of the four suspects. Air support located the other two suspects hiding in the backyard of a nearby residence. Officers maintained their perimeter and K-9 units were called to assist. After several public service announcements, one of the suspects came out of a trash can he was hiding in and was taken into custody. The final subject was located in the backyard and taken into custody.

On October 7, Team 1 officers responded to an auto burglary in progress. The caller indicated three subjects were unlawfully entering parked vehicles at an apartment complex. Air support acquired a visual of the offenders entering a vehicle and driving off the property. With the guidance of air support, officers conducted a felony traffic stop and took all three offenders into custody.

On October 17, Officers Avila and Martinez were dispatched to a residential burglary in progress. The caller reported two male subjects were removing several items from a garage and loading them onto a dolly. The two subjects made entry after they cut through a chain link fence and pried open the garage door. As officers attempted contact, the two male subjects fled on foot. Officer Avila apprehended one male subject. A search incident to arrest revealed narcotics and drug paraphernalia in the pockets of the subject. The subject was also found to have a felony warrant. The stolen items were returned to the homeowner.

On October 18, Team 10 officers were dispatched on a shots fired call. When they arrived, they located a female who had been shot in the shoulder. She reported that she was a passenger of a vehicle when an unknown vehicle pulled up and began shooting into the car. She reported that she exited the vehicle but the driver, who had been shot in the face,

continued to drive. Officers gathered information and relayed it to the Bernalillo County Sheriff's Office (BCSO). A few minutes later, BCSO located the vehicle. The male refused to speak to officers, but was treated for the head injury.

Southwest Area Command...

- On October 11, Officer M. Reeder noticed a motorcycle traveling at a high rate of speed.
 Officer Reeder caught up to the motorcycle and noticed it did not have a license plate. The motorcycle stopped at a residence and the driver walked into the house. Officer Reeder made contact with the driver and noticed the ignition to the motorcycle was damaged. Officer Reeder ran the vehicle identification (VIN) number and concluded the motorcycle was stolen. He placed the driver under arrest for receiving/transferring a stolen motor vehicle.
 - On October 14, Officer Bailey was dispatched to a local hospital regarding domestic violence. The victim advised the offender had her cell phone and car and was afraid he would seriously injure or kill her. Officer Bailey worked with the victim to locate the offender through cell phone text messages and conversations. The victim convinced the offender to pick her up at the hospital. The offender responded to the area and, with the assistance of Northwest Area Command officers, was taken into custody. The victim's vehicle and property were returned to her.
 - On October 14, Officer Garcia was on patrol when he spotted a stolen vehicle in the front vard of a residence. The stolen vehicle had been involved in other residential burglaries and the offenders may have been armed. A perimeter was established and three subjects were taken into custody. One of them had felony warrants and was involved in other violent crimes. The other two were wanted for homicide. Five stolen handguns and other stolen property were recovered in the vehicle and in the residence. In October, Officers Madrid and Bisagna were selected by the National Law Enforcement Officers Memorial Fund as recipients of its Officer of the Month Award after talking a suicidal male subject off an I-40 overpass earlier in the year. They will be honored during National Police Week at a special awards ceremony in Washington, D.C. in May 2017. On October 24, Officer A. Michaud was dispatched to a local store where a shoplifter stabbed a customer who was trying to stop

him from fleeing. Officer Michaud calmed the victim and obtained his statement before he was transported to the hospital. Through investigation, Officer Michaud identified the offender and forwarded the case to Southwest Impact detectives.

On October 31, officers were concluding a dispatched call when they observed a suspicious truck which had been involved in a stolen vehicle incident. The license plate was run through Motor Vehicle Department (MVD) records and it showed the owner was wanted for an outstanding warrant. Officers initiated a traffic stop and two females were arrested. A firearm and a stolen United States Postal key were found in the vehicle. The females had extraditable warrants from Texas.

Northwest Area Command...

On October 13, officers were dispatched to a local retail outlet regarding a possible drunk driver. A witness observed a female get out of a vehicle and stumble into the store. Officers were also advised that the vehicle was listed as stolen in the National Crime Information Center (NCIC) database. As officers arrived, a female sitting in the driver's seat attempted to run, but was detained after a short foot pursuit. The driver and other occupants in the vehicle were arrested for warrants or transferring/receiving a stolen vehicle.

On October 18, officers were dispatched on a domestic violence call. A mother called police after her daughter had been beaten by her boyfriend. The incident took place earlier in the day at the boyfriend's apartment. The boyfriend had struck the daughter several times and strangled her until she was unconscious. The daughter managed to escape and went to the mother's residence. Several red swollen areas on the daughter's face and arms were observed and paramedics were summoned to examine her. Officers proceeded to the boyfriend's apartment where he was placed under arrest and transported to the Metropolitan Detention Center.

On October 20, Northwest Impact detectives conducted a follow-up investigation on a residential burglary and auto theft. The offenders were identified as being associated with an Albuquerque gang. Through investigation and assistance from the Gang Unit, arrest warrants were issued for both offenders. Northwest Impact Detectives arrested both offenders.

The offenders were related to several cases throughout Albuquerque and Bernalillo County. On October 26, Northwest Impact detectives were working a long term investigation on several commercial burglaries at Albuquerque retailers and restaurants. The offender would break into the business and either steal money from the safe or steal the safe itself. Working in conjunction with the Investigative Services Unit, the identity of the offender was obtained. Detectives conducted surveillance on the offender and he was caught in the act of committing a commercial burglary and auto theft. Detectives apprehended the offender. After searching his residence, a significant amount of stolen property was recovered and 21 cases of commercial burglary were tied to the offender. On October 31, officers were dispatched to a disturbance at a treatment center. Dispatch advised that multiple residents of the treatment center were violent and out of control. When officers arrived, all of the male subjects were controlled and inside their designated rooms. The lead nurse stated the residents became upset when they were advised they had to go to bed. The males ran through the hallway and punched the walls. Two of the males physically threatened the nurse and pulled personal property from her pockets. Two other residents caused damage to an entertainment center and desk in excess of \$1,000. The residents calmed down after they were informed police were on their way. The two residents involved in the threat were arrested and transported to the Juvenile Detention Center. The full report was forwarded to Juvenile Probation and Parole for further review and prosecution.

SPECIAL SERVICES BUREAU APD Academy...

- In October, the Recruiting and Selection Unit received the following: 350 interest cards including 262 cadets, 69 public service aides (PSAs), 14 laterals and five military certification by waiver.
- The October 7-9 testing consisted of 134 individuals scheduled to test; 39 attended city entrance; 25 attended Saturday testing and 19 were passed to background.
- The October 21-23 testing consisted of 209 individuals scheduled to test; 62 attended city entrance; 42 attended Saturday testing and 36 were passed to background.
 - In October, 40 cadets were seated for the 117th

Cadet class.

On October 1, the 115th Cadet Class started phase III of on-the-job training with an anticipated completion date of October 29, 2016.

Special Operations Division...

Tactical

- In October, the K-9 Unit responded to 156 calls for service and were called out 82 times. The K-9 Unit conducted 65 building searches and three area searches. The K-9 Unit responded to five SWAT activations and seven calls for assistance by other agencies.
- On October 1 through 9, the K-9 Unit worked the Albuquerque International Balloon Fiesta tactical plan.
- On October 10, the K-9 Unit assisted the Investigative Support Unit with the apprehension of an armed robbery suspect.
- On October 11, the K-9 Unit conducted a K-9 demonstration for the Citizen's Police Academy.
- On October 15, the K-9 Unit conducted a K-9 demonstration for the APD Hero's Academy.
- In October, SWAT conducted three tactical operations and assisted the New Mexico State Police with two tactical operations.
- On October 3, the SWAT team responded to a . domestic violence call involving shots fired. A neighbor reported observing a male and female in a physical fight outside their apartment. As they entered the apartment, the neighbor could still hear an argument and what sounded to be a physical struggle inside. The neighbor reported hearing a single loud pop that sounded like a gun shot. After the noise, the sounds of fighting ceased. Field officers could not make contact with the subjects in the apartment and requested SWAT. Through an escalation of tactics, SWAT was able to have the female and male exit the apartment. The male subject was taken into custody for numerous violent felony warrants. The residence was cleared of all other occupants and detectives took responsibility of the apartment for a search warrant. On October 5, the SWAT team assisted the • New Mexico State Police SWAT team with a high risk search warrant. The search warrant involved a male subject who had an extensive violent criminal history and was wanted for felony warrants involving human trafficking. The subject was the target of a SWAT call-out about a year ago as well. Both teams conducted the operation and took the subject into custody without incident. The apartment was secured for

detectives to conduct a search warrant. On October 12, the SWAT team responded to a male subject on the roof of a commercial building. Field Services officers negotiated with the subject for several hours, however the subject refused to come down from the roof. While on the roof, the subject threatened officers while armed with a screw driver. He also dismantled and destroyed various structural items and property on the roof. Both SWAT and a crisis negotiation team responded. Through a combination of patience, resources, tactics and negotiations, the subject eventually came down from the roof top and surrendered to police. On October 19, the SWAT team assisted the VICE Unit with a high risk search warrant involving numerous individuals dealing heroin while armed. During the operation, one male subject was taken into custody and the residence was cleared for detectives to conduct a search. During the search, detectives located 27 grams of heroin, a stolen handgun, a sawed-off shotgun and a stolen motorcycle.

- On October 19, the SWAT team assisted the New Mexico State Police (NMSP) SWAT team with a barricaded subject wanted for a violent felony warrant. The subject fled from NMSP in a vehicle and then on foot and was tracked to his residence in Belen. At some point, the subject ran out the back door. Officers gave chase and he eventually surrendered and was taken into custody.
- In October, the Bomb Squad responded to 16 call-outs and assisted SWAT with three activations in providing robot, rook, and explosive breaching support.
- On October 7, a hiker found a suspicious package with a fuse sticking out. Bomb technicians x-rayed the device and located a dark explosive powder inside.
- On October 15, the Bomb Squad responded to a pipe bomb found in a back yard.
- On October 20, the bomb squad counter charged a chemical being used by chemists for research that had become highly volatile.

Office of Emergency Management... (OEM)...

- In October, City Council approved the new Comprehensive Emergency Management Plan for the City of Albuquerque.
- On October 14 through 21, OEM staff members attended the Emergency Management Accreditation Program training and International

Association of Emergency Managers Annual Conference in Savannah, Georgia.

Open Space...

On October 15, Open Space officers assisted with the APD Hero's Academy event where 30 children with cancer and other serious illnesses experienced being a police officer. Open Space officers facilitated the rappel station where the children were fitted with a harness and rappelled off of a tower.

On October 15, the Open Space Search and Rescue team was requested to assist with two hikers lost near the TWA crash site. One of the hikers had a stick impaled in their hand. A team started up to the TWA crash site from the Elena Gallegos hiking area. The team located the lost hikers and escorted them to the bottom where an ambulance was waiting to provide medical assistance.

On October 28, Open Space officers transported the hovercraft to an event at Chamiza Elementary School. Open Space officers spoke with 200 children and their parents regarding the hovercraft, police work and law enforcement in general.

Horse Mounted Unit (HMU)...

- On October 1 through 9, the Horse Mounted Unit worked the 2016 International Balloon Fiesta. They provided six horses for all fifteen events. There were no significant incidents to report.
- On October 15, the Horse Mounted Unit attended the Kids with Cancer Hero's Academy at the APD Academy. Two horses and riders attended this event.
- On October 27 and 28, the Horse Mounted Unit attended an event at the Mesa View Preschool. There were approximately 100 kids and parents over the two day period. Two riders and horses were provided each day.
 - On October 29, the Horse Mounted Unit attended Officer Appreciation Day. Three horses and riders were provided.

Homeland Security...

On October 1 through 9, personnel from the Homeland Security section coordinated with Albuquerque International Balloon Fiesta (AIBF) personnel, Federal Bureau of Investigation personnel, City of Albuquerque Emergency Operation Center (EOC) personnel, Bernalillo County EOC personnel, the

Albuquerque Fire Department, the United States Department of Homeland Security, numerous local law enforcement agencies and assorted military units assigned to the AIBF. The Homeland Security section was also responsible for the creation and implementation of the 2016 APD Incident Action Plan for this event.

- On October 11, Homeland Security personnel conducted civilian response to an active shooter training. This training was conducted at the Northwest Area Command Substation during the monthly Construction Industry Crime Alliance (CICA) meeting.
- On October 19 and 20, Homeland Security personnel assisted the APD Academy with phase II of Reality Based Training Scenarios and exercise controller exercises for the 116th cadet class.
- On October 28, Homeland Security personnel worked with and coordinated with the Bernalillo County Office of Homeland Security and Emergency Management in reference to possible dates for Incident Command System training.

Metro Traffic Division...

- In October, the Traffic Division spent a significant number of days working the Albuquerque International Balloon Fiesta.
- In October, the Traffic Division responded to 216 calls for service.
- In October, the division issued 291 moving citations.
- In October, the division wrote 129 reports, had 37 driving while intoxicated (DWI) arrests, four felony arrests and three misdemeanor arrests/ warrants.
- In October, the division investigated 114 crashes and six hit and run cases.
- In October, the DWI Seizure Unit checked in 63 vehicles, returned 21 vehicles, booted seven vehicles and removed 15 boots.
- In October, 494 vehicles were on the seizure lot.
- In October, 49 vehicles were auctioned bringing in revenue of \$35,470.

Prisoner Transport Unit (PTU)...

- In October, PTU processed 1,028 prisoners through the Prisoner Transport Center. The Albuquerque Police Department arrested 767 prisoners and other outside law enforcement agencies arrested 261 prisoners.
- In October, PTU made 202 trips to the Metropolitan Detention Center and accepted seven walk-in prisoners at the Metropolitan Detention

Center.

- In October, PTU worked one hospital guard duty assignment for a total of 31 days.
- In October, the Public Inebriation Intervention Program (PIIP) worked 20 days in the Valley and Southeast Area Commands generating 217 computer-aided dispatch (CAD) calls.

Metro Court Protection Detail (MCPD)...

- In October, 47 individuals were remanded by the court and booked and three were remanded but bonded out on site.
- In October, 24 individuals were booked with arrest warrants. An additional 44 were booked with arrest warrants but bonded out on site.
- In October, 73 misdemeanors and nine felony warrants were cleared.
- In October, 119 individuals were in police custody.
- In October, MCPD had a total of 739 calls for service and self-initiated activities.

INVESTIGATIVE BUREAU

Scientific Evidence Division...

- In October, Field Investigation responded to two call-outs and had 1,282 calls for service.
- In October, Field Investigations collected 724 latent fingerprint cards; tagged 486 evidence items; and tagged 414 photo CDs.
- In October, the Photo Lab received 381 requests for service resulting in 9,647 prints and 391 discs being produced.
- In October, 531 discs were tagged into the Photo Lab as evidence.
- In October, the Evidence, Identification and Disposition Unit supported the following backgrounds: 75 case dispositions, 32 employment, 53 firearms, 92 FBI and 25 CODIS requests. The unit distributed 20 RAP's and photos, finger printed 30 new APD applicants and classified 1,342 fingerprints in AFIS. In October, the Evidence, Identification and Disposition Unit received 7,649 evidence items, duplicated 5,494 audio/video recordings and supported seven pretrial viewings. Efforts to reduce inventory resulted in 437 items returned to owners, 5,780 items disposed of and \$3,428 received from auction proceeds. The Evidence Disposition Team coded 8,354 case disposition transactions into evidence history. In October, the New Mexico DNA Identification •

System (NMDIS) received 575 new convicted offender/arrestee DNA samples for a cumulative

total of over 114,457 collected. 491 samples were analyzed, uploaded and searched in CODIS with a cumulative total of over 107,454 searchable DNA profiles. As a result of these convicted offender/arrestee samples, 24 unsolved cases were matched to convicted offenders/ arrestees and six case-to-case matches were made, with a resulting total of 31 investigations being aided.

- In October, the Controlled Substances Unit completed 59 drug cases (36 were APD and 23 were Bernalillo County Sheriff's Office).
- In October, the Latent Fingerprint Unit completed 16 APD cases.
- In October, Major Crime Scene Investigations had two primary call-outs; two secondary callouts; six completed cases; and five pending cases.

Property Crimes Division...

Auto/NITe Unit ...

- In October, the Auto Theft Unit conducted 243 free vehicle identification numbers (VIN) etches. Detectives at the Auto theft Garage conducted 66 VIN inspections both to the public, as well as helping the field officers and other units in the identification of VIN altered vehicles.
 - During the International Balloon Fiesta, the
 Property Crimes Unit directed efforts towards
 keeping balloonists and their possessions safe at
 local hotels. This resulted in a 25% reduction
 in property crimes in the areas targeted by
 detectives. For the second year in a row there
 were no reports of balloons being stolen.
 In October, Auto Theft detectives hosted the
 biannual APD Advanced Auto Theft class.
 - Thirty-nine officers were certified to conduct law enforcement level three VIN inspections. Fourteen additional officers received their twoyear recertification.

Burglary and Organized Crime Unit ...

- In October, the Organized Crime Unit made several arrests and averted several crimes while working the International Balloon Fiesta Hotel tactical plan.
- On October 2, detectives found two subjects in possession of burglary tools attempting to break into several businesses and coin machines. The subjects were taken into custody with the assistance of Valley Area Command field officers. Both subjects had a history of previous property crimes.

On October 6, Detective Moore observed

numerous suspicious subjects in the parking lot of a local hotel. This led to the arrest of two of the subjects for outstanding warrants. These subjects had a history of property crime related arrests.

On October 8, detectives observed an auto burglary in progress at a local hotel. As detectives approached, three suspects fled the scene. After a short foot chase, two of the suspects were apprehended. The third suspect was identified and an arrest warrant was completed for his arrest. The stolen items were returned to the owner.

In October, detectives completed a long-term investigation resulting in the dismantling of a large scale theft and fencing ring affecting approximately 35 local retailers. The execution of a search warrant found several thousand articles of clothing and merchandise valued at over \$150,000. Four suspects have been arrested in this case.

Criminal Investigations Division...

- In October, the Armed Robbery Unit responded to ten call-outs and cleared 12 cases. Nine of these cases were submitted to the District Attorney's Office for prosecution.
- In October, the Sex Crimes Unit responded to one sex crime call-out. They also cleared 26 cases with six of those going to the District Attorney's Office.
- In October, the Family Abuse Stalking/Training Team (FASST) had six new cases assigned to them with all six being cleared.
- In October, field units forwarded a case to • FASST involving a subject with an active restraining order against him. The subject's estranged wife reported that he was continually showing up at her residence, place of work and child's school. In addition, the subject had made hundreds of calls and complaints to the Children, Youth and Families Department (CYFD) and APD with unfounded allegations into the wife's care for their child. Officers were concerned with the increased harassment in this case. The unit conducted surveillance and Detective B. Samora obtained a warrant for the subject. The subject subsequently turned himself in to the courts where he was arrested.

In October, the Missing Persons Unit assisted in the location of numerous adults including an amputee, a 77 year-old woman and an individual riding his bicycle across the country who was last known to be in Albuquerque.

Special Investigations Division (SID)...

- In October, the Central Narcotics Unit served three search warrants, recovered three firearms and conducted two undercover buy bust operations.
- In October, the Central Narcotics Unit purchased methamphetamines from a known drug trafficking group operating in the Northeast Area Command. The operation resulted in the execution of a search warrant and the seizure of trafficking quantities of heroin, methamphetamines and an extraction laboratory. Three subjects were arrested for trafficking and possession. A vehicle was also sealed pending a warrant due to additional narcotics and a firearm.
- In October, detectives from the Investigative Support Unit made eight felony arrests and arrested nine people for felony warrants.
- In October, detectives arrested an individual responsible for numerous burglaries and auto thefts. Several stolen vehicles, body armor and firearms were recovered as a result.
- In October, the Investigative Support Unit located and apprehended a serial safe burglar with the assistance of Northwest Impact detectives. The arrest cleared multiple burglaries and resulted in the recovery of approximately \$200,000 worth of stolen property.
 - On October 19, the Gang Unit conducted a search warrant at a residence. The warrant resulted in the seizure of 33 grams of heroin, 58 grams of marijuana, one stolen gun, three additional guns and one stolen motorcycle. One individual was arrested during the execution of the search warrant.
 - On October 5, Air1 was advised that a Valley Impact Unit was following a stolen vehicle. Air1 responded to the area and located the vehicle. Field units attempted a traffic stop at which time the vehicle fled. The vehicle drove at a high rate of speed, disregarded traffic control devices and turned off its headlights. Eventually, five occupants fled from the vehicle on foot. A perimeter was established and K-9 was mobilized to the area. Air1 located the subjects utilizing an infrared camera system. Three of the subjects surrendered without incident. One subject was observed hiding in a trash can and the second subject was located hiding in a bush in a backvard. The two subjects were contacted by a K-9 search team and were taken into custody. All five subjects were booked and the vehicle was recovered.

On October 8, Air5 responded to field units following a stolen vehicle. Upon arrival, field units initiated a traffic stop and the suspect vehicle fled. Air5 followed the vehicle through the city to a residence on the Sandia Reservation where the vehicle stopped and the driver went inside. As Bernalillo County Sheriff's Office (BCSO) Units and tribal police responded to the area, the suspect reentered the vehicle and again fled from officers. The vehicle drove through the town of Bernalillo where Bernalillo Police Department engaged and pursued. They followed the vehicle back into Albuquerque where they disengaged and Air5 continued to broadcast movements. The vehicle proceeded through the north valley area and avoided several attempts by officers to deploy spike belts. The vehicle was monitored as it entered the Rio Rancho and Corrales area and broke down. A BCSO deputy took the driver into custody after a short foot chase.

Behavioral Health Division...

Crisis Intervention Unit (CIU)/Crisis Outreach and Support Team (COAST) ...

In October, the training team conducted the first classes of Enhanced Crisis Intervention Team (eCIT) training. Three classes were conducted totaling 24 hours of training for 37 students. In October, the training team held a CIT training certification course for 29 students. The CIT course was implemented by experts and members of the community.
 In October, CIU and COAST provided 288

hours of training. They also contacted 137 individual and made 55 referrals to service.

Real Time Crime Center (RTCC)...

•

- In October, RTCC Bridge live operations assisted in providing information and creating workups on individuals involved in two SWAT call-outs. RTCC Live Operations identified three subjects that were barricaded inside a residence and provided critical information to the responding units regarding the subjects' history, cautionary information and information on means to contact the subject.
- In October, Live Operations personnel assisted with the Vice Presidential Candidate Pence and other presidential dignitary visits. They also provided assistance for protests and gatherings associated with the visits.
- In October, Live Operations provided video

assistance for the Albuquerque International Balloon Fiesta. Live Operations observed and identified suspicious activity and maintained situational awareness of threats that could jeopardize the safety of the attendees. Information obtained was reviewed and subjects involved were identified and supplied to the appropriate personnel overseeing the operation. The Real Time Crime Center video network received upgrades that allow Live Operations to view the Albuquerque Transit Center (ATC)

- cameras and Atrisco pedestrian bridge. Thirtyeight cameras from Albuquerque convenience stores and gas stations were also added to the video network.
- In October, the Crime Analysis Unit supervisor attended a Problem-Oriented Policing (POP) Conference in Tempe, Arizona. This conference included information on how Portland handles vacant homes being used by squatters and convenience stores' coordinating efforts with the Glendale Police Department. In addition, there were presentations on the stratification of POP in an organization and law enforcement working with prosecutors to provide community education and better information for the courts.

PROFESSIONAL ACCOUNTABILITY BUREAU Communications Division...

- In October, the APD Emergency Communications Center staff answered 83,881 incoming calls. There were 34,320 calls answered for 911 and 49,561 calls answered for 242-COPS. 911 Operators answered 88.23% of the 911 calls within 10 seconds (national standard is 90%, APD's standard is 92.0%); operators also answered 88.58% of the 242-COPS calls within 90 seconds (APD's goal is 90% answered within 90 seconds).
- In comparison to last year for October, 911 call volume increased by 4.9% and 242-COPS call volume decreased by 3.19%. This represents an overall decrease of 0.12%.
- On October 28, a tour was conducted for Hope Christian Academy Student Council
- In October, the Communication Center manager attended a Total Response System demonstration.
- In October, staff from the center attended a state meeting to discuss the impacts of the loss of

911 funds at the state level.

ADMINISTRATIVE SUPPORT BUREAU

Planning Division...

- In October, the Grants Management Unit met with the New Mexico Department of Public Safety and Office of Emergency Management to discuss upcoming grants.
- In October, Planning assisted in obtaining and distributing civilian complaint forms to appropriate department personnel. Planning also assisted in obtaining 205,000 fliers to be distributed in the City monthly water bills with information on the Civilian Policing Councils (CPCs) located in each of the six area commands. The forms and fliers were a requirement of the Court Approved Settlement Agreement (CASA) negotiated with the United States Department of Justice.



- In October, the Public Information Unit received 1,202 requests totaling \$8,394.85 in revenue generated from citizen requests/registers.
 In October, the Report Review Unit completed the following: 2,831 Automated Reporting System (ARS) transfers, 989 ARS supplements, 1,527 National Crime Information Center entries, 1,938 accidents, 2,995 officer calls and 122 Unified Crime Reports (UCR).
- In October, Court Services completed the following: 59 pretrial hearings scheduled, 373 arraignments processed, 412 felony cases submitted to the District Attorney's Office and 583 summonses submitted to the Metropolitan Court.
 - In October, the False Alarm Reduction Unit collected \$105,803 in fees and fines for a total of \$454,287 for the fiscal year. The unit entered 663 new accounts and mailed 12,588 pieces of correspondence. There were 1,432 false alarms in October which was an increase of 7.0% from this same month last year which was 1,339. In October, the Telephone Report Unit generated 688 original reports and 143 supplemental reports for a total of 831. This resulted in a savings of 2,160 hours of field services time and a savings of \$33,240.

In October, the Telephone Report Unit processed 626 on-line (Cop Logic) reports resulting in a savings of 1,627.60 hours of field services time and a savings of \$25,040. Albuquerque Police Department Monthly Report - October 2016

In October, the Inspection of Public Records (IPRA) received 115 requests, completed 78 requests, and collected \$3,818 in revenue. In October, the Inspection of Public Records (IPRA) billed 26 IPRA requests for a total of \$2,013.92.
