## <u>Meetings</u>

The SEACPC held regular meetings each month of 2018 except December. All meetings were held at the Cesar Chavez Community Center, 7505 Kathryn SE (Louisiana & Kathryn SE) on the third Thursday of every month, 6:00 PM to 8:00 PM. All of these meetings were open to the public. Every meeting began with the introduction of each board member present and each representative from the APD. Then every member of the public present introduced themselves and organizations they represented, if applicable.

Meetings always include an APD crime report for the SE Area, ride-along reports from the CPC Board members, Board discussions of APD Procedures, and time for community members to ask questions and receive answers/responses from the APD officers attending and Board Members. Many of the CPC meetings include a presentation by a representative from city government, the police department, or some organization providing services to those in need.

Meeting announcements and agenda for each month are publicized to the community through the online social network know as *Nextdoor*. Those community members attending the SEACPC meetings that have provided their email addresses also directly receive an individual email with these announcements and agenda. ## **Achievements**

CPC voting members attended many community sessions and performed outreach in various settings. Of importance were opportunities during neighborhood association and district coalition meetings where our members informed attendees of our goals to help strengthen the APD and community relationship.

The SEACPC also drafted a city ordinance proposal to codify and memorialize CPCs in perpetuity after CASA parties meet full compliance. The SEACPC also voted unanimously to forward this proposal to the City Council.

One of the most significant achievements this year was a letter sent from the SEACPC to the NM State Legislature supporting the budget requested by District Attorney Raúl Torrez. The letter was unanimously approved by the SECPC Voting Members and all signed the letter. Copies of the letter were sent to all State Representatives and Senators. We believe this action had an impact on the full funding that was given to the District Attorney.

## Lessons Learned

The SEACPC worked to inform community members of meetings and special presentations. Voting members aimed to perform outreach and helped to inform the community of APD's goals, its organizational structure, responsibilities and compliance status. CPC monthly meeting attendance and engagement often varied based upon the presentation subject matter. Several times neighborhood associations would be represented by several members of the neighborhood and attending to ask questions about APD response to specific situations of theft or burglary in the neighborhood.

## **Recommendations**

The SEACPC is looking at ways to make communication more effective between the Council, the Community, and the Department. Included in this effort is the use of YouTube, Twitter, and Facebook.

A survey distributed to CPC public attendees during meetings might possibly provide feedback regarding community members' diversity, topics of concern, suggestions and questions to be considered for future meetings and discussions.
