**5. Approval of Minutes**

**6. Presentation/ Discussion: Commander Campbell (Compliance Bureau)**

- We just recently did some restructuring in the compliance department, accountability and oversight will be done by Commander Lowe; I will go over policy and oversee everything that gets published.
- We are looking to get a compliance manager.
- Performance review unit – my team is responsible for all level ones of use of force.
- With the shut down a lot has stopped.
- We are all under Deputy Chief Garcia.
- We have been successful in what we have done, it has not been perfect but we are working on bettering all the paragraphs.

- We have to meet primary, secondary and operational requirements in compliance.
- IMR 8 that came out in November we were, 99.6% in primary, 75.4% in secondary, and 59.2% in operational compliance.

Q: Federal court hearing was going to be in December, but it was cancelled, has that been rescheduled?

A: Judge Brack will no longer serve as the Federal Judge on our case due to a medical reason. We now have to draw for another judge; however, we have not been able to get a new one due to the government shutdown. However, we will move forward with our monitors until we get a new judge.

#### **7. Discussion: Recommendations to APD from SE**

There are 6 area commands, so there are 6 CPCs. One of our task is to put recommendation to what we have observed or encountered.

Mike: The recommendation we want to submit, is to have easier access for the APD App. We want to make sure it looks the same on both iPhone and Samsung. The title of the recommendation is APDMobile App User Interface (UI) Improvements.

#### **8. Ride-Along & meetings attended reports**

December 4<sup>th</sup> – Ron Halbgewachs attended an oversight meeting and it was discussion in regards to the Police Oversight Agency.

December 18<sup>th</sup> - there was a meet and greet with the new APD Academy lateral transfer officers and new cadets. There were 38 cadets, and 11 laterals that graduated.

#### **9. Monthly Crime Report – Lt Anaya**

- Larceny: 165 up by 9.2%
- Auto thefts: 102 up by 36%
- Auto burglaries: 131 up by 41%
- Residential burglary: 103 up by 94%
- Vandalism: 108 up by 44%
- Commercial burglary: 52 up by 108%
- Arson: 8 up by 700%
- Drug violation: 18 up by 63%
- Disorderly conduct: 33 decreased by 65%
- DUI: 41 up by 52%
- Forgery: 11 decreased by 21%
- Fraud: 42 up by 163%
- Missing person: 14 up by 18%
- Prostitutions arrest: 5 decreased by 64%
- Recovered vehicles: 7 decreased by 42%
- Warrants: 81 up by 47%

- Family offenses: 228 up by 7%
- Homicides: 1 up but 100%
- Kidnapping: 4 up by 300%

Q: Is there any overlapping data between the crimes and COAST?

A: I do not think we have that data, but I believe it would be changed.

A: We do not have that information.

Q: Can I report a crime that was committed even if I was not involved?

A: We normally need the victim to follow up with the report.

Q: How do we help someone without us getting hurt?

A: If someone is in danger, we recommend you call APD and not try to handle the situation yourself.

Q: Any changes on the use of force policy?

A: They have gone through and passed mostly all except for SOP 2-57 and 2-57 is supervisory responsibility.
