6. Proposed City Ordinance for Continuance of CPCs

What happens to CPC when it has been breached?

All six area commands have been meeting once a month and we have put together an ordinance that will be proposed next year to a Judge. If the CASA disappears, we need to have an ordinance that will support CPCs. Once we receive agreement from all the councils, we will be going forward and presenting it to City Council.

It is broken down into 4 areas. (Attached at the bottom) Alerts need to be worked on, but if you want to see about accidents, APD does have a twitter and they post every accident that happens in the City.

Q: What is the purpose of the app?

A: You can report any crimes from your phone and you can see the response on there.

App looks different on android and iPhones; they should work on in looking the same.
