# 3. Presentation – Guest Speaker Ed Harness – Director, Civilian Police Oversight Agency (CPOA)

CPOA Board was the Police Oversight Board (POB)

Only have jurisdiction over APD (Sworn and Non-Sworn)

Criminal investigation and administrative investigations we do not do any criminal investigations

120 to 180 days recommendation for discipline (board to the Chief) APD has 30 days to do the review

Q: Who must concur with the investigation?

A: Chief, Deputy Chief, Internal Affairs, and the Area Commander

Six steps for investigation

1. Incident Occurs within three days IA must refer the complainant to CPOA

- 2. All investigations must be completed in 90 calendar days
- 3. An extension may be requested by the Chief
- 4. 150 days into the investigation the process of appropriate discipline shall take place
- 5. 180 days into the process the director shall submit a public record letter to the complainant and the Chief
- 6. Complaint Completed

51 to 49 Sustained we think that it happened

CBA and Department calls for progressive discipline

Q: Is this standard for the country?

A: No, in NJ they get the final say. Wisconsin acts like the appellate court body

Q: Appeal process for the police?

A: Yes

Q: Differences of opinions?

A: Nonoccurrence rate is really low. The ordinance has no enforcement provision... we have to rely on the CASA

Q: Is this public record?

A: See <u>cabq.gov/cpoa.gov</u>

Q: Is there a way without revealing without exposing the people who are being investigation?

A: It would take six months we now have a data analyst position did not pay well enough/tried to ocutsource

Q: It would be helpful for the public to know what the current workflow looks like?

A: Investigations timelines are what is keeping us out of compliance. Internal Affairs has to report use of force.

Q: Sound like a full-time job?

A: Can be and we have had a lot of turnover. The board spends 50% of its time on policy... the use of review policies we re-written and are currently being reviewed by the monitor...result is they have created training based on the policies...one things that changed is the board is given access to the policy.

Q: Attack against Ms. Van Deventer. Is she still a member of the board?

A: Yes.
