

FIELD SERVICES BUREAU-EAST

Southeast Area Command...

- In September, officers were dispatched to a possible auto burglary in progress. Officers arrived and detained multiple subjects. The subjects' vehicle contained methamphetamines, drug paraphernalia and stolen luggage from the airport. Detective Lujan contacted the owners of the luggage and they confirmed that their camera equipment valued at \$100,000 and clothing was stolen from the airport on September 1. A warrant was obtained for the vehicle, and the narcotics and stolen property were recovered. One subject was arrested for receiving and transferring stolen property and another arrested for possession of marijuana.
- On September 6, Officer Hill responded to a home invasion call. The offender broke into a residence, grabbed a display sword and demanded money from the homeowner. The offender struck the homeowner in the ear with the sword. The homeowner fought back and a neighbor called the police. As Officer Hill arrived, the homeowner was on top of the offender beating him. Officer Hill broke up the fight and placed the offender in handcuffs. The homeowner had a laceration to the ear from the sword but was fine. The offender was transported to the hospital due to being under the influence of a controlled substance. After he was processed at the hospital, the offender was placed under arrest for aggravated burglary, aggravated battery with a deadly weapon, and kidnapping.
- On September 6, Officer Fisher was dispatched to a disturbance call of a female throwing rocks at passing vehicles. Officer Fisher detained the female and conducted an investigation. The female appeared to be under the influence of narcotics or suffering from mental illness. After the investigation, Officer Fisher transported the female to the University of New Mexico Hospital for a mental health evaluation.
- On September 9, Officer Brito assisted detectives in apprehending a subject wanted on an outstanding felony warrant and reportedly making threats to harm officers. Officers apprehended the subject as he pulled into a hotel parking lot. He was booked on the felony warrant.
- On September 9, a caller reported a vehicle stolen from her home. Within three hours, police received four different armed robbery calls by teenagers in a vehicle matching the

description of the stolen vehicle. Officers saturated the area in an attempt to locate the offenders. The suspect vehicle was spotted by the Real Time Crime Center Video/Traffic Camera System traveling north at a high rate of speed. Officer McBrayer and Recruit Officer Wright-Brown then located the vehicle entering a dead end street. As officers converged, the suspects fled on foot. Officers apprehended four juveniles under the age of sixteen. These subjects were booked into the Juvenile Detention Center for armed robbery with a deadly weapon, receiving/transferring a stolen motor vehicle and outstanding misdemeanor warrants.

Northeast Area Command...

- On September 1, officers were dispatched to a home for a female wishing to report a lost credit card and driver's license. When officers arrived, they noticed the female was highly intoxicated and had a child living with her. The child's father was contacted and he was also highly intoxicated. Both adults had a hard time functioning on their own. The officers had the child placed in a safe environment and the adults were charged with child endangerment.
- On September 3, Officers Varela and McClaskey were dispatched on a call of a suspicious female acting irrational and possibly under the influence of liquor or drugs. The caller advised the female was going into the backyard of a residence and attempting to enter through the back sliding door. Upon arrival, the back door was found opened. Officers gave announcements at which time the female walked down the stairs with property belonging to the home owner. The female was taken into custody and charged with residential burglary.
- In September, officers and crime prevention specialists provided training for the management team of a convenience store chain. There were approximately 25 managers from throughout the city in attendance. The department was able to network with the managers and share information on various store locations. Each manager was given the appropriate crime prevention specialist contact for their area.
- In September, a local Cub Scout group requested a tour of the substation and a presentation on police work and fingerprinting. Officer Shannon showed them the police unit he drives. Crime scene specialist Oates showed them how to take fingerprints and demonstrated the different patterns associated with each individual

fingerprint. They also provided a presentation on how to call for help if needed, gun safety and making sure not to answer the door to anyone they did not know.

- On September 12, officers were dispatched on a suspicious person call. The caller stated an unknown subject broke the window to her neighbor's apartment and entered. Officers Martin and Barnard caught the subject after a short foot chase. The subject was arrested for residential burglary.

Foothills Area Command...

- In September, Detective W. Burton completed a prolonged investigation on a suspect. He obtained an arrest warrant for 62 felony counts, including multiple charges of residential burglary, auto burglary, unlawful taking of a motor vehicle and white collar crimes.
- On September 10, Officer B. Warwick was dispatched to a vehicle accident. A female was inside the vehicle and was transported to the hospital due to injuries sustained during the accident. Upon further investigation, it was found that three subjects were in a nearby parking lot with the hood up asking people for a jump start. A female arrived in her vehicle and offered to help. Once she got out, the three subjects pushed her down and attempted to steal her vehicle. The victim was able to get up and jump back in her vehicle. She fought the offenders as they took off causing the vehicle to crash. One offender stayed at the crash location and two ran on foot. Two of the three offenders were arrested and booked into the Metropolitan Detention Center.
- On September 3, Officer R. White was on random patrol when he checked a local motel known for stolen vehicles. Officer R. White checked several vehicles and found one that was stolen. He contacted the owner and the vehicle was recovered along with additional evidence to include merchandise receipts. The report was forwarded to the Auto Theft Unit for follow-up investigation.
- On September 12, Officer R. White was dispatched to a fight in progress. An anonymous witness advised Officer White that a male subject was inside a home where the fight occurred and the male had a felony warrant. Officers contacted all subjects who were then searched in police databases and the male was found to have a felony warrant for parole violation. The offender was located and booked

into the Metropolitan Detention Center.

- In September, the Crime Prevention Unit provided 76 people "live" crime prevention services at presentations.

FIELD SERVICES BUREAU-WEST Valley Area Command...

- On September 14, Officers B. Melendrez and J. Lee were dispatched to a domestic dispute. According to the call, an 11-year-old had called 911 to advise of a dispute between his mother and father where the mother was deemed to be the primary aggressor and using narcotics. Upon arrival, officers located a female that was non-compliant during questioning and tried to pretend that she only spoke Spanish. After running her information through the National Crime Information Center (NCIC), Officer Melendrez discovered that she had falsified her name but had provided her correct date of birth. By using various resources, Officer Melendrez discovered the female's real name. He then conducted a secondary check of her information through NCIC and discovered that she had a nationwide extraditable felony warrant for aggravated battery/attempted murder. She was then taken into custody and booked on the warrant.
- On September 10, Officers J. Chafin and T. Drager were dispatched to a disturbance. As they were on the way to the call, an additional caller reported shots fired from the party. Officer T. Wickens and Sergeant Wheeler also proceeded to the address. When Officers arrived, approximately 80-100 people, mostly juveniles fled on foot and in vehicles. Several were stopped and identified. They ranged from 14 to 19-years-old. All were extremely intoxicated. Officer Chafin interviewed several of the juveniles who confirmed they had consumed alcohol at this location and that it was provided by the homeowner. The homeowner, a 20-year-old male, was identified and admitted to supplying the alcohol to everyone present. He did not realize the age of the majority of those in attendance, but took responsibility. He was charged with six counts of contributing to the delinquency of a minor and booked without incident. The parents of juveniles detained were notified. The juveniles were released to sober rides with parents' permission.
- In September, Team 8 was assigned to participate in a speed racer tactical operation throughout the area command. Officer Drager

issued approximately 20 citations during one night of enforcement. Officers B. Melendrez and M. Laws continued a tactical operation aimed at eliminating dangerous street racing during the first half of September. In the area of Balloon Fiesta Park, officers increased patrol and responded to calls for service involving street racers. A total of four moving citations were issued as a result from the tactical plan.

- On September 9, Officer Joe Gumble responded to a hit and run traffic accident that resulted in an injury to a pedestrian. While in route, another call from the Northeast Area Command was received indicating that a citizen had a vehicle stopped because the driver had just hit a pedestrian on a bicycle and dragged the bicycle. It was determined that this was the same person involved in Officer Gumble's call. The pedestrian had to be transported to the hospital due to his injuries. The offender was transported and booked for leaving the scene of an accident, driving on a revoked license. The driver also had two misdemeanor warrants out of Santa Fe.
- On September 12, officers were dispatched to a domestic dispute call. While officers were in route, they were advised a male involved in the dispute was armed with two kitchen knives and the victim was locked in the bathroom with her son. When Officers arrived, the victim was able to exit the apartment and speak to officers. While talking to the victim, officers determined the suspect was still in the apartment and had several pending felony charges. Sergeant Higdon established a perimeter around the house and requested additional units. Officers spotted the suspect in the upstairs bedroom and he was given verbal commands. The suspect eventually exited the apartment without the knives and he was taken into custody without incident.
- On September 5, Officers Schatzinger and Lucero were dispatched to a shoplifting call at a local grocery store. Comments on the call advised that upon being confronted by store employees, one of the offenders brandished a firearm and threatened to shoot if they tried to stop him. Upon arrival, Officer Schatzinger spotted a female fitting the description of one of the offenders and took her into custody. She was not the subject with the firearm, but was in possession of the items stolen from the store.
- On September 12, Officer Stuyvesant was dispatched to a disturbance call and welfare check on a female. During the course of the investigation, he made contact with a

female subject who appeared to be living in the residence. The female he made contact with appeared to be concealing her identity. He detained the female due to her suspicious behavior and eventually identified her. She had three outstanding domestic violence warrants with a \$10,000 bond. All three warrants were later confirmed through the National Crime Information Center (NCIC). The subject was arrested and booked into the Metropolitan Detention Center (MDC) without incident.

Southwest Area Command...

- On September 10, Officers Martinez, McCue, Higgs and Bartlett were dispatched to an aggravated assault call in which shots had been fired. When officers arrived, they contacted the victim and formulated a plan to approach the offender's home. The offender was called out of the home and taken into custody without incident. He was later booked into the detention center for aggravated assault with a deadly weapon.
- On September 10, Officers McCue, Martinez and Higgs were dispatched to a domestic dispute in which a subject had threatened to stab someone with a knife. When officers arrived, they conducted an investigation which resulted in an arrest warrant for the offender. He has since been arrested for aggravated assault with a deadly weapon.
- On September 8, Officers Tafoya, Solis and Navarro were dispatched to a family fight in which the male choked the female caller until she lost consciousness. When officers arrived, the male immediately barricaded himself inside the apartment and began sending text messages to his girlfriend that he intended to shoot it out with police. Officer Tafoya was able to talk the male into opening the door and handcuffed him. Officer Tafoya did a great job ending the incident peacefully and the male was booked for aggravated battery upon a household member.
- On September 12, Officer F. Baca, S. Apodaca, and Recruit Officer D. Dixon were dispatched to assist Adult Protective Services with conducting a welfare check. Officers arrived and identified an elderly female who was bedridden. She made statements of being uncared for and left in soiled clothing for several days. They identified the offender as the son who admitted to not changing her because he was mad at her. Officers called for rescue, who assessed the woman and transported her to the hospital. The

victim requested to be moved to an assisted living facility where she could be safe from harm. The offender was summoned to court for neglect and domestic violence charges.

Northwest Area Command...

- In September, Sergeant Norris attended a meeting with the National Alliance on Mental Illness (NAMI) in a continuing effort to improve the working relationship between the mental health system and law enforcement.
- In September, Officer K. Lewandowski took a call where two juveniles ages one and two were walking outside. One child was only wearing a towel and the other was in pajamas. The mother was found passed out in the home and further investigation revealed bruising on the children. The mother was charged with child abuse without great bodily harm. The Children, Youth, and Families Department (CYFD) was notified of the incident.
- On September 6, Officer J. Montoya and Recruit Officer Nakamura were dispatched to a stolen vehicle call. Upon arrival, Officer Montoya located the vehicle and was waiting for back up when the vehicle left the parking lot. Officer Montoya followed the vehicle and initiated a traffic stop. The two passengers in the vehicle were detained. One of the suspects was in possession of a small bag of methamphetamine. She also admitted to taking the vehicle and said they were driving around the city looking for other items to steal. Both females were arrested for unlawful taking of a motor vehicle, possession of burglary tools, possession of controlled substance and conspiracy to commit a felony.
- On September 13, Officers H. Alvidrez, T. Barnhill, J. Trujillo, J. Montoya, Recruit Officer Nakamura along with Sergeant Hilger were dispatched to a vehicle that was reported to be car jacked by gunpoint in Rio Rancho earlier in the morning. Officers located the vehicle with the assistance of air support and attempted to pull the vehicle over. The vehicle accelerated and tried to elude the police. Officers turned off all emergency equipment and went in a different direction from the offender. Air Support continued to follow the vehicle and officers remained a safe distance away while following directions from Air Support. The vehicle went into Corrales and the Corrales Police Department attempted to stop the vehicle. Officers from the Northwest Area Command

did not enter the pursuit, but assisted by setting up spike strips. Detective Pitzer deployed his spike strip and successfully deflated the front passenger tire. The vehicle began to slow down and Corrales Police officers stopped the vehicle and detained the driver. Rio Rancho detectives were dispatched to the location and took over the investigation including arresting the subject.

- On September 11, Officer E. Ibarra was dispatched to a location that was a red tagged structure under the control of the city of Albuquerque. Information was provided and confirmed that subjects had entered the structure without permission. It was also verified that one subject was still within the structure. K-9 officers were called to assist and helped clear the residence. The canine indicated on a confined small closet. Verbal commands were given and an array of additional response eliciting actions was conducted without success. The Albuquerque Fire Department responded and provided a long rack pole to help safely remove the stacked clothing. After removing a few layers of clothing, a subject was identified and contacted. The subject surrendered and was charged with breaking and entering.

SPECIAL SERVICES BUREAU

APD Academy...

- In September, the Recruiting and Selection Unit received the following: 461 interest cards including 357 cadets, 64 public service aides (PSAs), 33 laterals and seven military certification by waiver.
- The September 9-11 testing consisted of 114 individuals scheduled to test; 29 attended city entrance; 22 attended Saturday testing and 17 were passed to background.
- The September 23-25 testing consisted of 169 individuals scheduled to test; 45 attended city entrance; 35 attended Saturday testing and 30 were passed to background.
- In September, 24 cadets were seated for the 117th Cadet class.
- In September, the 115th Cadet Class started phase II of on-the-job training and with an anticipated completion date of October 1, 2016.

Special Operations Division...

Tactical

- In September, the K-9 Unit responded to 172 calls for service and were called out 98 times. The K-9 Unit conducted 72 building searches

and 13 area searches. The K-9 Unit responded to three SWAT activations and one call for assistance by other agencies.

- On September 9, a K-9 Unit was called out in reference to an area search for subjects who ran from a stolen vehicle. Upon arrival, K-9 officers were assigned to search teams and they located the two wanted subjects hiding on top of a residence. The subjects were taken into custody without incident.
- On September 20 and 21, members of the K-9 Unit attended the Bill Lewis K-9 360 course. The course taught students best practices on liability, documentation, training, constitutional use of force and management.
- On September 21, the K-9 Unit was called out for an area search. The search was for members of a recently documented gang who had conducted an armed robbery in the Southwest Area Command. A firearm was used in commission of the robbery. Upon arrival, K-9 officers were assigned to search teams who located the subjects hiding on top of a residence. The subjects were taken into custody without incident.
- In September, SWAT conducted two tactical operations and assisted the New Mexico State Police with two tactical operations. On September 3, SWAT team responded to a call-out in response to a male subject barricaded and wanted for felony aggravated assault charges involving a knife. The male subject was also barricaded with his girlfriend who was unable to exit. After all other measures of negotiation failed, a gas plan was used to extract the occupants from the residence. Both the male subject and female exited the residence and were taken into custody. The apartment was cleared for a search warrant.
- On September 3, SWAT assisted the New Mexico State Police SWAT in Tukumcari, NM in response to a subject who was wanted for committing aggravated battery on a pregnant woman causing her to be airlifted to a hospital. The subject was barricaded inside his residence with other family members, including an invalid juvenile male who was bedridden. After all other negotiations failed, SWAT entered the residence and took the male subject into custody without incident.
- On September 14, SWAT assisted the New Mexico State Police SWAT team in Santa Fe with a high risk search warrant involving an individual who was suspected of making

homemade explosive devices. New Mexico State Police detectives maintained surveillance of the residence and watched as the occupants left the residence. The occupants were detained at an off-site location. SWAT cleared the residence for a search warrant.

- On September 20, SWAT received training on legal concepts of Intent, Means and Opportunity. These are legal standards that assist officers with making use of force decisions based on the Graham v. Connor standards. The training also consisted of scenarios based on a barricaded individual inside a residence. The scenarios involved officers utilizing crisis intervention training and crisis negotiation training, intermediate use of force, less lethal munitions and lethal force.
- In September, the Bomb Squad responded to 22 call-outs and assisted SWAT with three activations in providing robot, rook, and explosive breaching support.
- In September, the Bomb Squad trained for approximately 34 hours. Topics included bomb disposal and rendering safe pipe bombs. New members of the Bomb Squad attended 16 hours of the FBI's National Improvised Explosive course. Members of the bomb squad attended training at the FBI office on x-ray interpretation.
- The Bomb Squad trained approximately 65 hours with explosive detection K-9s on all explosive odors at different sites throughout the city.
- In September, the Bomb Squad conducted two demonstrations. One was for public safety day at Home Depot and the other was a fundraiser for Boys and Girls Club at the Albuquerque Sunport.

Office of Emergency Management... (OEM)...

- On September 20, the Mayor and CAO organized a ribbon cutting and open house at the Emergency Operations Center (EOC) attended by more than 100 people to recognize the remodeling and revitalization of the EOC.
- In September, OEM received a National Award for Disaster Resilience. Albuquerque was among only five U.S. cities to receive recognition from the White House. Albuquerque was an early adopter as it began its Building Resilience with Diverse Communities (BRDC) effort in April of 2016. Using the motto "Because We Care, We Prepare," the Mayor's Albuquerque faith leaders acted as a champion for the effort. This past July over 150 faith leaders attended a forum

hosted by the Albuquerque Office of Emergency Management, U.S. Homeland Security/FEMA, and Mayor Richard J. Berry.

Open Space...

- On September 11, Open Space officers assisted the Bernalillo County Sheriff's Office (BCSO) with a search for an injured motorcyclist. According to BCSO dispatch, a male subject had crashed in a ravine. Officers Candelaria, Smith, and Melvin responded and located the male subject. Open Space officers provided immediate medical assistance to the male and escorted him to where rescue was located so he could be transported to the hospital.
- On September 17, APD Search and Rescue team was requested for a call in the Bosque. The caller stated he observed a male subject who was down and out. Open Space officers obtained global positioning services (GPS) coordinates from the caller and escorted Albuquerque Fire Department (AFD) personnel to the location of the patient. An Open Space EMT (Officer Martinez) utilized his gear to take vitals of the patient, as some of AFD's medical equipment had not yet arrived on scene.
- On September 25, Open Space officers were dispatched to the West Mesa in response to an abandoned truck. Open Space officers responded to the area and located the truck and learned that it had been reported stolen. Officers contacted the victim to advise him of the condition and location of his truck. Officers met the victim and drove him to the location of his recovered truck. While the victim was examining his vehicle, he located a cell phone that was not his. Officers observed a number on the cell phone and made contact with the owner of the cell phone. The owner advised that his cell phone had been stolen in an unrelated auto burglary. The cell phone was also returned to the owner.

Horse Mounted Unit (HMU)...

- On September 2, HMU attended a community gathering at the Ladera Nursing Home. There were approximately 60 senior citizens in attendance.
- On September 7, HMU attended a demonstration at the West Mesa Community Center. There were approximately 100 kids in attendance.
- On September 8-18, HMU provided support to the State Police at the 2016 State Fair. The unit provided up to seven Mounted police officers

each day.

- On September 24, HMU attended the Home Depot Youth Public Safety Day. There were approximately 1000 citizens in attendance.

Homeland Security...

- In September, Homeland Security officers hosted a two day ALICE training at the APD Academy. ALICE training is a research-based, proactive approach to responding to an active shooter situation which authorizes and empowers those engaged in such an event to utilize building infrastructure, technology and human action to increase their chance of survival. There were a total of thirty-two law enforcement and civilian students who attended this course and were certified.
- In September, Homeland Security officers met with and continued to work with the Army National Guard representatives in preparing for the Vigilant Guard operation scheduled for August 2017.
- In September, Detective Brokaw attended the Respiratory Protection Course sponsored by the Federal Emergency Management Agency (FEMA) at the Center for Domestic Preparedness. The course was three days and provided essential information and the skills required to develop, implement, administer and sustain a respiratory protection program that fully complies with the laws and regulations regarding emergency-response actions. Detective Brokaw received his certification as a result of his attendance.

Metro Traffic Division...

- In September, the Traffic Division responded to 520 calls for service.
- In September, the division issued 2,748 moving citations.
- In September, the division wrote 319 reports, had 105 driving while intoxicated (DWI) arrests, 17 felony arrests, 27 misdemeanor arrests/ warrants and issued four felony warrants.
- In September, the division investigated 254 crashes and 15 hit and run cases.
- In September, the DWI Seizure Unit checked in 83 vehicles, returned 33 vehicles, booted 18 vehicles and removed 12 boots.
- In September, 361 vehicles were on the seizure lot.
- In September, 52 vehicles were ready for auction.

Prisoner Transport Unit (PTU)...

- In September, PTU processed 1,134 prisoners through the Prisoner Transport Center. The Albuquerque Police Department arrested 844 prisoners and other outside law enforcement agencies arrested 290 prisoners.
- In September, PTU made 200 trips to the Metropolitan Detention Center and accepted nine walk-in prisoners at the Metropolitan Detention Center.
- In September, PTU worked two hospital guard duty assignments for a total of 28 days.
- In September, the Public Intoxication Intervention Program (PIIP) worked 22 days in the Valley and Southeast Area Commands generating 298 computer-aided dispatch (CAD) calls.

Metro Court Protection Detail (MCPD)...

- In September, 71 individuals were remanded by the court and booked and one was remanded but bonded out on site.
- In September, 60 individuals were booked with arrest warrants. An additional 38 were booked with arrest warrants but bonded out on site.
- In September, 91 misdemeanors and 24 felony warrants were cleared.
- In September, 171 individuals were in police custody.
- In August, MCPD had a total of 865 calls for service and self-initiated activities.

INVESTIGATIVE BUREAU

Scientific Evidence Division...

- In September, Field Investigations completed 1,350 calls for service.
- In September, Field Investigations collected 1,045 latent fingerprint cards; tagged 615 evidence items; and tagged 431 photo CDs.
- In September, the Photo Lab received 354 requests for service resulting in 10,194 prints and 378 discs being produced.
- In September, 630 discs were tagged into the Photo Lab as evidence.
- In September, the Evidence, Identification and Disposition Unit supported the following backgrounds: 58 case dispositions, 29 employment, 28 firearms, 70 FBI and 38 CODIS requests. The unit distributed 68 RAP's and photos, finger printed 18 new APD applicants, classified 1,229 fingerprints in AFIS and processed 1,231 new and old arrests into APD's criminal history records.
- In September, the Evidence, Identification

and Disposition Unit received 9,196 evidence items, duplicated 5,815 audio/video recordings and supported 15 pretrial viewings. Efforts to reduce inventory resulted in 460 items returned to owners, 4,690 items disposed of and \$588 received from auction proceeds. The Evidence Disposition Team coded 3,181 case disposition transactions into evidence history.

- In September, the New Mexico DNA Identification System (NMDIS) received 506 new convicted offender/arrestee DNA samples for a cumulative total of over 113,882 collected. 485 samples were analyzed, uploaded and searched in CODIS with a cumulative total of over 106,693 searchable DNA profiles. As a result of these convicted offender/arrestee samples, 56 unsolved cases were matched to convicted offenders/arrestees and 12 case-to-case matches were made, with a resulting total of 68 investigations being aided.
- In September, the Controlled Substances Unit completed 78 drug cases (55 were APD and 23 were Bernalillo County Sheriff's Office).
- In September, the Latent Fingerprint Unit completed 23 APD cases.
- In September, Major Crime Scene Investigations had three primary call-outs; four secondary call-outs; fourteen completed cases; and five pending cases

Property Crimes Division...

Auto/NITE Unit ...

- In September, the Auto Theft Unit had 30 cases assigned to them; cleared 31 cases; completed 11 self-initiated felony arrests; completed 21 in-custody felony arrests; and completed four bait car arrests.
- In September, the Auto Theft Unit conducted 59 free vehicle identification numbers (VIN) etches. Detectives at the Auto theft Garage conducted 58 VIN inspections both to the public as well as helping the field officers and other units in the identification of VIN altered vehicles.
- From January 1, 2016 to September 30, 2016, the Auto Theft Unit has recovered 262 vehicles worth approximately \$3,110,400.
- In September, detectives arrested several repeat offenders. One of the offenders was arrested four times in September for auto theft related offenses. His arrest was as a result of stealing a city-owned bait vehicle. During the incident, the offender initially entered the vehicle and locked himself inside. He then kicked out the driver's window and climbed back out. He re-entered

the vehicle a short time later and was successful in stealing it. As field units and detectives got behind the vehicle, it was remotely disabled. The offender jumped out of the vehicle's window while the vehicle was still in motion and attempted to flee on foot. He was caught after a short foot chase.

- In September, the Auto Theft Unit arrested a repeat offender. He was arrested by detectives on three other occasions, all involving stolen vehicles. The offender had previously stolen a bait vehicle. On this incident, he was in a stolen vehicle and was caught trying to flee the scene on foot after leaving the stolen vehicle in an underground parking structure while trying to elude Air Support.

Burglary and Organized Crime Unit ...

- In September, Detective Jojola from the Organized Crime Unit (OCU) arrested an offender who had been involved in numerous commercial, residential, and auto burglaries throughout Albuquerque. He was known to be one of the most active property crime offenders in the past two months. In addition, he recently began intimidating witnesses from his previous cases. The offender returned to the business of his previous victims and began destroying property with rocks. He was caught on surveillance video which led to his latest arrest warrant.
- In September, Detective D. Moore with OCU arrested an offender who had a felony warrant and was fencing stolen property at various locations. In addition, the offender had been absconding from probation by stealing the identity of another victim. The offender had several identifications and licenses.
- In September, Detectives D. Moore, and V. Santistevan were investigating a recent residential burglary which took place at a law enforcement officer's residence. Detectives learned of a suspect's identity and his pawning of property at a specific pawn shop. Due to the offender's frequent pawning at this location, detectives staged in the area. A short time later, the offender returned to the pawn shop with additional property that was suspected to be stolen. The offender was taken into custody and \$4,000 in stolen property was recovered. The offender was booked into the Metropolitan Detention Center.
- In September, Detective V. Santistevan completed her pawn/metal case for a local

plumbing company. She completed a warrant for the offender after he was identified as the suspect. The offender was arrested on the felony warrant in reference to him pawning over \$6,000 worth of tools that were taken in several local plumbing company burglaries. Many of the tools were recovered and returned to the victims.

- In September, detectives with OCU led by Detective D. Moore, completed a long-term investigation involving the dismantling of a fencing/racketeering ring affecting a large local commercial chain of outlet stores. The losses are in excess of \$200,000 in merchandise over the past six months. Detectives arrested multiple offenders in connection to this case. Two of the suspects worked at the business where the merchandise was embezzled from and sold via an online fencing operation.

Criminal Investigations Division...

- In September, the Homicide Unit responded to two call-outs.
- In September, the Armed Robbery Unit responded to seven call-outs and cleared 24 cases. Twenty of these cases were submitted to the District Attorney's Office for prosecution.
- In September, the Sex Crimes Unit responded to three sex crime call-outs. They also cleared 12 cases with three of those going to the District Attorney's Office.
- In September, Family Abuse Stalking/Training Team (FASST) had seven new cases assigned to them with nine being cleared.
- In September, Detective B. Samora followed up with a case involving an elderly male victim. The offender called the victim her dad and had a long history of violence towards family members. Detective Samora ensured the victim was able to attend the grand jury hearing which led to an indictment on three felony and four misdemeanor charges.
- In September, Detective Samora assisted a victim who had continually been harassed by her ex-husband. He assisted the victim with obtaining a restraining order, completed a summons for the charges and reviewed a safety plan.
- In September, Detective D. Torgrimson traveled to Oklahoma to provide detectives with his completed case. The offender in the case was arrested for the improper disposal of a body and homicide charges are pending.
- In September, Detective R. Lewis opened four more homicide cases from the 1990s. He is

actively working with the FBI's Behavioral Analysis Unit on these cases.

Special Investigations Division (SID)...

- In September, the Central Narcotics Unit served four search warrants, recovered two firearms and conducted two undercover buy bust operations.
- In September, the Central Narcotics Unit was notified of a location in the Southwest Area Command which was supplying drugs to numerous individuals. Central Narcotics Detectives conducted undercover operations and were able to purchase heroin. A search warrant was served and five felony warrants and probation violations, as well as one misdemeanor warrant were cleared. The felony warrants and probation violations included charges of trafficking narcotics, tampering with evidence, and bribery of a public official.
- In May 2015, the Central Narcotics Unit arrested a subject for selling methamphetamines and heroin to an undercover detective. The suspect accepted a plea agreement for the 2015 narcotics case. Central Narcotics continued to receive reports that this individual continued to sell drugs and expanded his drug dealing to a specific area. Detectives observed a high volume of foot traffic frequenting these areas. Undercover detectives purchased heroin from the subject and another female for several weeks. Felony arrest warrants were obtained for both subject and on September 9, both suspects were arrested. Both subjects had additional warrants besides the drug warrants, which were cleared. Heroin was also found in the male suspect's vehicle which was sealed for a search warrant.
- In September, the Central Narcotics Unit received information that a subject was selling large quantities of heroin from his business. Undercover detectives were able to purchase heroin and obtained a search warrant for the business. With the assistance of Southeast Team 3 officers, a search warrant was served. The suspect was arrested after detectives recovered trafficking amounts of heroin which the subject had flushed down the toilet when detectives were making entry. The heroin, trafficking paraphernalia, and firearm parts were seized.
- In September, detectives from the Investigative Support Unit made two felony arrests, arrested eight people for felony warrants, responded to six call-out requests and conducted a combined 600 hours of surveillance in furtherance of ongoing investigations.
- In September, detectives conducted an operation to intervene in a planned payroll robbery at a local family owned restaurant. With the assistance of Armed Robbery detectives, the offender was arrested and the robbery was prevented.
- From September 8 - 18, the Gang Unit assisted the New Mexico State Police with gang identification and enforcement during the New Mexico State Fair. Multiple gang contacts were made during this event.
- On September 9, the Gang Unit was conducting surveillance at a local motel. The unit had received several complaints of gang and narcotic activity at a specific hotel room. While conducting surveillance, detectives located an occupied stolen vehicle. A plan was put in place and the driver and passengers of the vehicle were taken into custody. The driver and passenger were arrested for multiple felony warrants.
- On September 28, the Gang Unit along with the Safe Streets Task Force received information that a known gang member was in the Albuquerque area. The subject had an active felony warrant for his arrest for homicide out of California. Surveillance was established and the suspect was taken into custody without incident.
- On September 13, Air5 was on patrol when they were notified of a stolen vehicle. Air5 advised dispatch and requested ground units for support to stop the vehicle. Air5 performed a tactical follow advising the ground units of its travel location and direction. When units attempted to stop the vehicle it drove off at a high rate of speed. The vehicle then drove into the city Corrales where the Corrales Police Department (CPD) engaged the vehicle in an attempt to stop it. At one point, the vehicle intentionally went head on with CPD in attempt to avoid being stopped. The stolen vehicle drove through Corrales and almost into Rio Rancho but turned around when the driver saw Bernalillo County Sheriff's Office and Rio Rancho Police Department units ahead of it. The vehicle then turned around and drove back into Corrales where it was spiked belted by a Northwest impact detective. Shortly after being spike belted, the vehicle came to a stop and the driver was taken into custody. The vehicle was recovered, valued at \$5,500.
- On September 9, Air5 was requested to assist the Gang Unit who had sight on a stolen truck.

At the time there were two male individuals standing outside the open driver's door but nobody in the driver's seat. Eventually, one of the males got into the driver seat and drove and entered a local truck stop. Once the male exited the store, Gang Unit detectives took him into custody and the other truck's occupants. The stolen truck was recovered and the driver was arrested.

Behavioral Health Division...

Crisis Intervention Unit (CIU)/Crisis Outreach and Support Team (COAST) ...

- In September, CIU/COAST met with the Mayor's office, the Fire Department and providers on an initiative to help deal with the growing panhandler issue. It is a project where calls for service are mapped to provide information on where panhandlers are located. A team of COAST civilians, an officer, the Fire Department and mental health service providers will go to those locations and offer resources. The project will be implemented in October.
- In September, CIU Detective Matt Tinney and Dr. Nils Rosenbaum went to Tacoma Washington for the Crisis Intervention Training (CIT) regional conference to present a class on the APD CIT program and the APD CIT knowledge network. We now have law enforcement from Washington state joining the network to help create best practices in CIT policing.
- On September 6, Detective M. Tinney provided a 1.5-hour class on mental health awareness and de-escalation techniques to the managers of a convenience store who helped with the New Mexico Special Olympics. There were 20 managers in attendance along with members of the Special Olympics organization.
- On September 14, Detective M. Tinney gave a two-hour class on mental health awareness and de-escalation techniques to the Albuquerque Housing Authority. The class had 44 students ranging from maintenance to the supervisors.
- C. Lopez assisted a veteran who had an eviction notice and needed \$1,403 for past three months of rent. He had a full-time and part-time job and had spent his money getting loans and fixing his 20+ year old vehicle. The interest on the loan was hurting him financially. Although he tried numerous resources, he didn't have any luck. C. Lopez referred him to several local charities. The client received \$1,800. They all made it

possible for the client to pay his rent and avoid eviction and homelessness.

- In September, CIU team 1 had been working with an individual struggling to maintain his apartment. The CIU team had completed several home visits hoping to establish him with aftercare. He had been fairly resistant to talking with the CIU team, however, the last home visit caused him to rethink the purpose of the CIU team's home visits. He reluctantly agreed to go to the hospital for an evaluation of his medications. He continued to say that the CIU team was yelling at him, although nobody had raised their voice. It appeared the voices he was hearing had become increasingly bothersome to him. He was transported to the hospital and admitted. The goal was to reconnect him with services and aftercare that was more stable for him.

Real Time Crime Center (RTCC)...

- In September, RTCC Bridge deployed four video trailers to the New Mexico State Fair to assist state police in monitoring parking lots, the midway and the main ticket area.
- In September, members of the Crime Analysis Unit attended the International Association of Crime Analysis training conference in Louisville, Kentucky. APD's Crime Analysts received tools on how to analyze victimization patterns as well as the development of web mapping applications to assist with creating real time maps.
- In September, Crime Stoppers took 164 tips of which 54 were for the location of outstanding fugitives.
- In September, the Crime Stoppers Unit helped host the National Crime Stoppers Conference. Crime Stoppers coordinators from across the country attended the conference at the Embassy Suites. The conference also celebrated Crime Stoppers 40th Anniversary.
- In September, the Bridge assisted in 2,591 calls. Of these calls 838 of them were generated by detective, dispatchers and field officers requesting assistance.
- In September, the RTCC gained access to the Crimes Against Children Unit's Case Management System. The Bridge now searches the system whenever it encounters a juvenile's name in order to make sure they are not a victim of a previous abuse or neglect. Since acquiring the system, it has been searched 92 times on active calls.

PROFESSIONAL ACCOUNTABILITY BUREAU

Communications Division...

- In September, the APD Emergency Communications Center staff answered 82,431 incoming calls. There were 33,770 calls answered for 911 and 48,661 calls answered for 242-COPS. 911 Operators answered 87.09% of the 911 calls within 10 seconds (national standard is 90%, APD's standard is 92.0%); operators also answered 87.44% of the 242-COPS calls within 90 seconds (APD's goal is 90% answered within 90 seconds).
- In comparison to last year for September, 911 call volume decreased by 6.2% and 242-COPS call volume increased by 1.4%. This represents an overall decrease of 1.85%.
- NCIC remodel was completed the first week in September including two new ergonomic consoles increasing the capacity of NCIC to two full time work stations.

ADMINISTRATIVE SUPPORT BUREAU

Planning Division...

- In September, the Planning Manager attended the International Association of Law Enforcement Planners (IALEP). Mrs. Garcia-Cunningham was voted in as IALEP Board Secretary.
- In September, Planning assisted in the presentation for the 2017 GO Bond Program Plan for Capital Improvement Projects.
- In September, minor renovations to the Main fifth floor break room were completed.


Central Records Division...

- In September, the Public Information Unit received 1,212 requests totaling \$7,424.15 in revenue generated from citizen requests/registers.
- In September, the Report Review Unit completed the following: 2,610 Automated Reporting System (ARS) transfers, 947 ARS supplements, 1,738 National Crime Information Center entries, 1,927 accidents, 3,377 officer calls and 440 Unified Crime Reports (UCR).
- In September, Court Services completed the following: 91 pretrial hearings scheduled, 361 arraignments processed, 384 felony cases submitted to the District Attorney's Office and 418 summonses submitted to the Metropolitan


Court.

- In September, the False Alarm Reduction Unit collected \$114,396 in fees and fines for a total of \$347,929 for the fiscal year. The unit entered 669 new accounts and mailed 12,398 pieces of correspondence. There were 1,448 false alarms in September which was an increase of 7.2% from this same month last year which was 1,385.
- In September, the Telephone Report Unit generated 778 original reports and 147 supplemental reports for a total of 925. This resulted in a savings of 2,405 hours of field services time and a savings of \$37,400.
- In September, the Telephone Report Unit processed 624 on-line (Cop Logic) reports resulting in a savings of 1,622.40 hours of field services time and a savings of \$24,960.
- In September, the Inspection of Public Records (IPRA) received 102 requests, completed 126 requests, and collected \$1,602 in revenue.
- In September, the Inspection of Public Records (IPRA) billed 28 IPRA requests for a total of \$391.50.

TOP 10 PROPERTY CRIMES FOR SEPTEMBER COMPARED WITH AUGUST




TOP 10 PERSON CRIMES FOR SEPTEMBER COMPARED WITH AUGUST






Year-To-Date Comparison
