Summer Recreation Program Dates & Hours of Operation: The 2020 DSA Summer Recreation Program will be June 8, 2020 to July 31, 2020. Program hours are M-F, 7:30 am – 5:30 pm. This program is for children ages 5-12, 5 year olds must turn 6 by September 1, 2020 (**Documentation Required**).

Due to the high participant demand for the City of Albuquerque's Summer Recreation Program, the Department of Senior Affairs has implemented a Lottery process for selecting participants. **Parents/Legal guardians** interested in their child/children participating, must complete a Lottery Form at the facility they wish their child/children to attend and will be asked to show proof of residency with one of the following documents:

Lottery Forms will be provided and accepted from Monday, May 11, 2020 – Wednesday, May 20, 2020 at Manzano Mesa Multigenerational Center. You can pick up this form at the Center from 9am to 10am during the dates specified. You can also print the form online at www.cabq.gov/multigenyouth and bring it back to the center during the dates and times specified above. Lastly, you can have the form emailed to you and you can bring it back to the center during the dates and times specified or email it back to mmc@cabq.gov

The Drawing will take place at Manzano Multigenerational Center on Thursday, May 21, 2020. The Lottery Forms will be drawn based on the participant limit for Manzano Mesa Multigenerational Center. Those who are City of Albuquerque residents (per City Council) will have priority. Should slots still be available, non-city residents will be accepted until all available slots are filled. Once filled, a waiting list with City and/or Non-City residents will be posted in the order drawn.

Was My Name Selected? If your child(ren) was selected in the lottery drawing, you will receive an email (emails will be sent to the address on file), with instructions for registering your child(ren) into the Summer Program. The names of the children selected will be posted on Tuesday, May 26, 2020. The list will be posted from Tuesday, May 26, 2020 – Tuesday, June 2, 2020 at Manzano Multigenerational Center. **CALLS TO THE CENTER ARE NOT ENCOURAGED, PLEASE CHECK YOUR EMAIL FOR COMMUNICATION.**

Program Registration for those selected, Program Registration will take place the week of Tuesday, May 26, 2020 – Tuesday, June 2, 2020 from 9am to 10am at Manzano Mesa Multigenerational Center. Parents can register in person during the dates and times specified or email the completed forms to mmc@cabq.gov

If the child/children are not registered between the week of Tuesday, May 26, 2020 –Tuesday, June 2, 2020, their slot(s) will be forfeited. NO EXCEPTIONS.
