## FIRST SUPPLEMENTAL AGREEMENT

THIS FIRST SUPPLEMENTAL AGREEMENT is made and entered into this day of and of the corporation, by and between the City of Albuquerque, New Mexico, a municipal corporation (hereinafter referred to as the "City"), and University of New Mexico, a New Mexico corporation, whose address is 1841 Lomas Blvd. NE, Albuquerque, NM 87131 (hereinafter referred to as "UNM").

## RECITALS

WHEREAS, the City and UNM entered into a Memorandum of Agreement, dated December 20, 2011, hereinafter referred to as the "Original Agreement", which pertained to the development of a community broadband project and other related technology projects; and

WHEREAS, the Original Agreement allows for additional activities to be the subject of amendments to the MOA via a Scope of Work incorporated as an addenda to the MOA; and

WHEREAS, the City would like to include an addenda to the MOA; and

WHEREAS, the City has determined that an extension to the Term is necessary; and

WHEREAS, UNM is agreeable to an extension to the Term and the inclusion of the Addenda.

NOW, THEREFORE, in consideration of the premises and mutual obligations herein, the parties hereto do mutually agree as follows:

- 1. Section 6. of the Original Agreement is hereby amended to read as follows:
- 6. Term and Termination. This MOA shall have a term of thirteen (13) years beginning on the Effective Date as set forth in paragraph 11 below, unless the Parties agree by signed, written agreement to either extend or earlier terminate this MOA.
- 2. This Supplemental Agreement incorporates the attached Scope of Work herein as Addenda 1.
- 3. Except as herein expressly amended, the terms and conditions of the Original Agreement shall remain unchanged and shall continue in full force and effect unless there is a conflict between the terms and conditions of the Original Agreement and this First Supplemental Agreement, in which event, the terms and conditions of the First Supplemental Agreement shall control.
- 4. This Agreement shall not become effective or binding until approved by the City's Chief Procurement Officer.
