The 700 and 900 series buses curerntly have 3G Verizon mobile routers. This effort is to replace those devices (PinPoint X and GX70) with 4G devices (MG90)

2. BUSINESS CASE/JUSTIFICATION:

3G cellular service by Verizon will go away (originally Decmber, 2019) in December 2020. The 4G MG90 is 4G and will continue to operate after that deadline; it's a good time to switch to T-Mobile for additional savings; the MG90 provides greater flexibility (cellular radio and wireless radio) and will allow us to consolidate communication channels from different equipment aboard the bus.
