Althea Atherton- City Council will be voting on a bill in January that approved language from free fare to zero fare. Worried if language is changed it takes away benefits of zero fare.

Rikk Murphy: I agree that the program should remain with the same name.

Samuel Jensen: This may be an issue that we may need to review and take action on again from what we already passed.

Keith Campos: Safety Compliance Specialist, new to Transit. Oversees safety concerns Transit has with employees, public and facilities.

TAB Chairperson's Report – Steve Pilon, Acting Chair

Steve Pilon-Thanked Christopher Ramirez for all his hard work and great leadership.

Director's Report: Mike Davis, Deputy Director

Mike Davis: Shared Zero Fares October report, ridership increased 10.7%, increase in Sun Van ridership, Security calls increase 1.7%. zero fares report on ridership, maintenance, operating, marketing costs and updates. https://www.cabq.gov/transit/our-department/reports

Starting pay for driver were raised, Maintenance slots are being filled. Bus driver surveys received were very small, we're going to try again. Down 30% in drivers.

We're working closely with council to maintain zero fares, it was deferred to January 4, 2023. No action was taken. There was a discussion about the same of the program. We'll have a tactical plan submitted after the safety piece of the legislation is passed. We have been exploring different options for phone pass providers. There is a cost to using a pass system. Ticket app would be tied into our Transit app. We're working through the logistics. Legislation was deferred because an equity analysis has to be done. We have cameras on buses to help identify passengers who are causing chaos. December 20 Transit is having Tell All media briefing. This is an opportunity to share with the media. We've updated our Transit App you can now see routes that are canceled, due to operator shortage. (*line crossed out over route*)

Samuel Jensen: City council seems to be creating more new and complicated situations. We're setting up our drivers for additional conflict. A cost analysis would be helpful for City Council.

Ben Garland: How is transit going to track or flag a pass for people that are creating chaos? Worried about privacy act.

Jett Metcalf: City is willing to go through all these extra features to reduce more access to the bus. We can continue to make progress towards safety while increasing ridership, instead of adding more costs and logistics.

Information Items:

Mike Davis: Service animal policy is a change on one of the questions asked. E-bike and E-scooters policy to allow bikes on bus with limitations.
