## **Director's Report- Mike Davis, Deputy Director**

Mike Davis: April Sun Van ridership 18,325 trips with a 10% increase. On-Time Performance for pick-ups is 85.3% and for appointments is 93.2%. We received 63 Sun Van applications for April. Connect ridership 1,536 trips in April. We have 84 Sun Van positions and 62 are filled, with a 26% vacancy rate. We are doing well with vehicle needs. Community Volunteer Bus Stop Clean up on May 31.

Robert Romero: There was a decline on the online Sun Van applications. Call Center received 17,304 calls and 15,825 calls were answered. Average wait time is 1:26.

Chris Love: Is Sun Van ridership and call volumes at pre-covid level?

Mike Davis: Shared screen to ABQ Ride Dashboard to find ridership information.

Robert Romero: You can now schedule five days in advance our reps are being proactive on the calls, we use first call resolution to help at call volume goes up.

Jeff Blair: Is there information on safety of the passengers and drivers?

Robert Romero: It's a rare occurrence that we experience any acts of violence on drivers or passengers.

Mike Davis: We have cameras on our vans and the See Say App as other safety measures.
