- <u>I. Native Land Acknowledgement/Called to Order:</u> S. Allen called the meeting to order on Zoom at 11:33 a.m. and A. Lipman provided the Native Land Acknowledgement.
- **II. Approval of Agenda:** S. Brueggemann requested to remove Item III from agenda as Deputy Director Menendez was unable to attend the meeting due to medical leave. A. Lipman moved to approve the Agenda as amended; M. Salazar seconded; all approved.

IV. Approval of February 18, 2022 Meeting Minutes: J. Youngs moved to approved the February 18, 2022 meeting minutes as submitted; A. Lipman seconded; all

approved.

V. Adoption of the 2022 Open Meetings Act Resolution: S. Brueggemann acknowledged that Adoption of the Open Meetings Act usually occurs earlier in the year, but given that the UETF committee has not held quorum since the February meeting, action was required now. J. Youngs inquired if City policies mandated latent accessibility accommodations for all board meetings, or if they needed to be requested. S. Brueggemann clarified that accommodations are currently only provided by request, but that an upcoming City workshop on open meetings and accessibility may provide some updates. J. Youngs moved to approve the 2022 Open Meetings Act; A. Lipman seconded; all approved.

<u>VI. Public Comment:</u> No public comment; D. Arellano used time to introduce herself to the committee and describe her duties in the Mayor's Office.

VII. Update/Discussion/Reviews/Approval:

- **A.** UETF Ordinance Update: S. Brueggemann gave the Ordinance Update: the ordinance changes have come out of Legal with some corrections to language and formatting and were sent to the Department Director. Given changes to staff on the Executive level, some time is needed to bring the new Chief Operations Officer up to speed before it is forwarded as an Executive Communication. S. Allen requested that the Committee be made aware when the Executive Communication goes to Council.
- **B.** UETF Webpage Updates: S. Allen thanked staff member M. Sanchez for all her work on updating the webpage; M. Sanchez and M. Matishak will now work to develop a page dedicated to the Resiliency Residency projects. M. Matishak then gave a brief summary of various Resiliency Residency projects and shared that staff had developed the exit survey which will be used to evaluate the program.
