According to campaign finance reports filed by Trudy Jones, several current city contractors made contributions to her re-election campaign for City Council District 8. They include:

Bank of Albuquerque \$250 on 9/17/2019 KYLE BEASLEY who listed his employer as : BANK OF ALBUQUERQUE a current City contractor according to City of Albuquerque Contractor List.

Bohannan Houston \$500 on 9/20/2019 BRUCE STIDWORTHY who listed his employer as Bohannan Houston a current City contractor according to City of Albuquerque Contractor List.

Dekker/Perich/Sabatini \$500 on 10/2/2019 RICHARD DALE DEKKER who listed his employer as DEKKER/PERICH/SABATINI current City contractor according to City of Albuquerque Contractor List.

CBRE \$250 on 8/26/2019 THOMAS JENKINS whose employer was listed as CBRE, a current City contractor according to City of Albuquerque Contractor List.

BODE Aero Services \$3,000 on 10/2/2019 John Bode whose employer was listed as BODE AVIATION, Inc. a current City contractor according to City of Albuquerque Contractor List.

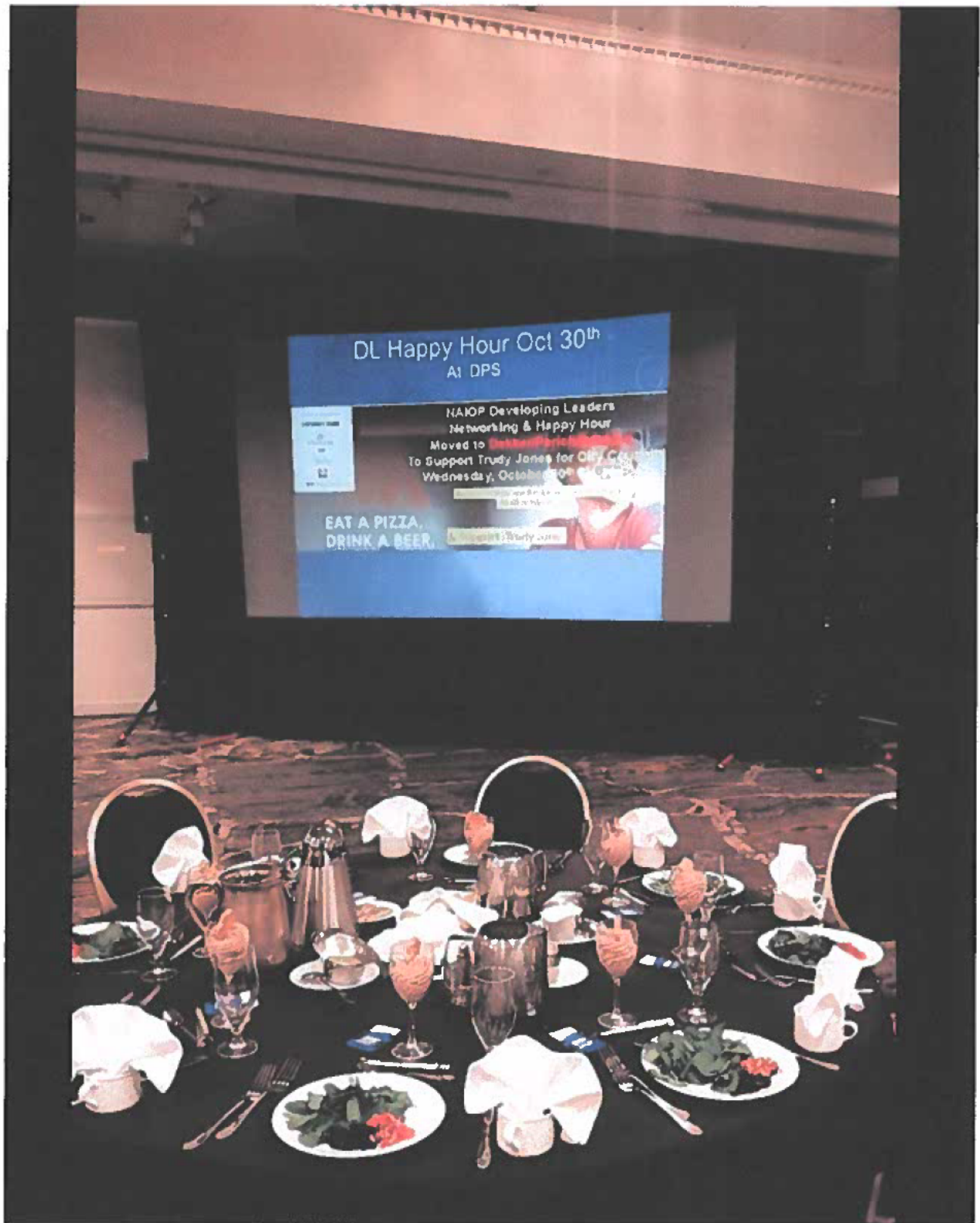
